By Jorge V. Rosales AZUSA - On Sunday, August 13, Azusa Council Member Robert Gonzales kicked-off the ninth annual "Kathy's Cool Kutz for Kids" a free back-toschool hair cut event at Memorial Park in Azusa.

This year for unknown reasons approximately only 100 school-aged girls and boys from Azusa showed-up to receive free professional back-toschool hair cuts from stylists and barbers who have their business in Azusa or daily work in one of the establishments in Azusa.

Kathy's Cool Kutz for Kids IX took place at the Memorial Park Gymnasium on Sunday August 13, 2017.

Potter and Councilman Gonzales came up with the idea for this event nine years ago. During the first year in 2009, 97 kids were serviced. The next year in 2010, the number of kids who received a free hair cut increased to nearly 200 kids. By 2016 the number of kids who received free haircuts increased to over 300.

Kathy's Cool Kutz for Kids IX was a success. It took place from Noon until 4:00 P. M. at the Memorial Park Gymnasium, which for one day became the largest hair stylist shop in Azusa or perhaps in the San Gabriel Valley at over 5000 square feet.


The event aimed to give children preparing for their first day of school a free hair cut to relieve some burden off the parents while giving kids the opportunity to look sharp on the first day of school.

This year's "Kathy's Cool Kutz for Kids IX" was coordinated by Councilman Gonzales and sponsored by Azusa Mayor, Joe Rocha, the City of Azusa, several hair stylists previously mentioned, as well as Vulcan Materials, Cory's Kitchen Foodbanks, Cardinal Laboratories, and Royal Coaches.

Vulcan Materials Company donated very colorful backpacks to each boy and girl. The other organizations contributed much needed school tools, such as pens, pencils, writing notebooks, and other tools for school use.

"I can't begin to express the gratification that overcame to me in seeing all those kids with their 'Cool Kutz' and smiles," said Gonzales. "They are now ready to face the new school year with a clean-cut look and with some very special free back-to-school back packs and school tools that every child received with their 'Cool Kut'."

The driver of the SUV got out and ran from the scene. He attempted to carjack another vehicle, but that driver was able to drive away. Witnesses said that an over-weight male Hispanic was the driver and he ran from the attempted carjacking attempt.

A married couple, both 70-year-olds, was injured in the crash. The man was driving and his wife was the passenger when the SUV crashed into the passenger side crushing the woman into the wreckage. The man was seriously injured with the woman in extreme critical condition. Firefighters had to use the Jaws of Life to cut the woman from the wreckage. She was in grave condition. Although the suspect was able to get away, the detectives did not give up on the investigation. They checked with and interviewed a number of witnesses, reviewed video surveillance cameras from the area. They were able to identify Mario Anthony Barillas, 37, of Baldwin Park as their suspect. He is a career criminal and they were able to obtain an arrest warrant and arrested him in Covina on Tuesday. Barillas' was being held on \$1.01 million bail. He is being charged with hit-and-run with injury, possession of a stolen vehicle, attempted carjacking, reckless driving and violating his preexisting probation stemming from a narcotics-related conviction.

GLENDORA - The Foothill Gold Line held a community meeting on August 7th with guests arriving at the Bidwell Forum between 5.30 and 7.30 p.m. There was no formal presentation. Hundreds of Glendora residents and residents from surrounding cities took advantage of this event to learn about the project's time line and other factors related to the Foothill Gold Line.

Similar meetings had already been held in the cities of San Dimas, Pomona, Montclair, Claremont and La Verne to keep the residents of the various cities informed.

The Foothill Gold Line from Glendora to Montclair is a 12.3-mile extension of the Metro Gold Line light rail system that currently runs between Los Angeles and the City of Azusa, along the Foothills of the San Gabriel Valley. The extension is part of the growing network of rail lines being built throughout Los Angeles County, and will add new Gold

Line stations in Glendora, San Dimas, La Verne, Pomona, Claremont and Montclair. Once completed, a trip from Glendora to Pasadena will take approximately 22 minutes and further to downtown Los Angeles will take approximately 51 minutes.


The Glendora to Montclair project will break ground in late 2017 and take nine years to complete. It is being funded by Los Angeles and San Bernardino Counties. The portion of the project within Los Angeles County (Glendora to Claremont) is being funded mostly by Metro's Measure M half-cent sales tax that was approved by voters in November 2016 and went into effect on July 1, 2017 (additional funds are coming from Measure R). The portion from Claremont to

Montclair is being funded by San Bernardino County.

The Glendora station and associated parking facility (with 420 parking spaces, charging stations for EVs, bicycle parking, and bus and drop-off areas) will be located just south of the city's historic downtown, east of Vermont Avenue and west of Glendora Avenue. The station will be a center platform station, with light rail tracks on either side (one for westbound and one for eastbound trains). Once completed, three tracks will run through the City of Glendora within one shared corridor - with two light rail tracks on the north side for the Gold Line and one track for freight on the south. While they will share the rail corridor, light rail trains and freight trains do not share tracks.

One Of Last Two Remaining Azusa WWII Veterans Passed Away

AZUSA - On Saturday, August 5, 2017, the community of Azusa lost one of the last two remaining World War II veterans. Manuel Michael Gonzales died after a brief period of illness and recent hospitalization at Inter-City Community Hospital in Covina in late June and released early July. The last time that Gonzales had been seen publicly was during the Azusa Memorial Day Ceremony on May 29, 2017.

Mike Gonzales, as he was most commonly known, was born February 24, 1922 in Dallas, Texas to Jose and Cesarea Gonzales. His father Jose worked in the railroad and early in his childhood they moved to Chicago, Illinois.

Prior to entering the U.S. Navy in 1943, Gonzales worked in the children's clothing industry in a company known as JK Industries in Chicago. During his WW II tenure in the Navy he served in the USS Decatur until his Honorable Discharge in May 1947.

On August 21, 1947 he was married to Josephine Luna who had been born in Azusa but was

visiting a sister in Chicago when she met Gonzales. The first two, Michael and Robert, of their five children were born in Chicago prior to their move to Azusa in 1952 because his wife could no longer tolerate the cold weather of Chicago.

In Azusa Mike and Josephine had three additional children, Teresa, Marie, and Diane. As an Azusan, Gonzales worked for the Azusa Post Office until his retirement in 1981. Josephine died November 2,

2011. Nearly seven years later Gonzales passed away on August 5, 2017. He'll be buried on Thursday, August 17, 2017 at Oakdale Mortuary in Glendora, CA following a 7:00 p.m. Rosary at White's Funeral Home on August 16 and a 9:00 a.m. Funeral Mass at Saint. Frances of Rome.is Johnny Granados

The only known remaining WWII veteran from Azusa, CA is Johnny Granados.

Glendora Mayor Boyer Tackles Districting Issue

GLENDORA - Glendora Republican Koffee Klatchers listened as as Mayor Gary Boyer explained the complexities of establishing voting by districts as demanded by Attorney Kevin Shenkman in his June 7th letter.

The charges in the letter said, "... voting within Glendora is racially polarized, resulting in minority vote dilution ..." Boyer categorically denied those charges and said Glendora, as other cities that have been challenged, just can't afford to go to court to challenge those charges. So far, Glendora, West Covina, Duarte and 60+ other cities, as well as 146 school districts, 27 community college districts, one (1) county Board of Supervisors and eight (8) water and other special districts have received a Shenkman letter or the same kind of letter from other attorneys.

Boyer said every city that tried to fight it has lost and cost them bunches:

Palmdale - \$4.7 million plus another \$3 million in other expenses; Modesto - \$3 million; Anaheim - \$1.1 million: and, Whittier - \$1 million.

The Mayor pointed out in 2001, when California Voting Rights Act was initiated and Gov. Gray Davis implemented in 2002, it took out several key requirements of the Federal Voting Rights Act that would have prevented this situation for Glendora and many other cities being challenged. Boyer told the group, Attorney Shenkman gets \$30,000 for sending out the form letter making discrimination charges and demanding a vote by district

or get sued.

Boyer made it very clear he and the rest of the Glendora City Council are not in favor of giving up city wide elections to go to vote by district. He encouraged those attending to take a look at the map provided by the city-hired demographer, Johnson, and create a four-district or 5-district voting map.

The Glendora Police Department Promotes School Safety

GLENDORA - The Glendora Police Department wants to welcome back all of our students for the 2017-2018 school year. We hope everyone enjoyed their summer and we join you in looking forward to a successful and productive school year. Chief Lisa Rosales said, "The Glendora Police Department cares very much about the safety of all our students and school staff." We value and enjoy our great partnership with the Glendora Unified School District. Last school year we successfully worked together for Child Safety Seat Awareness and developed a new Helmet Safety Program targeted at our middle schools, Goddard and Sandburg.

We are constantly looking for ways to improve vehicle and pedestrian safety in and around our schools. In this effort we reevaluated the effectiveness of our crossing guard locations and we will be reallocating two crossing guards to new locations. We based our determination on several factors including observation of the current

locations, interviews with the crossing guards, direct input from the crossing guard company supervisor, our School Resource Officer, the local schools, and input from community members we receive throughout the last school year.

We currently have 14 crossing guard locations in Glendora. We will move the crossing guards from two locations:

Lone Hill Ave / Route 66 (4way lighted intersection) serviced less than 10 students.

Grand Ave /Mauna Loa Ave (4-way lighted intersection) serviced less than 15 students.

The crossing guards will be relocated to:

Live Oak Ave / Whitcomb Ave (3-way stop signs) will service 80-100+ students.

The Glendora Police Department is also excited to announce the start of a pilot education program designed to encourage residents to drive safely around our schools. The "Glendora Safe Driving Pledge" will begin this week with the start of the 2017-2018 school year. Participating residents will "pledge" on the City of Glendora website to drive safely. Residents who make the "Glendora Safe Driving Pledge" will be entered into a drawing and winners will be announced at the Glendora Police Department Open House in May 2018. Residents will no longer be eligible for the program if they receive a traffic or parking citation in a school zone during the school year. More information will be released in the near future.



Dog Licensing Canvassing Efforts to Begin in the City of West Covina


WEST COVINA - Officers service related disability. from the Department of Animal Care and Control (DACC) will be in the City of West Covina beginning September 2, 2017, checking for current rabies vaccinations and ensuring residents are in compliance with licensing requirements. Securing a dog license is an important part of identification and can assist animal control agencies if your pet becomes lost.

Pet owners are advised to be in compliance with licensing requirements. The licensing fees for pets for City residents are as follows:

- Unaltered dog \$60
- Altered dog \$22

• Altered dog belonging to a senior citizen (60+)- \$10 West Covina's seniors are allowed to license an altered pet at the senior rate (limited to one (1) per household).

• Disabled Veteran dog - \$10 Proof of spay/neuter required in addition to proof of military

Bring medical records if you have them as well. Payment will be accepted via cash or credit card. Pre-registration

for this clinic is not required as services will be available on a first-come, first served basis.

Supervisor Barger Announces Proposal To Establish Blue Ribbon Commission On Public Safety

LOS ANGELES COUNTY -Supervisor Kathryn Barger announced today that she will introduce a motion, co-authored by Supervisor Janice Hahn, at the August 15th board meeting which will establish a "Blue-Ribbon Commission on Public Safety" to explore innovative solutions to criminal justice challenges resulting from statewide reforms.

The motion builds on a previous motion unanimously approved by the Board on February 21, 2017 which was also by Supervisors Barger and Hahn. The February motion requested a report on the murder of Whittier Police Officer Keith Boyer by a "Post Released Supervised Person," including an historical analysis of the gunman's involvement with the state parole system, his probation supervision, as well as recommendations for policies and procedures to help identify risk factors and ensure the highest level of public safety.

"Moving forward, Supervisor Hahn and I will be calling on our colleagues to support us on our collective goals of delivering meaningful treatment programs as well as enhancing public safety, including for our brave men and women in law enforcement," said Barger. "We have an opportunity to work collaboratively with all of our stakeholders to identify and implement lasting and meaningful solutions to these important goals which are not mutually exclusive."

"The tragic murder of Whittier Police Officer Keith Boyer has raised real questions about the County's policies and procedures regarding probation and our ability to adapt to statewide reforms," said Supervisor Hahn. "Public safety is our first priority. This commission would give us an opportunity to have this long-overdue conversation and allow us to take a critical look at our public safety policies."

Purposeful Aging Los Angeles Launches Landmark Age-Friendly Survey

LOSANGELES COUNTY -Purposeful Aging Los Angeles (PALA) - an Age-Friendly Initiative - launched a landmark survey today to gather feedback from County and City of Los Angeles residents that will guide the development of an Age-Friendly Action Plan for 2018-2021 for the Los Angeles region.

PALA seeks to prepare the Los Angeles region for a rapidly aging population through an innovative, sustained initiative that unites public and private leadership, resources and strategies. The older adult population (65 years and above) in the Los Angeles region will double between 2010 and 2030, from approximately 1.1 million to more than 2.2 million people.

"This is an opportunity for County and City of Los Angeles residents to speak out and help us make the Los Angeles region more age-friendly, allowing people to age in place and in community," said Cynthia Banks, Director of Los Angeles County Workforce Development, Aging and Community Services.

"We ask residents of every community in the County and City of Los Angeles to join us in changing the future of aging in our region by taking this incredibly important survey," said Laura

Trejo, General Manager of the City of Los Angeles Department of Aging.

The confidential PALA survey takes about 20 minutes to complete and can be filled out by anyone 18 years of age or older who resides in the County of Los Angeles. The survey is available in 10 languages at purposefulagingla.com and will be available from August 14, 2017 - September 15, 2017. Individuals and organizations are encouraged to help promote the survey to County residents using a Toolkit available at purposefulagingla.com.

Supporting Higher Education For Foster Youth

LOSANGELES COUNTY -The Board of Supervisors unanimously approved a motion by Supervisors Kathryn Barger and Hilda Solis to support Senate Bill 12 (Beall) which seeks to increase access to postsecondary education for foster youth.

"Access to financial aid and an awareness of how to navigate what is considered a complex and complicated financial aid system prevent many foster youth from even considering postsecondary education as an option after high school," said Supervisor Barger. "SB 12 streamlines the process and addresses some of the challenges that prevent foster youth from achieving their academic goals by providing much-needed support and guidance."

"Youth in foster care face tremendous challenges in their young lives, including suddenly changing schools and unexpected absences, and they need additional resources to meet their full potential. The key provisions of SB 12 include:

• A requirement for each county child welfare agency to identify a representative to assist foster youth with applications for postsecondary education and financial aid.

Get Ready for the Great **American Eclipse!**

GLENDORA - On Monday, August 21st, 2017, a total solar eclipse of the sun will be visible in the continental United States for the first time in almost 40 years. It is a scene of unimaginable beauty; the Moon completely blocks the Sun, daytime becomes a deep twilight, and the Sun's corona shimmers in the darkened sky.

Most of the country, being outside of the path of totality, will view a partial eclipse, which is still a beautiful experience. In the Los Angeles area, we can expect to see about 62% of the sun's surface covered by the moon.

If you would like to learn all about this event, the Glendora Library is the place to be on Monday, August 7th, at 6:30 PM. "Get ready for the great eclipse!" will be led by Tom Mason, a local astronomer and operator of the 60 and 100 Inch Historic Telescopes at the Mt Wilson Observatory. Mr. Mason will cover the following:

- How to view an eclipse - Why does an eclipse happen?

- Equipment and safety

All attendees will receive a free pair of solar glasses! These glasses allow anyone to safely view the sun at any time of year. The library has received a large shipment of these glasses, most of which will be distributed to second graders who attend Glendora schools. But a limited number will be set aside for anyone who attends the August 7th eclipse program. Don't miss out! Limit one set of glasses per person.



WEST COVINA - This past week, it was reported that a U.S. Marine helicopter crashed over the weekend when attempting to land on a U.S. Navy ship. The personnel were participating in a training exercise off the coast of Australia. Twenty three out of the 26 Marines were rescued at sea and taken to a hospital. One of the pilots and two Marine passengers however were not found and are considered lost as a result of this tragic accident. On Tuesday evening, West Covina Police Department Lieutenant Dennis Patton, Lieutenant Pat Benschop, Officer Eddie Flores, and West Covina Police Department Chaplain Dane Johnson met with the Velasco family to express condolences on behalf of the Mayor/City

Council and the entire City of West Covina extended family.

The West Covina Planning Commission adjourned its Tuesday, August 8, 2017, meeting in his honor. In addition, the City Council adjourned the Tuesday, August 15, 2017, City Council Meeting in his honor.

The City of West Covina City Council and staff are deeply saddened by the heartbreaking loss of West Covina resident Pfc. Bully Pulpit Strikes Repercussions Council Districts Come to Mayberry

Republican Assembly Leader, Chad Mayes and the gang of 6, rolled over voting for Cap and Trade giving us another gas tax increase and electricity rate increases. A vote by Republicans, not necessary for passage, and money, agreed across the aisles, will be targeted to funding the bullet train, otherwise known as the "train to nowhere".

Republican organizations, one after the other, wrote letters to Chad Mayes asking him to resign his Assembly leadership position.

For me, comments closest to home were those from Assemblywoman Melissa Melendez, (R-Lake Elsinore) who ended up resigning her Assistant Republican Leadership position unable to continue to support Mayes. She said it well replying to the vote, "Californians are struggling to make ends meet and unfortunately, what I have witnessed by the Assembly Republican Leader is a dereliction of duty to preserve and promote the American Dream for every single Californian. Assemblyman Mayes' actions on Cap-and-Trade demonstrate we no longer share the same leadership principles. came from Assembly Speaker Anthony Rendon, D-Paramount. Rendon's office declined to comment beyond a one-sentence letter issued by the speaker Wednesday announcing Melendez was no longer vicechair."

The Democrats didn't need her vote for Cap and Trade to pass ... it passed ... so what's the issue with Melendez speaking up to challenge her own Republican Leader on his leadership and his vote?

Glendora residents recently received in their mailboxes the August/September 2017 issue of Glendora Report, our official city newsletter.

Page Four describes the cynical shakedown letter Glendora received from Malibu attorney Kevin Shenkman, who specializes in forcing cities and school districts with at-large voting in local elections to switch to district elections or face a sure-tolose lawsuit in which he makes lots of money. The legal hook making this scheme so viable is innocently called the California Voting Rights Act, passed in 2002 by the Legislature and signed by then-Governor Gray Davis. Supposedly patterned on the federal Voting Rights Act of 1965, the California version has a vastly lower burden of proof and empowers attorneys to sue local governments and put millions of taxpayer dollars in their personal pockets unless the local jurisdictions submit to district voting.

The Glendora City Council bowed to political and fiscal reality and approved districting last month. Let's look at three common approaches to districting and see what you think of them.

The first approach is to create five council districts as small as geographically possible on the theory that the elected councilperson will represent their neighborhood. The experience is that they will indeed do just that. The problem is that they won't represent the city as a whole, and it could cause intra-city warfare between neighborhoods.


Long time SOS Glendora members will remember that Monrovia Nursery tried just such a divide and conquer tactic on us in 2005-07. They divided the Nursery area into 11 "neighborhoods", had local leaders in each one, and a series of catered meal (yum!) meetings in each one. In each one, they explained to the assembled residents how much they loved them, and how they were trying to do their best to make sure their neighborhood's concerns were taken care of in the development plan. They intimated other neighborhoods were the problem, and that Mom loved them the most!

SOS Glendora recommends Glendorans do not set themselves up for a divide and conquer strategy for developers and other interest groups in Glendora through this "My neighborhood first!" approach.

The second approach is four council districts and an elected Mayor. That lends itself to quartering the City, and promotes a citywide elected Mayor who usually tries to be a king maker throughout the four council districts to maximize his/her own influence.

much as possible while we are doing it!

Please note that all five districts share a piece of Route 66 by virtue of council districts being oriented north to south. That means that all five council people own a piece of that Route 66 Corridor Specific Plan, and we can hold all five of them accountable to us residents for future developments in that corridor. Nobody gets to wash their hands of it and say "it's not in my district!" Nobody gets to ignore south Glendora either. Four out of five will have a piece of south Glendora, and all of them had better be responsive to residents from ALL parts of Glendora.



The third approach is the Glendora United approach, and it is the one recommended to you. In this strategy, five council districts are created and the rotational system for selecting a Mayor that Glendora has successfully used for over a hundred years is continued. After consulting our local homeowner leadership group, SOS Glendora officially recommended the following map to the City for the new districts.

Please note that a majority of these proposed districts unite Glendora by running from the north end to the south end of our town. We don't want to be fractured into north and south, east and west. Some geographic division is intrinsically required by the very concept of districts, but we want to unite Glendora as What can you do to help? Go to the Glendora City website and register your support! Please go to the city website http:// www.ci.glendora.ca.us/ . The districting information will be on the front page and you click more information. Then click Meetings/Documents and go down to the presentation link. Click it and you will see a live link to the City Clerk email. Click that and write: Dear City Council

Please approve the Glendora United Districting Plan to keep Glendora unified and provide our citizens with the best representation.

Deadly Violence at Virginia Protest Rally over Removing Robert E. Lee Statue. Are You Kidding Me?

Rancho Owner... Recent housing values in the San Gabriel Valley suggest an escalating price in home values however the price of land in the San Gabriel Valley has always been an appreciable investment. In 1865, land was a valuable commodity and owning it provided owners with an asset in which to further build one's estate and value.

In the San Gabriel Valley, William Wolfskill and Leonard Rose each purchased subdivided parts of Rancho Santa Anita from Hugo Reid, most of which was located in the present City of Arcadia. Wolfskill was from Kentucky, arrived in Mexico California in 1831 and acquired 11,000 acres of the prime acreage throughout the eastern San Gabriel Valley for \$20,000. He was a horticulturist, who developed the first commercial grape in California, and in 1856 was deemed to have the best vineyard in the state. In 1862, Wolfskill owned two-thirds of all orange trees in California. With his purchase of Rancho Santa Anita, Wolfskill and his expertise were seen as a perfect match to make the rancho prosperous again.

But one year later, Wolfskill took ill and his life was cut short. In that short year, he only had time to do one thing, plant Eucalyptus trees, which still exist today on Santa Anita property.

His son, Louis, took over ownership of Rancho Santa Anita and soon the increase of American businesses turned the rancho into valuable real estate property. The price of land continued to escalate throughout Southern California, and Louis began to sell off parcels of Rancho Santa Anita in order to increase his profits. Alfred Chapman purchased 1,700 acres on the west boundary for \$19,800, nearly the same price his father paid Hugo Reid for over 11,000 acres nearly 3 years before. Chapman's property would later be called Chapman Woods, as it is still called today. Louis Wolfskill offered the majority of his property, especially around the Reid homestead and lake, for sale. Today the site is located on Los Angeles County's Arboretum.

In 1870, Rancho Santa Anita was offered for sale at \$9.00 an acre, by 1872 it had increased to \$10.50 an acre. Finally, a Los Angeles merchant, Harris Newmark, purchased the entire rancho for less than \$10 per acre. Newmark had learned of a proposal to build a railroad adjacent to Rancho Santa Anita and sensed an increase in value of his recent investment. With no intention of developing the rancho, Newmark held on to the property, hoping eventually to turn a hefty profit with a big sale.

Enter E.J. 'Lucky' Baldwin, who after some shrewd negotiating by Newmark, purchased Rancho Santa Anita for \$25 an acre, a 150% increase in what Newmark paid just a few years earlier....



Weak U.S. Dollar Boosts **Multinational Stock Profits**

Recently I read a great report that illustrated how the "international" stocks within the S&P 500 (defined as those with more than 50% of their revenue outside the U.S.) are soundly beating the "domestic" stocks (defined as companies that earn over 90% of their revenue within the U.S.). This report showed that since the 2016 Presidential election international stocks have risen 28.4% while domestic stocks were up "only" 12.8%.

One reason international stocks rose faster is the weaker dollar. Another reason is international stocks were cheap in comparison to U.S. stocks. A third reason international stocks have been hot is that China's National Bureau of Statistics announced that its GDP expanded at a 6.9% annual pace in the second quarter. This acceleration in GDP growth is being boosted by a surge in both exports and imports, so China appears to have resumed its leadership role as one of the strongest economies in the world and investors are aggressively buying Chinese ADRs. Many have questions if China's economic numbers are accurate.

The failure of the Republicanled Senate to pass healthcare reform became another factor causing the U.S. dollar to hit a 13-month low. A weaker U.S. dollar is good for most multinational companies and exporters. The Trump Administration is not encouraging a strong U.S. dollar, since a weak dollar boosts exports as well as making imports less competitive. In addition, the Fed's recent admission that inflation is cooling off and that it will not raise key interest rates soon has also contributed to a weaker U.S. dollar. A weak dollar tends to narrow the trade deficit, which has been a persistent drag on U.S.



GDP. One key to getting GDP growth back to 3% is to significantly narrow the trade deficit.

Meanwhile last Thursday, the European Central Bank (ECB) left key interest rates unchanged and painted a picture that inflation has been "subdued" due to low energy prices. The big surprise was that ECB President Mario Draghi said that a "substantial degree" of monetary accommodation is still needed despite improving economic growth in the European Union. Furthermore, Draghi said that the ECB had not discussed the future of its bond buying program (e.g., quantitative easing), but would do so in the fall.

This essentially squelched any speculation that the ECB might wind down its quantitative easing sooner than later. When Draghi speaks at the Kansas City Fed's conference in Jackson Hole, Wyoming in mid-August, it looks like he may not make any significant announcement that would impact financial markets.

Commodity prices were down in the first half of 2017 but are now rising, since commodities are universally priced in U.S. dollars. A weak dollar tends to lift commodity prices higher.

Housing Shortages Have Also Impacted the Economy

One clear reason for our housing shortage is the lumber tariff enacted recently. Back in April,

Commerce Secretary Wilbur Ross announced a 20% tariff on Canadian softwood lumber imports due to the Trump Administration's determination that Canada improperly subsidizes its lumber exports. Lumber prices are now on the rise, which apparently caused the National Association of Home Builders' sentiment index to decline to 64 in July, down from 67 in June.

Interestingly, homebuilder sentiment is now lower than it was prior to the Presidential election. The reason that homebuilder sentiment is important is that there is a shortage of housing, so builders still have tremendous power to raise home prices. Their sentiment shift is an interesting development worth watching.

The Commerce Department recently announced that housing starts in June rose to an annual pace of 1.22 million, significantly above economists' consensus 1.16 million estimate. June's housing starts were 8.3% higher than May and 2.1% higher than a year ago. Building permits also rose 7.4% in June compared to May and are now up 5.1% vs. a year ago. Single family home starts rose 6.3% in June compared to May, so builders are still favoring multi-family homes. The acute shortage of new homes for sale may have to be addressed politically. Median home prices should continue to rise due to the lack of inventory of new homes for sale, so hopefully building activity will improve in the upcoming months.

Your Money - Ask Julia

A number of years back, we got a line of credit to do some major repairs on our home. Our 'draw' period ended almost 5 years ago, and the bank gave us 5 more years to continue making interest-only payments. In 2 months, our payment amount will almost double when we have to start paying principle plus interest. It's not in our budget; we know we cannot afford it. What do we do now?

It's commendable that you are aware of this impending financial problem and are ready to take some kind of action now. Here are 3 steps to start with: 1. Let's find out what amount of equity you have in your home (now that house values have risen), and see if you qualify to refinance your first and line-of-credit into one loan. 2. If not, then we'll need to look at your budget to see where you might be able to re-allocate funds. 3. Sometimes it becomes necessary to get a part-time job. But, don't panic. Just take one step at a time.

My wife and I are looking into getting some life insurance. I am insurable, but my wife has some health issues and will be 'rated.' Is there a way to get some life insurance on her without paying the higher 'rated' premiums?

We could look into a secondto-die life insurance policy with a first-to-die rider. Normally, a second-to-die life insurance policy is used to pass more money to heirs. The cost is typically lower because the payout is based on

the lives of two people, while the insurance company only pays when the last one dies. By paying extra for the first-to-die rider (typically less than 'rated' premiums) the insurance company will pay at the passing of the first person insured on the second-todie policy.

Now that a new school year is starting, I'm thinking that I should be saving for my children's college educations. What are my choices, and what's best?

The earlier one starts to save for expensive things in life - college, home purchase, retirement, the better. Setting up a savings plan is a wonderful gift from parents, grandparents, aunts, and uncles. Choices include College Savings Plans, Roth IRA's, Annuities, and Life Insurance with a cash account. What's best for you and your children really depends on your specific situation - how much money you have available to invest, how many children you have to save for, and your personal concerns. I personally

don't recommend a College Savings Plan (ScholarShare/529, etc.).

We are totally stressing out with worry that we won't have enough money for retirement. Is there something we can do to relieve our stress?

You have just taken a big, brave step in the right direction! You spoke up, and asked for some help. 

In the future, use best practices with your credit card. Opt for two-factor authentication when available while shopping online to make it more difficult for scammers to take over your accounts. The good news is that car seats, booster seats and seat belts save lives. In fact, in 2015, car seats saved the lives of an estimated 248 children under age 5.

The bad news is every day in America, too many children ride in car seats that have been installed incorrectly, or are riding in the wrong car seats for their ages and sizes. On average, two children under 13 were killed and 319 children were injured every day in 2015 while riding in cars, SUVs, pick-

There's good news, bad news installed their child's car seat, many have not.

> What's more, according to NHTSA data, in 2015, about 25.8 percent of children 4 to 7 were prematurely moved to seat belts, when they should have been riding in booster seats. Technicians can also help educate consumers about choosing the right car seat for their child, the importance of registering that car seat with its manufacturer, and what to expect if the seat is subject to a safety recall.

> Anyone driving with a child in the car should read and carefully follow the installation instructions included with a car seat as well as the vehicle owner's manual.

NHTSA recommends keeping children in rear-facing car seats as long as possible, up to the car seat's top height or weight limit. Then, it's time for a forward-facing car seat with a harness and



ups and vans.

The great news is that when used correctly, car seats reduce the risk of fatal injury by 71 percent for infants and by 54 percent for toddlers. For infants and toddlers in light trucks, the corresponding reductions were 58 percent and 59 percent, respectively. By law, all children must be buckled up in appropriate car seats or booster seats while riding in cars.

Keeping Kids Safe During Child Passenger Safety Week, September 17-23, 2017, many communities will have Certified Child Passenger Safety Technicians on hand to provide training on how to use car seats, booster seats and seat belts for children. While most parents confident they've correctly


tether. After outgrowing this car seat, the child should ride in a booster seat until he or she is the right size to use a seat belt safely. For a seat belt to fit properly, the lap belt must lie across the upper thighs, not the stomach, and the shoulder belt should be snug across the shoulder and chest, not the neck or face.

Whether they are in a car seat, a booster seat, or buckled in their seat belt, children under 13 should always ride in the backseat because it's safer there.






