# Citrus College Honors Graduates, Alumni at Annual Commencement Ceremony

GLENDORA - Citrus College celebrated the academic achievements of 1,404 graduates during its annual commencement ceremony on Saturday, June 17. Of the various degrees awarded to the Citrus College class of 2017, 916 were associate degrees for transfer. This number reflects a 21-percent increase in the number of students receiving transfer degrees compared to the 2015-2016 academic year, signifying a new institutional record.

Glendora resident Christopher Badoyan is a member of this year's graduating class who received an associate degree for transfer in history. The first in his family to attend college, Christopher hopes to one day earn a doctorate in education and become a college counselor.

"I chose to enroll in classes at Citrus College after high school because I wasn't sure which way I wanted to go, and I knew that the college faculty and staff could help me find my path," he said. "Since then, I have become more confident and sure of my abilities. I now know what I want to

Monrovia resident Johnny Elie Baradii was also among those honored during Saturday's ceremony. Originally from Leba-



non, Johnny moved to the San Gabriel Valley to pursue higher education. Upon the recommendation of a relative, he enrolled at Citrus College.

During his time at the college, Johnny worked as a math, physics and chemistry tutor in the Math Success Center. He was also active in the STEM program and earned a Citrus College Key of Knowledge, the highest academic honor bestowed by the

In the fall, Johnny plans to

transfer to a University of California institution as a civil engineering major.

"Being a civil engineer will put me in a position to innovate, create and design infrastructures that are better for human beings, animals and the environment," he said. ## **Azusa Police Department Releases** Video of Auto Burglary Suspect

Department recently released a video of a suspect who has been

burglarizing cars in the area of AZUSA - The Azusa Police citrus Avenue and Gladstone Street. The video has been posted on various social media sites in-

cluding Facebook. It shows a male suspect with a flashlight looking into a family SUV and then opening the door and going through the vehicle to find items to steal. The Azusa police are asking for help from the community in identifying the suspect. If you see the suspect, do not approach him as they believe he is extremely dangerous and might do just about anything to get away. Call the police immediately.

It is believed the video shows the suspect committing the burglary in the early morning hours of June 13 which would be a Tuesday.

Citizens in the area have applauded the police for posting this video and those that live in the area of the crime state that there has been a high level of this type of crime in their area. The police have not stated if they have recovered any other evidence such as fingerprints or any other reliable pieces of evidence to identify the subject.





## Cannabis Advisory Group To Begin Work

LOS ANGELES COUNTY - Los Angeles County's cannabis regulation efforts have entered an important new phase with the convening of a diverse advisory group made up of health and policy experts, community leaders, cannabis industry representatives and other key stakeholders.

The group will meet eight times between June 29 and August 31 to develop recommendations for the County as it formulates regulations for commercial and personal-use cannabis in unincorporated areas. These meetings are part of an extensive and inclusive planning process that will also include a series of upcoming meetings to gather public input.

Topics to be discussed by the advisory working group include youth access and exposure to cannabis, taxation and revenue, operational standards for cannabis businesses, and the cultivation of cannabis for personal use, among others.

The all-volunteer group is being convened by the Los

# **County Budget Takes Balanced Approach To Meeting Public Needs With Fiscal Prudence**

LOS ANGELES COUNTY

— On a unanimous vote, the Board of Supervisors have authorized a \$30 billion budget for Fiscal Year 2017-1018, announced Supervisor Kathryn

"CEO Sachi Hamai and her team have developed a balanced budget that addresses the County's priorities while still taking a fiscally cautious approach to the use of taxpayer funds. This dedication to fiscal prudence will be especially important as we begin to allocate Measure H revenue to implement homeless strategies in the most effective and efficient manner.

Additionally, the county budget includes a \$27.4 million allocation for the Rainy Day Fund which is vital to ensuring the continued provision of services in the face of unanticipated economic challenges. I look forward to the supplemental budget phase when we will be able to further augment the Rainy Day Fund.

For their collective efforts to educate credit rating agencies on the county's fiscally prudent financial management practices, I commend the Chairman, Supervisor Mark Ridley-Thomas, the CEO, Auditor-Controller, Treasurer and Tax Collector, and DHS whose efforts lead to a recent upgrading of the county's bond rating – we achieved the highest possible short-term ratings, and our long-term credit rating was upgraded to the highest it's been in a decade."

## Freeways Shut Down as Pursuit Ends at 10 & 605 Freeways. Two Arrested

BALDWIN PARK - on Thursday, June 22, around 11 PM the television news channels quickly diverted their attention to a pursuit in the area of El Monte and Baldwin Park by the 10 and 605 freeways. Police were chasing two robbery suspects who were trying to get away and driving at excessive and dangerous speeds as well as making maneuvers that were endangering the lives

of others. As the police helicopter and news helicopters tracked the suspects, the ground units backed off in an attempt to slow the suspects down. This failed to do anything other than to allow the suspects to continue to drive in an extremely dangerous manner. Ground units knew it was a matter of time before there would be a deadly collision and they resumed their ground pursuit.

The suspect did just about everything to get away from the police including driving in the wrong direction on the freeway a number of times.

With the news helicopter being able to zoom in on the suspects vehicle with their cameras, it established the fact that there were at least two suspects in the vehicle. One a woman and the other man.

As the pursuit continued on

the freeway, the suspects took an access road and then reversed their direction of travel once they got into a blended lane on the freeway and started driving towards traffic again. As seen on TV, this was at the interchange of the 605 and 10 Freeways. When the suspect realized that the police did not make the same maneuver, they pulled their car to the side and jumped from the vehicle. As they ran down the embankment, the news chopper zoomed in on the two suspects. The male suspect was out running the female suspect and went under an access bridge. Police from El Monte, the California Highway Patrol, Irwindale, West Covina, and the Sheriff's Department all converged on the area where they set up a perimeter to lock the suspects up into that area. At this point, the CHP started shutting down the freeway of traffic. Soon, the news helicopters spotted the male suspect

During that time, the female suspect was found and taken into custody. As more and more police officers showed up to find the male suspect, a number of departments brought their canines to help with the search. The suspect was located and taken into custody.

It was believed that the suspects were involved in armed robbery. However at this time it has not been confirmed.

## **Barger Opposes \$3 Million Legal Defense For Illegal** Immigrants Facing Deportation LOS ANGELES COUNTY

On a 4-1 vote with Supervisor Kathryn Barger opposing, the Board of Supervisors authorized a \$3 million agreement with the California Community Foundation to provide

legal defense for illegal immi-

grants facing deportation. "Our federal immigration system is broken. It is the federal government's responsibility to support states and counties in their efforts to address the costs of illegal immigration," she said. "Consistent with my position on this issue on December 20, 2016, county taxpayers should not be forced to bear the cost to provide free legal representation for those facing deportation." On December 20, 2016 the

motion to create the Los Angeles Justice Fund passed on a 4-1 vote. This motion directed the County CEO to identify and set aside \$1 million in Fiscal Year 2016-2017 and up to \$2 million in Fiscal Year 2017-18 with the purpose of providing legal representation to illegal immigrants at risk of deportation. This funding would be in addition to a \$2 million contribution from the City of Los Angeles, and a \$5 million contribution from the philanthropic community. The totality of these contributions would bring the Los Angeles Justice fund to a total of \$10 million.

## Edict From AG Becerra Ignored

Times reported California's new Attorney General Xavier Becerra has issued orders "prohibit[ing] state employees from official travel to Alabama, Kentucky, South Dakota and Texas based on his determination that they have enacted laws that are discriminatory based on sexual orientation and gender identification." 

## The Takeover Of Authentic Religion

"If that is what religion has become, I want nothing to do with it." This came from a young adult, speaking about the takeover of religion by the political rightwing that now owns the evangelical version of the Christian faith. My young friend is not alone.

While "Christian" now seems to mean right-wing politics, authentic religion in America is being increasingly sidelined. Nobody who takes a serious look should have the slightest doubt that for years religious popularity has been in a free-fall. People, principally young American adults, have bailed out of organized religion in massive numbers. While for some time that been true for the progressive or liberal churches, for the last decade it has also been true for evangelical institutions. Today there are fewer emerging mega churches, and many that became prominent twenty years ago are beginning to fade, even to close. If you want the statistical evidence for these statements, take a look at The End of White Christian America, a recent well-researched analysis by Rob-

ert P. Jones. While the reasons for this decline are many and complex, chief among them is the takeover of religion by a strident new form of fundamentalism. This institutional phenomenon has its roots, not in traditional Christian ethics, but in a carefully designed political effort. In many conservative churches the way of Jesus has been turned on its head and now looks more like proclamations by the Tea Party than it does the Sermon on the Mount. While

American religion had been moving in that direction for a number of years, the drift became an avalanche with the coming of the

secularist, Donald Trump. His political appeal, which includes racism, nationalism, militarism and xenophobia, has invited a too-easy transition for much of the American faithful evangelical community. Trump, who is dedicated to issues that are the opposite of a Jesus-based ethics, was elected with the whole-hearted support of from 81% to 86% of America's evangelical voters. One of the results is that thoughtful young American adults have bailed out of their churches in significant numbers.

The strength of American Christianity was formerly seen in how the nation consistently adopted a societal agenda that institutionalized justice, economic equality, civil rights, world peace, ecological sensitivity and compassion for the left out. America's main-line churches and synagogues supported public policies and laws that flowed from these ethical norms. From civil rights to immigration, America's churches backed what

they saw as a dynamic flowing from Jesus' perspective on the shape of a more just world.

Just what part of the Trump agenda do evangelicals believe is grounded in a responsible Christian ethic? Is it "America first," a wall on our southern border, the removal of health insurance from 23 million Americans, calling climate change a hoax and doing away with any program to counter global warming, the proliferation of firearms in everyone's hands, or the massive arms build up?

At the same time while liberal religion was working and witnessing for social and economic justice, it found itself hindered by anarchists and other advocates of violence who resorted to destruction of property, disruption at demonstrations and threats of assassination. Liberals have no affinity or a common cause with these thugs, and have consistently joined the rest of society in repudiating them. Nevertheless, there are conseratives who brand these activities to be the very essence of liberalism.

Why progressive religion has stood quietly by while evangelicals have continued to define religion in Tea Party-like terms, remains unclear This in not only a political obscenity it is also a perversion of the essential ethic that has defined the Christian imperative. It is past time we branded this religious perversion for what is, a confiscation of religion by political operatives.

**TV Heroes....** With the passing of Adam West a few weeks ago, it brought back memories of the Batman TV series which ran from 1966 to 1968. As a young kid growing up at that time, Batman was the show everyone waited for all week. It was so popular that it ran on two separate week nights, Tuesday and Wednesday, and was rated as one of the top TV shows during its time on the network. It seemed like it ran for more than 3 seasons but that may have been because of all the reruns of the show. But it was Adam West which made the show what it became. He played a straight and narrow super hero who seemed to be more at ease wearing his cowl than without it. He talked in an almost boring rhythm with a flair for dramatic pronouncements. The TV show added to his delivery by showing colorful images with action words like WOW, POW, ZAP and WHAM in bright colorful overlays during fight scenes.

West started out as a small bit role actor who was struggling to make it in the business until he

appeared in a commercial which was seen by the future director of the Batman series. He took a screen test and sure enough he got the lead role of the masked crusader Batman. West had his doubts that he could successfully play the part of the crimefighting Batman but something happened to his confidence when he put on the black cowl and flowing cape. He became the Batman, even though a bit goofy, he played a more heady version of the comic book character, a version which appealed to the young kids in the mid 60's.

West completed filming the first show which was to make its debut on TV on a Tuesday evening. The show ended in a cliff-hanger and continued to the next show which would air on Wednesday night. West was so disappointed after watching the initial show that he went to the market to get some quick food and spirits to drown away his disappointment. While waiting in line, he heard the kids ahead of him pressuring their mother to get home as fast as possible so

that they could watch Batman. At that point West knew he had fallen into something special.

The show's popularity grew and would become a Top Ten rated show, both Tuesday and Wednesday showings. The series only lasted three seasons but reruns kept it in the forefront so that generations of kids would be able to watch it long after its original showings had finished their run. West became entrenched as Batman and the stereotype made it difficult to find new acting assignments. But instead of fighting the dilemma, West embraced it and appeared as the first Batman character in any way or event asked of him and his popularity remained strong. Adam West will always be remembered as the Batman but when the City of Los Angeles displayed the Bat-signal on City Hall it was a reminder to all of us that West, the person, was much more than a comic book charac-

## **Don't Confuse Housing Recovery** with Housing Strength

In the first quarter, household wealth grew by \$2.35 trillion to a record, which Bloomberg News claimed is "underpinning consumers' ability to continue spending and will contribute to the economic expansion." The household wealth number was a big increase, but most of it was in stocks. Countless studies of the wealth effect have shown people do not readily spend stock market wealth. They do, however, spend housing wealth. Still, as Bloomberg points out, home values are rising, mortgage debt is growing and housing is contributing to spending again.

Ten years ago, housing contributed two percentage points to annual GDP growth. Now, it accounts for no more than a few tenths. Builders remain cautious, regulation continues to prevent many young less affluent buyers from becoming homeowners. And, with the Fed raising rates, it's not likely to get much better any time soon.

Existing home sales are resales. That is, for every existing homebuyer, a seller has to move out. When existing home sales climbed above 7 million in 2005. it marked a furious pace of housing turnover. The 1.4 million pace of new home sales in 2005, however, revealed housing's overheated state. The prior peak newhome sales rate, in the late 1970s, was 800k. We almost doubled it in 2005.

For decades before the housing boom and bust, first-time buyers freed up homeowners to move up into bigger homes. New construction was primarily a response to population growth. While the correlation between new and existing sales wasn't consistent, it remained close to a constant five-to-one ratio, existing to new, for four decades from 1975 until 2005.

The 2009 sales collapse hit

one home bought as a speculative investment plus tighter mortgage guidelines blocking first time buyers. Based on the 16.7% drop in first-time purchases between the decade up to 2007 and the decade hence, CNN Money estimates 3 million first time buyers, or 300,000 per year, have been blocked from buying a home in the past ten years.

The number of spec houses on the market has risen 50% from its Great-Recessionary low. Nevertheless, at 59,000 it is lower than at the trough of both the 1990 or 2001 recessions and well below the 2007 peak of 194,000. Builders are more cautious, at least in part because regulation has made it very expensive to finance more than one housing construction project at

Real residential investment by all builders in new construction expenditures recovered from a low of \$377bn in the second quarter of 2009 to \$615bn in the first quarter of 2017. That is a whopping 63% increase, but the rise attests more to housing's weakness during the Great Recession than its strength today. New residential construction recently has accounted for just 3.6% of GDP, still below the 1982 low (as a % of total GDP). Until 2009, 1982 was the weakest year for housing construction since WWII.

Housing construction contributed only 0.04% to GDP

but construction never added much to GDP growth anyway. At the peak of the boom, in 2003, it added just 0.66% to GDP growth. Housing's biggest boost to GDP has come from mortgage equity

Mortgage finance and consumption boost

From 2004-08 households extracted equity from their homes at a rate of \$600-800 BIL-LION a year by refinancing and running up home equity lines of credit. By 2009, home equity credit lines peaked at \$700bn, while total mortgage debt peaked at \$14.8 trillion. Mortgage debt has increased since the first quarter of 2013, but at \$14.4 trillion, it remains 2.7% lower than eight years ago. Home equity credit continues to shrink as existing lines are paid down faster than new ones are opened.

Even as equity lines shrink, households are using cash-out mortgage refinancing to extract equity at a rate exceeding the drop in Home Equity Lines of Credit (HELOC). As a result, cash available from housing finance sources is contributing to consumption again.

The contribution is small, however. During the boom years, households extracted equity amounting to a whopping 4-7% of GDP every year from 2002-07. They used this money to consolidate debts, finance consumption and build small businesses. In contrast, last year's extraction amounted to 0.44% of GDP and followed seven consecutive years of mortgage debt consolidation. In other words, there is once again wealth extraction going on, but it is tiny compared to past periods of spending exuberance and negative saving rates.

Oils are much better, with synthetic products and are actually required in the majority of cars today with extended service intervals of 7,500 to 15,000 miles; it is more critical than ever to use the correct oil and oil filter. Many oil filters are only designed to filter for up to 5,000 miles, of engine failure on a 15,000-mile oil change. Filters not designed to go the distance will clog up and can start bypassing so no oil is being filtered at all. This can be disastrous on today's high performance engines.

Don't use just any oil. Our shop has what I call the wall of oil. We carry 20 plus different oils; they are not compatible with each other and don't let anyone tell you different. If your car requires a 0w20 oil, that's what it takes, the engine is designed to work at peak efficiency and emission levels for that specific

The sad thing is some people don't have all the oils and will use what they have on hand. While the incorrect oil will work and you may never know the difference,

it slowly wears out your engine and premature engine failure is imminent.

The difference between a car going 100,000 miles and one going 400,000 miles is directly related to the oil and filter you choose and interval change frequency.

Make sure you check your owner's manual and talk with your service professional to ensure the oil and oil filter they are using on your vehicle will go the

## **Brandywine Homes To Build Community Offering 28 Single-Family Homes**

Saddle Creek Will Offer Much-Needed Housing in Underserved San Gabriel Valley

**SAN DIMAS** – Following an entitlement process that took more than three years, Saddle Creek 28 Group, a subsidiary of Brandywine Homes, has acquired a 10-acre site entitled for 28 single-family homes in San Dimas, Calif. Saddle Creek is scheduled to break ground later this year.

"Saddle Creek is the first significant new-home neighborhood to be approved by the City of San Dimas in years," said Dave Barisic, principal in charge of sales and marketing for Brandywine Homes, a pioneer of infill development in Southern California. "We hope to bring back families who have moved out of the area

because of the lack of new housing opportunities in the San Gabriel Valley."

The detached, single-family, one- and two-story homes at Saddle Creek will range from approximately 2,700 to 3,700 square feet and feature designer finishes, gourmet kitchens and master suites.

"Finding a home in this area with lot sizes from 7,500 to 13,100 is practically unheard of," Barisic said. "The homes will feature a 12-foot-wide side yard that can accommodate an RV or a large boat, which you don't see in new homes these days."

Located in eastern San Gabri-

el Valley and surrounded by the scenic San Gabriel Mountains, San Dimas is a tight-knit community with excellent parks and recreational facilities and public schools. Claremont Colleges, Cal Poly Pomona and the University of La Verne are nearby, and Los Angeles is a 30-minute drive.

According to the National Association of Home Builders' formula to determine the local impact of single-family housing in typical metro areas, adding 28 single-family homes will generate \$8 million in local income, \$1 million in taxes and other revenue for local governments and 110 local jobs.




