The participants represented many schools in our community in grades 6 - 11: Goddard Middle





Investigation Leads to Charges against Curacao for Unlawfully **Preying on Consumers**

LOS ANGELES COUNTY -An extensive investigation by the County of Los Angeles Department of Consumer and Business Affairs (DCBA) in conjunction with the Office of California Attorney General Xavier Becerra has resulted in a lawsuit announced by the Attorney General against retailer Curacao.

Curação is a retail store chain that ranks among the 50 largest electronics and appliance retailers in the United States and has nine locations in Southern California. The company actively markets its products to members of the Latino community - specifically low-income, Spanishspeaking, and undocumented immigrants - who lack a credit history and have minimal experience with credit card and retail installment agreements. In the lawsuit, Attorney General Becerra alleges that Curacao engages in numerous and pervasive unlawful, unfair, and fraudulent business practices.



County Supervisors Orders Adoption Of Recommendations To Improve Standard Of Care For The Mentally Ill

LOSANGELES COUNTY -

The Board of Supervisors approved a motion by Supervisor Kathryn Barger to adopt Department of Mental Health recommendations to improve the delivery of quality and humane treatment for those who are gravely disabled and incapable of seeking or accepting mental health treatment and care.

"Within the County's chronically homeless population, there is a significant segment of individuals who refuse treatment but are clearly in need of care," said Barger. "I strongly believe that if someone's mental disorder prevents them from providing for their own basic needs then they are in fact, 'gravely disabled' and in need of treatment and

As part of the process ordered in the Barger motion, the Department of Mental Health convened a full range of county and community stakeholders to thoroughly examine current methods of engagement, delivery of services, and related laws which empower the county to care for the gravely disabled. As a result, thirteen recommendations were presented to the Board which collectively set forth a bold and innovative initiative to improve the process by which individuals re-

One recommendation calls for the expansion of Psychiatric Mobile Response Teams in an effort to grow response capacity and widen the range of activities

delivered by each team -- not only for the purpose of outreach and hospitalization under 5150 detention, but also real time triage. Further recommendations include the development of new partnership models, increased capacity at licensed facilities, and the exploration of furthering court-ordered evaluation and treatment.

"The County has a moral obligation to ensure that those who are suffering from grave mental illness – who are living in deplorable conditions and unable to provide for their own basic human needs - receive the treatment and care that would drastically improve their quality of life," Barger added.

Probation Reform: Oversight and Accountability

LOS ANGELES COUNTY - If not, the Board would consider Determined to transform the deeply troubled Probation Department, the Board of Supervisors voted unanimously to consider an independent entity that would consolidate the various reforms recommended over the years and propose a roadmap for finally implementing those changes, with oversight and accountability.

"The reform efforts already underway are promising but fragmented," said Board Chairman Mark Ridley-Thomas, principal author of the motion. "We need a singular vision and a comprehensive approach that will leave no stone unturned in addressing, once and for all, the deeply entrenched and systemic problems plaguing the nation's largest Probation Department."

"The need for reform and accountability is underscored by troubling events over the past several weeks, including the sentencing of a Probation officer who sexually assaulted girls as young as 15 at Camp Scudder, and the discovery that youth are still subjected to solitary confinement at Central Juvenile Hall more than a year after the Board banned that practice," he added.

The motion called for analyzing whether the existing Probation Commission can be strengthened and repurposed to serve as that independent entity. creating one.

The Office of Inspector General, which already provides oversight of the Sheriff's Department, may see its scope expanded to include the Probation Department. Supervisor Sheila Kuehl had sought that amendment to the motion.

The motion's coauthor, Supervisor Janice Hahn, said, "This is the time to move forward and bring together everybody's past, present and future wishes and dreams and visions for the kind of Probation Department that LA County warrants, one that will have real accountability and reform as we move forward."

"There have been numerous and sometimes duplicative efforts to examine the Department over the past couple of years, and I think the time has come for us to stop doing that," Supervisor Kathryn Barger said. "There's a lot of data, research, interviews, analysis, legal opinion and more that is ready at our fingertips. Having transparency is key, as is having a roadmap moving for-

A diverse group of stakeholders provided testimony in support of the motion, including representatives of State Assemblyman Raul Bocanegra and LA Mayor Eric Garcetti, as well as a range of criminal justice reform advocates.

LA County Bar Association Independent Juvenile Defender Office director Cyn Yamashiro was one of four Probation Commissioners who spoke in favor of the motion. He noted that after decades of efforts to reform Probation, "we are still in what I would almost describe as a crisis." He likened Probation to a ship with competent captains hoisting its sails but hampered by a number of problematic crewmembers below deck, adding, "I think oversight will be akin to a tugboat to get the ship going where it needs to go."

Jose Osuna testified that he is a former probationer who works with current probationers as external affairs director of Homeboy Industries. "I come to you with 30 years of frustration (with the department) but I do favor this motion because I think any step in the right direction is a good thing, and I think this is a strong step. I think we need to find a way to tie all these (reform) efforts that we've undertaken and spent so much taxpayer money on, so that these efforts don't go to

Urban Peace Institute criminal justice program manager Josh Green said the motion "represents an opportunity to create the lasting vision and oversight that are essential to transforming Probation."

Glendora School Bond Measure GG Explained

Measure GG on the November 7, 2017 Glendora ballot is a \$178 million dollar property tax school bond measure to be repaid by Glendora property owners over the next 30 years. It is named Measure GG because it is a follow-up to 2005's Measure G which itself was preceded by another school bond measure. Many Glendorans have asked for an explanation in light of the Argument Against Measure GG on the Official Sample Ballot mailed to all voters. People are particularly confused and in the dark about the "District of Choice" program prominently featured in the No on GG Argument. Here is a fair and balanced analysis for Glendora residents.

Among the provisions in the complicated deal worked out for the 2017-18 California State Budget was the Legislature continuing the statewide District of Choice program for another five years. The Legislature had ended this controversial and little used program in 2016, but was persuaded to continue it this year as part of the budget deal. District of Choice is a program used by 47 school districts around the state, or about 5% of the total number of districts (1,000). When a school district declares itself to be a District of Choice, as Glendora Unified School District did right after the November 2009 school board election, it throws itself open to students residing outside Glendora who wish to transfer into Glendora schools.

When parents asked the Glendora Unified School District over the last eight years how many students from other communities attended our schools, specific numbers were not provided. Last year, the State Legislative Analyst's Office (LAO) published a 38 page special report on the District of Choice would like to read the whole thing. http://www.lao.ca.gov/reports/2016/3331/district-ofchoice-012716.pdf

I was surprised to see that Glendora has 19% percent of its students, the third highest percentage in the state, attending Glendora schools from other communities through this program. Azusa has by far the largest number of students in Glendora schools through the program. LAO Figure 5 below shows that 14% of the statewide total of about 10,000 students participating in these programs were in Glendora Unified as of the 2014-15 school year.

It's clear to us that very few Glendorans understand the situation. You need to know the facts and then make up your own minds.

The advantage of District of Choice to the Glendora school district is that these out-of-district students bring their state ADA money with them and help fill our classrooms and pay the district's bills. A disadvantage is that once accepted, they do not have to reapply each year. Retired Glendora Police Chief Tim Staab reported to the City Council several years ago that his school resource officers spend a disproportionately large amount of their time dealing with out-of-district students.

One other important point -Glendora property tax payers are already paying for two previous bond issues floated by the Glendora Unified School District that also have a 30 year payback. Glendorans are traditionally very generous and supportive of their schools. Both previous bond measures were sold to voters on the basis that they would provide extra help for Glendora kids. You may have noticed that the Glendora Unified School District sent out a taxpayer paid survey to all

voters in May 2017 asking all

program. Here is the link if you Glendorans to identify what needs in the district they would most like to see fulfilled. There was no option of not having their property taxes raised listed in the

> Proposition 13 in 1978 set a two thirds voter approval requirement for new property taxes. Is that fair? Well, the taxes are only going to be paid by property owners, not all residents or those who aren't even residents who will benefit from the spending of the new tax money. So yes, it's only fair that a supermajority of votes be required to impose new taxes on a minority of the peo-

> However Proposition 39, approved by a majority of statewide voters in 2000, reduced this voter threshold required for approval of new property taxes for education purposes to 55%. If Measure GG is approved by the reduced 55% threshold for education purposes that would make three property tax measures at the same time Glendora property owners would be paying back to the Glendora school district.

> So what is a bond anyway? Is it a tax? Yes, it is a form of taxation. But unlike sales taxes and gasoline taxes which are paid up front, and by all those who purchase their benefits, bonds are taxes paid back by only some taxpayers, property owners, and over a thirty year period like a mortgage. Glendorans have been especially generous because the majority of those who pay these indirect extra taxes do not have kids in Glendora schools, especially our senior citizen home-

> For the first time, approximately 1 in 5 students benefitting from this extra money in Proposition GG would not be Glendora kids. Check out the Glendora Unified School District website to see how they are approaching it http://www.glendora.k12.ca.us/



Hurricanes Destroy Some Jobs -But Will Add Many More

October began strongly with 1% or greater gains in most major indexes. As of October 18 the S&P 500 had set a record for consecutive trading days (342) without a 5% decline - despite recent hurricanes!

Due to disruptions from three major hurricanes in September, the Labor Department reported on Oct. 6 that a net 33,000 payroll jobs disappeared in September, the first monthly payroll decline since September of 2010, ending seven straight years of monthly payroll job growth. Ironically, the unemployment rate in September declined to 4.2%, down from 4.4% in August, due to a temporarily "disappearing" workforce.

Despite Hurricanes Harvey and Irma, the U.S. manufacturing sector did not miss a beat. Furthermore, due to all the insurance claims for home repair (dry wall, flooring, etc.) and vehicles, manufacturing activity is expected to remain robust for the foreseeable future, which should help boost fourth-quarter GDP growth. Vehicle sales surged 6.3% in September, after declining every previous month this year. GM's sales rose 17%, Toyota rose 15%, and Ford & Nissan each rose 9.3% in September due to strong light truck

Speaking of GDP growth, the Commerce Department reported recently that the trade deficit declined 2.7% to \$42.6 billion in August, down from \$43.6 billion in July, reaching an 11-month low. A weaker U.S dollar helps boost exports and shrink the trade deficit, which is also good for overall GDP growth.

The stock market rally is running hot, buttressed by three recent factors - all of which have yet to be verified. They include (1) the passage of reasonable tax reform (see my article from last week), (2) the appointment of a new dovish Fed Chairman, and (3)

the fate of the global economic stimulation trade that has been lifting all the world markets, thanks to rising economic growth rates in developed and emerging economies. By focusing on these three factors, the market doesn't really care about North Korea or crossing the \$20 trillion debt threshold for the U.S. federal debt - or several other long-term

concerns. The assumption that one, two, or maybe even all three of these market catalysts come to pass is now being priced into stocks. If they all come true, that opens the way for S&P 500 earnings to grow by another 10% or more. The market's broad sector participation is yet another reason to stay enthused about the potential of seeing another strong leg up. Translated, the S&P 500 index could trade up to 2,800 by January of 2018.

As the market sets new highs most weeks, some hedge funds that are shorting this rally are getting met with margin calls. Most of us have heard the famous quote by economist John Maynard Keynes, "The market can stay irrational longer than you can stay solvent," meaning the markets can act perversely in the short-term.

What might be the trigger or set of circumstances that trips up the market's torrid uptrend? A black swan event, like an attack on North Korea or a massive earthquake in a city like Tokyo or Los Angeles could do it. It might be the looming negative cloud

that could slow the bullish stampede in stocks, specifically a sudden shift in how the bond market

The new Fed forecast, which shows FOMC members' expectations for future rate hikes, signaled one more hike in 2017 (December) and three in 2018. So, not only has the dollar gotten a fresh bid with the upbeat data and the Fed reversing course from printing money to retiring debt, Treasury yields have jumped back up to levels not seen since July. Though we've been through more than one bout of bond selling in the past two years, this time around feels like the selling may build on itself because of the global stimulation of economic conditions.

Inflation has yet to rear its ugly head in any meaningful way, but there are some tea leaves on the path to global growth that are more prevalent now. With labor markets now showing shortages in select markets, we might have seen lows for the cycle in both bond yields and inflation as measured by the Personal Consumption Expenditures (PCE) Inflation Rate, a major yardstick of Fed policy.

Granted, the normalization of the Treasury yield curve is generally considered to be a good thing (as it represents more economic prosperity) but when money becomes more expensive it also has a negative effect on investor psychology. And we've been spoiled by cheap money for nearly a decade now. We probably should be on the lookout for how the near-term action in the bond market impacts the behavior of the stock market. I think we will find them to be highly correlated going forward.

allow you to take out up to 10% per year after the first year (up to a pre-set amount of your initial investment), waiving the usual early-withdrawal contractual penalties and fees. AARP recently stated that annuities can be great, but can also be a nightmare. Annuities are great, and only become a nightmare if you do not follow the policy's rules. The most common mistake heirs make is to cash out an inherited annuity, sometimes losing thousands of dollars.

My friend received a life insurance settlement check shortly after the death of her husband. Will she have to pay income taxes on this?

Probably not. The funds paid to a beneficiary from a life insurance policy are not considered taxable income. Nowadays, there are life insurance policies that can have funds available to the living, as well as the tax-free funds for their heirs. 

Property Tax Relief Available for Those Impacted by Fires

SACRAMENTO – Board of Equalization Member Jerome first-hand how that fire skipped Horton announces property tax relief for homeowners impacted by the recent fires, as well as by flooding, earthquakes, and other calamities. In many cases, the damaged property can be reappraised in its current condition, with some taxes refunded to the property owner. Once rebuilt, the property's pre-damaged value will be restored.

The outbreak of wildfires throughout the state is the deadliest series of simultaneous fires in the state's recorded history, according to Cal Fire. More than forty people have died and thousands of lives have been terribly disrupted. Member Horton visited a fire site to inform residents that they may be entitled to several tax breaks and deductions due to the loss of their homes and

property in the fire. He observed one home entirely only to engulf another, totally destroying it.

"No one should have to pay property taxes on property that no longer exists," said Member Horton. "Tax records and other important documents are often destroyed during a fire, so I encourage impacted homeowners to document the damage as much as possible so they may take a deduction for their loss."

To qualify for property tax relief, you must file a claim with your county assessors' office within the time specified in your county ordinance, or 12 months from the date of damage or destruction, whichever is later. The loss estimate must be at least \$10,000 of current market value to qualify.

The disaster must be the result of a Governor-proclaimed state of emergency. When a timely claim for deferral is filed, the next property tax installment payment is deferred without penalty or interest until the county assessor has reassessed the property and a corrected tax bill has been sent to the property owner.

In addition, taxpayers who have sustained losses attributable to the recent wildfires in President-declared or Governor-declared disaster areas may claim the loss in either the year in which the event occurred or the prior year. Affected taxpayers that have an estimated federal income tax payment originally due on or after Oct. 8, 2017, and before Jan. 31, 2018, will not be subject to penalties for failure to pay estimated tax installments as long as such payments are paid on or before Jan. 31, 2018. The Franchise Tax Board will abate interest if requested in writing.






