# The Wall That Heals: Vietnam War Memorial Wall - Honoring One Name At A Time

**SAN DIMAS** - A truck carrying the replica of the Vietnam Veterans Memorial, in Washington D.C., was escorted through Pomona, La Verne, Covina, Glendora, and San Dimas on its way to Lone Hill Middle School, 700 S. Lone Hill Ave. in San Dimas, CA., on Wednesday, March 21, 2018. The wall was on display there from March 22 at 10:00 am, with a candlelight vigil ceremony on March 24 at 7:00 pm., and ending March 25 with a closing ceremony before dismantling the Wall.

The three-quarter scale Wall replica is 375 feet in length and stands 7.5 feet high at its tallest point. Like the original Memorial, The Wall That Heals is erected in a chevron-shape and for the first time in the history of The Wall That Heals, visitors were able to do name rubbings of individual service member's names on The Wall.

The replica is constructed of Avonite, a synthetic granite, and its 144 individual panels are supported by an aluminum frame. Machine engraving of the more than 58,000 names along with modern LED lighting provide better readability of The Wall day and night.

The replica honors the more



than 3 million Americans who served in the armed forces during the Vietnam War and bears the names of more than 58,000 men and women who died there.

The names on The Wall That Heals replicate the names on the Memorial in Washington, D.C. As on the Memorial, the names are listed alphabetically by day of casualty. Beginning at the center/apex, the names start on the East Wall (right-hand side) working their way out to the end of that wing, picking up again at the far

end of the West Wall (left-hand side) and working their way back to the center/apex. Thus, the beginning and ending of the conflict are joined at the center, signifying an epoch in American history.

The Wall That Heals exhibit also features a mobile Education Center. The exhibits tell the story of the Vietnam War, The Wall and the era surrounding the conflict, and are designed to put American experiences in Vietnam in a his-


torical and cultural context. The San Dimas Community Foundation HEROES hosted The Wall That Heals to honor those who served and sacrificed.

The exhibit includes the wall replica and a mobile education center comprised of: digital photo displays of "Hometown Heroes" -- service members whose names are on the wall that list their home of record within the area of a visit; digital photo displays of Vietnam veterans

from the local area honored through VVMF's In Memory program, which honors veterans who returned home from Vietnam and later died as a result of their service; video displays that teach about the history and impact of the wall and of the collection of items left at the wall in D.C.; educational exhibits told through items in the collection; a map of Vietnam and a chronological overview of the Vietnam War.

Through The Wall That Heals, The Foundation was able to return the names home to San Dimas and surrounding communities and allow Vietnam veterans and their family members who cannot make it to Washington, D.C. the opportunity to see The Wall. It also gave San Dimas and surrounding communities a teaching moment for younger generations on why we should honor those who have served and sacrificed so much.

The next two stops of The Wall That Heals before it leaves California are scheduled for San Luis Obispo, CA March 29-April 1, 2018 hosted by the County of San Luis Obispo Veterans Services Office and Gardena, CA April 5-April 8, 2018 hosted by the City of Gardena and The Gardena Veteran's Committee.

The County of Los Angeles has been preparing for "the big one" or any other extreme emergency. They have Mobile Medical Assets that include, for example:

- 4 Trailers
- 100 bed capacity
- Mobile surgical suite

These units can be moved to help hospitals that may have been damaged. Their plan includes stored antibiotics located throughout LA County.

In Duarte, a new CERT (Community Emergency Response Team) has been formed under the leadership of Anthony Hadloc, Community Service Officer. The members of the CERT are all volunteers who have completed a 20 hour basic skills course. The pur-

pose of CERT is to augment the Public Safety Staff. These folks are those in bright green vests who go door-to-door prior to an evacuation due to potential flooding, for example.

It was great to learn how much our local agencies are prepared and can work together in case of emergencies. It's also a great reminder for all of us to be prepared!

## Arcadia Woman's Club Hosts Appreciation Lunch for Arcadia's First Responders



## Assembly Member Blanca Rubio Brings Duarte Community to Sacramento

**DUARTE** - The Duarte Chamber provided the opportunity for local businesses, residents and officials to have lunch with Assembly Member Blanca Rubio and to hear how she is representing our area. Assembly Member Rubio was elected in 2016 and is considered a "Moderate Democrat" since she does have a commitment to represent business issues along with those of the community.

Blanca has worked tirelessly to give her constituents a voice in the Capitol, placing advocacy for children, women, families, students, and immigrants at the forefront of her work. Since her election in 2016, Blanca has authored bills that support victims of domestic violence, create opportunities for children within the foster care system, ensure our youngest students are given proper support to succeed in school, and support for immigrant communities. Through her work as Chairwoman of the Human Service Committee, Blanca has raised awareness of women's rights by authoring resolutions that declare August Breast Feeding Awareness Month and October Domestic Violence Awareness Month.

Blanca made it clear to everyone in attendance that she is an advocate for issues in her district, and her staff is always avail-

able to assist constituents, including cities, businesses and organizations with state related concerns. In one case during a meeting of the Joint Legislative Audit Committee where discussion of the state and regional water boards was being considered, she recalled the multiple concerns relayed from the foothill cities in her district regarding the burdensome cost of the MS4 Sotrm Water Permit. The impact to Duarte would be multiple times their annual budget. During this committee discussion, Blanca asked that the audit include the cities in our district to shed light on the process and outcome. The audit was released earlier in March and the CA Auditor's report validated the many concerns by the foothill cities. Had it not been for the advocacy of cities like Duarte, she would never have had the opportunity to speak on their behalf when the chance was presented.

After her update, the Assembly Member responded to several questions from the attendees including what she sees as the biggest issue for businesses over the next two years. Her biggest concern is workforce development and the need for businesses, public entities and schools to partner and ensure young people are getting the skills and training needed for the workplace. One

example the anticipated number of employees retiring in the next few years from the Gas Company - leading to a shortage of trained welders. Bob Cruz, past Chair of the Duarte Chamber, was able to share information regarding a partnership between Delafied (a Duarte Chamber member business) the Duarte Chamber, Duarte Unified School District and Mt SAC. Collectively, a welding "Boot Camp" was created for Juniors and Seniors in High School for training through Mt. SAC. Mr. Cruz continued, "The first camp was held last summer and was so successful that the group wants to expand it in the future. Assembly Member Rubio eagerly responded, "Let us know how we can help you grow that. I will use that as an example of how they [chamber, education and businesses] are working to develop their workforce.

Attendees at the luncheon included members of the Duarte Chamber Board, Duarte Unified School District Board members Doug Edwards and Reyna Diaz, DUSD Superintendent, Allan Muceron, Duarte Mayor, John Fasana, Duarte Mayor Pro-Tem Liz Reilly, Duarte City Council Member, Tzeitel Paras-Caracci as well as representatives from the offices of State Senator Anthony Portantino, and County Supervisor, Katherine Barger.


On the program, Joe Callahan from the Literacy Program will add a tutor's perspective to Co-


the Oak Woodlands where Oaks twist and turn to reach specks of sunlight.

## Arrest of Roca Way Residential Burglary Suspects

**MONTEREY PARK** - On March 21, 2018 at approximately 4:02 p.m., Monterey Park Police received a call of three suspects breaking into a residence in the 100 block of Roca Way in Monterey Park. The three suspects were seen in the backyard of a residence, smashing a sliding glass door, and making entry into the residence by the resident monitoring an in-home video sys-

tem. The resident promptly notified the Monterey Park Police Department. Upon the arrival of officers, the suspects attempted to flee through neighboring yards, but were quickly apprehended in the area. All three suspects were arrested for residential burglary.

The suspects are identified as: Bryant Burnett, 26, from Los Angeles, Bail Amount \$140,000.

Tywan Brown, 20, from Los Angeles, Bail Amount \$100,000. Tyron Jennings, 19, from Los Angeles, Bail Amount \$50,000.

All three were booked for 459 PC/Residential Burglary. Burnett and Jennings were released after posting bail, Brown remains in custody and is set to appear for arraignment at the Alhambra Superior on Friday March 23, 2018 at 8:00 a.m.

## Barger Announces \$20,000 Reward In Murder Of Motorist By Boulder Dropped On 134 Freeway

**LOS ANGELES COUNTY** - Supervisor Kathryn Barger announced that she will introduce a motion before the Board of Supervisors on Tuesday, March 20 asking for a \$20,000 reward for the person(s) responsible for dropping a boulder from the overpass at Orange Grove Boulevard in Pasadena onto the 134 freeway resulting in the death of Christopher Lopez.

On Tuesday, March 13, 2018 at approximately 8:55 p.m., Guadalupe Gutierrez was driving with her husband, Christopher Lopez, their 4 year-old daughter and Mrs. Gutierrez' mother west-bound in the HOV lane, at ap-

proximately 70 miles per hour.

When the car passed under Orange Grove Boulevard in Pasadena, a 30-pound boulder crashed through the windshield hitting Mr. Lopez who was seated in the passenger seat. Mrs. Gutierrez drove her husband directly to Glendale Adventist Medical Center. Despite the efforts of emergency personnel, Mr. Lopez succumbed to his injuries and was pronounced deceased at the hospital. Mr. Lopez is survived by his expectant wife Guadalupe and their daughter.

CHP Investigators are seeking witnesses who may have noticed any suspicious person(s) or ac-

tivities around the area of Orange Grove Boulevard and State Route 134 freeway on the evening of the incident. Supervisor Barger encourages anyone with any information to contact investigators at the following numbers or the Crime Stoppers Hotline.

## Investigation by Los Angeles County Consumer and Business Affairs, Attorney General Leads to Charges against Alleged Unlawful Immigration Consultant

**LOS ANGELES** - A joint investigation by the County of Los Angeles Department of Consumer and Business Affairs (DCBA) and California Attorney General's Consumer Law Section and Division of Law Enforcement has resulted in criminal charges against Edgardo Guerrero of "Oficina Guerrero." Guerrero, who is not an attorney, is accused of defrauding undocumented immigrants and their families seeking lawful permanent residence in the United States. He charged thousands of dollars for legal services that he was not legally qualified to give and failed to

maintain a required bond. California Attorney General Xavier Becerra announced the arrest and filing of charges today.

If you paid Guerrero for immigration assistance and believe he may have defrauded you, please contact DCBA immediately by calling (800) 593-8222.

"Our department stands at the ready to educate, defend, and speak up for the residents of the County, especially the most vulnerable among us," said DCBA Director Brian J. Stiger. "If you believe you are a victim of fraud, regarding immigration services or any transaction, we are here to

help." "No one, regardless of status, should have to deal with fraudulent behavior while seeking legal advice," said Attorney General Becerra. "At a time when the Trump Administration stokes fear and desperation in communities across the State, the California Department of Justice is committed to protecting families from unscrupulous practitioners who would exploit them for personal gain."

Guerrero was arrested on March 22, 2018, booked into the Los Angeles County jail, and is being held on \$80,000 bail.

## DACC Acknowledges National Pet Poison Prevention Week

**LOS ANGELES COUNTY** - March is recognized as Poison Prevention Awareness Month and National Poison Prevention Week is globally observed the third week of March. This year it fell on March 18-24 and the County of Los Angeles Department of Animal Care and Control (DACC) encourages all pet owners to make your homes pet safe.

Please be aware of what can pose as dangers to your pets:

- Dangerous foods for dogs and cats- Chocolate, coffee, alcohol, avocado, macadamia nuts, grapes, raisins, yeast dough, raw/uncooked meat, eggs, Xylitol (found in sweeteners, gum, candy, toothpaste), onions, garlic, milk, and salt.
- Household plants- Be aware of the plants you have in your home and yard. Indigestion of some plant materials by an animals can be fatal.
- Cleaning agents- Never al-

low pets access to areas in which cleaning agents are being stored. Some may cause mild upset stomach or severe burns to the tongue, mouth, and stomach.

If you suspect your pet has eaten any of the dangerous items, please note the amount ingested and contact your veterinarian or the ASPCA Animal Poison Control Center at (888) 426-4435.

## California Democrats Protect Illegal and Citizen Felons

California Republican Party Chairman and former California Senator, Jim Brulte, told Stuart Varney, Fox News, "Democrats have had total control of California for the better part of 8 years. They've made a total mess of it ... and things are worse than before Jerry Brown was elected Governor ..."

Brulte continued, "It is not just illegal immigrant felons Democrats care about protecting. It is citizen California felons. Casillas leaves behind two young sons.

A year ago, Whittier Police Officer Keith Boyer was shot and killed by a gang member with a violent history, in and out of jail and on probation when he shot and killed that officer. Reports indicated the killer told detectives he was high on marijuana and other drugs at the time of the shooting. Local elected officials blame recent laws undermining California's Criminal Justice System, supported by Gov. Jerry Brown --AB 109, Prop 47 and Prop 57 - and have launched a campaign to undo the disastrous rise in crime rates those laws have created.

Comment made to me by a source close to police activities and attendee at the police funerals:

"Gov. Jerry Brown showed up at both funerals, Boyer and Casillas, hoping to speak and law enforcement shut him down. At the recent funeral of Pomona Police Officer Gregory Casillas, Brown got a finger to his face with the charge, "You have done this," referring to the three pieces of legislation he orchestrated

to allow 40,000 plus criminals released to the streets of California.

Gov. Jerry Brown and Democrat antics in California have reached the New York Times, reporting, "Trump Sues California Over Immigration Laws" and called the lawsuit a preemptive strike against the sanctuary state laws. Named in the lawsuit are Gov. Jerry Brown, State Attorney General Javier Becerra and targeting the three state laws passed to protect illegal immigrants, and more specifically illegal felons.

California Values Act, known to some as SB 54, the sanctuary state bill by Sen. Kevin de Leon, running against Dianne Feinstein for U.S. Senator, is one of the target laws of the Trump Administration. The bill has been strongly opposed by law enforcement and immigration officials because of the limitations it places on state and local agencies in information sharing about serious criminal activities, specifically information on criminal illegal felons.

The Immigrant Worker Protection Act, written by Democrat Assemblyman David Chiu (San Francisco) prohibits local businesses from providing access by immigration officials to employee records without a court order and levies a fine of up to \$10,000 for those caught violating that law. The California Attorney General, Javier Becerra and California Labor Commissioner have exclusive authority to enforce this new law, the New York Times reports.

In host Stuart Varney's final comment to Brulte, he said there is no way Republicans can take over Sacramento to reform this mess Brown has made of the legal system in California because they would be bucking the teach-

ers' unions, municipal employee unions and the large Hispanic communities that traditionally have voted Democrat.

Brulte responded by saying, "Make no mistake about it. Illegal immigrant felons do most of their crimes in the Hispanic community. MS13 [the largest, most violent gang in California] may be a theoretical gang to Jerry Brown but it is a real world experience to a lot of Hispanics in California and why they appreciate taking illegal immigrants out of their community, those illegal immigrants that are felons."

From Shade's Perspective: Law enforcement is a large, serious and most ferocious opponent of Brown's AB 109, Prop 47, Prop 57 and SB 54, Sanctuary State bill. The League of California Cities, made up of local elected officials and inspired by the death of Keith Boyer, has launched the Take Our Communities Back campaign because of the violent crime and cost cities and counties. Personally, in my education community where I work, teachers are angry and fed up because one of their own was seriously attacked by an early-released criminal who is up on eight charges for that assault that almost killed her. ## A 380 Page Informercial


I have recently completed reading an amazing book! These days turning on the TV in search of a news story may result in being confronted with a 60-minute advertisement for a new diet program or another get-rich-quick scheme. Every now and then one of these infomercials will show up disguised as a book hustling a product you can't live without. To read it takes longer—much longer—than 60 minutes, and you probably needed to pay for it. I got the book in question on my Amazon Kindle for twenty bucks.

Let me give you a taste of the sales pitch for which I paid good money. Here is a quote found on page 282.

*Having known and observed (him) for a number of years, what I've come to understand is that (he) deeply respects the men and women of God who have such strong godly principles. (he) is a man who treated everyone around him with respect, no matter his or her title or job.*

The author of this hymn of praise is none other than Mike Pence, whose main job seems to be keeping the boss' ego sufficiently inflated, as if that were necessary on behalf of a man who manages to turn every encounter into the occasion for self-aggrandizement.

Much of the book's last hundred pages are given over to a parade of conservative religious leaders seeking to outdo one another in claiming that God chose Trump to be President. "We

*thank God every day that he gave us a leader like Donald Trump,*" said the minister of the First Baptist Church in Dallas. Other evangelical heavies hold that the opposition to Trump is the result of "demonic activity." The devil made us do it!

Scattered throughout the last half of the book are attacks on "The Johnson Amendment" which prohibits tax-exempt institutions from endorsing or funding candidates for public office. Here is a blatant attempt by Christian conservatives to obliterate the "wall of separation" between church and state. These evangelicals see this wall as inhibiting their ability to establish their religious perspective as the foundation of government, leading to a Christian State.

A hard look at Donald Trump's religious beliefs and perspectives will have to wait until a recognized religious scholar produces an honest objective analysis. This book just doesn't do it.



# A Cohesive Fed

The FOMC raised the federal funds rate target range 25bp to a 1.50% to 1.75% range, exactly as expected. The statement acknowledged a stronger economic environment but reaffirmed the Fed's commitment to gradual rate hikes.

The FOMC downgraded its characterization of growth from solid to moderate, consistent with Q1 GDP closer to 2% than 3%. In its forward guidance, the FOMC now expects a stronger economic outlook, with the economy likely to continue to grow "at a moderate pace" in the medium term. The unemployment rate has been flat at 4.1% for five months, but the statement mentions strong employment growth and an unemployment rate that "stayed low." The FOMC's unemployment rate forecast was revised significantly lower in their Summary of Economic Projections.

Chairman Powell telegraphed the rate hike in his recent Humphrey-Hawkins testimony when he emphasized the need for continued gradualism now that economic headwinds have shifted to tailwinds. Powell was not alone in his message. The Fed team was remarkably cohesive in the two weeks before the pre-meeting blackout period. There was - as always from the independently-minded bunch making up the FOMC - a range of opinion and emphasis, but the range was remarkably tight.

Gradualism in rate increases makes sense, but maybe only if future expansion is robust. With Wednesday's hike, the fed funds rate will have surpassed the most popular estimate of a neutral rate. The Fed is no longer removing accommodation. It is tightening. From here, the FOMC anticipates gradual rate hikes because participants expect the natural rate will rise. Given the neutral rate is about zero and inflation is running at 1.5%, a neutral fed funds rate is 1.5%. The fed funds rate target has been 1.25% to 1.5% up until now, meaning it was just short of neutral.

Even though it is tightening,

the gradual pace indicates a dovish shift in the FOMC consensus. The FOMC appears to be contemplating the same gamble Greenspan took with the economy in 1995-96. Greenspan made clear the Fed was going to tolerate the things traditionally believed to lead to inflation - though not inflation itself. It was a gamble on higher productivity growth.

There were all sorts of things going on at that time that might have explained low inflation. Wal-Mart started importing more goods from China than most G-7 countries. Globalization, an emerging market recession and other factors played a role. But Fed economists are now convinced productivity gain was the most essential element (because it kept unit-labor costs under control). Foreign competition may have spurred firms to keep prices low, but higher productivity made it possible. Without accelerating productivity, inflation would have roared.

The Fed's doves think an elevated utilization rate of capital and labor might have been the trigger for that productivity burst in the mid-90s. Today they advocate policies that would allow utilization to rise soon in hopes of stimulating a repeat.

The hawks are not at all convinced this is a good idea because economists don't know where higher productivity comes from. As a result, the Fed has a choice to make between:

The doves' way: Allow faster growth and risk higher inflation. This amounts to a bet the road to productivity growth runs through strained capacity, investment and doing more with fewer hours

worked. If that is the road chosen, it won't likely happen without the Fed first allowing demand to accelerate to the point where capacity is strained. The payoff if correct might be: faster economic growth, faster real income growth, continued low inflation, real wage gains, rising living standards, lower debt/GDP ratio and lower consumption/investment ratio. The cost if wrong could be inflation high enough to warrant triggering a recession in 2-3 years.

The hawks' way: Tolerate faster growth only if productivity accelerates first, because if growth speeds up and productivity doesn't, the unemployment rate could fall far enough to trigger an inflation spike. This was the Fed's logic in 2004-06 when productivity never accelerated, quite possibly because capacity utilization was pretty low (labor and capital).

The bond market is calm now because the latest economic data adds up to a weaker-than-expected economic picture. We do not expect it will continue this way. By mid-year, economic acceleration should be obvious. If the Fed continues to push the idea of allowing inflation to exceed 2% for a time, yields will likely rise again.

But, if the FOMC doves are right and productivity reaccelerates, traders will figure it out much faster than in 1996-97 because the Fed is so much more open in its communication than it was back then. We no longer have to wait for the Chair's semi-annual testimony to learn which direction they will be headed with rates. Nor do we have to run the testimony through a Fed-speak-to-English translator to understand it. If productivity accelerates, Powell, Brainard, Williams and the rest will be out explaining in plain English why it will keep inflation in check.

# Your Money - Ask Julia

*Is it better to go to my bank for a home loan? Or is it better to use a mortgage broker?*

Bank loan originators are not required to be licensed and are not held to the same standards and regulations as brokers in terms of testing and ongoing training, mortgages are not their main focus (they also offer auto, boat, personal, etc. loans), are only able to offer limited loan products they have in-house, often charge higher rates, and are slower to adapt to change due to large organizational operations. An independent mortgage professional is a licensed mortgage expert (consistently undergoing continuous training), specializes in mortgages only, partners with several lenders to offer multiple loan products giving you more options, often offers lower rates and cheaper costs due to less overhead, and adapts to industry changes quickly.

*Is this true? Can I invest in an IRA for 2017 even though it's 2018?*

Yes, you can, but the deadline is April 17. A traditional IRA is tax-deductible. Those funds and the growth will be taxed upon withdrawal. Although a Roth IRA is not tax deductible, it has many benefits upon withdrawing funds. Since you would have already paid taxes on the money you invest into a Roth IRA, that amount will be free of taxes in the future. Unique to Roth IRAs, the growth (interest earned) is not only tax deferred, it can also be income tax free.

*I have a couple of CDs that mature this month. Should I reinvest them into CDs or do you have something that is*

still safe, but could earn a higher rate?

If your CDs are your only emergency fund, you probably want to leave some of that money there. If you want safe, tax-advantaged savings for future use, and/or to leave to heirs, then I would recommend moving some of that money elsewhere. If suitable for you, consider a fixed-indexed annuity, or a fixed-indexed life insurance policy.

*What taxes would I have to pay if I flip real estate?*

When you buy a home, fix it, and sell it, you will have to pay taxes based on the amount of time you held onto this asset. If you hold onto it for a year or less, you're going to be taxed on your short-term gains at ordinary income-tax rates. If you hold this asset for more than a year, you're going to be taxed at the long-term capital gains rate. If you "flip" real estate too frequently, you are considered "in business" - opening a whole different set of rules. You can defer tax on your real estate gain by exchanging it for another property, known as a like-kind, or Section 1031 exchange. This must be clearly stated in escrow. You can do unlimited

1031 exchanges your whole life.

*I read an article the other day that said if you have an adjustable rate mortgage you could be in for a huge adjustment because interest rates going up. Can you look over my adjustable mortgage loan paperwork and explain it to me?*

Yes. Scan your document(s) and attach it to an email to me and I'll look it over, and explain it to you so that you can make an informed decision, rather than an emotional one, on whether it's best to refinance or not. This is a free service. If you cannot scan, send me an email and I'll reply with my address so you can send me a copy of your document(s). Meanwhile, rest assured that most adjustable rate mortgages protect the borrower from huge adjustments through "caps"-the maximum amount of each adjustment. Years ago, adjustable rate mortgages didn't have "caps" so the borrower could be shocked by ridiculous adjustments.

# What is Schedule C on your Income Tax Return?

Many individuals are small business owners or single proprietor. The business is usually managed by the proprietor, and the business structure is not as complex as a partnership or corporation.

The IRS made it easier for small businesses to file its income and expenses during the tax year by using Schedule C. The Schedule C can be found on your personal income tax return (1040).

The Schedule C is the complete information you will provide to the IRS as to how much your business has earned during the year (gross amount). You will also itemize your business expenses, backed with receipts. If there is profit left (net gain or net revenue), it will be added to the rest of your income from other sources during the year.

Your net income from Schedule C is subject to Self-Employment tax. Self-Employment tax is paying your own

Social Security and Medicare contribution for both the employee's and the employer's share. In this case, since you are considered as an employer to yourself, 50% of your self-employment tax becomes deductible on your personal income tax return.

**Example 1:** I earn money on the side from writing my blog. Since a freelance writer is considered as self-employment, I will use Schedule C when I file my income tax return for the

earnings from blogs.

**Example 2:** I sell merchandise to the public. I didn't register my business as a partnership or corporation. Therefore, I will use Schedule C when I file my income tax return.

**Example 3:** I teach piano lessons or Taekwondo on weekends. All the income I received from my weekend gig will be on Schedule C.

## California's Deadliest Earthquakes Author To Talk At Museum





# "The Wall That Heals" Attracts Thousands

SAN DIMAS - The "Wall That Heals", the Viet Nam Veterans Memorial Replica, was driven through Glendora to the Lone Hill Middle School grounds on 700 S. Lone Hill Avenue, on March 22 where it was exhibited through March 25. Hosted by the San Dimas H.E.R.O.E.S. (Helping Establish a Remembrance of Every Service Person), The Wall was visited by thousands of war veterans, some in uniform, some wearing their veteran's hats, visitors and relatives of those who died in the Viet Nam War. It was a somber scene, with families pencil tracing the names of their relatives, some praying, some just reminiscing of the war that took the lives of so many young Americans.

Among the people who visited the wall was the Henderson family, relatives of U. S. Army Sergeant Stanley Tillitson who died at the age of 23, in Viet Nam. Stanley's sister Linda explained how it was his third term of service in Viet Nam. Stanley volunteered his service. He was off duty, but working at a hospital, helping with army personnel who were addicted to drugs, when an enemy shell hit the hospital throwing Stanley back, breaking his neck instantly. She will never forget that dreaded day in April 1972, when two U.S.

Army Officers arrived at their home in Bell, California, to give their family the sad news.

There were various programs through the four days that the wall was in San Dimas. With a Candlelight Vigil on March 24, where U.S. Marine CWO Joseph Martinez spoke, to the Closing Ceremonies on March 25th. Gary Enderle President of San Dimas Community Foundation / H.E.R.O.E.S gave the welcome speech and Taps was

played by the All Forces Honor Guard from the Memorial Honor Detail of Riverside National Cemetery.

Do you remember who the U.S. President was, who ended the Viet Nam War? On Jan. 23, 1973, It was President Richard Nixon who announced an accord had been reached to end the Vietnam War. In a televised speech, Nixon said the accord would "end the war and bring peace with honor."
