New Senior And Community Center In The City Of Covina

COVINA – Officials from the Los Angeles County Development Authority (LACDA) joined Congresswoman Grace Napolitano, Mayor John King and council members of the City of Covina, and other project partners to celebrate the ribbon cutting of the City's new Senior and Community Center. Located at Kelby Park, 815 N. Barranca Ave., the single-story wood frame building will provide services, events, and activities for the residents of the Covina community.

Nearly half of the building will be dedicated to enriching the lives of seniors through a variety of services such as nutrition, health information, recreation classes, life-long-learning opportunities, and special events. To complement the services, the center will include a kitchen, fitness center, multipurpose rooms, classrooms, and a courtyard. The LACDA provided more than \$693,000 in Community Development Block Grant (CDBG) funds and \$2.5 million from the Sec-

tion 108 Loan Guarantee Program, leveraged with \$5.2 million in City funding to finance the demolition, design, and construction of the new center. Monique King-Viehland, LACDA Executive Director said, "The Covina Senior and Community Center is a repre-

sentation of the golden years we envision for residents. It's a home away from home, where community members are welcomed, and given a sense of hope with the services available."

The City of Covina has

partnered with the LACDA to deliver CDBG-funded projects and programs to their residents for more than 40 years. The City contracted with **GKKworks** and Pankow Builders to manage, design, and construct the project. Fifth District Supervisor Kathryn Barger, whose District includes the City of Covina, provided the following quote, "Whether it's a delicious lunch where residents can break bread together, a party where they can show off their dance moves, or a class where they can learn new skills, every opportunity at the new Covina Senior and Community Center provides residents with the tools they need to thrive and make daily life more vibrant. New Way To Save All Shelter Pets

The lives of nearly 733,000 cats and dogs could be saved with the help of caring humans and an innovative Web-based platform introduced this week by Best Friends Animal Society.

Envisioned as a tool to help animal lovers help their communities save more pets, the new community lifesaving dashboard combines groundbreaking data visualization technology with the most comprehensive data set on animal welfare ever published.

Two years in the making, the tool crowdsources, validates and translates complex data about the dogs and cats in U.S. shelters.

It brings an unprecedented level of transparency to the animal welfare movement, unlocking new opportunities for saving pets by providing a detailed picture showing precisely—on a city, state and community level—where cats and dogs need to be saved. For the first time, anyone with a smartphone or computer will be able to easily access

his or her community's snapshot of how many cats and dogs need to be saved and find tools to help individual shelters save more pets. The organization used independent research, government data and even FOIA requests to create the most comprehensive data set on animal welfare ever published.

Best Friends CEO Julie Castle says the investment in data was necessary to achieve the organization's goal of bringing the whole country no-kill by 2025.

"Up until two years ago, we didn't even know how many shelters existed," she said. "How can you possibly save all the animals if you don't even know how many need to be saved?

"With this data in hand, our goal to save every savable pet by 2025 is finally within reach," Castle said.



AZUSA - Azusa police responded to an assault (stabbing) call just before midnight on Sunday July 28th to an apartment complex on the 500 block of East Gladstone Street in Azusa. The victim was found with multiple stab wounds and was transported to the hospital in critical condition.

Authorities filed an attempted murder charge Wednesday against an Azusa man. Oscar Vidrio, 40, was arrested. He has had 4 arrests since December of 2017. He was in court and pleaded not guilty on Wednesday, July 31. His bail was set at \$1,080,000.00.

A second man was also arrested. Joseph Loera, 22, who has had 6 other arrests over the last 18 months, originally had his bail set at \$2,000,000.00. However, it doesn't seem he has been charged and the DA is wanting a further investigation to see if he had any involvement at all. At this time, he is being detained because of the probable cause.

Governor Signs Senator Chang's Bill to Address Human Biohacking

SB 180 is the first ever legislation addressing emerging CRISPR technology

SACRAMENTO - Following unanimous support in the Legislature, the Governor signed the first bill into law addressing the emerging CRISPR technology. Authored by Senator Ling Ling Chang (R-Diamond Bar), Senate Bill 180 is a new consumer protection law that requires sellers of gene therapy kits known as "DIY CRISPR Kits" to include a notice prior to the point of sale, as well as a label, stating that CRISPR kits are not intended for self-administration.

"CRISPR technology is becoming widely available to the public but many in the scientific community have sounded the alarm that it could have negative consequences outside professional labs," said Senator Chang. "The technology is moving faster than regulations, so it's important to be proactive about preventing safety mishaps by amateur users of CRISPR kits. While I'm a huge proponent of supporting scientific curiosity and imagination, I'm very concerned about the amateur use of this technology and its impact on consumer and public safety."

Use of CRISPR in garages and kitchens has been growing among so-called biohackers and many have made attempts to alter themselves with the technology. The owner of one company selling DIY CRISPR Kits recently came under investigation by California's Department of Consumer Affairs.

CRISPR, short for CRISPR-Cas9, is an acronym for "Clustered Regularly Interspaced Short Palindromic Repeats" which are unique DNA sequences found in some bacteria and other microorganisms.

The United States Food and Drug Administration has stated that the sale of gene therapy products with the intent of self-administration is against the law, and cites concerns about safety risks. There have been instances caught on video of individuals injecting themselves with CRISPR Cas-9 edited materials with the intention of editing their physiology.

Public Health Reports First Two Cases of West Nile Virus among Los Angeles County Residents

The Los Angeles County Depart- the following actions to reduce have had severe disease and apment of Public Health (Public Health) has identified the first two cases of human West Nile virus infection in Los Angeles County for the 2019 season (excluding Long Beach and Pasadena as cases identified in those cities are reported by their local health departments). A resident of the San Fernando Valley region and a resident of the southeastern region of Los Angeles County are recovering after becoming ill at the end of July. "We are glad to hear that these two people are recovering from their West Nile Fever infections and wish them well. Every year in Los Angeles County, we see cases of West Nile virus infection, which can be serious even deadly, especially for people over 50 and those who have existing health problems," said Muntu Davis, MD, MPH, Health Officer for Los Angeles County. "Mosquito bites aren't just annoying, they may make you sick. So, everyone should take protective action by using mosquito repellent when outdoors and getting rid of items in their homes or yards that collect standing water where mosquitoes can breed." West Nile virus (WNV) is spread by the bite of an infected mosquito. Symptoms may include fever, headache, nausea, body aches, and a mild skin rash. WNV can affect the nervous system and result in meningitis, encephalitis, paralysis and even death. People over 50 years of age and those with chronic health problems are at higher risk of severe illness. While not all mosquitoes carry this virus, the type of mosquito that spreads this virus is found throughout Los Angeles County.

the risk of West Nile virus infection:

• Avoid mosquito-infested areas at dawn and dusk.

· Consider wearing longsleeved shirts and long pants when you are outdoors, particularly at these times and when in areas where more mosquitoes are present.

• Use Environmental Protection Agency (EPA)-registered repellents containing DEET, picaridin, or oil of lemon eucalyptus. These are effective defenses against mosquitoes when used as labeled.

• Check your window screens for holes to make sure that mosquitoes cannot enter your home.

• Dump stagnant water. Do not allow water to collect and stagnate in old tires, flowerpots, swimming pools, birdbaths, pet bowls, or other containers. These are prime breeding grounds for mosquitoes.

· Clean and chlorinate swimming pools; drain water from pool covers.

• Stock garden ponds with goldfish or other mosquito-eating fish. These eat mosquito eggs and larvae.

• Empty and wash birdbaths and wading pools weekly.

· Cover rain barrels and empty weekly.

The number of people infected with WNV each year in LA County is estimated to be more than 10,000, because most infected persons do not experience any illness or perhaps only mild illness. These cases are neither reported nor recognized as WNV. Moreover, Public Health continues to report elevated numbers of WNV cases in LA County over the previous 5 years, at an average of 197 cases per year. Over

proximately 1% of patients with severe WNV have died from complications. The longest recorded WNV season extended through mid-December in 2017.

Public Health collaborates with local vector control agencies to target areas for mosquito control activities as well as educate people about how to protect themselves. There is no vaccine for WNV and no treatment to cure the illness once an individual becomes sick. Reduction of mosquito breeding sources and protection from mosquito bites are the best ways to prevent WNV infection.

"It's important to remember that West Nile virus is transmitted by infected mosquitoes," says Truc Dever, General Manager of the Greater Los Angeles County Vector Control District. "That's why residents need to take measures to prevent mosquito bites. Remember to tip and toss anything that can hold water on your property and use insect repellent when mosquitoes are present. Reducing the risk of mosquitoborne disease infection is a shared responsibility for everyone who lives, works, and recreates in LA County."

Newsom Blocks Water Storage Propaganda, Pandering, and Politics For the next one and a half and Transfer Proposal years we will have to endure the

March 2018, L.A-based Cadiz, Inc, that owns 70 square miles of property with water rights in the Mojave Desert in San Bernardino County, presented Upper San Gabriel Municipal Water District with options to increase the water supply in the San Gabriel Valley. Cadiz's proposal was to pump up to 16.3 billion gallons of ground water a year out of their basin to sell to those in Southern California.

Cadiz estimated reliable water for 400,000 people over 50 years and 3,500 new jobs with water rates competitive with MWD rates and less expensive than desalination and recycled water.

With an approved Environmental Impact Report (CEQA) and rights to use an abandoned gas line over an existing railroad right of way to move the water, a proposal was made to Upper District with choices to take no action, direct staff to further evaluate District's water supply options or to authorize the general manager to execute the nonbinding letter of intent regarding purchase and sale agreement for water with the Cadiz Water Project.

Upper District voted 3-2 NOT to execute the non-binding agreement to allow for future negotiations with Cadiz Water Project. Board Member, Anthony Fellow said they needed to have Sen. Dianne Feinstein and MWD on board before Upper District took any action. Then-Board Member, Brian Urias, voted against doing anything based on letters from Cong. Judy Chu, Supervisor Hilda Solis, Assembly Members Ed Chau and Chris Holden, and Senator Anthony Portantino and Speaker Anthony Rendon.

In response to the Cadiz proposal, Sen Dianne Feinstein charged, "For close to two decades, Cadiz has been trying to ram through a water extraction project that would harm the Mojave Desert. And now we hear from the Metropolitan Water District that the water Cadiz wants to extract could contain dangerous chemicals that pose a threat to the safety of Southern California's water supply."

Former Mayor of Glendora 2016, Feinstein asked President Obama to use the 1906 Antiquities Act to expand the protection area an additional 1.8 million acres naming Mojave Trails, Sand to Snow and Castle Mountains as National Monuments. In February. Feinstein announced approval of California Desert Projection and Recreation Act adding another 716,000 acres of desert land.

October 2015, the Cadiz project was blocked by Obama's Bureau of Land Management (BLM) over the use of an 1875 railroad right of way for the water transfer pipe location. When President Trump came into office, BLM reversed their decision and Cadiz started to move forward and ownership rights of Arizona and California Railroad Company and the 2008 99-year lease between Cadiz and ACRC railroad held.

Cadiz History:

1983 -- Cadiz Inc. was founded after acquiring 11,000 acres in Cadiz Valley of eastern San Bernardino County. Through NASA technology analysis and research, it was determined the land was situated over a large, naturally recharging aquifer system able to provide a high-quality, reliable water supply to Southern Californians and much-needed underground storage for surplus water.

1984 -- production wells determined high-quality groundwater.

1986 - As good agricultural land, the first grape vineyards were planted and in 1989, a citrus orchard and seasonal crops added. The vineyards, citrus or-In 1994, Sen. Dianne Fein- chards and seasonal vegetable crops continue to flourish. 1998 -- Cadiz began developing a water supply and storage project designed to provide storage of imported surplus Colorado

River water for MWD and return that water and native groundwater to MWD when needed. Lack of surplus water stopped the project.

2008 -- Re-designed the project to deliver a reliable water supply to Southern California, routing conveyance pipeline over ARZC Rail right of way to avoid disturbing public lands and connect the Cadiz Valley with the Colorado River Aqueduct.

2011-12 - CEQA environmental review/permitting process led by Santa Margarita Water District (SMWD) and San Bernardino County, separately, approved the Project's groundwater management plan and conservation of approximately 50,000 acre-feet of water per year for 50 years with habitat preservation plan.

2013-16 -- SMWD and County defended CEQAs, and projectapprovals were upheld by Superior Court against six cases, sustained by Court of Appeal, and became fully-vested, not subject to further challenge.

Aug 1-2019 Gov. Gavin Newsom signs SB 307 looking like a targeted effort to block the Cadiz Water Project.

SB 307 says "... transfer of water using a conveyance facility that has unused capacity to transfer water from a groundwater basin underlying desert lands ... in the vicinity of specified federal lands or state lands to outside of the groundwater basin unless the State Lands Commission (SLC), in consultation with the California Department of Fish and Wildlife (CDFW) and the Department of Water Resources (DWR), finds that the transfer of the water will not adversely affect the natural or cultural resources of those federal and state lands.

Additional environmental review by State Lands Commission is smoke and mirrors. SLC, established in 1938 to "...manage 4 million acres of tide, submerged lands, the beds of navigable rivers, streams, lakes, bays, estuaries, inlets, and straits." is made up of 3 commissioners with Lt. Gov. Eleni Kounalakis, Chair.

For two decades Cadiz has

Electronic Medical Records (EHRs) were part of the bumpy road to the ACA. President Obama, promised that EHRs would "cut red tape, prevent medical mistakes and help save billions of dollars each year." The unwary believed the puffery versus the facts.

The promise: EHRs are efficient. Reality: Hundreds of different brands mean that the records cannot be exchanged between physicians, but they can be sent to the Office of the National Coordinator for Health Information Technology.

The promise: EHRs save time. Reality: Doctors spend half their time on the computer rather than talking with patients.

The promise: EHRs save lives. Reality: Software problems have memorialized incorrect information. One in 5 people surveyed by Kaiser Family Foundation has found a mistake in their records.

The promise: EHRs are private. Reality: There were more than 2,000 data breaches of 176.4 million patient records between 2010 and 2017.

It sounds so virtuous to insist that "healthcare is a right." Thus, if you do not believe medical care should be free, you are not a moral person. This technique echoes Aldous Huxley's view that "the propagandist's purpose is to make one set of people forget that the other set is human."

(Of course, bearing arms is a constitutional right, but guns are not given away for free. Indeed, gunowners are thought by some to be horrible people). Free medical care for all is short, simple, and seductive.

The promise: Medical services are free. Reality: Government may deny the request for prior authorization for your treatment, or ration treatments for older folks, such as hip and knee replacements and cataract surgery. In the government health system 307,000 Veterans might have died waiting for medical care.

The promise: Drugs are free. Reality: The medication your physician thinks is best for you is not on the government's formulary.

The promise: There are no without out-of-pocket costs. Reality: Private health insurance is abolished, leaving no consumer choice.

The promise: It's free! Reality: Your taxes will be raised to heights unknown.

"Free" is America's new verbal Potemkin village of health care, where Susie gets a free birth if she survives her abortion, free medical care for life, and even free food. All Susie has to do for herself is breathe. This is a panderer's view of America. In fact, we are a country of individuals who want to govern their own lives and of physicians who want the freedom to properly care for their patients.

More Families Have a Plan to Pay for College

College may be getting more expensive, but new research suggests that more families are preparing to meet those costs one way or another.

Eighty percent of families say they are confident in how they paid for college last year, and nearly half have a plan to pay for all years of college, according to "How America Pays for College 2019," a recent study from Sallie Mae and Ipsos, an independent global market research company.

All this preparation could be attributed to the fact that the overwhelming majority of families recognize the value of higher education, with 90 percent of families agreeing college is an investment.

"The individual and socioeconomic benefits of a college education are clear, so it's particularly gratifying to see that families continue to view college as a worthwhile investment," says Raymond J. Quinlan, chairman and CEO, Sallie Mae.

On average, families report spending \$26,226 on college in academic year 2018-19, with a sizeable portion of costs --43 percent -- covered out-ofpocket through income and savings.

Scholarships, grants, and gifts -- used by 82 percent of families -- covered 33 percent of costs, and that "free money"



can be especially important, both logistically and psychologically, opening doors to opportunities that would be otherwise unavailable and even making a difference in the way students view the college experience as a whole.

The study also found that while borrowing covered 24 percent of overall college costs, 57 percent of the families who borrowed to pay for college say they had always planned to do so as part of their paying-forcollege strategy. What's more, many families are getting a head start on paying their loans back, with 41 percent making payments on student loans while the student is in school.

Families are being proactive in other ways, too. Seventyseven percent of families completed the Free Application for Federal Student Aid (FAFSA) for the 2018-19 academic year. Completing the FAFSA is the


Federal Reserve Gives Wall Street What It Expected

The Fed cut rates by 25bp and announced balance sheet runoff will end August 1st, two months ahead of schedule. As noted by Bloomberg Economics, the Fed avoided using the word "insurance," "risk-management," or "preemptive," all key words expected in the case of a one-anddone rate adjustment. Instead the decision to cut was a response to too low inflation and global uncertainty. The statement notes uncertainty continues, which leaves the door open to further cuts.

HOW CAN NEGATIVE IN-TEREST RATES BE ATTRAC-TIVE?

With \$13 trillion of global government bonds now showing negative yields, the question that begs to be asked is how low is too low for interest rates and what is the end game? It is commendable that the Fed tried to normalize monetary policy, but such a maneuver is very difficult to do in a world where many other central banks are doing the opposite. Just as Fed policies affect the rest of the world - particularly due to the reserve currency status of the U.S. dollar the opposite actions by other major world central banks also (at least somewhat) effect the U.S. economy, whether we like it or not.

The 10-year Treasury note probably wouldn't be at 2.05% today if it were not for the growing pile of \$13 trillion in negative-yielding world government bonds. Investors chasing riskfree yields end up in our U.S. Treasury market, as the safest place to go for positive yields. Global bank Quantitative Easing activity supports the Treasury market and the U.S. dollar, despite America's rising federal deficits. It will remain difficult for the dollar to decline in an environment where negative interest QE policies are abundant



globally (especially while only the Fed has been shrinking its balance sheet).

Quantitative easing is like printing money, but for financial institutions only (they are the only benefactors). It differs as only banks have access to those electronic dollars, or euros or yen. As excess reserves are abundant in the system, they find shelter in government bond markets. In the U.S., QE worked as excess reserves first found homes in Treasuries and mortgage bonds and then trickled down to riskier fixed-income instruments. What's happening is pulling the economy out of a deflationary hole by the force-feeding of credit into an overleveraged system that was otherwise going to deleverage naturally.

While excess reserves have no credit multiplier effect, due to the way they were never lent into the Fed funds market, they do have a spending and credit multiplier effect. As deficit spending trickled down through the economy, people got paid, they deposited the money in their banks, banks lent much of that money out, it was spent again, and the credit multiplier cycle did help economic activity in the U.S. Regrettably the same QE dynamic has not been able to produce similarly good results in Europe or Japan.

As the world reacts to the Fed cutting the Fed funds rate by 25 basis points, the investor community, helped by global central

bank QE policies, had already driven the 10-year Treasury yield from a high of 3.24% in early November to a low of 1.94% in June 2019, or a 130 basis point decline in just seven months. As far as I am concerned, the market has already delivered a large reduction in longer-term riskfree rates in the United States. One could say that the Treasury market is forcing the Federal Reserve to cut the Fed funds rate to become more in tune with market-driven rates. The question is are those rates really marketdriven if global QE policies helped them get there?

So far, there has not been any foreign 10-year government bond that has printed a negative yield of a whole percentage point, although there is one that has come close at -0.76% in Switzerland. Closely related to the Swiss bonds are the German bunds, which closed last week at -0.32%. Other 10-year government bonds with negative yields include the Netherlands (-0.21%), Japan (-0.13%), and France (-0.07%).

The moral is that policies of foreign central banks have their effectiveness limits. Europe and Japan have some very serious structural and demographic issues that central bank policy alone cannot solve. I am worried that trying to do too much QE will backfire in Europe as well as Japan. Administering more monetary medicine to a sick patient (after it has not yet worked) is probably not the best way to proceed. For the time being, the dollar is likely to remain strong; and, returns from U.S. financial markets should continue to be better than anything in Europe or Japan.

According to the news, the Feds lowered the interest rate. Should I refinance?

The Feds lowered the interest rate of the money they loan to banks and other lenders. Q: I'm always being told I need my filters changed. What's that all about?

This information was entered into their computer system and a hit was made. They compared prior mug-shot pictures and was able to confirm the identity.




Los Angeles County Child Support Services Observes "Child Support Awareness Month 2019"


