America's Christian Credit Union Celebrates National Foster Care Month

GLENDORA – America's Christian Credit Union (ACCU), a faith-based financial institution, celebrated National Foster Care Month with gusto. While sponsoring events in line with its call to Missional Banking, the credit union also reinforced its core value of Building Stronger Families.

On Saturday, May 18, ACCU's premier foster care partner, Olive Crest, hosted a Foster Champions breakfast at Eagle Rock Baptist Church. The gathering included about fifty champions from all over Los Angeles County, representing churches, nonprofits, and individuals passionate about this ministry. The keynote speaker was Jason Johnson, a prolific blogger and mobilizer who has been spearheading foster care ministries across the country.

"We need to aim for long-term sustainability," said Johnson. "Sustainability is built on the back of ministry." He shared insights and strategies, and suggested ways in which everyone can do something, even those who cannot commit to bringing a child into their household.

The following Saturday, May 25, ACCU participated in the 12th Annual Foster Youth Townhall, keynoted by state senator An-

thony J. Portantino (D-La Canada Flintridge). About 60 foster youth, group home parents, and sponsoring agencies gathered for the townhall at Pasadena City College. ACCU was honored with a certificate of recognition from the State Senate, in recognition of service to foster youth.

"Through America's Christian

Credit Union's investment in the community and partnerships," said Sen. Portantino, "you have assisted families who have opened their own hearts to young children and foster youth. Your support will go a long way in ensuring foster youth have the support they need to finish high school, apply for college and pay for college."

ACCU President/CEO Mendell Thompson reiterated the credit union's commitment to helping foster youth become financially literate and increase their chance for greater success in independent living. To this end, VP/Chief Development Officer Fawn Imboden shared three initiatives being offered by the

credit union: a 3-week financial literacy program; internships for qualifying foster youth; and a mentorship program run by ACCU staff.

Last but certainly not least, three ACCU staff took time on a Sunday afternoon to attend an adoption meeting at Shepherd's Grove Presbyterian Church, Irvine, CA. Hosted by Zero by 2020 Vision, the meeting was being held to spread the word about foster adoption to some 20,000 Christian congregations in Orange County, CA. Pastor Max McGhee of Saddleback Church, Zero by 2020 leader and himself an adoptive father of a Rwandan son, mentioned ACCU's Adoption Loan services, which have helped over 1,850 families responding to the call to adopt.

The nation has more than 440,000 children in the foster system, and 35,000 of them are in Los Angeles County alone. This crisis demands that the church seek ways to realize the promise in Psalm 68:6, that God sets the lonely in families. Even though National Foster Care Month is over, the need remains. Will you join us in this important mission to ensure that the foster children in our midst have a family to call their own?

Elected Officials & Community Leaders Celebrate Grand Opening of America's Job Center of California (AJCC) and Community Resource Fair

"Recent data shows that the communities surrounding Slawson Occupational Center have some of the lowest median earnings in the County, ranging from just over \$19,000 to \$23,000," said Los Angeles County Supervisor Hilda L. Solis, who represents Southeast Los Angeles. "Through collaboration and co-location of service providers, we can equip prospective workers with the tools to grow their careers. As a former Secretary of Labor, I am fully committed to providing job training services to those who are most in need—from our immigrant residents, people experiencing

homelessness, dislocated workers, Veterans, justice-involved residents, and transitional-age youth. Today's grand opening is an important step to matching workers with good jobs, which will help families thrive."

The Slawson AJCC will specifically provide job seekers with assistance in assessing skills, finding job opportunities, help preparing a resume, accessing academic support and more.

"The Richard N. Slawson Occupational Center is unique and in addition to providing opportunities for students to earn a high school diploma, students have the opportunity to learn English and other skills to prepare them for new careers or upgrade their skills," said Jackie Goldberg, newly elected board member of the Los Angeles Unified School District (LAUSD). "Having the AJCC located within an LAUSD school provides an additional oncampus resource for our students, and it will provide job seekers and employers who utilize the AJCC greater accessibility to the training and resources available at our school."

Otto Solorzano, Acting Director of Los Angeles County Workforce Development, Aging, and Community Services said, "The Slawson AJCC will provide job seekers with opportunities to launch careers or upgrade and improve their existing skillset, while engaging employers to provide experienced workers and other training services they need to grow their business. Through the Slawson AJCC, we can introduce students in programs such as accounting, medical coding/ billing, electrical, construction, and more to gainful employment upon completion of their programs."

Attendees had the opportunity to tour the AJCC facilities and participate in a community resource fair that included Los Angeles County Departments such as the Department of Mental Health, Department of Public Health, Department of Public Social Services, Los Angeles Homeless Services Authority, the Office of Supervisor Hilda L. Solis, and more.

GLENDORA - On The morning of May 18th, Andrew Amezquita, then age 17, of Troop 491 Glendora, lead over 18 fellow Scouts, adult Scout leaders, and other volunteers on his Eagle Scout Service Project along a steep and winding East View North Fork Trail in the South Hills Wilderness Park in Glendora. Together they adjusted a misaligned trail sign and used "fire-style" rakes called a "Mcloeds" to both cut back the overgrown brush, and widen and level uneven ground created by recent rains. This service project was part of Andrew's requirement to earn the rank of Eagle Scout.

Andrew chose to work on the trail following a talk with Dick Swinney, Chairman of the Glendora Trails Council. "I really enjoy the outdoors so it was an easy choice," said Andrew. The third of a mile trail is part of the trail system in the South Hills Wilderness Park and begins at Elwood Avenue as part of the Alosta Canyon Trail and connects with other trails in the park. After hiking the trail with Mr. Swinney and listening to his concerns, Andrew formed and executed his plan to restore the trail in accordance with the Eagle Scout Service Project requirements for leadership, safety, local impact, hours of work, materials needed, and call for volunteers. The Glendora Trails Council provided the heavy hand rakes used and Pizza Hut donated the lunch for the volunteers.

The day of the project was sunny and cool, much to the relief for Andrew and the volunteers, who spent from early morning until the early afternoon clearing and shaping the hilly trail with hand tools. The day's hard work and the number of volunteers relieved a vis-

ibly concerned Andrew with "how fast everything got done and the project was completed." At the conclusion of the project, the trail had been widened an extra four feet, which made for an easier and safer walk for hikers.

A Scout since 2011, Andrew Amezquita recently graduated Gladstone High School in Azusa and plans to enlist in the United States Army after graduation.

The Eagle Scout Service Project, or more simply the Eagle Scout Project, provides Boy Scouts in the Boy Scouts of America (BSA) the opportunity to demonstrate leadership skills while performing a project for the benefit of his community. This is the culmination of the Eagle Scout candidate's leadership training, and it requires a significant effort on his part.

The Orchard will be developed on the southeast corner of Azusa Avenue and Foothill Boulevard on the site formerly known as "Block 36." This four-story mixed-use development will feature 163 residential units consisting of a mix of one-, two-, three-bedroom, and live/work units. Residential amenities at The Orchard include a swimming pool and spa, community room, fitness room, dog park, community garden, and rooftop decks. The ground level will include approximately 32,500 square feet of retail and restaurant space, which will be anchored by a 4screen Laemmle Theatres. Laemmle Theatres is the premier exhibitor of art house cinema with several locations throughout the Los Angeles area.

The project aims to bring sophisticated transit-oriented living and engaging retail and restaurants to the Downtown area of Azusa. The Orchard is located just one block south of the Azusa Downtown Gold Line Metro Station.

Parking Fee Instituted at Duarte/City of Hope **Gold Line Station**

DUARTE - Effective immediately, Metro Gold Line riders will now have to pay \$3 a day to park at the Duarte Park and Ride lot adjacent to the Duarte/City of Hope Gold Line station. The station joins the ranks

of other busy stations having to pay to park along the San Gabriel Valley route. The new \$3 daily parking fee also went into effect Monday at the parking structure in Arcadia. Transit riders looking to park at either of the structures will need their TAP cards as proof of ridership when they pay for parking at a kiosk outside.

The Gold Line has been expanding into the San Gabriel Valley's foothill communities over the past few years. Metro officials say certain stations such as Duarte and Arcadia have gotten busier than others due to a mix of non-metro using car drivers utilizing the structures as free parking, in addition to an overall increase in ridership.

Paid parking is already part of the routine at other Gold Line stations, including APU/ Citrus, Irwindale, Monrovia, and the Del Mar parking garage in Pasadena. Parking is still free at the Sierra Madre station. For additional information about the Metro Gold Line Duarte/City of Hope Station, call Metro at (323) 466-3876.

The Orchard To Break Ground Los Angeles County To Launch **Typhoid Prevention Plan**

Supervisor Barger's Motion Directs Public Health Department to Report Back on Efforts to Eliminate Risk for Law Enforcement and the General Public

LOSANGELES COUNTY-

In light of a recent case of typhoid fever contracted by an LAPD officer, the Board of Supervisors unanimously approved a motion by Supervisor Kathryn Barger to direct the Department of Public Health to investigate and report back with a countywide communicable disease prevention and intervention plan.

"Under this plan, the Department of Public Health will examine the root causes of the communicable diseases associated with trash and rodent infestations and develop a comprehensive plan to protect the health and safety of our residents and law enforcement personnel," Supervisor Barger said.

While there is not presently an outbreak of Typhoid Fever in Los Angeles County, there are other cases that have been reported separately from the case reported by LAPD. In 2018, the Los Angeles County Department of Public Health reported 14 cases of Typhoid Fever and in 2019, has received reports of five cases to date. These cases are almost always travel-related. All cases are reported to the Department of Public Health, which conducts thorough investigation of each

Typhoid fever can be a lifethreatening illness caused by the bacterium Salmonella Typhi. Typhoid fever is more common in areas of the world where water may be contaminated with sewage or where sanitation is poor. Typhoid is typically spread through eating food or drinking water that has been contaminated with fecal material from an infected person. The disease is not common in the United States, and the Centers for Disease Control (CDC) estimates that only 350 cases of Typhoid fever occur throughout the nation each

The motion directs the Department of Public Health, in coordination with local health departments, city sanitation departments, and other pertinent stakeholders, to develop a countywide communicable disease prevention and intervention plan that identifies areas that are at an elevated risk for disease transmission due to unsanitary conditions, and provide recommendations to mitigate disease transmission risk in these areas with a report to the Board in 60 days.

DPSS to Replace MTA Metal Bus Tokens with New Transit Access Pass (TAP)

LOS ANGELES COUNTY

- Effective July 1, 2019, the Department of Public Social Services (DPSS) will discontinue the issuance of the metal Metropolitan Transportation Authority (MTA) bus tokens and transition customers into using a new stored-value Transit Access Pass (TAP) card that will enable simpler and safer travel throughout Los Angeles

DPSS currently issues MTA bus tokens to help meet the emergency transportation needs of customers participating in various assistance programs administered by the department.

The new TAP card contains a pre-set value and one-year expiration date. The cards will be issued in three values:

(\$3.50, \$7.00, and \$10.00).

Bus tokens will no longer be sold by MTA or issued by DPSS beginning June 28, 2019, but will be accepted as MTA fare until November 29, 2019.

West Covina Police Department Looking for 3 Armed Carjacking Suspects

WEST COVINA - Officers from the West Covina Police Department are asking the public for help in identifying the suspects who carjacked a driver at gun-point and stole his black Mercedes-Benz outside of the Edwards movie theater in West Covina Saturday night, June

The suspects approached the driver just before 9 p.m. and demanded the vehicle according to the West Covina Police Department. Although the driver was threatened at gun point, indicating they would kill the driver, the driver was uninjured.

The police want information that would help get these suspects off the street and jail them before they kill someone. The police describe the three suspects as male Hispanics in their late teens and wearing

dark clothing. The vehicle was last seen heading west on the I-10 freeway. Police are hoping that people in the area saw these three individuals and might be able to add to their description and might be able to help identify who they are.

Fireworks Prohibited in Walnut

It is unlawful for any person to manufacture, assemble, store, transport, receive, keep, offer to another or to otherwise have possession with the intent to sell, use, discharge, cause to be discharged, ignite, detonate, fire or otherwise set to action any fireworks of any description within the City's municipal boundaries. Tariffs Gone; Drug Cartels Thrive

Vice President Mike Pence met with "top Mexican Officials" this past week to convince them Mexico has a responsibility to stop the massive human flow to and across our southern border. The impact of literally thousands of human beings at the border and crossing without interdiction is an incredible strain on our resources, and, more than that, presents a harrowing threat to the health and safety of our legal residents and the security of the entire country.

Talks with Vice President Pence, Secretary of State Pompeo and Mexico's Foreign Affairs Secretary Marcelo Ebrard initially netted no results, but under threats of President Trump's increased tariffs, Mexican officials came around. Reports from President Trump indicate Mexico has agreed to send thousands of troops to the border area to stem the flow to and across our border. But that doesn't solve all our border problems.

The re-incarceration of Joaquin "El Chapo" Guzman, head of the powerful Mexican Sinaloa Drug Cartel, gave us all the feeling of victory over the illegal trafficking occurring over the border from Mexico into Southern California. However, like bacteria growing in a jar, new leadership has sprouted up. Ismael ("El Mayo") Zambada García, with "El Chapo's" sons, will continue to do the cartel's business operating in 17 of the 33 Mexican states. The big business of smuggling in and distributing their products throughout the U.S. -- like Columbian cocaine, Mexican marijuana, Mexican and Southeast Asian heroin, methamphetamines and fentanyl -- will continue unless and until a united strong message reverberates out to our leadership in D.C. and all our governors.

Derek S. Maltz, a narco-terror expert and former Drug Enforcement Agency Senior Officer, says, the Mexican drug cartels have established headquarters throughout the U.S. and pose one of the country's "greatest criminal, national security and public health threats" we've ever known. Maltz, before retirement, establish the Counter Narco-Terror-

Former Mayor of Glendora ism Operations Center (CNTOC) that has taken out bigtime narcoterrorism operations, including a money-laundering scheme supporting the Lebanese terrorist group Hezbollah."

Maltz testified May 30th before the Ohio House Criminal Justice Committee about the infiltration of the Mexican drug cartels into Ohio. He told the Committee on April 12th Indiana State Police had intercepted 6 kilograms of fentanyl transported from California headed to Ohio. Medical experts and DEA said that amount of fentanyl had the potential to kill up to 3,000,000 residents of Ohio or 25% of their population.

Fentanyl is one of the most powerful synthetic opioids on the street today and is 80-100 times stronger than morphine. One grain, the size of a grain of salt, can do severe damage or cause death. Naloxone spray or injection provides only temporary relief to restore breathing before the drug takes over the body again.

Testifying with Derek Maltz before the Ohio Criminal Justice Committee was Sara Carter, investigative reporter, and Heidi Riggs, a mother who lost her daughter to heroin addiction. All three are supporting Ohio's House Resolution 10 calling for the federal government to designate the Mexican drug cartels as Foreign Terrorist Organizations (FTO).

Within that Resolution, is the statement of U.S. DEA Acting Administrator, Uttam Dhillon, declaring "Mexican drug trafficking organizations are the biggest criminal threat the United States faces today".

Judicial Watch, Inc., a conservative, non-partisan educational foundation, has written a white paper on Designation of Mexican Transnational Criminal Organizations as Foreign Terrorist Organizations (FTOs) and Reassessing the Mexican Government under the "Trafficking Victims Protection Act" (TVPA). A three-part assessment is required to qualify as an FTO:

- · Organization is a foreign or-
- Engages in terrorist activity
- · Activity is unlawful and threatens the security of the United States nationals or the national security of the United
- Currently there are 67 FTOs according to the white paper.

The process of enacting these designations begins with the Department of State and Secretary Pompeo, is then handed off to Coordinator for Counterterrorism, Ambassador Nathan Sales, appointed in 2017, responsible for preventing and countering threats to civilian security, including terrorism, mass atrocities, and violations of human rights and the rule of law. There is a set procedure and allows for the organization to appeal the designation of TCO. All assets of the organization may be frozen.

The discussion put forth by Judicial Watch in their White Paper and Ohio's House Resolution 10 are not the first attempts at quashing the drug cartels. In 2012, Texas Congressman, Michael McCaul, introduced legislation, H.R. 4303, that would have directed the Secretary of State (Hillary Clinton) ... "to designate as foreign terrorist organizations certain Mexican drug cartels and submit a report on the activities the Department of State is taking to assist Mexico with drug cartel violence, and for other purposes."

We now have a President who doesn't back down and is determined to deal with this quiet assault on our country. It is time to put forth McCaul's legislation and support Judicial Watch's White Paper and Ohio's House Resolution 10.

Those Terrible Regulations

In any recitation of what will make America great again, Trump will focus on the damnable "regulations" that have choked the nation. He has vowed to eliminate thousands of these toxic inhibitions to American business. *A requirement for oil and gas companies to report methane emissions.


*A rule limiting methane emissions on public lands, including intentional venting and flaring from drilling operations.

- *A freeze on new coal leases on public lands.

*An executive order designed

to preserve ocean, coastal and Great Lakes waters. *A rule that required mines to

prove they could pay to clean up future pollution.

*An order that had set a goal of cutting the federal government's greenhouse gas emissions by 40 percent over 10 years.

*A rule that required braking system and other upgrades for "high hazard" trains hauling flammable liquids, like oil and etha-

*A program designed to limit exposure to lead, which is known to damage brain and nervous system development.

*A rule that prevented coal companies from dumping mining debris into local streams.

mate Fund, a United Nations program to help poorer countries reduce carbon emissions.

Here is how the Trump Administration seeks to deal with the safety of the air we all breathe and the water we all drink. ers of several of the numerous oversight committees in the House of Representatives. They continuously bemoan that the Executive branch refuses to give them documents and allow staff members to testify before their committees. Where did the Congress get this power of oversight?

If one does a word search on the Constitution of the United States looking for the term Congressional oversight one will not find either of these words as they are not in the Constitution. Then how did the current numerous oversight committees in the House and Senate come into be-

Oversight is an implied power

- not a stated power. Originally, 'oversight' was intended for the elected officials to make sure that the once laws were passed that the intent of these acts were implemented by the appropriate departments of government. When oversight is used for that purpose this is a necessary function of congress. However, what has happened is that congress has slowly passed laws - sometimes over the veto of the president - that have eroded the power of the presidency.

In 1978 a Workshop called; Congressional Oversight and Investigations, was created, the product of which was a manual on the oversight process. The following has been taken from this document:

"Throughout its history, Congress has engaged in oversightbroadly defined as the review, monitoring, and supervision of the implementation of public policy-of the executive branch."

"Woodrow Wilson wrote in his classic Congressional Government (1885): "Quite as important as lawmaking is vigilant oversight of administration." Today's lawmakers and congressional aides, as well as commentators and scholars, recognize that Congress's work, ideally, should not end when it passes legislation. Oversight is an inteand economical manner. In light of this destination, oversight can be viewed as one of Congress's principal responsibilities as it grapples with the complexities of the 21st century."

Additionally, this document identifies the formal source of this congressional power as: "Despite its lengthy heritage, oversight was not given explicit recognition in public law until enactment of the Legislative Reorganization Act of 1946. That act required House and Senate standing committees to exercise "continuous watchfulness" over programs and agencies within their jurisdiction."

Also from this document comes the following: "The power to organize the executive branch. Congress has the authority to create, abolish, reorganize, and fund federal departments and agencies. It has the authority to assign or reassign functions to departments and agencies, and grant new forms of authority and staff to administrators. Congress, in short, exercises ultimate authority over executive branch organization and generally over policy."

If one takes this paragraph literally it gives congress the total power to abolish any part of the Executive branch of government effectively disabling the presidency. Is it any wonder that congress is in such disarray? Was this the intent of the founders with their concept of 'separation of powers' and checks and balances? This document was obviously written by a group of power hungry oligarchs in congress.

To them there is only one branch of government and they are it.

The Congressional Oversight Manual - is a guideline not a law.


Bears Endlessly Tout Myth of America's Decline

On May 31st the 10-year Treasury bond yield collapsed to 2.13% (a 20-month low) after the stock market sold off in the wake of the surprise threat of tariffs to be imposed on Mexico (to be enacted on June 10th if the Mexican government does not sufficiently cooperate with the Trump Administration to help stop the flood of illegal immigrants into the U.S). I expect that Mexico will find a way to cooperate to avoid the tariffs, since Mexico is led by savvy business people who do not want to jeopardize their lucrative trade deals with the U.S.

Sharply dropping Treasury yields in a good economy often means the market was worried that the economy will not be so healthy the following year. However, another big driver of falling yields in the U.S. is the situation in Europe, where the German 10-year bund closed on Friday at -0.20%, while the German 2-year federal note closed Friday at -0.64%.

However, the latest drop in Treasury yields is not all about negative rates in Europe. The failure of trade talks with China and new potential sanctions on Mexico, in addition to the impact of foreign buyers of auctioned US debt instruments, negatively impact interest rates. Trade frictions have not yet produced an "economic event", but they have the potential to become substantial disruptors to economic performance especially in Mexico and China. To a lesser degree the USA would also be negatively impacted - all three countries at the same time - should both trade fights escalate.

It should be noted that last Tuesday Federal Reserve Officials indicated that they were closely watching recent trade tensions. Chairman Powell was quoted as saying: "We are close-

ly monitoring the implications of these developments for the U.S. economic outlook and, as always, we will act as appropriate to sustain the expansion. Cutting rates apparently is "back on the table"

The other factor that spooked the stock market a week ago Friday was China's National Bureau of Statistics reporting that its purchasing managers index (PMI) slipped to 49.4 in May, down from 50.1 in April. Since any reading below 50 signals a contraction, China's official PMI signals that U.S. tariffs on \$200 billion in Chinese goods may be taking a toll. The Wall Street Journal recently had a great article on how "The Real Winners from Trump's Tariffs Are China's Neighbors," like South Korea, Taiwan, Vietnam, and other countries in Southeast Asia, which are taking business away from Chi-

Every credible market pundit being interviewed by the financial media is asked to provide a prediction of when the "coast will be clear" to allocate more capital. With the full understanding of the toll the sell-off has been having on stock prices, the market is getting to a place where some technical indicators, contrary indicators, and real-time data points seem to suggest that a selling climax may have already passed. While there is an intense focus on the major averages, more attention should be paid to the sec-

tors that matter most - both to the

stock market and to the economy itself - namely, technology and the consumer.

If the consumer accounts for two-thirds of domestic GDP, then we should all take note of the spike in last week's Consumer Confidence report for May, which came in with a reading of 134.1, the highest reading since November 2018. In both of these months, the market was in fullthroated decline! Adding to this data point, the Present Situation Index increased from 169.0 to 175.2 and the Expectations Index rose from 102.7 to 106.6. The key takeaway is that consumer confidence has not been impacted by increased trade tension between the U.S. and China or the implied threat of prices on imports being passed on to the con-

Are we seeing an "oversold bounce" or something in the tea leaves that suggests something better? It's very hard to say, especially when the negative noise level is turned up so high.

I'm not saying this compilation of data points is a green light for a major market reversal, but I'm simply taking note of historically pivotal market trends, both here and abroad, that have bent but are not broken.

Betting against America doesn't often pay. One of the world's richest men tells the America-in-decline crowd:

"For 240 years it's been a terrible mistake to bet against America, and now is no time to start. America's golden goose of commerce and innovation will continue to lay more and larger eggs." - Warren Buffett.

Dads, grandpas, great-grandpas, step-dads, father-figures enjoy letting your family celebrate YOU on Father's Day. Some dads might want expensive gifts, but most are very happy to be acknowledged and thanked for their role in your life. Share some childhood memories that were special between you two. You might even be able to reenact an experience like going camping, fishing, eating ice cream, or just looking through photo albums. Write a summary page of your insurances, investments, wishes, trust, etc. Review and update your beneficiaries. Consider a Limited Power of Attorney for your finances and medical care.

late 60's and is trying to figure out if it's best to continue renting, or to take half of his retirement savings to buy a house and have no mortgage payments for the rest of his life. What do you recommend?

This scenario would involve some more facts and 'numbercrunching.' Will the other half of his retirement savings be enough to last his lifetime? The cost of renting can continue to rise, or the landlord could sell, or decide to live in the rental. The cost of taxes and insurance can continue to rise, and there's the cost of maintenance and repairs. Renting helps the landlord's finances, and provides free maintenance and repairs. Purchasing builds equity which could be utilized at a later date, either by financing or reverse mortgage.

Is there somewhere else to invest my CD money that's safe, will earn a little better returns, and I could get to some of it, just in case a need arises?

Some of that money should be kept in an emergency fund. You have a couple of good choices for the other amount. One product line offers a start-up bonus, a






