Takeover Robbery in Glendora Ends with One Arrest and One Suspect Dead

GLENDORA - A takeover robbery at a jewelry store ended up with a shootout with police which left one suspect dead, one suspect arrested and one still being sought.

Glendora police responded to a robbery call at 750 W. Route 66 on Friday, Sept. 6 just after 12 noon. When they arrived, they saw a woman in a vehicle which could be the get-away car. They detained and handcuffed the woman and took her into custody. Officers found out there were two male black suspects with guns in the Jewelry Store. Officers quickly started blocking off the area and after the robbery, the suspects ran through the rear door where they saw the police setting up a containment area. The suspects split up with one suspect heading east through the rear parking lot. He crossed Vaceno Dr. and then ran through the parking lot of Flappy Jacks Pancake House and crossed Route 66 and continued to run east. He came to a mixed-use complex located at 633 W. Route 66 where he turned in to go through the parking lot. Soon he realized he was trapped because of the security gate and fencing. The officer who were giving chase ordered the armed

refused to comply.

With the concerns that the dangerous armed suspect might try to gain entry into an occupied office or business and endanger other lives they had to naturalize a very bad situation. With the suspect being a threat to officers and others, they continued to order the man to comply, but it went bad and then a shooting took place with the suspect being hit and going down.

In the meantime, other responding officers attempted to track down the other male suspect who was described as being of thin build with short



Student's Report of Kidnapping Attempt was a Hoax


WEST COVINA - Recent reports to police about attempted kidnapping on Wednesday were being investigated when a report came in on Thursday, Sept. 5th of a 12year-old boy who reported to police that on that morning while walking to Traweek Middle School that he was accosted by two individuals. He said he was able to escape from the two men. One man was driving a black Mercedes who tried to lure him inside his car and at the same time a second man, who was riding a bike. road up and attempted to assist the first man by grabbing and trying to push the boy into the car. The boy claimed he fought off the two suspects and got away.

After the incident was put out by the news media, police later said the boy admitted to investigators that he made the whole thing up. It was unclear as to why the boy lied about the incident which caused alarm for students and parents. This also caused a lot of police resources to be used as well.

On Wednesday, there were two reports of attempted kidnappings where officers responded. Just after 1:00 p.m., a 10-year-old girl said a man approached her and asked the girl if she wanted a ride as she walking home from school. Around 3:00 p.m., a passerby said they were concerned when sedan following a young girl as she was walking on the sidewalk. This was in the area of Lark Ellen Avenue and Workman Avenue. Police responded to the area and they were not able to locate the reporting party or girl.


In both Wednesday and Thursday cases, investigators determined that no attempts were made to kidnap the children.

Governor Signs Bill to Require Screening of All Sexually Violent **Predators Before Release**

SACRAMENTO - Governor Gavin Newsom has signed into law Senate Bill 141 coauthored by Senator Ling Ling Chang (R-Diamond Bar) and authored by Senator Patricia Bates (R-Laguna Niguel) that will require all inmates convicted of a sexually violent offense to be administered a comprehensive risk assessment before their parole hearing.

"As California continues to expand the possibility of early release of inmates sentenced to life terms, this added legal assurance will make our neighborhoods safer," said Senator Chang. "I'm proud to stand up for crime victims and improve public safety."

SB 141 will require the California Board of Parole Hearings to consider the results of a "comprehensive risk assessment for sex offenders" for inmates that have a prior conviction for a sexually violent offense before their parole hearing. The assessment specifically tests for an inmate's likelihood to engage in sexually violent behavior.

"Protecting California's communities is one of my top priorities and I am pleased that the Governor signed Senate Bill 141 into law," said Senator Bates. "Every sexually violent predator should be screened before their parole hearing. I thank San Diego County District Attorney Summer Stephan, my legislative colleagues, and the Governor for their assistance in strengthening the law."

Current law requires the screening of inmates sentenced to a determinate term for their potential to engage in a sexually violent offense before they are released on parole, but not those sentenced to an indeterminate term. SB 141 closes this loophole and ensures that those sentenced to an indeterminate term are also evaluated.

SB 141 was inspired in part by a Southern California man who was convicted of murder and rape with a foreign object in 1989 and is now eligible for parole. The inmate previously was committed as a Mentally Disordered Sex Offender (MDSO) to Patton State Hospital for previous crimes, had been diagnosed with sexual sadism, and was convicted for a sexually violent offense that otherwise qualifies him to stay behind bars.

L.A. County Launches Fair Chance Hiring Campaign to Raise **Awareness of the Benefits of Hiring Justice-Involved Workers**

LOS ANGELES COUNTY -Members of the Los Angeles County Board of Supervisors joined business leaders and community partners to announce the launch of an awareness campaign to promote the Fair Chance Hiring Initiative, which encourages businesses to actively hire members of the justice-involved com-

"Today, we challenge employers to think outside the box when making their hiring decisions," said Los Angeles County Supervisor Hilda L. Solis, who authored the motion to establish the Fair Chance campaign. "Studies clearly show that hiring rehabilitated people with past records is a smart business move: they work harder, stay longer, and promote faster than other employees. LA County also offers incentives and support to businesses that hire individuals who have been justice-involved. Everyone deserves a fair chance to get back on their feet – and when they do, everyone benefits."

As part of the campaign, business executives will be asked to sign the Fair Chance Hiring Pledge, which is a commitment to provide justice-involved individuals a fair chance to participate and to thrive in our economy by promoting fair chance hiring practices. The pledge is available at fairchance.lacounty.gov. Companies that sign the pledge will receive guidance from County Business Services Representatives who will work with them to recruit and keep qualified candidates. The County connects businesses to tax credits, training reimbursement, and other resources when they hire qualified workers who were once incarcerated.

"Hiring justice-involved individuals is not only good for business, but provides an opportunity to transform lives," said Supervisor Mark Ridley-Thomas. "Stable employment can help individuals reenter society with the tools they need to lead healthy and productive lives, leading to greater safety in our communi-

The Fair Chance Hiring initiative is a key component of the County's overall efforts to expand employment opportunities for justice-involved individuals and to reduce recidivism. Research shows that approximately one in three working-age Americans has a felony criminal record and up to 65% of individuals released from incarceration are unemployed a year after release.

"There is a great need for work opportunities among members of the reentry community," said Vincent Bragg, who founded the advertising agency ConCreates after leaving prison. "Too many of us have been undervalued and overlooked because of complex circumstances. It is vital to have programs like this that can help move the needle toward meaningful change."

"We have been hiring reentry individuals for several years and can attest to the dedication, reliability and incredible work ethic of our justice-involved employees," said Ken Wiseman, Chief Workforce Development Officer at AMS Fulfillment. "It is great to see the County offering incentives to businesses that hire from this pool of qualified, talented people."

The Fair Chance Hiring Campaign also seeks to raise awareness of the State's Fair Chance Act, which went into effect in January 2018. The law generally prohibits businesses with more than five employees from asking about a job candidate's criminal record before tendering a conditional job offer.

California Veterans Will No Longer Need to Pay Adoption Fees at Animal Shelters

SACRAMENTO - Following strong bipartisan support, Governor Newsom signed Senate Bill 245, authored by Senator Ling Ling Chang (R-Diamond Bar), which calls on animal shelters throughout the state to waive pet adoption fees for military veterans. California is home to two million military veterans, including many who struggle to cope with Post-Traumatic Stress Disorder (PTSD) and a companion animal could be beneficial with their recovery efforts.

"This is a big win for veterans and shelter animals," said Senadog is a 'man's best friend.' When I'm home my four-legged companions are a part of my family. Buster and Pepper bring me joy and laughter and I benefit from the positive effects of their companionship. Our brave heroes deserve the same happiness, and I'm glad we can reduce the barriers for bringing together veterans seeking companion animals and pets in need of a home."

Under SB 245, the process for confirming an eligible veteran by a shelter would be streamlined by using the state's existing "VET-

tor Chang. "As the saying goes, a ERAN" driver's license designation. This law is effective January 1, 2020.

Since Senator Chang's tenure, she has advocated on behalf of veterans and shelter animals with other legislation that are on their way to the governor's desk for his signature. She co-authored Assembly Bill 427 which would exempt military retirement pay from state income tax for veterans who are residents in California, and introduced Senate Bill 64 which would require a microchip be implanted in all dogs and cats before they are released.

California Sends 6th Urban Search & **Rescue Task Force to Bahamas to Assist** in Response to Hurricane Dorian

SACRAMENTO - As a part of an agreement with the US Office of Foreign Disaster Assistance and the Los Angeles County Fire Department, California is providing a sixth Urban Search and Rescue (US&R) Task Force to the Hurricane Dorian impact

In response to a request from the Government of the Bahamas, the US Agency for International Development/Office of Foreign Disaster Assistance is deploying an International Medium US&R

Team with Water Rescue Capabilities from the Los Angeles County Fire Department to the Bahamas to support search and rescue operations in response to Hurricane Dorian.

The Los Angeles County Fire Urban Search & Rescue team, known internationally as USA-2, will deploy to the Bahamas with 57 personnel, four US&R Canine Search, and an International Medium US&R equipment cache with additional water rescue capabilities.

Hurricane Dorian is the second strongest Atlantic hurricane on record and the strongest to ever hit the Bahamas. Dorian brought life-threatening wind, rain and flooding to the northwestern islands of Abaco and Grand Bahama.

The LA County Fire Department will also deploy a member of USA-2 to USAID Ops Center in Washington, D.C., to serve on the OFDA's Response Management Team in support of the urban search & rescue mission.

CAGOP Ensures Trump Has Delegates

The Presidential Tax Transparency and Accountability Act, SB 27, introduced this year by Democrat Senators Mike McGuire and Scott Wiener "... requires a candidate for U.S. President and a candidate for California Governor to file copies of their income tax returns with the Secretary of State (SOS) ... "and must file the last five years' tax returns and do it by the end of November to be on the March California Primary Ballot, Gubernatorial candidates, however, will be required to file beginning in 2024. Gov. Gavin Newsom signed that bill believing it is "California's sovereign authority" to regulate who is listed on the state's bal-

Newsom has told most of the news agencies, in so many words, it is important to have that tax information so voters know who they are voting for and what their real choices are for President and governor. Former Governor Jerry Brown was presented with a similar bill and vetoed it during his term after refusing to release his tax forms in the 2010 and 2014 elections as did his challengers.

Back from the Republican State Convention in Indian Wells this weekend, I can tell you those there feel it is unconstitutional and many of us are outraged that this Democratic legislature and Gov. Newsom feel they are able to create legislation that disenfranchises many of us voters with this bill for their own self-serving political end-run.

Republican National Committeewoman and Vice-President of the Republican National Lawyers Association, Harmeet Dhillon, has filed a lawsuit challenging SB

27 in Supreme Court and told Republicans attending the Convention she believes they may get a decision back by the end of September. San Francisco Chronicle article by Alexei Koseff on August 6th reported "... three Republican voters also sued in Sacramento, naming Newsom and Padilla as defendants in "a naked political attack against the sitting President of the United States" that "subverts the franchise for cheap political gain."

tutional in California, and most believe it is not, the questions become far more serious for all voters in all the states in this country. It simply means, at the whim of any majority party, a voter could be disenfranchised by that majority who would decide who should be allowed on the ballot based upon majority party's demands. In this case, a pres-

A candidate's health records that would violate in place privacy laws? School and college records? Perhaps it is the political opposition party that is the needy one.

The overriding question becomes should states be able to dictate ballot eligibility to the federal government by setting the qualifications and requirements for federal candidates and officers? At one time, when there was a movement to set term limits for Congress, the Supreme Court ruled the states can not set or add qualifications for federal candi-

The California Republican Party took action this weekend to approve a rule change to make sure California will be able to send delegates to the Republican National Convention even if President Trump is kept off the California ballot. The measure would allow the State GOP to hold a special convention after the March 2020 primary to select delegates and alternates to send to that summer convention.



The Health Insurance Debate

"Life liberty and the pursuit of happiness" is the Jeffersonian trinity of values that stand at the heart of this independent nation. While exact definitions would come later, we are just becoming aware that "Life" must include universal health care, and every Democratic candidate for President has made that affirmation. The question is not "Should everyone be covered," "but "What is the best way to get it accomplished?"

The philosophical principle called "Occam's razor" holds that given a plethora of possible solutions, the best one will be the least complicated. As I looked at this issue in April of 2016, I had concluded that "Medicare for All" was the simplest solution, and I said so in a column. But as I have continued to study the issue, I have had to alter that opinion. Bernie Sanders wrote the bill calling for "Medicare for All," and has doubled down on his unqualified support. But he has framed it as an angry broadside attack on the insurance industry, the pharmaceutical industry, Wall Street and the "one percent." His plan would also declare illegal the existence of every health insurance company.

In the recent debates on this issue Bernie has been joined by Elizabeth Warren and Kamala Harris. At the core of the opposition to this solution is the obvious conclusion that when you obliterate the health insurance companies you cancel every one of their policies. That affects more than a hundred and fifty million Americans. Advocates of Medicare for All insist that they are just offering a less expensive better alternative without deductibles and co-payments, and as-

sume that Americans will gladly make the exchange.

Advocates, however, fail to recognize the millions who are now happy with their coverage, and the unions who have fought for decades to obtain it for their members. For Democrats to rattle even a minority of union members is a political death wish. What is more, a significant number of Americans are uneasy about the scope of big government and would see this as just another socialistic takeover of a legitimate capitalistic enterprise.

When these issues have been raised, the answer has come back, "Democrats need to stop using Republican talking points." I have long believed that in any dispute wisdom lies in listening to your opponents and taking seriously what they say, particularly if their appeals are directed at the very independents you need to cultivate.

I have an advantage over America's politically elite. I can consider new evidence and change my mind without being branded a flip-flopper. And change my mind I now have. Pushing Medicare for All may simply doom the American people to four more years of "Trumpism." And for that reason alone at this juncture I

have come to believe that it is a political disaster, and wisdom dictates that candidates unalterably committed to it must be rejected. Bernie Sanders is locked in. If Elizabeth Warren, who to this point has been my candidate of choice, cannot alter her position, and if she prevails, I'm afraid she will lead America into years of the racist, nationalist bigotry only celebrated by America's right-wingers including those who shouted, "Jews will never replace us!"

If Medicare for All is not the answer, what might be? Democrats have but a few months to clarify their position, but wherever they come out there are a few guiding principles: 1. The plan must cover everyone. 2. The plan must provide a choice. 3. The plan must allow every person the right to stay with their trusted physician and current plan. 4. The plan must be available to the poorest Americans.

Has any such proposition been proposed? It is unclear, but it may start with Mayor Pete's call: "Medicare for all who want it." This might come with an alternate government plan built on the Affordable Care Act. In addition, the proposal must guarantee that every American should have the right to seek private coverage or purchase supplemental insur-

Having watched the latest debates and followed the responses, it appears to me that the overall winner was Donald Trump. Democrats, before it is too late, step back, take a deep breath and find a better answer to the health insurance issue.

China is Slowing and the U.S. is Growing

Few would argue against the position that when the S&P 500 hit a new all-time high in late July, it was a new high not to be trusted. Rumors of a trade deal and the prospect of a 50-basis point rate cut were somehow being thought of as being a "done deal". Both assumptions were at best rumors and guesses by many position takers on Wall Street. Such a fickle market that goes up on poorly grounded momentum was bound to give way after absorbing a double-dose of disappointment after the Fed cut rates by 25 basis points and China devalued the

Recent equity performance delivered another roller-coaster ride, but the S&P's net decline was only 1%, and just -4.5% from its all-time high on July 26. The big news was the ongoing protests in Hong Kong, which are casting a cloud over China and raising concerns about global growth. These protests have now become more violent, including petrol bombs by some rioters and tear gas by the riot police to disperse crowds.

Protestors congregated at the airport, knowing that the Chinese police would not use tear gas within the airport, but riot police stormed the airport recently to disperse the protestors. These protests are now hurting the Hong Kong economy, so it will be interesting to see how this fight over lost freedoms in Hong Kong will eventually be resolved. In the meantime, the Chinese military remains on the border and if they enter Hong Kong for the first time since just after World War II, the stock market will likely have an adverse reaction.

If you watch Bloomberg TV, CNBC, CNN, MSNBC (etc.), they are increasingly blaming the Trump Administration for the China trade talk standoffs. I look at things a bit differently. President Trump's negotiation style is to make everyone involved as uncomfortable as possible to try to get a better outcome. Whether the Chinese delegation will come to Washington D.C. in September for continued negotiations is now in question. If these formal trade negotiations get

financial markets could have an adverse reaction.

In a surprise move to lure China back to the trade table, the Trump Administration delayed the 10% tariffs on \$300 billion in imported goods until December; this lifted the market. This move also gives the Trump Administration room to negotiate from strength in September with the threat of another 10% tariffs on \$300 billion to be imposed in December. Clearly, the Trump Administration wants to try multiple avenues to negotiate a new trade deal with China before the election season peaks in mid-

The Chinese National Bureau of Statistics announced last week that its industrial output rose 4.8% in July compared to a year ago - a significant deceleration from the 6.3% increase reported in June. Retail sales in China also slowed to a 7.6% annual pace in July, down from a 9.8% pace in June and economists' expectations of an 8.5% annual growth in July, so this was a major disappointment. It appears the tariffs are working in cutting into the buying power of the Chinese economy.

In the meantime, the International Monetary Fund (IMF) apparently is not siding with the U.S. after it declared China a currency manipulator - which is a serious allegation. If the IMF had concluded that China is a currency manipulator, then U.S. businesses would be able to sue for damages, which would create a big, endless legal mess. Instead, the IMF apparently believes that the weakness in the Chinese yuan is due to its decelerating economic growth, exacerbated by the Hong Kong protests. I should add that since the head of the IMF,

Christine Lagarde, is due to become the President of the European Central Bank (ECB) in November, the last thing she wants is to pick a fight with China to

tarnish her IMF legacy. The big news from Europe last week was that mighty Germany's economy contracted at an annual rate of 0.4% last quarter. Declining exports were largely responsible for contracting GDP growth. The German 10-year bond is now yielding -0.684% and all maturities out to 30 years continue to have negative yields.

Europe is trapped in a negative-yielding economy with zero growth due in large part to a paralyzed and geriatric welfare-state whose "youth movement" is composed of immigrants who increasingly refuse to work.

The past two weeks show erratic behavior similar to last May - a market correction month like August, after which the market righted itself. My view is that the ground under the market has shifted and earnings growth tied to attractive P/E ratios will begin to matter more following the kind of shakeout investors have just endured. There will still be plenty of high-beta stocks that will trade higher, but only if they held their crucial technical support levels during the current washout.

Professional money is paying super close attention to those stocks that not only exceeded second-quarter sales and earnings estimates, but also provided solid upside guidance for the third quarter and for the full year. Plus, those stocks that have the luxury of dominating their space will also maintain a strong institutional fan base in some of the hottest secular themes, such as 5G technology, artificial intelligence (AI), digital advertising, space wars, mobile e-commerce, and advanced medicine. That may sound like a lot, but the playing field of superior stocks has actually gotten smaller.





• Act quickly. For health-related emergencies, time is of the essence, so go to the nearest emergency room or hospital or call 911 as quickly as possible and then notify your insurance plan as soon as you reasonably can.


