Glendora Police Shut Down Mansion House Party Violating Municipal Codes And Health Orders

GLENDORA - On August 22, 2020 the City of Glendora and the Glendora Police Department were alerted from concerned neighbors about a planned "Mansion House Party" at 1120 E Sierra Madre in Glendora. The event organizer going by the Instagram handle "@iamkingbell" was promoting a "100 Summers Mansion Party" which included music guests intended to perform, presale tickets and provided off-site bus transportation. The residence is a large exclusive home, which was listed on rental websites such as vacationrenter.com, VRBO and Airbnb as available for short term rentals. The police department has responded to many calls at the residence for loud parties, littering, parking and unsafe vehicle use.

On Saturday, August 22, City staff worked all day to contact the promoter and the homeowner explaining this type of activity was not allowed, and that it also violated the Los Angeles County Health Department Order for a nonessential gatherings. The party

promoter disregarded City staff and held the event knowingly violating the administrative city permit process and the health department order.

Enforcement of the Glendora Municipal Code and the Health Order occurred. The party promoter was issued two administrative citations for the Municipal Code violation (\$450), and issued a citation for hosting a gathering in conflict with the current health department order (\$1000). At just past mid-

night as the third administrative citation was preparing to be issued, the party host decided to end the function. Although the event ended, it took more than 90 minutes for all guests to leave and vacate the neighbor-

In addition to the administrative citations issued to the party host, (5) five vehicle code violations were issued to party goers found in the area, one

vehicle was impounded, one arrest was made for a misdemeanor bench warrant and 19 parking citations were issued. Additional police personnel were brought in to address the location once the promoter made it clear he had no inten-

tion to cancel the event. "The City of Glendora, City Council and the Police Department do not condone this type of gathering and willful disre-

spect for the law, Health Department order and the disruption to the neighborhood," stated Interim Police Chief Matt Egan. "Although we were limited by certain legal requirements at the time of this event, the City of Glendora will be pursuing administrative fines, fees and potential litigation against both the party host and the homeowner."

"We at the City apologize for the disruption of our resident's lives; however, administrative actions take time. Staff is continuing to take enforcement action and if new problems are encountered we will act swiftly," said Mayor Michael Allawos. "This flagrant disregard for the sanctity of this neighborhood, willful disobedience of the City permitting process and the Los Angeles County Health Department Order are unacceptable. The City is working closely with our partners to ensure issues like this one do not occur again as well as looking into untapped legal tools."

Azusa Freeway Crash Kills One and Injures Another

AZUSA - On Friday, August 21st a high-speed crash occurred around 2:15 a.m. just off the 210 freeway at the Azusa off ramp. A 24-year-old Rancho Cucamonga woman, who was the driver, died in the crash and her 33-year-old female passenger, who is also from Rancho Cucamonga, was injured.

They were in a 2010 Mercedes GLK 250 SUV headed eastbound on the 210-freeway approaching Azusa Ave. For an unknown reason, the vehicle left the freeway and slammed into a tree and caught fire. The passenger was able to get out of the mangled vehicle; however, the injured driver was trapped in the wreckage. She could not get out and burned to death.

The passenger had a number of injuries including a broken left arm. She was transported to the Pomona Valley Hospital Medical Center where she was admitted

for treatment.

It is unclear what caused the crash, but speed appears to be one factor. Also, a toxicology report from the driver will be needed to determine if alcohol or drugs were a possible factor as

The southbound Azusa onramp to the eastbound 210 freeway was closed for about 3 hours. It 1164.

was opened up around 5:30 a.m. People had to detour by going south on Azusa Avenue then make a U-turn and enter the freeway from the northbound lanes.

Azusa Offers Grants To Local Small Businesses

AZUSA - The City of Azusa and the Los Angeles County Development Authority (LACDA) opened the application for a Small Business Grant Program available to local businesses (with less than 500 employees) that have been economically impacted by the COVID-19 pandemic. The City is offering grants of up to \$10,000 to eligible businesses that create or retain jobs for low and moderate income

- Working capital to continue operations
- Payment of outstanding business expenses
- Adaptive practices needed to remain open (i.e. equipment and

supplies for physical distancing). The Los Angeles County Development Authority (LACDA) will serve as the administrator of the program on behalf of the City. Businesses can participate by submitting an intake form during the five (5) day application period from August 24, 2020 to August 28, 2020. A lottery will be completed and the selected businesses will be requested to complete an application. LACDA will work with the selected businesses to complete an application, execute an agreement and provide grant funds directly to the business owners. "We need to support our local small businesses as much as possible," said Azusa Mayor, Robert Gonzales. "The Pandemic has had detrimental effects on many of our favorite local establishments and the City is committed to providing resources."

As a participating city in the Los Angeles Urban County Community Development Block Grant (CDBG) Program, the City approximately received \$241,825 in one-time only CDBG Cares Act funds for the express purpose of responding to, addressing, and mitigating the impacts of the COVID-19 pandemic. The Azusa City Council designated these funds to be used for the Small Business Grant Program and an Emergency Utilities

Assistance Program, a program designed to provide utility assistance to income eligible households economically impacted during the COVID-19 pandemic. The program is scheduled to launch later this month.

Additionally, in response to COVID-19, the City implemented a Share Space Program allowing businesses (with guidance from the Department of Public Health) to extend their business operations into private sidewalks, walkways and parking lots. Further, on August 11, 2020, in partnership with Los Angeles County, it opened an indoor COVID-19 testing site available to anyone, regardless of insurance or ability to pay in the City's North Recreation Center (NRC) at Memorial Park, 340 N. Orange Place, Azusa.

Foot Care Tips for Those With Diabetes



For those with diabetes, a seemingly insignificant foot problem can produce dangerous consequences. Experts say that managing this risk is an important part of diabetes care.

"Living with diabetes increases the risk of developing a wide range of foot problems, often because of two complications of the disease: nerve damage and poor circulation," says Dr. Brett Sachs, DPM, FACFAS, a Denver foot and ankle surgeon and Fellow Member of the American College of Foot and Ankle Surgeons (ACFAS). "However, you can play a vital role in prevention."

To avoid serious foot problems that could result in losing a toe, foot or leg, follow these guidelines from ACFAS foot and ankle surgeons:

- Inspect feet daily. Diabetes may cause nerve damage, which takes away the feeling in your feet, so a daily visual inspection is important. Check for cuts, blisters, redness, swelling or nail problems. Use a magnifying hand mirror to look at the bottom of your feet. Call your foot and ankle surgeon if you notice any issues.
- · Bathe feet gently. Wash your feet daily with a soft washcloth or sponge using only lukewarm water. Dry by blotting carefully.
- Moisturize. Use a moistur-

- izer daily to keep dry skin from itching or cracking. But don't moisturize between the toes -that could encourage a fungal infection.
- Cut nails carefully. Cut nails straight across and file the edges. Don't cut too short, as this could lead to ingrown toe-
- Never treat corns or calluses yourself. Don't perform "bathroom surgery" or use medicated pads. Visit your doctor for appropriate treatment.
- Wear proper socks. Always wear clean, dry socks. You may want to consider those made specifically for patients living with diabetes, which have extra cushioning, no elastic tops, are higher than the ankle and are made from moisturewicking fibers.
- Shake out your shoes. Remember, your feet may not be able to feel a pebble or other foreign objects, so always inspect shoes before wearing them to help prevent blisters and sores that could lead to an infection or non-healing wound.
- Keep feet dry. Change your socks if they get wet. You may also consider using an antiperspirant on the soles of your feet.
- Never walk barefoot. It can be tempting to go barefoot in warmer weather. Never do so, not even at home. Always wear

- shoes or slippers to avoid getting scratched, cut or even burned from hot surfaces.
- Be active. Staying active is important. Just be extra careful, particularly if you play sports, to monitor your feet for related injuries.
- Treat your diabetes. Keep your blood sugar levels under control. Untreated diabetes can result in other conditions affecting the feet, including diabetic peripheral neuropathy and Charcot foot, a condition in which the bones of the foot are weakened enough to fracture.
- Don't smoke. Smoking re-
- stricts blood flow in your feet. • Get periodic foot exams. Your foot and ankle surgeon works with your other healthcare providers to prevent and treat complications from diabetes. See your foot and ankle surgeon regularly, or as soon as you notice any problems, to help prevent the foot

Gap Year or Goal Year? Delayed College **Enrollment Means Delayed Dreams**

As colleges and universities across the nation announce suspension of in-person classes for fall 2020, 40 percent of incoming freshmen at four-year institutions say it is likely or very likely they will not attend college this fall.

This decision amounts to a 'gap year" without any of the perks. A practice that has long been popular in Europe, a gap year is a time for students to take a break between high school and college for the purpose of travel, experience work volunteerism. The practice has grown in awareness and popularity in the U.S. in the past decade. For many students, a gap year has become a valuable time for personal growth and an opportunity to deepen professional awareness and explore career interests.

Covid-19 has changed all that. The pandemic has rendered travel nearly impossible, and job and volunteer opportunities are few and far between. At the same time, the increased danger of attending classes on a college campus has prompted many of the nation's most prestigious institutions, such as Notre Dame, University of North Carolina at Chapel Hill and Michigan State, to switch to primarily online instruction for incoming freshmen.

This has left many students and their parents questioning exorbitant tuition rates, when the same high quality of instruction, with fully transferable courses, is available online from a community college at a fraction of the

Recently, students at Rutgers



launched a petition calling for a tuition cut, and it has received more than 30,000 signatures. Princeton has offered its students a 10 percent discount on remote education. The majority of California's four-year colleges and universities are also limiting instruction to primarily online offerings, but at a cost much higher than the same courses at a California community college.

Rather than deferring the start of a college education that could change the course of your future and help you achieve your

dreams, why not give your goals a shot? Enroll at a local community college-and do it now-and make your gap year a goal year instead

How to Stop Bears from Trashing Your Home or Campsite



Summer is the time of year when hungry bears roam through backyards, rummage through trash bins, and even break into homes to get food. This is especially true in San Gabriel Valley foothill cities. Also, they may roam through campsites searching for food.

Not only can bears be a nuisance, they can also present a danger to pets, livestock, and humans. Did you know that bears can smell food from up to 20 miles away? They can easily tear a house door off its hinges if they smell food left out on a kitchen counter or table. Other wildlife such as mountain lions, deer, coyotes, and raccoons are also drawn to the smell of food and food waste.

Tips for Bear-Proofing Your Home and Campsite

To protect your home, follow these simple tips from the California Department of Fish and Wildlife:

- Wait to put trash out until
- the morning of collection day. · Keep your waste and recycling containers clean to re-
- duce odors that draw wildlife. · Don't leave trash, groceries, or pet food in your car.
- Clean outdoor grills after each use and store them in a garage or shed when not in use.


- Only provide bird feeders from November through March, and try to make them inaccessible to bears.
- Don't leave any scented items outside, even non-food items such as suntan lotion, insect repellent, or candles.
- Install motion-detector alarms, lighting, or sprinklers.
- If you have citrus trees, pick citrus off the trees as soon as it is ripe. Promptly collect fruit that falls and use or dispose of it properly.
- Securely block crawl spaces and other openings around buildings where animals could get in or even hibernate.

For campsites, Fish and

Wildlife has these tips:

- Never keep food or toiletries in your tent. Use bear lockers if available, or the trunk of your car. Check with camp or park personnel first.
- Haul garbage out of camp regularly.
- Clean dishes and store food and garbage immediately after meals.
- Clean your grill after each use.



the Foundation awarded a grant of \$35,000 to AUSD to ensure that all students in the district were able access their classes online.

AUSD Superintendent Arturo Ortega responded, "Due to the COVID-19 pandemic, the Azusa Unified School District will begin the year in a distance learning format. This will require all students to be connected to the internet in order to access instruction. This generous donation from the Canyon City Foundation will provide internet connection for our AUSD families who lack access. The district will purchase internet connection from service providers, as well as hot spots for families who are unable to install internet in their homes."

Neighborhood Homework House, a partner with the school district in supporting students and their families, received a grant of \$55,000 from the Foundation. The majority of the funds will be used to continue their direct support work. A smaller portion will be used for a challenge grant to raise additional funds to prepare for resuming face-toface instruction once that is pos-

Neighborhood Homework House has met the Covid challenge by offering online support to students and their families during the pandemic. At the same time, it looks forward to offering support in their traditional model in the future. Foundation Board President Miles Rosedale declared, "The Board of Directors holds the Neighborhood Homework House up as a model non-profit Azusa agency for its ability to offer services in the City of Azusa for more than two decades and, in doing so, to leverage the Foundations' support to garner additional funding from many private donors and larger foundations."

The Foundation Board also awarded \$90,000 to the City of

Azusa to support two key areas that will promote the overall health of the community. Part of the funds will enable staff to continue to offer important direct services to residents through programs such as English as a Second Language, Neighborhood Connections and Citizenship

The remainder of the funding will go to support the launch of the All in for Azusa Initiative for a second year. This initiative aims to create a broader safety net of programs and services for the residents. The City of Azusa has been identified as a "prototype" of Healthy San Gabriel Valley, a program that has worked for a decade to improve health and decrease violence in the region.

Healthy San Gabriel Valley has earned the distinction of being one of 13 sites across the State of California to transform the health of our communities, with funding from some of the largest private foundations in the state. The City, supported by the Foundation, will now be able to facilitate All in for Azusa, using evidence-based models that ensure "no wrong door" for social and health services for residents. The Director of Community Resources Dr. Miki Carpenter stated, "This work is crucial, as we must do much more work upstream to prevent poor health in our most vulnerable residents and to improve the quality of life of all Azusans."

Canyon City Foundation was established in 2005 as an outcome of the sale of Monrovia Nursery property. The Foundation awarded its first grants in 2006 and continues to annually award grants to qualified organizations. More information about the Foundation and its work can found

Los Angeles County COVID-19 Rent Relief

Arcadia Residents Are Eligible to Apply

ARCADIA - In an effort to assist renters with limited means affected by the COVID-19 crisis, the Los Angeles County Board of Supervisors has provided \$100 million in CARES Act funds to create a COVID-19 Rent Relief program, operated by the Los Angeles County Development Authority (LACDA). Residents of all cities and unincorporated areas located in Los Angeles County, apart from the City of Los Angeles which operates its own program, are eligible to apply for the funding. The City of Arcadia is partnering with the LACDA to promote and administer this program. The program is accepting applications through August 31, 2020. Approved applicants are eligible to receive a one-time grant of up to \$7,500 -\$10,000 for residential rent.

The emergency rental assistance program is intended to meet the needs of low-income renters who have struggled to pay their rent and/or who are behind on paying rent due to the economic impacts caused by the pandemic. The program's goal is to assist between 8,000 to over 9,000 households. Eligible renters must qualify based on income and have struggled to pay rent, due to the COVID-19 pandemic. Their landlord must provide a W-9 and sign a participation agreement in order to have the rent paid on behalf of the tenant. This program will exclude units located in the City of Los Angeles.

A residential tenant must complete an online application www.211la.org/lacounty/rentrelief or by calling 2-1-1, where a representative can assist in completing an online application on the tenant's behalf. Public Health Sees Increase in MIS-C Cases in L.A. County Children

LOS ANGELES COUNTY -The Los Angeles County Department of Public Health (Public Health) is reporting nine additional cases of multisystem inflammatory syndrome in children (MIS-C). This brings the total cases of MIS-C in L.A. County to 25 children.

Twenty-eight percent of these cases were between the ages of 0 and 5 years old, 44% were between the ages of 6 and 12 years old, and 28% were between the ages of 13 and 20 years old. The majority of cases (68%) were Latino/Latinx.

No children with MIS-C in L.A. County have died.

MIS-C is a condition that af-

fects children under 21 years old all ages. No matter how young across the country who may have been exposed to COVID-19 or had COVID-19. Different body parts can become inflamed, including the heart, lungs, kidneys, brain, skin, eyes, or gastrointestinal organs and there can be lifelong health impacts.

"Our hearts go out to the many families who are experiencing the sadness of losing a love one to this pandemic," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "Today we report another death that occurred in a young adult under the age of 29. This is a reminder that the risk for having negative outcomes due to COVID-19 is for

you are, this virus can be deadly. We continue to see more young people drive new infections and have more severe adverse health outcomes to COVID-19 including children with multisystem inflammatory syndrome. We must continue to work together to lower transmission among people of all ages, so please continue to wear a face covering, stay home when sick, wash hands frequently, and do not gather with people you don't live with."

Public Health advises physicians to consider for MIS-C in patient children under 21 years old and to notify the department immediately of any cases.

LACoFD Deploys Resources To Assist With Statewide Wildfire Emergency

In response to the widespread and unprecedented wildfire activity in Central and Northern California, and the state of emergency as declared by Governor Gavin Newsom, the Los Angeles County Fire Department (LACoFD) has deployed resources to assist communities in and around Santa Cruz as part of the California Fire Assistance Agree-

As of August 22, 2020, the LACoFD has sent five engine strike teams that have been assigned to the Scotts Valley area to help battle the CZU August Lightning Complex Fire. Each engine strike team consists of five engines and one battalion chief; in total, we have 23 engines and 101 personnel deployed to assist with firefighting operations. Many Southern California fire agencies are providing assistance and aiding in the battle.

This week, Northern and Central California experienced unusual weather, including lightning strikes, that have

sparked hundreds of deadly and destructive wildfires. Please be assured this deployment to assist with the CZU August Lightning Complex Fire will not impact the delivery of emergency services to our Los Angeles County residents and commu-

The fire got dangerously close to homes and forced evacuations of the residents. The fire was beat back with the assistance of a water dropping helicopters and ground firefighters.

As of Thursday evening, some residents were allowed back in to the area, however, there were some areas that needed to be restricted because of firefighting equipment and apparatus parked in the street and to also maintain an open road in case of a flare up. The fire worked its way up

towards Hillside Dr., and this is where the homes were threatened. The roads were close off to through traffic from Aroma and residents had to access the area from Grand Avenue or Citrus Avenue to the

Los Angeles County Fire Crews aided the West Covina

Fire Department fighting the fires. Although less than 5 acres burned, it was stubborn because of the thick foliage and terrain of the area.

As of Saturday, most responders had left the area with only a few watching for possible flair ups. There were no homes lost or damaged but there was one injury to a firefighter. This was reported as a minor leg injury but the firefighter was required to go to the hospital for treatment.

Investigators are looking for the ignition point of the fire and the cause of the fire was not immediately available.

"TIME JOCKEY" - Fighting Joe Hooker

Sonoma Connection... General Joseph Hooker was a Union general during the Civil War who fought in a number of key battles in the war between the states. A brash, innovative tactician on the field of battle, Hooker received his share of promotions while in the Army but was also bypassed on other promotions after he suffered defeats to General Robert E. Lee and other Confederate generals. When things didn't go his way, Hooker would resign his commission only to return a few months later and return after he was recruited back into service. His nickname of "Fighting Joe" was applied through a clerical error and even though Hooker did not initially accept it, his popularity grew with the mistaken nickname and he decided to

just keep it.

With his reputation now established as a "fighter", Hooker was assigned to guard Washington D.C. He was known as a hard-drinking ladies' man, and a division of women usually accompanied Hooker and his own division of soldiers. In addition, his military divisions were known to have rather lively parties with lively ladies and even livelier gambling opportunities.

While stationed in Washington D.C., Hooker drew a large number of prostitutes which gathered close to where Hooker's men were available. The prostitutes became known as "Hooker's Division" and the name "hooker" was applied to working ladies of the evening. Whether or not this was the first use of the term "hooker" to describe a prostitute is un-

known but it seems more than a coincidence that General Joseph Hooker and "hookers" had a similar connection.

When the Civil War ended, General Hooker relocated to Sonoma, California, and bought a mail-order cabin and built it on land which was once part of General Mariano Vallejo's land grant. Hooker's wild parties followed him to Sonoma and with the parties came a loyal following of "Hooker's Division". Fighting Joe Hooker left his legacy on the battlefield but his own name made for a much livelier existence on the east and west coast...

YES! On Prop 20 to Fix California Crime

There is no ballot measure with more history creating more angst than Prop. 20, formerly titled Reducing Crime and Keeping California Safe Act of 2018, now titled Criminal Sentencing, Parole, and DNS Collection. Known as the Prop 47 and 57 "fix-it" measure, it has ardent supporters, like Democrat Jim Cooper (AD-9, Elk Grove) and those with a passionate penchant to see it defeated, like former Gov. Jerry Brown.

Assistant District Attorneys Association (ADDA) President, Michelle Hanisee, and her organization, have written reams of arguments against Prop 57 and warned about the disastrous results created by AB 109, Prop 47 and Prop 57 only to be ignored. We see the results on our streets today. The 2018 measure failed to make the ballot because half a dozen county registrars didn't verify signatures - they ran out of

To understand the importance of what Prop 20 will remedy, we need to know the history of revisions to our criminal justice system and who the major players have been.

2011, U.S. Supreme Court ordered California to reduce prison overcrowding. No new prisons or contracting out for additional capacity occurred. Instead AB 109 was passed shifting the prison population - non-serious, non-violent, and non-sexual violations - to county jails. Problem: some inmates had previous felony convictions and those felonies weren't considered before releasing them. Convictions included domestic violence, rape, elder abuse, lewd & lascivious acts with a minor and terrorist

County jails are for shortterm incarceration with a constant turnover to provide new space for new offenders. As jails reached overflow capacity, more criminals were released to our streets. 45,000 received early release. Violations of parole resulted in "flash incarcerations" or 10 days max back in jail. L.A. County jail still holds the title of largest mental health facility in

2014, Prop 47 was written -Safe Neighborhoods and Schools Act - reducing felonies to mis-Javier Becerra is responsible for providing the title to proposi-

• Illegal drug possession of heroin, cocaine and methamphet-

meanors are:

• Shoplifting, forgery, fraud or theft if the value of the property is under \$950 and with that comes a citation and no jail time.

 Persons already convicted and jailed of those crimes were allowed to petition for early release. Another 13,000 criminals were on our streets.

ADDA Michelle Hanisee on Prop 47: "In a devastating investigative series titled "Meth Mayhem," Fox 11 examined the drug and homeless crisis on L.A. streets, as well as Prop 47's contribution to that crisis." During an interview, George Gascón, one of the authors of Prop 47, and now running for L.A. County District Attorney against Jackie Lacey, said, "We can't have [a] person as D.A. who has no clue how to treat drug addiction." In that article, Hanisee commented that during Gascon's tenure as San Francisco D.A. that city had 50% more drug addicts than high school students.

In 2016, Prop 57 appeared and Attorney General Becerra titled it Public Safety and Rehabilitation Act. 30,000 non-violent offenders became eligible for parole and were back on our streets. Non-violent offenses, according to Prop 57, are hate crimes, arson on forest land, assault with a deadly weapon on a peace officer, human trafficking of a minor, rape by intoxication, drive-by shooting, corporal injury on a demeanors. Attorney General child and active in a street gang to name a few. Gov. Gavin News-

om supported passage of Prop 57

along with Gov. Jerry Brown's Ballot Measure Committee -\$4.138 million and the California Democratic Party - \$1.174 million with a total of \$18 million to see Prop 57 passed.

Prop 20 proposes to fix three problems:

1. Reform the parole system so violent felons are not released early from prison; strengthen oversight of post release community supervision; and, tighten penalties for violations of parole.

The parolee will be released to the county of his last residence unless it is in the public's interest to locate him/her in another county. Considerations will include work opportunities, availability of intervention and treatment and friends or family support units.

2. Reform Prop 47 theft laws to restore accountability for serial thieves and organized theft rings and change them from misdemeanors to "wobblers" meaning they could be charged as felonies. Included are thefts of a firearm, from an elder, and a vehicle, and unlawful use, sale or transfer of an account - debit or credit card.

3. Expand DNA collection from persons convicted of drug, theft and domestic violence related crimes to solve violent crimes and exonerate the innocent. When Prop 47 was passed it changed felonies to misdemeanors not requiring DNA samples. Prop 20 would restore and require DNA samples from shoplifting, grand theft, receiving stolen items, forging a check, bond or bill, domestic violence, prostitution with a minor, and causing bodily harm to an elder or dependent adult.

Guest Commentary: RISE to the Occasion, Glendora!

Public education is foundational to our modern American way of life. It is a powerful equalizer and has the capability to help each of our children realize their full potential. Here in Glendora, it has always been one of the most important parts of what makes us a community of hometown values.

In 2020, we said goodbye to longtime Superintendent Dr. Rob Voors, who sheparded Glendora Unified School District (GUSD) for many years. Our School Board hired Dr. Penelope DeLeon to replace him. DeLeon comes from four years as Superintendent of the Oxnard Union High School District in Ventura County. Prior to that, she was Chief of Secondary Schools for the Fontana Unified School District. DeLeon started out as a teacher before becoming a High School Principal and then moved into district administration. She holds a Doctorate in Organizational Studies from the University of La Verne. Welcome, Dr. DeLeon!

Parents received an email from GUSD last week informing them that Dr. DeLeon would lead a virtual Zoom session on Wednesday September 21, 2020 at 6 PM on something called the RISE Coalition. RISE stands for Race, Inclusion, Social Justice, Equity. Apparently, this program is being introduced to our District at least in part because of the protests that developed after the horrible killing of a black Minneapolis resident, George Floyd, by a white police officer. Protests developed all over the country and resulted in a reexamination of race relations, including a large dose of discussion of racism in America's past. Leftists aligned with Sen. Bernie Sanders and many others in large cities across America, including BLM and Antifa, made the argument and continue to make it today that rampant police racism and brutality, along with "institutional racism", runs throughout American society right now and wholesale changes including defunding the police, tearing down historical statues and "canceling" American heroes and history is necessary to fundamentally transform America into an equitable soci-

One slide is entitled "A Framework For Change". It includes "Removing Barriers to Success" "Leveling the Playing Field" and "Teaching Cultural Understanding and Modeling Mutual Respect" among others. Are these problems in Glendora? If not, why are we "fixing" them?

Another one is entitled "Teaching Cultural Proficiency" and includes "Ethnic Studies, Gender Studies at the High School Level". Readers are invited to check out the websites of any state college and examine the curriculum offered right now to college students in various kinds of ethnic and gender studies. Do you want this at Glendora High School and if so, what do you want it to replace? Real History? Math/ Science? Sports? Foreign Language? The fact is that curriculum changes mandated from the state over the past decade have ensured that plenty of material on civil rights and the importance of ethnic groups is already part of our curriculum right now. So what's the need we'd be filling?

A third highlight is the one entitled "Leveling The Playing Field", and asks how to ensure equitable distribution of human, fiscal and time resources. What does "equitable" mean? You might think it means equal - it doesn't. It means giving different groups of people different amounts of these resources according to a perceived need. Did vou know Glendora is already part of a new "equitable" school funding formula established by former Governor Jerry Brown throughout the state? Extra money is allocated to districts like the Los Angeles Unified School District because of greater perceived need for dollars and those "extra" dollars are taken away from...you guessed it! Glendora and other suburban school districts. Do you want to do that sort of "equity" inside our school district as well where some students get more resources than others?

Glendora schools treat everyone fairly now, and focus on individual success for every student without pitting groups against each other. Affirmatively Furthering Fair Housing Rule And How It Will Change Your City

Most of us have heard of the 1968 Fair Housing Act (FHA). This act was passed by during the administration of Lyndon Johnson and was intended to further desegregation by enabling poorer peoples in the inner cities to migrate out of the highly populated areas to move to the suburbs where there is less crime and more job oppor-

tunities. It is highly unlikely any of you have ever heard of the Affirmatively Furthering Fair Housing Rule that the previous administration appended to the FHA. In July 2015 the Housing and Urban Development administration (HUD) promulgated the Affirmatively Furthering Fair Housing Rule (AFFH). This rule requires that cities and towns, which receive federal money for any housing or urban development related purpose must perform an evaluation to examine whether there are any barriers to fair housing, housing patterns or practices within their city. They must identify bias based on any protected class under the Fair Housing Act. From this evaluation the city must create a plan for rectifying fair housing barriers. The stated intention is to promote equal housing opportunities and level the playing

field so that all neighborhoods provide the quality services and amenities that are important for people to live successful lives.

What was not disclosed in

this AFHH Rule is that any city that receives HUD monies must fill out a detailed assessment of every neighborhood within their city assessing the diversity of the neighborhood and provide an affirmative plan on how the city will mitigate any "perceived" segregation within any area of the city. If the city fails to complete the plan in a manner that is acceptable to the HUD bureaucrats the city would be liable to a major law suit. To mitigate those areas of the city where there is not a balance of affordable housing along with the already established demographics the city would be forced to purchase land and build at taxpayer expense affordable HUD housing. Then the city would be required to, again at taxpayer expense, advertise the HUD housing in the inner cities to get low income (and probably under educated and unskilled people) to move out of the inner cities. Finally, the suburbs would be required to furnish local taxpayer funds to the inner cities to help reduce poverty in the urban areas.

To even make things worse

for the suburbs Senator Cory Booker wanted to deny any city federal highway money if the city decided not to take HUD moneys and did not submit to the AFFH Rules.

This entire AFFH Rule was a power grab by the administrators in HUD to take over zoning laws of the cities and impose Washington DC rule.

On the bright side under the current administration the AFFH Rule has been terminated. Under the leader ship of HUD Secretary DR. Ben Carson this unwieldy and costly rule was scrapped. Carson said that implementation of the Obama legislation had proven "to be complicated, costly, and ineffective" saying: "After reviewing thousands of comments on the proposed changes to the Affirmatively Furthering Fair Housing (AFFH) regulation, we found it to be unworkable and ultimately a waste of time for localities to comply with, too often resulting in funds being steered away from communities that need them most... Washington has no business dictating what is best to meet your local community's unique needs."

This administration is replacing the AFFH rule with the Preserving Community and Neighborhood Choice rule, which Carson said will offer state and local government the benefit of the doubt to maintain fair housing practices. "This brand-new rule...defines fair housing broadly to mean housing that, among other attributes, is affordable, safe, decent, free of unlawful discrimination, and accessible under civil rights laws. It then defines 'affirmatively furthering fair housing' to mean any action rationally related to promoting any of the above attributes of fair housing," the HUD secretary's statement read

One may well ask "if this rule has been recinded why should anyone care". A good question indeed and here is the answer: If the Democrat Party is returned to total power this draconian rule will be resurrected from the dead where it belonged. The Federal Government will take over the zoning laws of all cities and municipalities across this nation. Your neighborhood will be destroyed and replaced with a new version of the inner city that these people claim to want to make more just and equal.

Is this great nation to become just another victim socialist ideals or will it remain on the path of freedom and opportunity for all? We the people must make that momentous decision.

Oil Filter Warning

most important parts of the engine. Its job is to filter out any contaminates created by the normal wear and heat of the engine. When your car has the oil changed, most likely the oil filter is also changed, at least I hope

Years ago, we all knew that the oil and filter was changed at 3,000 miles, it was just the way it was. Enter the new age of cars, oils and filters; especially synthetic oils which last much longer as stated in some of my previous articles. Many oil changes can last 5,000 to 10,000 miles depending on the type of car, type of oil and how many quarts of oil are in the oil pan.

The oil filter is one of the ommended the 3,000-mile service, any oil filter would easily protect the engine for that mileage, but not many oil filters would protect your car for more than 5,000 miles. If you are driving longer than 5,000 miles between oil changes and using a low cost oil change shop, you may be

Let me explain. Oil filters all look the same on the outside, but are very different on the inside. The difference lies in the amount of filtering material used and type of drain back valve used inside each filter. Less expensive filters, as you would suspect, have less filtering material and a less reliable drain back valve.

damaging the engine and not even know it.



but the results can be catastrophic. When you drive longer than 5,000 miles on one of the low cost filters, the filter starts to lose the ability to keep the contaminates contained and they slip into the engine bearings, causing premature wear. The eventual outcome is engine failure. It does not pay to have an inexpensive oil change and an inexpensive oil filter put on your newer model car.

Currently, there is not a standard or law that says what part or quality of part, needs to be put on your car. If you have an engine failure that should be covered by a warranty, and you have been using cheap oil/filter, this is not only scary for you, the consumer, but it could get downright ugly as the manufacturer may deny the claim. Ultimately, the consumer should be aware of what is going on with the car and use a service center you trust.

A cheap oil change may save you money short term, but will not save you money in the long

El Monte Union Measure HS Facilities **Bond Fuels New Construction at Schools**

EL MONTE – Construction of a new multipurpose building and gymnasium at Fernando R. Ledesma High School is moving forward as El Monte Union plans a host of new Measure HSfunded projects, including a new Community Education Center and synthetic track and fields.

Approved by voters in November 2018, Measure HS authorized \$190 million in facilities bonds that are funding enhancements of learning facilities at each high school. The first series of bonds was sold in June 2019 for \$56.7 million. It is anticipated that the next series will be sold in 2021 or 2022.

Among the first large-scale projects funded by the bond measure is the multipurpose building and gymnasium, which aims to promote healthy living, collaboration and sustainability. It will include a full basketball court and bleachers, classrooms, weight room, restrooms, kitchenette and offices. The anticipated completion date is summer 2021.

El Monte Union will unveil a new Community Education Center at the District Office this fall.

Rosemead High School's athletic stadium will receive a new synthetic track and field and concession buildings, with construction to begin in January 2021 and

be completed in July 2021. Meanwhile, South El Monte's quad will be revamped over fall.

"We have been moving very swiftly to push projects forward while our students and staff are not on campus, including our HVAC installations that took place throughout the school dismissal period," Superintendent Dr. Edward Zuniga said. "We are very excited to get these projects off the ground and ensure that we continue to provide our students with high-quality learning and play environments that are safe and welcoming."





GLENDORA - Thank You For Your Commitment & Service Baskets were put together by the East San Gabriel Valley Republican Women Federated, with the support from the Covina Republican Center and the 48th Assembly District Republican Central Committee and were presented to the Glendora Police Department Officers and Staff to let them know our groups appreciate them and support fully their efforts each and every day they come to

Representatives from each organization, along with former Mayor Judy Nelson who is a Republican Federated member, went to the Glendora Police Department on Wednesday to give them the baskets with snacks and nibbles to make sure they know we think very highly of them in our communities and are on their side in these chaotic days.

Glendora Police Department will tell you their "... primary mission is to enhance the safety and security of the community by providing professional, frontline law enforcement services..." and those services include Child Safety Seat Inspections, a Volunteer Auxiliary, Glendora Safe Schools Program and the Explorer Program. The Department follow Glendora P.D. on social media to be aware of the latest

events in town.

Glendora Citizens Academy is an 8-week, one night a week, outreach program to introduce the average citizen to the duties and activities of the police officers and provide an understanding of the Criminal Justice System.

And that system allows for orderly protests as a way of speaking to government agencies and its leadership. Glendora had protestors, just as other cities did, protesting the death of George Floyd and supporting Black Lives Matter. Glendora Police took to the street in downtown Glendora to monitor the protest to ensure it stayed orderly. With back up from La Verne Police Department, it was a peaceful display with no rioting or damage done.

One of the frustrations of all law enforcement officers are some of the current policies including some of those brought on by Prop 47 and, additionally, by COVID 19 that restrict jail time or provide no incarceration time at all. Glendora had the experience of arresting one person three times in one day and pulled in help from other agencies.

same man. They confiscated the stolen property and cited and released the perpetrator again. Later that night, a car was reported stolen and was tracked down in La Puente. L.A. County Sheriff's Department responded as well as California Highway Patrol and eventually arrested that same man in Pasadena.

Prop 47, passed by the voters in 2014 said property stolen under \$950 gets a citation, no jail time. More recently, the Judicial Council, due to the COVID 19 situation, set bail for most misdemeanors and low-level felonies at zero. Both of those mandates tied the hands of Glendora Police Department in this situation. All law enforcement agencies are faced with the same frustration, not to mention the citizens who become the victims of this policy.

On Glendora PD Facebook: August 22, the Police were alerted about a planned "Mansion House Party" in Glendora. The organizer, "@iamkingbell" was promoting the event with music, presale tickets and off-site bus transportation to the house listed on vacation rental sites. More on that later but just another wrinkle law enforcement is now faced with these days.


