SACRAMENTO – Governor Gavin Newsom administered the oath of office to California Highway Patrol (CHP) Commissioner Amanda Ray, a historic move making her the first woman in its 91-year history to lead the largest state law enforcement agency in the nation.

Newsom appointed Ray as the 16th Commissioner on October 20, 2020, following the retirement announcement of Commissioner Warren Stanley after 38 years of service with the CHP.

"I am thankful to Governor Newsom for trusting me to lead this exceptional organization and honored to follow in the footsteps of many innovative leaders who have come before me, including my friend, Warren Stanley," Ray said. "I would not be where I am today without the foresight of those in 1974 who decided to give women the opportunity to become CHP officers, paving the way for many women to assume leadership roles in the Department. I look forward to further guiding the Department and its 11,000 women and men in engaging with the communities we serve to ensure California remains a safe place to live, work, and visit."

Ray began her career with the CHP in 1990, rising through the ranks to her appointment as Deputy Commissioner in February 2020. She has served as incident commander during several high-profile events, including the Department's response to COVID-19, civil unrest, and wildfires.

Ray has appointed two members to her Executive Management team. They are Jim Epperson as Deputy Commissioner, her second-in-command responsible for the day-to-day operations of the Department, and Ryan Okashima as Assistant Commissioner, Staff, who will oversee the administrative functions of the Department, including a \$2.8 billion budget, departmental training, information technology, and personnel administration. Rich Stewart was previously promoted in August 2020 to the position of Assistant Commissioner, Field, responsible for all patrol and air operations throughout the state as well as protective services.

Los Angeles County To Launch Grant Program To Help Restaurants Impacted By Covid-19 Restrictions

Eligible Businesses Can Receive \$30,000 in Working Capital Assistance

LOS ANGELES COUNTY -In an effort to assist restaurants affected by the COVID-19 restrictions, Los Angeles County will launch the Keep LA County Dining Grant Program on Thursday, December 3, 2020, at 12:00

a.m. The Keep LA County Dining Grant will provide \$30,000 to use this Program.

"Earlier this year, restaurants made incredible sacrifices to align with public safety protocols in order to open for in person dining and help pay their bills," said Supervisor Kathryn Barger, Chair of the Los Angeles County Board of Supervisors. "These restaurants, the vast majority of which employ fewer than 25 people, truly represent the small business community that drives the County's economic engine. The recent health officer orders to close in person dining was a devastating blow and as a result, the Board identified the need to immediately deploy grant funding to support these impacted small businesses." "Restaurants are integral to the economic, social, and cultural fabric of our County," said Los Angeles County Supervisor Chair Pro Tem Hilda L. Solis. "They contribute to the historical identity of our communities and are also responsible for employing a workforce that is dependent on jobs with low barriers to entry for their livelihood. I am keenly aware that many are not in agreement with the recent temporary suspension of outdoor dining, but it is necessary to protect our collective well-being.

Nonetheless, it is critical that we continue to assist this sector by providing funding to impacted restaurants so that we can help keep them afloat while we weather this pandemic together. Together is the only way that we can beat this virus, not alone and not divided."

"This pandemic and the recent closure of outdoor dining has been devastating to our restaurants and restaurant workers," said Los Angeles County Supervisor Janice Hahn. "These grants are meant to help as many restaurants as possible make ends meet and make it through this crisis. We know it won't be enough. We need another federal stimulus package to get a lifeline to all of our businesses and workers that are struggling." The application period will begin Thursday, December 3, 2020, at 12:00 a.m., and be available through Sunday, December 6, 2020, at 11:59 p.m., or until 2,500 applications are received, whichever comes first. 

The new ruling, of NO OUTDOOR dining was the last straw! The restaurant just couldn't keep running at a loss any more. "It's devastating"


said Roberto Campos. The overhead was too high, with paying the rent and twenty employees, it was just impossible!

High Numbers of Daily Cases and Hospitalizations is Serious **Cause for Concern**

New Order Aims to Reduce Risk of Transmission


LOSANGELES COUNTY - With COVID-19 cases and hospitalizations surging, L.A. County announced additional safety modifications that became effective on Monday, November 30, 2020 and remain in effect for three weeks through December 20, 2020.

The new temporary order aims to reduce the risk of transmission several ways, including by:

· Asking individuals to remain in their homes and with their immediate households as much as possible;

• Reducing mingling with others not in your household;

• Requiring everyone to wear a face covering whenever they are engaging in activities outside their homes where they are, or can be, in contact with others not in their house-

• Reducing capacity at sites where non-household members mingle to avoid crowding.

Right now, the most important action we can all take to stop the surge is to stay home as much as possible. All public and private gatherings and events with individuals not from the same household are prohibited, except for faithbased services and protests. Residents are still permitted to travel to and from essential businesses, work or provide services to a healthcare operation or essential business; residents may also engage in essential activities, or participate in permitted individual or household outdoor and indoor activities while practicing required distancing, infection control and masking.

Restaurants, bars, breweries and wineries remain closed for

in-person dining and drinking, as there is high risk of transmission of COVID-19 when people are eating, drinking and talking together without a face covering, as happens when people are dining onsite at restaurants. They are permitted to remain open for pick-up, delivery, and take-out and breweries and wineries may remain open for retail sales at 20% occupancy.

Governor Newsom Announces Immediate Assistance for Businesses Impacted by **COVID-19 Including Temporary Tax Relief and \$500 Million in Grants**

SACRAMENTO-As the federal government fails to provide additional financial stimulus support to main street businesses, Governor Gavin Newsom today announced that California will provide temporary tax relief for eligible businesses impacted by COVID-19 restrictions. The temporary tax relief entails an automatic three-month income tax extension for taxpayers filing less than \$1 million in sales tax, extends the availability of existing interest and penalty-free payment agreements to companies with up to \$5 million in taxable sales and provides expanded interest free payment options for larger businesses particularly affected by significant restrictions on operations based on COVID-19 transmissions. The total tax relief, if fully utilized, is estimated to have billions in impact. These efforts are informed by recommendations made by the Governor's Task Force on Business and Jobs Recovery.

"California's small businesses embody the best of the California Dream and we can't let this pandemic take that away," said Governor Newsom. "We have to lead with health to reopen our economy safely and sustainably while doing all we can to keep our small businesses afloat. With this financial assistance and tax relief, California is stepping up where the federal government isn't. By providing potentially billions in immediate relief and support, our small businesses can weather the next month as we continue partnering with the Legislature to secure additional funding and investments in small businesses in the new year."

Small businesses are drivers of economic growth – creating two-thirds of new jobs and employing nearly half of all private sector employees. California is home to 4.1 million small businesses, representing 99.8 percent of all businesses in the state and employing 7.2 million workers in California, or 48.5 percent of the state's total workforce.

The COVID-19 pandemic has presented a significant challenge to small businesses, employers and employees. An August Small Business Majority survey data found that 44% of small businesses are at risk of shutting down. Data released through the Census Current Population Survey found that minority-owned businesses are disproportionately impacted: the number of active businesses owned by African-Americans dropped by 41%, Latinx by 32%, Asians by 25%, and immigrants by 36%.

The announcement builds on the state's ongoing business support throughout the pandemic, including the Main Street Hiring Tax Credit, which authorizes \$100 million in hiring tax credit for qualified small businesses. The credit is equal to \$1,000 per qualified employee, up to \$100,000 for each small business employer. The application opened December 1.

Building on the state's ongoing support throughout the pandemic, the Governor announced the following immediate support and relief:

Tax Relief for Businesses Impacted by COVID-19

In April 2020, the Governor, through Executive Order, allowed taxpayers to apply for penalty and interest relief for 90 days for any taxpayer reporting less than \$1 million in sales on their tax return. Through November 22nd, some 9,287 plans with almost \$149 million in tax relief have taken advantage of this program.

The Governor will direct the California Department of Tax and Fee Administration to do the following:

· Provide an automatic threemonth extension for taxpayers filing less than \$1 million in sales tax on the return and extend the availability existing interest and penalty free payment agreements to companies (with up to \$5 million in taxable sales)

• Broaden opportunities for more businesses to enter into

interest-free payment arrangements.

• Expand interest-free payment options for larger businesses particularly affected by significant restrictions on operations based on COVID-19 transmissions.

\$500 Million for New **COVID Relief Grant for Small Business**

The Governor announced the creation of a \$500 million COVID Relief Grant administered by the California Office of the Small Business Advocate (CalOSBA) at the Governor's Office of Business and Economic Development for small businesses that have been impacted by COVID and the health and safety restrictions. Funds would be awarded to selected intermediaries with established networks of Community Development Financial Institutions to distribute relief through grants of up to \$25,000 to underserved micro and small businesses throughout the state by early 2021. Non-profits would also be eligible for these grants. CalOSBA is establishing the program and will make it available to small businesses as soon as possible.

Increase Funding for the California Rebuilding Fund by \$12.5 million.

Last week, the Governor announced the opening of the California Rebuilding Fund which makes available \$25 million to help impacted small businesses rebuild from the economic crisis and keep local economies strong. This program is built to be a resource in the market for the next year as businesses pivot and recover.

An increase of \$12.5 million would allow the Fund to be fully capitalized. The additional funding will help the 3rd party administrator of the fund raise \$125 million to make more low-interest loans to small businesses with less access to loans from traditional banking institutions.

Spread Holiday Cheer: Drive Sober This Season

LOS ANGELES COUNTY-The holidays will feel a bit different this year, but one thing that has not changed is choosing a sober way to go.

This holiday season, the Los Angeles County Sheriff's Department encourages the community to make sure every holiday celebration ends with a sober driver.

Starting Nov. 30 and through Dec. 15, the Los Angeles County Sheriff's Department will have additional officers on patrol looking for drivers suspected of driving under the influence of alcohol and/or drugs.

In addition, officers will be actively looking for other unsafe driving practices – speeding, not wearing a seat belt, driving distracted, not yielding to bicyclists or pedestrians - to make sure everyone has a safe holiday.

"2020 has been a tough year so let's try and end it on a good note by being safe on the road during the holidays," said Sergeant Robert Hill said. "Taking simple safety measures helps make sure we can all enjoy the holidays."

The Los Angeles County Sheriff's Department reminds drivers that driving high does not fly. Marijuana, prescription drugs, and over-the-counter medications may impair, especially in combination with alcohol and other drugs.

"There's no joy in a DUI," Sergeant Hill said. "Sober is the way to go."

More Erratic Chaotic Wildly Speculative Shutdowns

Tuesday, November 24th, County of Los Angeles Health Director, Dr. Barbara Ferrer, ordered closure of all restaurants in L.A. County, both indoor and outdoor dining, despite 3,000 comments objecting to closures at that meeting. The vote to support Ferrer's order was 3-2 with Supervisors Kathryn Barger and Janice Hahn objecting. Supervisor Ridley-Thomas supported the motion, but will be leaving to take his seat on L.A. City Council. Closure will last three weeks.

Supervisor Barger said, "There is no data to support closing restaurants. This action was arbitrary and only further encourages private gatherings, which is where the virus is actually spreading."

While Ferrer was pushing for County restaurant shutdowns, the City of Los Angeles voted to keep their restaurants open as did the City of Pasadena. Pasadena has its own health department and so does Long Beach but Long Beach decided to follow the lead of L.A. County and close their restaurants. Long Beach Post News reported their health officials see 'dining out as inherently risky' because they remove their face coverings to eat.

One restaurant owner told Glendora City Council at their special meeting called to find solutions, he was at a dead end with recent round of closures. He said he has rent to pay and, to comply with previous rounds of county regulations, contracted for a tent that is an additional \$4,000 a month. He just doesn't have the money to continue and refuses to take out any more loans.

Glendora is not the only city upset over the new rollbacks. City streets, or employees from the public sector and which sector. How many doctors and health care providers have come down with COVID 19? Rudy's Restaurant, historic area Monrovia, was cited by the health department for not having barriers at each table, but Rudy said he's never been given any standards for those barriers --like what material to use or how to install them to be in compliance. When he asked health officials for instructions, they said they didn't have any.

Additionally, Supervisor Kathryn Barger told Fox News: ["... increased case counts are not coming from businesses reopening, but from gatherings where people aren't wearing masks, citing Public Health data that only 10 to 15% of positive cases reported dining out with someone who tested positive, while more than 50% reported being at a private social gathering with someone who tested positive."

The California Restaurant Association is suing Los Angeles County in an effort to overturn the county's plan to suspend inperson dining due to the recent surge in COVID-19 cases. A previous lawsuit has been filed by the Restaurant Association of California to help their industry recover more than \$100 million in fees for liquor, health permits and tourism charges.

dining venues, we need to sup-


port them, not bankrupt them.


Stunning Post-Election Market Recovery

Two important things impacted the US economic outlook recently. First, better than expected economic releases boosted the GDP outlook. For example, the Atlanta Fed's GDP Now surpassed Wall Street's 5% fourth quarter GDP forecast. Then, very positive vaccine news was received. Moderna reported 94.5% effectiveness in preliminary phase-3 trials, while Pfizer and BioNTech have also submit results for FDA approval. Pfizer's trials now show 95% effectiveness compared with the better than 90% announcement on November 9. Additionally, AstraZeneca announced that its COVID-19 vaccine was as much as 90% effective in preventing infection without serious side effects. The only not so good news is that any vaccine immunity is still months away.

While these positive vaccine result dramatically changed expectations, they also suggest likely more optimistic trends. For now, anyway. There are still other important factors, especially related to government policy, that might tip the outlook back toward more pessimism. The recent Covid positive case surge cannot be ignored. This explosion in positive cases is much worse than expected as recently as a few weeks ago. At the very least the resurging pandemic will delay America's recovery.

The third-quarter earnings reporting season has been one for the record books in terms of positive earnings surprises. Also, a significant rotation is underway. Stocks that were once the face of the Covid crisis - like Boeing (BA), Carnival (CCL), or Delta Air Lines (DAL) - are recently part of the face of the recovery.

While uncertainties about Presidential vote counts and voting irregularities will likely persist, Wall Street apparently just wants to see a divided Congress.



The upcoming Georgia Senate seat run-off elections are now critical to making that possible. The market's big relief rally may assume that at least one Republican Senator will be reelected in Georgia. Republican gains in the House were also good news. Not surprisingly the major pollsters were proven wrong yet again.

It also would be beneficial if the U.S. could unite. A first step might be to grow and prosper despite lock down threats related to the latest coronavirus surge. I expect that much of the cash on the sidelines will continue to pour into the stock market, especially after all election and coronavirus lock-down uncertainty ends. November and December are seasonally strong market months. This also is the beginning of the season for a lot of year-end pension funding.

Coronavirus vaccine availability should help reduce the negative news related to impacted businesses, schools and personal lives. In the meantime, President Trump remains the top Repligen salesperson, since he credits that company's antibody treatment for his quick recovery from Covid-19. Clearly, we are learning to live with this China virus, but early treatment remains crucial. As effective treatments and vaccines become more available, it will be interesting to see if Democrats become more freedom friendly, no longer supporting shutdowns (like Europe has recently re-imposed).

I certainly do not want to downplay the severity of this pandemic. Thanks to therapeutics, the death rate from Covid has fallen, but it is still dangerous, especially for older or physically impaired people. It was interesting to compare the flu numbers from 2018-19 to Covid numbers. In the 2018-19 flu season, the CDC estimates 39-56m people had the flu, of whom 18-26m saw a doctor, 410-740k were hospitalized, and 24-62k died. The low numbers in each range are documented, while the high numbers are estimated. Not everyone with the flu, including many who die from it, are confirmed.

In contrast, in less than a year, there were 11.8m documented US Covid cases and 256k at least somewhat coronavirus related deaths. In other words, a quarter the number of cases, but many times the number of coronavirus counted deaths. However, as explained by Dr. Birks, everyone who dies in the USA while also testing positive for this China coronavirus has been counted as a Covid-19 death. This counting methodology is not true with the flu. or even for Covid in other counties. It is easy to understand how reported Covid deaths in the USA could be overstated.

This fourth quarter is likely to show some rosy economic and corporate earnings data, closing out 2020 in bullish fashion! However, the first quarter of 2021 could provide some resistance to the bullish trend if certain events don't unfold the right way. These political, health and economic concerns are no secret, and they are converging at the same time.



Act of Defense... Millions of us use them on a daily basis. As Southern Californians, it's hard to imagine what we would be doing without them. In a state with the most automobiles, drivers and population in the entire nation, our lives would a disaster without them. I'm talking about our highways, the artery of our transportation system, the heart of the nation's system of commerce. The convoy included 24 Army Officers, 248 men and 81 trucks whose objective it was to test the East-West roads in case an entire Army had to move across the United States in the event an actual conflict oc-

curred.

The convoy started in Washington DC, moved north into Pennsylvania, into Ohio, across the Midwest, over the Rockies and finally into California. It followed "Lincoln's Highway", which is today U.S. Highway 30, and averaged 58 miles per day traveling at a speed of 6 miles per hour. But eventually the convoy arrived in San Francisco after 62 days and 3,251 miles. Most of the roads were actually dirt roads, wheel paths, desert sand, and mountain trails which resulted in 230 road accidents as trucks went off the road, bridges were too low, and truck mechanical failures slowed progress of the convoy. The trip started as a fact-finding journey and the final results indicated that the United States Army would not be able to adequately mobilize an army to move across the continental United States. One of the officers within the convoy was a young Lieutenant Colonel by the name of Dwight D. Eisenhower.

Even though the final report identified an inadequate system of roads across the transcontinental United States, funding still had to be identified through Federal and State legislatures. For over 20 years, a complete funding solution could not be agreed upon but when World War II occurred, the Supreme Allied Commander recognized how Germany used a complex system of highways known as "autobahn" to rapidly advance the German mechanized military operations. The Supreme Allied Commander was General Dwight D. Eisenhower, the same person who was a member of the First Transcontinental Motor Convoy.

When Eisenhower was elected as President of the United States in 1952 one of his priorities was to establish a transcontinental highway system and on June 29, 1956, the Federal Aid Highway Act passed and he enthusiastically signed it. The freeway system would eventually be known as "The Dwight D. Eisenhower System of Interstate and Defense Highways" and will be 65 years old in June. What started out as just a simple test of roads in the United States, ended up being bigger than anyone could have expected. Our intricate system of highways has made life livable in heavily populated areas like Southern California, and provides for us a defense system just in case we need it

Can You Recognize Signs of Stroke?

Many people are avoiding inperson doctor's visits to limit potential exposure to coronavirus -- or are simply ignoring health concerns altogether. However, when it comes to medical emergencies such as stroke, immediate medical attention is critical.

The fifth leading cause of death in the U.S., stroke occurs every 40 seconds and it can happen to anyone, of any age, at any time. When 59year-old Paul "David" Dyches had a stroke on the job this past August, he quickly realized something was very wrong.


"I never experienced a feeling like this before, and I knew we had to do something right away," says Dyches, who was experiencing classic stroke symptoms of weakness in his arms and legs. Upon his arrival at the hospital, he was evaluated via tele-neurology by experts over 150 miles away. After doctors confirmed he was experiencing a stroke, they delivered treatment immediately and he was able to be discharged the following day.

While in some cases quick action can help with recovery, statistics suggest that many Americans may be avoiding hospitals when they need them most due to anxieties surrounding the pandemic. A recent study published in "JAMA Internal Medicine" showed that emergency room visits to five major healthcare systems decreased by more than 40 percent as COVID-19 cases spiked.

As patients such as Dyches are learning firsthand, hospitals have a range of protocols in place to help keep patients and staff safe from coronavirus infection.

"The hospital staff set me at ease right away," says Dyches. Beyond pandemic fears, one age-old barrier to seeking timely medical attention for stroke is simply awareness of signs and symptoms. While Dyches can credit himself with recognizing a classic symptom -- arm and

adults are able to recognize 10 signs and symptoms of stroke, according to a nationwide survey*. What's more, nearly 70 percent of the survey respondents say they're knowledgeable about stroke, yet 62 percent falsely believe that signs of stroke come on slowly over a day or two, when in fact symptoms of stroke can come on suddenly.

Experts say that immediate medical attention, which is vital, relies on everyone learning and being able to recognize the BE FAST signs and symptoms of a stroke in themselves and others and calling 911 immediately. BE FAST stands for Balance, Eyes, Face, Arm, Speech, Time and refers to these signs of stroke:

• Balance: Sudden loss of balance

• Eyes: Loss of vision in one or both eyes

• Face: Face looks uneven or droopy

• Time: Immediately call 911

"I am a testament to the fact that emergencies like stroke don't stop for a global health pandemic," says Dyches. "Anyone who experiences stroke symptoms should call 911 and get themselves to the ER as quickly as possible."

Dementia Related Psychosis: Four Caregiver Facts You Need to Know



Approximately 2.4 million people or 30 percent of people living with dementia in the U.S. may experience hallucinations and delusions associated with dementia-related psychosis. These symptoms might include seeing something that isn't there or believing something that isn't true and can be frequent, persistent and recur over time.

According to advocates, improving management of these troubling symptoms starts with recognizing and understanding what patients are experiencing. То learn more, UsAgainstAlzheimer's, the Lewy Body Dementia Association (LBDA) and Acadia Pharmaceuticals, surveyed patients and their caregivers. Findings highlighted important, infrequently discussed, considerations for caregivers:

1. Symptoms can happen frequently: The most common symptoms of dementia-related psychosis reported by surveyed patients were visual hallucinations (89 percent), auditory hallucinations (54 percent) and distortion of senses (54 percent) and such symptoms can happen frequently. Of patients who reported recent visual hallucinations, 61 percent indicated they occurred at least

experienced these kinds of symptoms associated with her Alzheimer's disease and in talking with other caregivers, many people think this could never happen to their family until it does."

2. Dementia-related hallucinations and delusions greatly impact a patient's overall health and quality of life: Most surveyed patients said their activities of daily living (75 percent), sleep (63 percent), family life (56 percent), and safety (about 56 percent) were affected by dementia-related hallucinations and delusions. Care partners reported that symptoms make it difficult for their loved ones to know what is real and what is not real, contributing to their anxiety, and impacting their personal relationships.

Jo Anne, 70, from Maryland, was surprised by her husband's hallucinations. "Before Ed was diagnosed with Lewy body dementia, he would tell me that he saw mice or insects in the house so, of course, I'd go check! When these experiences increased in frequency, I knew that we needed to talk to his doctor about why he was having persistent hallucinations."

Research shows that these kind of neuropsychiatric symptoms may pose challenges. For tia such as Lewy body dementia, Alzheimer's disease, Parkinson's disease dementia, vascular dementia, and frontotemporal dementia. Unfortunately, caregivers of people with dementia compared to non-caregivers can experience high rates of emotional and physical stress as well as depression, an increased likelihood of comorbid conditions, hospitalizations, and doctor visits. In fact, caregiver burden is associated with increased desire to place people with dementia in long-term care.

4. Getting help as early as possible is key: Living with dementia-related hallucinations and delusions takes a toll on both patients and caregivers. That's why advocates urge caregivers to get educated about what to expect from dementia-related psychosis and find support.

"If you see your loved one exhibiting new symptoms, then take the initiative to tell their health care provider, who can offer advice on how to cope," urges Frangiosa.

Every day, the U.S. Postal Inspection Service works to protect your mail, USPS employees and USPS facilities. It's just as important to it as it is to you that these items reach their destinations safely, and the Post Office could use your help to keep your mail and packages safe. Here are a few tips to consider this holiday season: 1. Don't leave your delivered mail and packages unattended. You wouldn't leave important items sitting on the front seat of your unlocked car overnight. So don't leave your mail and packages sitting in mailboxes or on front porches for any length of time.
