This Marks the 7th Year the Food and Beverage Provider Has Participated in the Holiday Tradition

PASADENA - Pasadena Center Operating Company, Centerplate, city officials, and volunteers prepared over 250 turkeys at the Pasadena Convention which will feed over two thousand families for Union Station Homeless Services Thanksgiving Dinner.

An annual Thanksgiving dinner hosted by a Pasadenabased homeless services provider will celebrate its 50th anniversary this year. "While this year might bring unique methods of celebrating Thanksgiving, there still is one distinct purpose: to feed those in need with a full holiday meal," Union Station Homeless Services said in a statement.

The event began when a group of volunteers from the All Saints Church in Pasadena gathered to organize their first dinner and form the first incarnation of the Union Station Homeless Service. Since then, dinners have been held annually at Central Park's Christmas and Thanksgiving, an expression of compassion and care for those who would otherwise not be able to enjoy such a holiday meal.


Cosmetics and Beauty Supply Company which is behind the Sport Barber Shop, 14434 Valley Blvd. It caused \$2.5 million in damage. \$2 million to the building and \$500,000 to the contents and products.

The call came in to the fire department around 11 p.m. on Wednesday, November 17th and fire fighters fought to bring the fire under control for more than 4 hours. They finally knocked down the fire around 3:15 a.m. but not until the roof caved in just after midnight.

The fire was hard to knock down most likely because of the product line inside the building. Some beauty supplies are very flammable. Nail polish and nail polish remover, hair spray and many other products

can fuel the fire. Nearly 2 dozen firefighters were on scene to fight the fire which was near the corner of 6th Avenue and Valley Blvd.

There was no injuries and the cause of the fire is under investigation.

This Holiday Season, Doctors Urge **Public to Make Safety a Top Priority**



With COVID-19 infections at an all-time high, medical experts urge the public to make safety their number one priority throughout the holiday season.

"Nearly a year into this pandemic, people are yearning for a return to normalcy. However, COVID-19 cases are surging and with flu season already upon us, bringing together people from different households during the holidays is far too great a safety risk," says Susan R. Bailey, M.D., president of the American Medical Association (AMA).

During this unusual year, the AMA is sharing top tips for a safe and healthy holiday season:

1. It may not be the way you're used to celebrating, but consider limiting this year's gatherings to just the people who live in your household.

2. If you live somewhere warm, you may be able to add a few people to your plans, but only

if your get together is outdoors and safely physically distant.

3. Take advantage of the video conferencing technologies available at your fingertips to bridge the distance between you and family or friends. Whether it's watching holiday movies, unwrapping gifts or sharing recipes together, many of these traditions can still happen virtually.

4. Interested in holiday deals and discounts? Shop for bargains from home. And if you must go to the store in person and you're at-risk, check ahead of time to see if there are special hours for you.

5. Consider additional outdoor activities that can bring together other people in your circle without the dangers of dining inside. Go apple picking, leaf peeping or hiking. Think beyond the traditional holiday activities and start new traditions.

6. Disappointed that your

usual large dinner is for a smaller group? You can still cook a large meal and share a portion with neighbors or friends. The Centers for Disease Control and Prevention recommends "delivering them in a way that doesn't involve contact with others."

7. Continue to follow everyday safety guidelines to prevent the spread of COVID-19: wash your hands, maintain physical distancing and #MaskUp.

Holiday Traditions and Creative Performances: The Show Must Go On


The year was 1606, and in response to the return of the plague in London, Shakespeare's company of players, the King's Men, was forced to lock the doors of the famous Globe Theatre.

and bars as the five-day average of new cases increased to more than 4.000 cases. The modified order takes effect Wednesday, November 25 at 10:00 p.m.

To reduce the possibility for crowding and the potential for exposures in settings where people are not wearing their face coverings, restaurants, breweries, wineries and bars will only be able to offer take-out, drive thru, and delivery services. Wineries and breweries may continue their retail operations adhering to current protocols. In person dining will not be allowed, at minimum, for the next 3 weeks.

Los Angeles County established thresholds for additional actions if the five-day average of cases is 4,000 or more or hospitalizations are more than 1,750 per day, to restrict in-person dining at restaurants, breweries, wineries and bars.

If the five-day average of cases is 4,500 or more or hospitalizations are more than 2,000 per day, a Targeted Safer at Home Order will be issued for three weeks. The Order would offer additional restrictions while allowing essential and emergency workers and those securing essential services to leave their

There are 1,401 people with COVID-19 currently hospitalized and 26% of these people are in the ICU. Over the past 7 days, the number of hospitalized patients increased by nearly 35%.

Public Health reminds everyone to stay home as much as possible for the next two to three weeks to change the trajectory of surging cases and save lives. COVID-19 can be unintentionally spread to other people unless we all practice the simple safety precautions that prevents spread. Virus transmission can be significantly reduced if we all keep distance from others who we don't live with, always wear a face covering properly over our nose and mouth, and wash our hands frequently.

Additionally, it is very important that if you are even mildly sick or think you were exposed to someone with COVID-19 that you stay home and away from other people, especially those at greater risk of becoming seriously ill from COVID-19 and consider being tested for COV-

To date, Public Health identified 364,520 positive cases of COVID-19 across all areas of L.A. County and a total of 7,438 deaths. Testing results are available for more than 3,542,000 individuals with 10% of all people testing positive.

"As we modify our Thanksgiving holiday celebrations, we are reminded of the many families who will miss their loved ones who have passed away from COV-ID-19. We send wishes for healing and peace," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "The persistent high number of cases requires additional safety measures that limit mixing in settings where people are not wearing masks. We hope individuals continue to support restaurants, breweries and wineries by ordering for takeout or delivery. We also fervently hope every L.A. County resident supports all our businesses by following the Public Health directives that we know work to slow spread. Unfortunately, if our cases and hospitalizations continue to increase, we will need to issue further restrictions to protect our healthcare system and prevent more deaths."

Woman Identified in Fatal Crash in Irwindale

IRWINDALE - Irwindale police responded to a traffic collision on Nov. 15th around 5:30 a.m. on Lower Azusa Road, just west of the 605 Freeway overpass.

When first responders arrived, they found that a 2018 Chevrolet Cruz had crashed into a utility pole on the north side of the street. Inside they found the driver, an elderly woman, dead.

It appears that the woman was eastbound on Lower Azusa Road and for some reason, she jumped the center di-

vider and crossed the oncoming lane and impacted a utility

At the time, the driver was not identified. Since then, they have released the name of the woman. She was identified as Margot Kruse, 81, of El

There is some speculation that the woman may have had a medical issue just before the accident.

The single-vehicle crash is under investigation. Anyone with information on the crash was urged to call police at 626-430-2244.

Los Angeles County to Implement Tighter Safeguards and Restrictions to Curb COVID-19 Spread

LOS ANGELES COUNTY -As COVID-19 cases surge and hospitalizations continue to increase, the Los Angeles County Health Officer Order has been modified with an effective date of Friday, November 20 to reduce the possibility for crowding and reduce the potential for exposures in settings where people are not always wearing their face coverings in an effort to prevent more cases, increased hospitalizations and more deaths.

The following will go into ef-

- For non-essential businesses permitted to operate indoors—including retail stores, offices, personal care services occupancy will be limited to 25% maximum capacity.
- The number customers at cardrooms, outdoor mini-golf, go-karts and batting cages will be limited to 50% maximum outdoor capacity.
- Services at personal care establishments may only be provided by appointment to customers wearing face coverings by staff wearing face coverings.
 - the customer or the staff to remove their face covering, such as facials and shaves, are not permitted. • Food and drinks cannot be

served at these establish-

• Services that require either

· Restaurants, breweries, win-

ments to customers.

eries, bars, and all other non-essential retail establishments must close from 10:00 p.m. to 6:00 a.m.

• Outdoor gatherings remain the only gatherings permitted, and they must only include 15 people maximum who are members of no more than 3 households.

The Health Officer Order will be amended to reflect the above restrictions.

At this time, the County is reporting 2,884 cases as the fiveday average and 1,126 hospitalized patients.

The County continues to anticipate the potential continued surge of cases and hospitalizations. The County has established thresholds for additional actions if cases or hospitalizations continue to increase.

If the five-day average of cases in the County becomes 4,000 or more or hospitalizations are more than 1,750 per day, the following restriction will be added:

• Outdoor and indoor dining at restaurants, breweries, wineries and bars will be prohibited and these businesses will only be able to offer pick-up and delivery. Businesses in this sector are being notified via email by DPH, which will work with them to ensure a smooth transition.

If the five-day average of cases in the County becomes 4,500 or more or hospitalizations are more than 2,000 per day, the fol-

lowing restriction will be added:

- A Safer at Home Order will be instituted for three weeks. The Order would only allow essential workers and those securing essential services to leave their
- A 10:00 p.m. to 6:00 a.m. curfew would be mandated, with essential workers exempt.

"Los Angeles County is at a critical moment to save lives and curb the spread of COVID-19. I urge our residents, businesses and community leaders to heed this warning and follow these heightened safeguards so that additional restrictions do not need to be imposed," said Dr. Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "We are so grateful that many of our residents are wearing face coverings, keeping physically distanced and avoiding gathering with people they don't live with, but we need everyone to do their part and follow these measures. Lives and livelihoods are at stake and our entire community will be affected by our collective action if we do the right thing."

L.A. County Launches Digital Contact Tracing for COVID-19, Aiming to Reduce Exposure Notifications from Days to Hours with Healthvana

In battle against growing community spread, L.A. County launches first-of-its-kind campaign that empowers patients to anonymously notify close contacts of a positive test result

LOSANGELES COUNTY-

As California's counties reach sobering new milestones in COV-ID-19 cases, L.A. County and its partner, Healthvana, are taking a bold step to control community spread. Individuals with a positive test are now able to immediately and anonymously notify anyone with whom they have recently come in close contact, using their mobile phones.

By reducing COVID-19 exposure notifications from days to hours, officials hope to further reduce community spread by encouraging close contacts to quickly quarantine and obtain a free test. This is only one aspect of the County's extensive effort on contact tracing which is led by the Department of Public Health.

"This is a prime example of

how to harness technology to help Angelenos immediately inform their contacts and help slow the spread of infection, especially as we see the rate of infections and hospitalizations rising in communities across the County," said Dr. Clemens Hong, Director of Whole Person Care with the Department of Health Services, which oversees the County's testing sites. "By rapidly alerting people who may have been exposed to the virus so they can use that information to isolate themselves and protect their loved ones, we can make big strides in slowing progression and reducing the terrible impacts of COV-ID illness." Los Angeles County has part-

nered with Healthvana since April 2020, which already delivers test

results for county-operated sites. Test result notifications are sent via text message or email the moment the lab processes the sample. With this added feature, individuals who receive a positive test result can easily click a link within the web-based patient portal to enter contact information for any recent close contacts.

These close contacts instantly receive a notification from Healthvana alerting them that they may have been exposed to COVID-19 with links to resources, including locations where they can schedule a free COVID-19

"Patients are the most underutilized resource in healthcare and L.A. County is the first to empower their community to be part of the solution in this way to slow the spread of COVID-19," said Ramin Bastani, CEO of Healthvana. "Millions of test results later, we know people prefer to use their phones when it comes to COVID-19 – on average, patients access their results in less than 30 minutes. Now we have a chance to reduce exposure notifications from a few days to a few hours."

The contact tracing feature will be initially rolled out to County-operated testing sites. There are currently over 180 total testing sites across the region which include County-operated sites, City of Los Angeles-operated sites, State-operated sites and locations run by community clinics, pharmacies, and various other testing partners. Healthvana has delivered over 750,000 COVID-19 test results to County-operated testing sites since late April. Los Angeles County was one of the first counties to deliver test results via Healthvana, which has been proven successful: 50% of individuals view test results in 10 mins or less; 75% view their test results in one hour or less; and 90% view their test results in four hours or less.

Slow the Fast Down: Public Encouraged to Follow the Speed Limit

A new statewide initiative encourages drivers to "Slow The Fast Down" and understand the dangers of speeding.

The Los Angeles County Sheriff's Department supports efforts by the California Office of Traffic Safety to address an emerging traffic safety issue: speeding.

"We are seeing changes in driving behavior, and the number of people traveling at excessive and extremely dangerous speeds is alarming," Los Angeles County Sheriff's Department, Sergeant Robert Hill said. "COVID-19 puts the value of protecting lives in perspective, and practicing safe driving is one simple way everyone can keep themselves and others safe.'

Excessive speeding went

In a world where resources are already hard to come around for non-English speaking families, the ambiguousness of current policies only make it more difficult.

There also should be more widespread information available to parents and educational advisors about how in person learning should occur. Instead of one size fits all policies and procedures, it is essential to acknowledge that every situation is unique. Local authorities should work to see what sort of procedures would be best for the condition their area is in. Having unclear policies that intend to apply to every school regardless of the severity of Covid-19 cases in that area is vastly irresponsible and will not be effective; instead, it may lead to confusion and outright ignorance of these policies. The pandemic is a continuously evolving and rising threat in the United States. All action which could change the course of this disease must be done carefully, in a detailed manner, and with bipartisan cooperation.




But has anyone really thought about the future of Donald Trump if it doesn't include a trip back to the White House in 2021? Theories about his future are all over the place.



Path Toward Ongoing Growth In 2021

Although Wall Street hates confusion and gridlock, the relief rally continues with some weighty issues for the market to contend with during the next few months. Many uncertainties related to election irregularities and apparently verifiable fraud cannot be encouraging. No matter who wins this disputed election, if we want our economy to thrive again, we must avoid Biden's threatened Dark Winter of lockdowns. Recent new Covid-19 cases in many states offer excuses for some governors to close businesses and schools to an extent which will damage the economy as well as hurt our children. Many other state governors are struggling to find an appropriate balance between new restrictions for safety and keeping the recovery and in person school systems going. Further restrictions might appear inevitable, but many small businesses may not survive new extended regional lockdowns.

There is growing evidence that lockdowns don't cure Covid, but they certainly kill economies. The other G-7 countries stayed locked down longer than the U.S. and they also used contact tracing and mask mandates. The currently worst of the G-7 economies (UK and Italy) had similar Covid death rates and are now seeing new waves of Covid infections and deaths. Extended lockdowns did not appear to previously help them that much, but here they go again. Sweden, by contrast, which didn't lock down, has no similar Covid-19 resurgence. Sweden also has lower coronavirus death rates than Italy or the

Economist Don Luskin measured U.S. state economies based on severity of lockdowns. He found some states with the most severe lockdowns had a greater spread of the virus. "States with longer, stricter lockdowns also

had larger Covid outbreaks." New Jersey and New York are the only states with over 6% Covid death rates. Massachusetts has the third highest USA coronavirus death rate (per confirmed coronavirus case), just under 6%. By comparison, the Covid-19 death rate per confirmed case for the entire USA is about 2.2%; and, a very high percentage of counted Covid deaths were old or health challenged individuals.

One better alternative to lockdowns is to let those people who are known to be at lower risk (those of us in good health under age 65, including children and most those of working age) carefully go to school and work. Older people or those with health risks should continue to take maximum precautions and use good judgement in avoiding any exposure to Covid-19. Dr. Fauci indicated after the election that this China virus shouldn't be a problem much longer; however, that message seems to have changed drastically recently.

Case numbers are surging in some states due in part to wider testing, while death rates are declining due to better care, as well as protection for those most vulnerable. What is RMD? When does it start? Is there a way to avoid it?

Can it affect my tax bracket? RMD is Required Minimum Distribution. It's the annual amount that must be withdrawn from a traditional IRA or a qualified retirement plan (401k, 403b, Keogh). Although you are allowed to begin taking penaltyfree distributions from tax-deferred retirement accounts after age 59 ½, you must begin taking distributions upon reaching age 72. The amount of your RMD distribution depends on your age, your life expectancy, and the value of the account. (Refer to IRS tables.) If you do not take RMDs, you might have to pay a 50% federal income tax penalty on the amount that you should have withdrawn. Tax-deferred retirement plans are subject to ordinary income tax. If your RMDs are large, you might be pushed into a higher tax bracket. Plan ahead to figure out the best time to begin taking your RMDs. Note: Roth IRAs contain posttax money, grow tax-free, and do not fall under the RMD rules. Distributions from certain lifeinsurance policies can be taken (if done correctly) income tax free, too.

My wife is healthy, but I was 'rated' for life insurance, meaning my premiums would be higher due to some health problems. Is there another way to provide for my family whenever I die?

One choice would be to apply for a second-to-die life insurance policy with your spouse, along with a first-to-die rider. Qualifications for this life insurance would be based on your spouse's qualifications. Because of the rider, the life insurance policy would pay out whenever one of you passed. Another choice would be to invest in an annuity. This would be a contract between you and an insurance company, but without life insurance underwriting. Annuities can be used to help ensure a steady stream of income in retirement, as well as help ensure that your beneficiaries will be taken care of in the event of your death.

Signs Your Brakes Need Attention

Noises - A scraping sound means metal is rubbing metal and that tells you that your brake pads are worn out and need to be replaced. A squealing noise doesn't always indicate a problem depending on the materials used in the pads but shouldn't be ignored as it could also mean the pads are worn or your system is missing

a gasket. **Swerving** - If your vehicle swerves to one side when you apply the brakes the front brakes need to be checked to make sure the "power" of the brakes are evenly distributed. This could indicate a leak or a mechanical problem or a miss-match of brake pad brands on either side. It is best to have it checked out if you notice this issue.

Signs you need to have your vehicle towed - Pedal to the floor is a sign that the car has a leak or a bad master cylinder. This is a situation where you need to get your car towed in for repair immediately. Do not drive your vehicle if this occurs. Another issue is when your brakes "lock" as this is caused by a damaged pad.

Keep in mind that your brak-

ing system endures a lot! The components are constantly bombarded by water, road grit, heat and contamination of its fluid. We suggest you have your brake system inspected once a year so it can do what you need it to do...bring you to a stop!

During this year's Click it or Ticket seat belt enforcement campaign, the Los Angeles County Sheriff's Department will have additional officers on patrol looking for drivers and passengers who are not wearing a seat belt. This includes drivers who do not properly secure children in child safety

While the seat belt use rate in California was 96% last year, there has been a noted drop in seat belt use by back seat passengers. A recent report by the Governors Highway Safety Association (GHSA) found only 76% of rear seat passengers wore seat belts.

"Wearing a seat belt is your best defense on the road," Los Angeles County Sheriff's Department Sergeant Robert Hill said. "It only takes a few seconds and helps keep you and your family safe."

According to the National Highway Traffic Safety Administration (NHTSA), seat belts

saved nearly 15,000 lives of people ages five and older in

The fine for a seat belt violation is \$162. California law requires a child be properly secured in a safety seat in the second row of a vehicle, when available, until they are at least 8 years of age. Children under the age of 2 must ride rear-facing or until they reach 40 pounds or 40 inches in height.

California has a primary seat belt law, which allows law enforcement officers to ticket someone for not wearing a seat belt without committing another traffic violation.

"TIME JOCKEY" - Calistoga

Historic Napa Valley **Town...** Nestled among the best tasting wine vineyards of the Napa Valley is the small, quaint, historic town of Calistoga. Before wine-making became a lucrative business, the Calistoga area was home to a number of natural hot springs which the Native American people known as Wappo used extensively and provided the foundation for a number of local Wappo villages.

When John Sutter was building his fort in Sacramento and employing James Marshall to build his sawmill, he needed skilled carpenters to complete most of the technical construction work. Sam Brannan was the leader of a Mormon group in San Francisco who brought his team to Sutter's Fort to work as carpenters for Sutter. Brannan also took a position as the storekeeper at the fort and learned the business of buying and selling goods. When James Marshall discovered gold, and Sutter confirmed the finding, Brannan was one of the first to hear about it and shortly thereafter quit his job as did the other Mormons, and went to San Francisco to purchase

goods for a new store he was going to open.

In San Francisco, Brannan was

the first one to announce gold had been discovered along the American River as he wildly ran through the streets shouting about the news. As Brannan's entrepreneur ventures grew with business from the incoming gold prospectors into the Sierra foothills, his revenues also increased exponentially. His increased wealth allowed Brannan to purchase large amounts of land and one of the areas he acquired property was the hot springs area previously inhabited by the Wappo. Seeing an opportunity to further expand his wealth, Brannan founded a town around the springs and recalled that he wanted it to be like Saratoga, New York, a town on the East Coast which was known for thoroughbred horses and warm water springs. Brannan came up the name "Calistoga" for Californiais-Saratoga and as the town grew in population so too did business revenues also grow.

The Napa Valley-Calistoga Railroad line was established to support the growing grape and wine production ventures in the area and real estate development began to spread. The town grew with the increased population growth and soon Sam Brannan was California's first millionaire. His credits include being a pioneer, promoter, preacher, politician, philanthropist, railroad and land developer and newspaper-

Today, the City of Calistoga, still retains its old-time charm of a small country town with restaurants, shops, bakeries, a gold course, hotels, and even a book store all along its main downtown thoroughfare. The scenery around Calisotga is among the best California has to offer with acres after acres of the best wine produced in California and the United States. Sam Brannan struck gold again when he established the township of Calistoga, proven testimony of Brannan's business acumen and vision


