WHITTIER - Río Hondo Police Academy celebrated the graduation of 49 cadets in Class No. 210 during a special drivethrough ceremony held Nov. 5 at the College's Whittier campus that followed COVID-19 physical distancing guidelines.

The event featured the Los Angeles Police Emerald Society Pipe and Drums Corps, a presentation of colors by the Pasadena Police Department Honor Guard and an invocation by Covina Police Chaplain Ron Butler.

"After six long months of intensive training amid very restrictive COVID-19 conditions, the cadets of Class 210 have earned the right to graduate from the Río Hondo Police Academy, joining the ranks of hundreds of police officers and police chiefs who have come before them at the Río Hondo Police Academy since 1964," Acting Superintendent/President Teresa Dreyfuss said.

Cadet training covers constitutional law, criminal law, domestic violence, traffic enforcement, emergency vehicle operations, tactical first aid and CPR, mental health, lifetime fitness, firearms, among other subjects mandated by Peace Officer Standards and Training.

The cadets represent 23 police departments from Los Angeles, Orange and Ventura counties, who

What Parents Can Do About **Cyberbullying Amid the Pandemic**

Screen time is on the rise for kids and teens as a result of remote learning and social distancing measures. At the same time, cyberbullying and hate speech are reaching new heights amid the current crisis, according to analysts.

A recent new study conducted by L1ght recorded a 70 percent

uptick in hate among children and teens during online chats since December 2019. While this is worrying, there are steps parents can take to help protect kids from the surge of online toxicity they may be encountering:

• Pay attention: There are many common red flags that a child is either involved in cyberbullying or a victim of it. Those who are instigating or participating in cyberbullying may exhibit increased secrecy around their mobile device or laptop, display arrogance or have other behavioral problems. Signs your child is a target of cyberbullies include depression and anxiety, (particularly while or after using their device), problems with sleeping, changes in appetite, self-harm or suicidal thoughts.

• Communicate: Open a line of dialogue with your child about what they are experiencing, but be patient. Your child may be reticent to share everything going on with you at first. It can be helpful to draw in the assistance of another adult role model or even a professional therapist. If your child is the one doing the bullying, work on identifying

their motivations, so you can better address the root of the issue, and of course, continue to serve as a positive role model when it comes to expressing empathy and kindness toward others.

• Keep kids active: When remote class time is not in session, it's important to place an emphasis on spending quality time offline. Encourage kids to be physically active outdoors in order to raise levels of moodboosting hormones and promote better sleep at night (something that may be suffering more these days as a result of additional blue light from screens). If possible, arrange for socially distanced meet-ups with close friends, such as bike rides. Get kids involved in positive hobbies like reading, playing an instrument or art.

• Manage screen time: As parents know, actually managing screen time can be tricky. Kids are not always upfront about what they are doing online and there are many hours a day where it's simply impossible to monitor your child. However, new tools are proving essential in helping parents protect kids from the harmful effects of cyberbullying. For example, OurPact from Eturi Corp. is an app that allows parents to set online schedules for kids, as well as grant or restrict access to websites and apps. Parents can also take screenshots of online activity to ensure their kids are staying safe. These can also be used to facilitate discussions regarding smart digital health. Fire and Explosion at an Irwindale Cabinet Manufacturing Plant

IRWINDALE - On November 7th just before 6 a.m. the Los Angeles Fire Department responded to a fire at 4414 N. Azusa Canyon Road in Irwindale. This is the Decore-ative Specialties which is a cabinet manufacturing plant. The plant is located behind the Pepsi plant on Azusa Canyon Road. The Decoreative Specialties has been in operation since 1965.

The fire was to the rear of the building near a dust collection silo. Sawdust is highly combustible when it is a floating mass.

At some point while the firefighters were fighting the fire, the silo exploded into a fireball which sent the firefighters running to take cover. There was one main fire line already in place with a number of other lines being deployed to get more water

on the fire when the explosion happened. No firefighter was injured from the explosion or while fighting the fire.

After they got more lines in to fight the fire, they got it under control. Firefighters remained on the scene for hours to make sure there were not going to be any more issues.

The cause of the fire remains under investigation.

FEMA Financial Support Deadline Extended for LA County Residents Affected by the Bobcat Wildfire

LOS ANGELES COUNTY -Los Angeles County residents who lost their home or sustained other losses due to the recent Bobcat wildfire can apply to receive federal assistance now. The deadline to register with the Federal Emergency Management Agency (FEMA) has been extended to December 16, 2020.

FEMA gives eligible wildfire survivors financial support to help pay for needs such as rent, home repairs, medical/dental costs, funeral expenses and other disaster-related expenses.

If you are a Bobcat wildfire survivor, you can register for FEMA assistance in three ways: Online at

www.disasterassistance.gov; • Download the FEMA app on

your smartphone or tablet; or

• Call the FEMA Helpline at 1-800-621-3362 (TTY 800-462-7585) between 7:00 a.m. and 10:30 p.m. Pacific Daylight Time. The helpline has specialists who speak many different languages.

If you use a relay service such as a videophone, Innocaption or CapTel, provide FEMA the specific number assigned to that service when you register.

When registering for FEMA assistance, be prepared to provide your personal information, including your Social Security number, insurance policy information and a description of the damages or losses suffered due to the Bobcat wildfire.

Start with a simple internet search. Search for reviews of the company. When evaluating these reviews, look for more recent ones. Read the reviews, don't just look at the ratings. See what other customers are saying about the business. Typically, people will write reviews for businesses that are really good, or really bad.

The Better Business Bureau (www.BBB.org) is a great place to get customer reviews on businesses.

Another place to search for ratings on businesses is Yelp (www.yelp.com).

Check the business address of the company on a mapping service (i.e.: Google Maps). Verify the address is valid and that the business is located there. If you find a business located in a residential area, that should be a reason to search further.

The Arcadia Police Department encourages you to research any business before engaging in an agreement for any services. The more you know, the less likely you are to become a victim.

Sheriff's Department Parking Enforcement Resumes On Sunday, November 15, 2020

LOS ANGELES COUNTY -The stay-at-home order issued in early 2020, in response to the COVID-19 pandemic brought to light the need for additional parking and a new way to address parking enforcement across Los Angeles County. Understanding the needs and challenges of those in the communities we serve, the Los Angeles County Sheriff's Department Parking Enforcement Detail relaxed parking enforcement to help cope with parking availability and administrative concerns.

In the face of new challenges to prepare for inclement winter weather, parking enforcement will resume issuing citations for

public right of way. Beginning Sunday, November 15, 2020, the Los Angeles County Sheriff's Department, Parking Enforcement Detail will again issue street sweeping and expired registration citations, as well as, towing vehicles in the areas we serve across Los Angeles County. To avoid receiving a parking citation or having a vehicle towed, we urge drivers to be mindful of this change.

Resumed enforcement will include:

1. Street sweeping: All streets with posted signs for street sweeping will be enforced, per 15.20.07(2) LACVC

2. Expired registration: Vehiall parking violations within the cles with expired registration

will be cited for 4000(a)(1)CVC; registrations expired in excess of six months, in violation of 4000(a)(1) CVC, will be towed, per 22651 (o)(1)(A) CVC

3. Red tag warnings: Red tag warnings will be issued to vehicles parked on the street not displaying signs of movement, including excessive dirt, debris underneath and around the tires, flat tires, missing parts, and vandalism. If the vehicle has not been moved after 72 hours or three days, a citation for Abandonment Prohibited 22523(a)(b) CVC will be issued and an additional 48 hours or two days will be given. If the vehicle still has not been moved, it will be towed, per 22651(k) CVC.

Citrus College Ranked Among Top Colleges, Universities In Nation For Hispanic Students

A "little glitch" resulted in 6,000 votes erroneously given to Joe Biden rather than President Trump.

Arizona, Maricopa County, biggest in Arizona, there were rejected votes due to what is called "over voting." An overvote occurs when someone votes for more than the maximum allowed and the result is a vote or ballot which is not included in the final tally. (If a voter voted for two candidates when only one was allowed.) And, there were other cases where an entire ballot had been voted, counted and the registered voter of that ballot was challenged and perhaps not able to vote or had to vote provisionally. We should hope Reagan's quote becomes more appropriate than Biden's recent quote: "We're about to go into a Dark Winter". My colleagues on Wall Street hope that Election Week doesn't turn into Election Month, or worse! The last time there was a contested Presidential election in 2000 it took five weeks to get election results. That bitter legal battle was only settled by the courts. In 2000 the market responded negatively to uncertainty, as the S&P 500 Index fell 8.4% between election day and the day Gore conceded in the wake of a Supreme Court ruling that ended the Florida recount.

Punch card voting ballots were summarily eliminated from the Florida election process, followed by national election changes by 2014. Interestingly, during the 2000 "hanging chad" election uncertainty, Bush and Gore were fairly civil in their decorum to each other. Life went on without major social upheaval, as it should. That was expected in the past.

Over the last 90 years, from 1929 to 2019, one party controlled both chambers of Congress as well as the White House in nearly half of those years. Despite huge market swings, the S&P 500 rose an average 7.45% during those 91 years (according to Dow Jones Market Data). During one party rule, market indexes were up 30 times and down 15 years. In the other 46 years, when there was a split government, the index climbed 7.26% on average, rising 29 times, falling 16 times, and remaining unchanged once. While political party control many not have statistically made much difference in the past, that was before one party went radical and supported socialism as



well as a green new deal!

There certainly has been a "V" shaped recovery brewing recently, as GDP rose at a 33.1% annual rate in the third quarter. Specific details look even better, with consumption beating expectations and private investment absolutely booming. The biggest drag on growth recently has been trade balances, reflecting the surge in demand from American consumers - which fueled imports - and relatively weaker recovery outside the US - which hurt exports.

The third quarter rise in GDP was bigger than the 2nd quarter drop in percentage terms, but smaller in dollar terms. Nevertheless, this is what a V-shaped recovery looks like. Of course, given this is political silly-season, and the candidates differ in their descriptions of the economy, it is important to realize they both are theoretically correct. As President Trump claimed, the recovery is V-shaped, and as Vice President Biden claimed, it is also K-shaped. That is, the recovery is not yet complete because recovery from the CCP's coronavirus caused recession has not yet equally benefited all lower earning workers. But don't ignore lockdowns in blue states, where employment in restaurants and other non-essential employers are still severely restricted.

Nevertheless, economic growth boomed during the third quarter. There is only \$670bn, or 3.5%, of GDP to make up before the entire loss from the lockdown recession is recovered. To make that up in a single quarter, GDP would have to rise at a 15.1% annual rate (which is unlikely this quarter). Nevertheless, the economy could fully recover during the first half of 2021, especially if vaccines are as effective as are recently developed therapeutics in speeding COVID recovery. Nevertheless, COVID resurgence fears mean fourth quarter markets may be challenging, especially if Biden / Harris were to win.

The blame game, finger pointing and extreme uncertainty continue to come at the expense of our American society. "Your ALL OR NOTHING approach is hurting hard-working Americans who need help NOW," Treasury Secretary Steven Mnuchin said in response to a letter from House Speaker Nancy Pelosi (which detailed six areas that must be addressed before stimulus talks could move forward in the Democratic controlled house). Pelosi's PORK included significant state and local (bail-out) funding. While another aid package is overdue, Pelosi said it may be possible to strike a COVID relief deal in the so-called lameduck session of Congress.

In the meantime, markets will likely be volatile until at least the Presidential election is resolved.

My mom just told me that Dad will probably be entering a nursing home next year. She's planning to apply for Medicaid for him. Does this mean that she'll have to 'spend down?'

There is a 5-year 'look back' limiting people from 'hiding' assets by various methods. You can start investing in your own IRA for around \$100 per month. Then, as your income increases, you can put in more. Or, you could apply for a life insurance policy that includes a cashaccruing account, available for you to use for anything you want (downpayment on a house, retirement, etc.) while you're alive. You might even ask your parents to match your retirement savings, up to a set limit, for the first year to help you get a start and build a good habit.

We both plan to retire in 7 or 8 years, but are worried that we won't be able to afford the payments on our mortgage that still has 12 years left. What could we do?

You have several choices. 1. Pay off your mortgage early. Go to Bankrate.com and use their mortgage amortization calculator. Put in the mortgage balance, rate, and number of years. This will allow you to see the amount you could pay each month in order to pay off your loan in 8 years rather than 12 years. 2. Refinance now, while still employed, into a 30-year mortgage to lower your payments to an affordable amount. You can still pay it off in a shorter time, but this gives you a lower payment, if needed. 3. Upon retirement, rent your home out, or sell it and obtain less-expensive housing. 4. In retirement, if you find yourself cash poor (not enough money to pay the essential bills) and you have a high amount of equity in your home, you might qualify for a reverse mortgage (HECM -Home Equity Conversion Mortgage), allowing you to stay in your home without mortgage payments. Use a loan professional who specializes in Reverse Mortgages.

If I get an annuity, how can I know, for sure the income from it will last my whole lifetime?

Insurance companies use mortality tables to determine how long you are expected to live. However, nowadays, people are living longer. Covid-19: The Twofold Pandemic

America's true colors. Racism towards Asians in the United States has been largely ignored; amid a pandemic, this bigotry has been amplified, and it is now more crucial than ever for society to take a stand. Covid-19's second wave is on the brink, and the United States has just reached a record number of daily cases on October 24th. Along with this, the anti-Asian sentiment has risen once again.

According to NBC news, anti-Asian conspiracies rose 85% after news of Trump's Covid-19 diagnosis was announced, seemingly attributed to frustration over Asian people "starting" the virus. This virus does not seem to be ending anytime soon, but what Americans can do is to end this false narrative. When political leaders, celebrities, and popular culture are targeting specifically the Chinese community, educating others about the truth of the situation is crucial towards the goal of equality. Democratic Congresswoman Judy Chu stated that anyone who states that they cannot see the connection between rhetoric and increased racism "is lying to themselves".

The Asian community faces a strong dilemma of how they stand in the coronavirus situation. While others worry about the economic and health effects of this pandemic, Asian Americans face a niche issue of how it affects their standing in the United States. Especially as they turn to

It takes a pandemic to show increasingly racial rhetoric from certain political leaders, the decision for how they should vote is not an easy feat. Examples of this can be linked to terms such as the "Chinese Virus", which on the surface seems unproblematic, but can generate much larger societal issues. Further, one needs to look no further than President Trump's Tulsa rally, in which he coined Covid-19 as the "Kung-Flu" to find instances of this commonplace discrimination. Not only was our own president promoting this type of behavior, the thousands of supporters cheering behind the president is yet another alarming occurrence

> Again, in Phoenix, the president used the term following chants of "Kung-Flu" from the crowd. When explained as the Chinese virus or Kung-Flu, users of this phrase often claim that it is merely due to its origination in Wuhan; however, when one delves deeper into this matter, we can look back at examples such as the Spanish flu to understand why it is so inappropriate. When H1N1 started to be called the Spanish Flu, its meaning was largely political and had hidden biases. Though it was not clear that the virus stemmed from Spain, this name made the Spanish people sustain the burden of the effects of the virus, but economic and political. Further, phrases like "Kung-Flu" become not a geographical issue as the president says, but an attack on

Chinese American heritage as a whole.

This only proves that racism against Asian-Americans are not a thing of the past, rather, it is an issue which the country must come together to oppose. When the president makes an obviously racially charged remark, it is the duty of political leaders, democrat and republican alike, to criticize his actions. The status quo of the party now defending his words after the president's own counselor Kellyanne Conway had just deemed the phrase offensive not long ago is not acceptable.

For the country to move in a direction of equality, acceptance, and tolerance, speech like this ought to be condemned in any circumstance. For countless years, Kung-Fu has been almost a key symbol of Chinese society and attaching that especially important emblem to a pandemic only divides the country even further.

Today, it is important to understand a disease is not an issue of race, ethnicity, or even culture, but is a societal issue that the world must come together to defeat.

Arcadia Unified Secures \$5.7 Million in Taxpayer Savings

ARCADIA - In a year filled with unfavorable financial figures for many, the Arcadia Unified School District has secured \$5.7 million in silver-lining savings for Arcadia taxpayers. Capitalizing on low interest rates and the district's exceptional credit rating, Arcadia Unified took action to refinance its current bonds and once again created savings for taxpayers.

"With interest rates falling to historic lows, we were grateful to use this opportunity to create savings for our taxpayers while also being able to get more than we planned for out of these bond dollars," said Arcadia Unified Superintendent of Business Services Dierk Esseln, who heads the district's business and fiscal services teams.

Arcadia Unified's refinanced bonds are those from Measure I, which was originally passed by Arcadia voters in November 2006. Measure I, or the Arcadia Neighborhood Schools, Health, Safety and Repair Measure, authorized \$218 million of general obligation bonds to be spent solely for the improvement and modernization of Arcadia Unified's schools, classrooms, and facilities.

To date, every project on the district's original capital improvement list has been completed, with every Arcadia Unified

school receiving upgrades to classrooms and campuses. Upgrades have included improved technology and renovations in every classroom in the district; increased safety features, such as additional security lighting and fencing; landscaping and sidewalk repairs; new phone and master bell systems; the Arcadia Performing Arts Center; improved utility and power infrastructure; new library and media centers; electronic marquees at every school; enhanced student support and services facilities; and several additional needed restorations and repairs district-wide.

"Our theme for this school year is 'opportunity'," shared Arcadia Unified Superintendent Dr. David Vannasdall. "While this year has been rough on us all for many reasons, we are doing our very best to find all of the opportunities we can to help make the most of this time, and this is a prime example of that."

While low interest rates started the refinance conversation, a key component to the district's ability to take advantage of the low rates is its high credit rating, explained Assistant Superintendent Esseln, who advised that an integral part of the refinance process involved a review of the district's credit rating by two industry-leading credit rating agencies, S&P Global Ratings (S&P) and

Moody's Investors Service (Moody's).

S&P and Moody's affirmed the district's bond ratings of AA and Aa1, respectively, citing reasons for the exemplary ratings as Arcadia Unified's prudent fiscal practices and strong financial position with healthy reserves. Of California school districts that have issued rated bonds so far this year, only 27% received as high a rating from S&P and only 10% received as high a rating from Moody's, according to the district's bond refinance report.

Arcadia Unified had the same superior credit rating when it underwent a similar bond refinance of Measure I bonds in 2017. which resulted in taxpayer savings of over \$80 million.

Another positive result of Arcadia Unified's exceptional bond rating, coupled with a competitive bidding environment and cost management, was a gain of over \$260k in more funds for district facilities modernization than budgeted. Projects that will be worked on with these additional funds include, but are not limited to, upgrades to technology network cabling; district-wide playground, field shade structures, lighting, and building controls; modernization for the kitchens and locker rooms of each of the district's middle schools; a Stagecraft Building to complement the Arcadia Performing Arts Center; and updates to Arcadia High's locker rooms, stadium field rooms, and weight room.

In addition to its sound fiscal practices, Arcadia Unified was recently named in the top 1% best school districts in the nation, according to Niche. Arcadia Unified has also achieved the rare feat of being named to the prestigious AP® District Honor Roll in consecutive years for 2017 and 2018. Likewise, each Arcadia Unified elementary and middle school has been recognized over the years as California Distinguished Schools by the California Department of Education. How COVID-19 Has Changed How to Shop for a Medicare **The Way We Do Business Forever Plan from Home**



The COVID-19 pandemic has fundamentally changed how business gets done. And when it comes to midsized and small businesses, the importance of investing in new technology, facilitating remote work and maintaining a tech-savvy workforce has never been so clear, according to a new survey.

Conducted by The Harris Poll for CIT Group Inc., a leading national bank focused on empowering businesses and personal savers, the survey of leaders of U.S. middle-market and small businesses is designed to illuminate the intersection of technology and talent.

Compared to last year's survey, significantly more leaders today believe continuous technological investment is a business requirement.

"The resiliency and flexibility that technology can deliver businesses has been convincingly proven by COVID-19," says David Harnisch, president of CIT's Commercial Finance division. "Business leaders have taken that lesson to heart and are focused on making technology a fundamental part of their 'tomorrow thinking'.'

Most executives surveyed wish that they'd invested even more in technology over the past 12 months. In fact, more than three in four middle market executives believe investments in technology would have helped their company fare better during the pandemic. For small businesses, roughly half felt similarly.

However, there's little question how important technology will be going forward, with the majority of respondents saying it's crucial to future success.

Seemingly determined not to repeat the mistake of under-investing, the majority plan to invest as much or more in their business over the next 12 months as compared to the past year. Only 15% of small businesses say they may invest less this coming year, likely due to financial constraints resulting from the pandemic.

"Small businesses don't always have the financial resources that larger enterprises often enjoy," says Ken Martin, managing director of CIT's Small Business Solutions group. "When investments are imperative, borrowing or leasing may be the right solution to acquiring the technology needed to remain competitive."

When it comes to these upgrades, investments that make it easier for employees to work remotely are a clear priority. Over the next 12 months, 71% of middle market executives and 31% of small business leaders

who plan to invest will spend on technology that facilitates remote work.

"It's not just a matter of convenience. Businesses that empower employees to work remotely have a clear competitive advantage," says Denise Menelly, CIT's executive vice president and head of Technology and Operations.

This is a trend that's likely here to stay. Approximately a quarter of small businesses operating remotely expect -- and want -- these changes to remain permanent after COVID-19 subsides, and about 40% of middle market executives expect the same, with some seeing it as a means to grow the company.

However, this digital transformation puts a premium on a techsavvy workforce able to support customers and collaborate with colleagues remotely. While many believe their current workforce has the skills to keep up, businesses are also substantially more likely than last year to say companies need to focus on hiring tech-savvy talent.

While the COVID-19 pandemic has created a great deal of uncertainty for small and midsized businesses, it has in many ways clarified what's needed to remain successful in an evolving world. (StatePoint)

Review changes. In late September, health plans send their MA customers a document called the Annual Notice of Change (ANOC) with information about costs, benefits, available doctors and facilities for the upcoming year. Check this document to see if anything in your plan will change.

Weigh extras. Pay attention to extra benefits not available with Original Medicare but which may be built into an MA plan at no additional cost, such as dental, vision, transportation or even an allowance for purchasing certain over-the-counter items. In these times, you might be especially interested in benefits that help you stay healthy while safe at home, such as telehealth, prescription drug delivery and inhome fitness programs.

Know your network. Beyond cost, make sure the plan's net-



Consider costs. To estimate total costs, first, know the plan's premium or monthly cost. Second, check for out-of-pocket costs, including copays and deductibles on doctor and hospital visits and prescription drugs. Finally, check to see what the cost will be if you need to see a specialist. In some plans, you pay more for going outside your network.

Don't forget prevention. Many MA plans cover preventive health screenings beyond those covered by Original Medicare. Talk to your doctor about which screenings are important for you given your age and health status. Employers, promote teleworking when possible to reduce workplace exposures to COVID-19



Employed adults who tested positive for COVID-19 were almost twice as likely to report regularly going to a workplace* than those who tested negative

When telework isn't possible, implementing worker safety measures can help protect employees and the community
