**GLENDORA** - Around two hundred people gathered last week to rally for an end to abortion in Glendora and across the country. Participants, standing outside the Planned Parenthood at the corner of Route 66 and Glendora Avenue, held signs, prayed, and sang.



Connie Murphy, a rally participant, said that she hoped "for an end to abortion and for the Planned Parenthood employees and their prospective clients to become totally aware of the consequences of their actions."

"Women have cried in my arms, grieving over the abortion they had years before," said Catherine Contreras, another participant. "Other women and teens girls have shared with me their fear and concerns with continuing their pregnancy, and their relief knowing they were not alone in their journey - that we will help them. We know that being pro-life means being prowoman. There is so much help available."

"We know from testimony of women who were seeking an abortion and saw people praying outside, that they chose life, seeing it as a sign of hope or a message from God that they weren't alone," said Contreras, who is the founder of Vox Vitae, an organization dedicated to raising up teens and families to be "voices for life."



### **Suspect Crashes Car and Eludes Police, But Forgets His Gun in the Vehicle**

COVINA - On Saturday morning, October 17th, just after 1:00 AM, Covina police officers noticed a vehicle with blacked out windows. Officers attempted a traffic stop so as to inform the driver that the windows of the vehicle are too dark and would need to be addressed. If anything, the driver would be given a warning or possible a fix-it citation.

When the officers attempted to stop the car, it took off from the area of Azusa and Arrow Highway. It headed north on Azusa into the city of Azusa. The driver took to the side streets at excessive speeds. The driver has already run red lights and was running stop signs.

At one point, the vehicle was traveling so fast it hit a dip at Louise Ave and Paramount Street and went airborne. The driver lost control and disabled his vehicle when he went up over the curb flattening two tires. At that time, the driver got out and ran from the vehicle, however he forgot to take his Glock pistol and two loaded magazines, one of which was an extended magazine.

The police set up a containment area, brought in a K-9 and helicopter to assist in finding the suspect. However, it appeared that the suspect was able to get out of the containment area and was not located.

Police recovered the weapon and it will be checked for finger-



### LOS ANGEI LES COUN **Watchdog Agencies Release Initial Analysis of Skilled Nursing Homes**

LOSANGELES COUNTY -The Inspector General and Auditor-Controller each released their initial report detailing their ongoing investigation into skilled nursing homes. Supervisor Mark Ridley-Thomas called it a critical first step towards improving operations at these facilities, which have accounted for about 42 percent of Los Angeles County's COVID-19 death toll

"We still have a lot of work to do, but the Inspector General and Auditor-Controller's reports provide us with a starting point for tackling complex and deeply-entrenched problems that have plagued skilled nursing homes for decades," said Supervisor Ridley-Thomas, who is scheduled tomorrow to bring 20,000 donated N95 masks, a decontamination kit, and mobile COVID-19 testing to skilled nursing homes and their employees. "We are undertaking the due diligence required to develop long-term solutions for improving the quality of care at skilled nursing homes while simultaneously tak-

ing timely steps to promote the ongoing safety of both patients and staff."

Overseen by the State of California but regulated locally by the LA County Department of Public Health (DPH), skilled nursing homes have been the epicenter of the pandemic in LA County, with about 16,000 infections and 2,500 deaths among patients and staff. In May, the Board of Supervisors approved Supervisor Ridley-Thomas and Chair Kathryn Barger's motion directing LA County's Inspector General to investigate skilled nursing homes for the first time. They also tasked LA County's Auditor Controller with monitoring the facilities and creating a public dashboard showing their COVID-19 case totals, testing frequency, mitigation plan status, personal protective equipment supply and other information. The dashboard went live last month.

In his first interim report back to the Board, Inspector General Max Huntsman examined skilled nursing homes' COVID-19 mitigation efforts and provided an overview of existing regulatory and oversight structures. He said subsequent reports will analyze the long-standing, complex issues that left many skilled nursing homes ill-prepared to prevent and control the rapid spread of COVID-19 and the systemic failures that have allowed substandard conditions to persist.

"My office is conducting an exhaustive review of barriers to adequate care that have, in many instances, left nursing home residents neglected and abused," Inspector General Max Huntsman said. "Our County's most vulnerable residents deserve better, and we are committed to identifying and recommending all reforms necessary to give them the care they need. The pandemic has exacerbated systemic problems, and we need immediate responses and long-term solutions."

After posting the skilled nursing homes dashboard in September, Auditor Controller Arlene Barrera released her own first interim report, which pointed out the number of outstanding investigations into skilled nursing facilities. She noted that in addition to 5,407 open investigations, DPH's Health Facilities Inspection Division (HFID) reported an additional 6,228 in-progress investigations related to other long-term care and short-term care health care facilities.

The Auditor Controller also confirmed that as of June 30th, HFID reported 10% of the 5,407 in-progress investigations had been prioritized at the level of "Immediate Jeopardy," because the facility's alleged non-compliance with one or more requirements has caused, or is likely to cause, serious injury, harm, impairment, or death to a resident.

Upcoming reports by the Inspector General and Auditor Controller are expected to include recommendations for addressing this backlog and for streamlining the process.

### **Habitual Felon Arrested** for Attempted Murder of Ex-Girlfriend

AZUSA - Back on Sunday, October 4 at 2:40 AM, Azusa police responded to the area of the 900 Block of W. Foothill Blvd., believed to be at the Foothill Apartments.

They found a victim, a woman who had been repeatedly stabbed as many as eight times and in critical conditions. The unidentified victim is the ex-girlfriend of the suspect who was identified as Octivio Easu Perez. A full-blown search and investigation was launched for the suspect by the Azusa Police Department. They got a tip on his location and raided that location and arrested the suspect on Wednesday, October 14th. Azusa Police detectives secured the arrest and bail was set for \$1,000,000.00 and he was charged with attempted murder. His next court date is November 10th 2020.

The woman is still recovering. Back on March 3, 2020, Perez was convicted of a felony and given 6 months and served about 2 months, then released only to attempt to murder a woman.

On December 29th, 2019 he was convicted of a felony and was given 5 months and served 1 month.

Los Angeles County Supervisor Hilda Solis and Los Angeles County Registrar-Recorder/ County Clerk Dean C. Logan responded to an incident Sunday night where a Vote by Mail Drop Box located outside the Baldwin Park Library on Baldwin Park Boulevard was damaged by fire. The incident is being investigated as arson.

The Los Angeles County Registrar's office immediately requested an investigation through local law enforcement and has reported the incident both to the FBI and the Attorney General for investigation and to obtain all available footage to determine the cause of the fire.

The Registrar's office has acquired and is reviewing all material collected to determine the appropriate notifications to voters whose ballots may have been impacted and will ensure they can exercise their fundamental right

"The arson of an official ballot drop box by the Baldwin Park Library in the First District has all the signs of an attempt to disenfranchise voters and call into question the security of our elections," said Los Angeles County Supervisor Hilda L. Solis. "Tampering, or attempts to tamper, with our democracy will not be tolerated. Rest assured, LA County residents' voices will be heard when they vote, including in this election. Every lawful ballot will be counted, and residents can register to vote by today's deadline at LAVote.net. Voters can call the County Registrar-Recorder/County Clerk if they submitted their ballot at the Baldwin Park Library Dropbox to verify their ballot was received and take any remedial measures."

New Workforce Partnership with the Los Angeles Cleantech Incubator Addresses PPE Shortage and Youth Unemployment During Historic Pandemic

LOSANGELES COUNTY-The Los Angeles County Department of Workforce Development, Aging, and Community Services (WDACS), in partnership with Goodwill Southern California and the City of Baldwin Park, launched an innovative collaboration with the Los Angeles Cleantech Incubator (LACI) to provide personal protective equipment (PPE) to essential healthcare workers. This partnership began on August 24, 2020. Through Los Angeles County's Youth@Work Program, youth aged 14 - 24 assemble face shields.

Face shield materials are created with high tech 3D printers, assembled by youth workers, then donated to hospitals across

an educational series introducing youth to career opportunities in cleantech, including project management, industrial manufacturing and industrial design.

Youth@Work places LA County youth in a paid job that leads to a long-term career pathway in high-growth in-demand industries. LACI unlocks innovation through startups, transforms markets with partnerships, and enhances community to create an inclusive green economy. This program is part of the LA County Works Initiative to train our workforce to get back to full employment.

"This partnership helps to address PPE shortage and youth unemployment" said Otto Solórzano, the Acting Director of WDACS. "We are helping health-

"Our advanced prototyping center has produced tens of thousands of face shields for essential workers while at the same time continuing to train LA's future workforce. This work has been crucial to LACI's mission and we are grateful to our partners for making this happen together."

## **Trader Joe's Robbed**



### **Glendora Police Department Awarded Traffic Education and Enforcement** Grant from the Office of Traffic Safety

GLENDORA - Glendora Po-

lice Department received an \$80,500.00 grant from the California Office of Traffic Safety (OTS) for a one-year enforcement and education program. The money will fund various activities intended to reduce deaths and injuries on California roads.

"We extend our gratitude to the Office of Traffic and Safety for their continued support of our effort in providing public awareness in preventing traffic related injuries and deaths." said Glendora Police Chief Matthew Egan.

The grant-related activities are for the 2020 federal fiscal year, which runs from Oct. 1, 2020 to Sept. 30, 2021.

The funding from the OTS will be used for numerous programs, including:

• DUI/driver's license checkpoints.

• Patrols specifically looking for suspected alcohol and/or drug-impaired drivers.

• Patrols targeting violations of California's hands-free cell phone law and vehicle code violations by drivers, motorcyclists, bicyclists, and pedestrians that put other roadway users at risk.

• Patrols targeting the primary causes of crashes: Speeding, improper turns, running stop signs or signals, right-of-way violations and driving on the wrong

side of the road. • Patrols specifically looking for seat belt and child safety seat

violations. • Traffic safety education presentations for youth and community members on distracted and impaired driving, bicycle and pedestrian safety.

• Serving warrants to multiple DUI offenders.

· A statewide prosecutor training network for managing DUI cases and treatment programs for DUI offenders.

• Officer training to identify

suspected impaired drivers and conduct sobriety tests. "The funding will go toward

efforts aimed at preventing deaths and serious injuries on our roadways," OTS Director Barbara Rooney said. "Our road safety problems are clear. We must work toward improving roadway safety for everyone by changing behaviors to ensure every person, regardless of how they travel, goes safely."

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

### **Another Azusa Brush Fire**

AZUSA - Los Angeles County Firefighters responded to a brush fire Friday Morning October 15th on the border of Duarte and Azusa at the end of Encanto Parkway. This isn't far from the old shooting range. This is also the same area of the Vulcan Material Company mining area.

When firefighters arrived, they reassessed the situation from a full brush fire response which was originally requested with Air Units and bulldozers,

to a ground control operation. The Air Units and the bulldozers were cancelled.

The fire was contained to about 3,000 square feet and was extinguished in a short time and the fire crew stayed on scene in the event of any hotspots or flare-ups.

### Four R's in a Glendora Education

I come from a background that always talked about standards and basics in education being the three R's - reading, writing and arithmetic. Obviously, not a group well-versed in language or award winners in spelling bees but definitely vocal about keeping the basics in education.

Glendora Unified School District has decided to add another R -- something called the RISE Program, an acronym standing for Race, Inclusion, Social Justice, and Equity. All I know of Glendora and most places I go, support the philosophy being promoted with this acronym with no need for a program.

Having worked in a local school district, the first thing that pops into my head when someone says "new program" is how much will it cost and how much is it really needed? School districts I am familiar with have been under the financial gun for a while and are struggling to make ends meet today. Schools in our area are suffering from declining enrollment which affects ADA (average daily attendance) the basis for their budget. No legislator has yet come up with a way to fully fund education without counting each and every head, every day, in each school and then issuing funds based on that head count. Fewer students, fewer dollars. And add in, or subtract out, more dollars to districts with students requiring additional services.

Those in Glendora who want to understand and discuss the need for RISE in GUSD, are told:

"As a response to an outcry from our students and staff to address issues of race and diversity following the George Floyd incident this past spring, the Board of Trustees asked Superintendent DeLeon to begin the work of ensuring every single student from every background thrives in GUSD. Dr. DeLeon and her team created the acronym R.I.S.E. after listing the 4 main areas to be addressed-race, inclusion, social justice and equity. R.I.S.E. is not and never has been affiliated with any group or curriculum found on the internet."

To site a far-away, disconnect-

while disavowing any connection to Black Lives Matter (BLM) and other organizations involved in the protests because of that death makes it difficult for me to understand why this program would be necessary. I am not aware of any police discrimination or excessive force issues in Glendora, or adjacent police departments, creating any hardships in the education system. I am open to explanation and correction but it seems to me the political, socio-economic and some discrimination issues from other areas have been pulled out to create the basis for a program I don't see supported by this community and especially the parents of students in Glendora School District.

Best intentions sometimes have repercussions like the 2016 bill, AB 2016, signed into law by former Governor Jerry Brown. The Senate analysis of that bill concluded it was unnecessary and redundant because the Instructional Quality Commission (IQC) was revising the History-Social Science Framework, that included ethnic studies courses. Envisioned by the legislators was a course that would teach "the history, politics, culture, contributions, challenges and current status of ethnic groups in the United States ... preparing California's ethnically diverse student population to become global citizens."

Forward to March 2020, the San Francisco Chronicle reported in the most ethnically diverse state with 92 languages spoken, the IQC had come out with a draft model curriculum focusing on "four core groups" -- African, ed incident like the George Asian, Mexican/Latino and Na-Floyd death as a reason to imple- tive Americans. Additionally, the ment this program in Glendora, draft "sharply diverged from the

politically neutral AB 2016 [to] partisan political agendas and activism - for instance equating capitalism with racism, lionizing "revolutionary" warriors, and advocating for student engagement in "tactics of resistance" and "direct action" such as protests against police brutality and anti-Israel boycotts."

The Board of Education received 20,000 public comments, 19,000 were critical of the draft with thousands from outraged ethnic groups not included in the new curriculum. Angry legislators that supported AB 2016 called the draft "a setback" in need of revision; and, the Board of Education said most of the draft will remain unchanged and used in California classrooms. And perhaps, as the Senate Analysis reported, without additional funding for the cost of this new course.

As currently proposed, the RISE Coalition will be made up of students, staff and interested community members who will meet monthly to design a Framework for Change defined as:

· Identifying core values and beliefs - self-reflection

· Teaching cultural understanding and modeling mutual respect

• Improving and/or instituting inclusive practices

· Removing barriers to success

· Leveling the playing fieldequitable distribution of resources (both human and fiscal)

· Providing forums for open discourse

· Celebrating diversity, potential, growth and the unique contributions of everyone from every race, religion, gender, ethnic background

Anyone who wants to know who the Glendora School District is and if the students are learning can take a look at the Single Plan for Student Achievement that is called "a blueprint to improve the academic performance of all students ... and to coordinate all educational services at the school." This plan is reviewed by a School Site Council and identifies students by gender, race, ethnicity, grade level, disabilities ... it is a summary of each school's make-up and perfor-




## **How Certain Are Fourth-Quarter Market Gains?**

Investors survived the third quarter, which included September's dismal results. But, how optimistic should we be about the coming historically strongest calendar quarter? Past fourth quarters have usually been filled with positive drama. During the last 20 years, according to Bespoke Investment Group, the Dow Jones Industrials 4th quarter gains have averaged 4.5%! During those same years gains in the first three quarters COMBINED have averaged less than 4%.

The fourth quarter has generally been where annual gains have been solidified. The third quarter is where market doldrums often occur. Over the last 20 years the fourth quarter was the best, and the third quarter was worst. Fourth quarter opportunities seem to be expected. Even going back further, from 1950 through 2017, the first nine months of the year averaged combined gains of +4.53% for the S&P 500, while the final three months averaged +4.05% (according to Stock Trader's Almanac).

There are some technical reasons for this anomaly. During the fourth quarter, when third-quarter earnings are reported, companies start announcing guidance for the coming year. Also, some investors start filling out pension plans before year end. Gift purchase at Christmas also benefit 4th quarter results. It also can't hurt that a more festive spirit is felt around the holidays. Many parts of the economy are now enjoying a positive recovery, with the most damaging Covid-19 restrictions being reduced. Assuming the current pro-business administration continues, a return to a vibrant economy in 2021 looks probable.

The stellar fourth-quarter average market performance over the last 20 years even includes controversial / financially challenged election years of 2000



and 2008. The 24% market drop in the fourth quarter of 2018 also negatively impacted 20-year averages (for the 4th quarter). Big Money generally sells stocks in September and then piles back into stocks just before and after the election, especially when the outcome appears to be clear.

During the chaotic elections of 2000, 2008, and 2016, there was no incumbent. It was a choice between two new candidates, coming after the 8-year terms of Bill Clinton, George W. Bush, and Barack Obama. Since 1950 incumbents running for re-election have won almost every time. Each time an incumbent ran for re-election, we saw full-year market gains – and all but 2012 delivered a positive fourth quarter.

Recent fourth-quarter returns aren't any better (or much worse) than the average +4.05% returns for the fourth quarters from 1950 to 2017 as charted by Stock Trader's Almanac. In presidential election years where young or unproven first-time presidential candidates were running during a recession, like 1960 and 2000, 4th quarter gains did not occur. After the Nixon vs. Kennedy election the market declined -9.3% during that 4th quarter. In 2000, after the Bush vs. Gore election, markets declined -6.2% for the full year and -8.1% in the fourth quarter, possibly more driven by the tech bubble crash than the election. During the most serious contraction in modern times (2008 which in-

cluded the Obama vs. McCain election) markets fell -38.5% for the full year and -22.6% in the fourth quarter. Generally, the market tends to be much calmer in election years with an incumbent running (but that may also be because the incumbent almost always wins reelection).

As for the once-scary preelection month of October, there's not much to fear. 1976, 2012 and 2018 brought us minor declines, while all other Octobers in this list were up slightly or little changed. There also seems to be less uncertainty when an incumbent is running for reelection. Like him or not, any incumbent is a known commodity. Most Presidents have grown into their challenging responsibilities after four years in the pressure cooker.

Even with all of the media politicizing and extreme economic disruption caused by the CCP's Covid-19 driven recession, 2020th fourth quarter could follow past positive trends. President Trump has not only shown definitive action steps as a leader, he has driven the left-wing radicals crazy with his America first results. Most patriotic Americans also recognize that it is critical to reelect Donald Trump for four more years. Antifa riots and the Chinese Communist Party's anti-America efforts have not gone unnoticed by most USA patriots. *I've been getting SO MANY* phone calls and so much mail about enrolling in various Medicare Supplement and Prescription drug programs. How can I know if these guys are for real or if they are fakes?

If you suspect that you are being taken advantage of, have questions about an insurance offer, scheme, or agent, call the Dept. of Insurance 1-800-927-4357, or go to www.insurance.ca.gov Open enrollment is from October 1 to December 7, 2020. Here are some tips: 1. Make sure the person is a licensed insurance agent. 2. Don't accept uninvited sales calls of any kind. 3. Never give out personal information (Medicare Card number, Social Security number, bank account numbers, or credit card information over the phone. 4. Be aware: Medicare has no official sales reps. 5. Federal regulations prohibit marketing of Medicare products wherever healthcare is delivered. 6. Federal regulations prohibit offering free meals for listening to a sales presentation or for signing up in a particular plan. 7. Federal regulations prohibit selling additional insurance products during any sales or marketing presentation for a Medicare Advantage or prescription drug plan. 8. Read and understand the plan.

My sister just entered a rebab/nursing home center to get her strength back and get some rehab from having a mild stroke. Now she's being told that if she had spent 3 days in a hospital first, followed by the

doctor's orders to go to a rehab/ nursing home, Medicare would pay up to 80-percent of the bill. However, since she didn't have a hospital stay, Medicare will pay nothing. She's also a veteran, but never got her VA card. Is there anything we can do now?

Her medical doctor should be fully aware of the 3-day-hospitalization rule; talk to him about the situation. As far as getting her VA Medical Card, she needs to find out the location of her local VA office (often at a VA hospital), make an appointment, present her 214 Discharge papers, and fill out an application. Also make an appointment with a VA patient advocate.

#### Can I take money from my annuity to help a relative?

It depends on the rules in your annuity policy. You can contact your agent, or the annuity company to ask them the particulars about your policy. Some policies allow you to take out up to 10% per year after the first year (up to a pre-set amount of your ini-

tial investment), waiving the usual early-withdrawal contractual penalties and fees. AARP recently stated that annuities can be great, but can also be a nightmare. Annuities are great, and only become a nightmare if you do not follow the policy's rules. The most common mistake heirs make is to cash out an inherited annuity, sometimes losing thousands of dollars.

Last year we had to pay capital gains on our mutual fund's distributions. Is there a way to decrease the amount of capital gains tax we must pay?

With investments like mutual funds, stocks, CDs, and savings, your earnings are taxed annually. You might want to consider moving at least some of your mutual fund's dollars to a tax-deferred investment, or to an insurance product. With a tax-deferred investment, you'll pay taxes only when you withdraw funds. Some insurance products offer "loans" which are not taxable, and which could be re-paid from the death benefit.

### **State's Response to Wildfires**

**SACRAMENTO** – Gover- Declaration to bolster the state's nor Gavin Newsom announced that the President has approved California's request for a Major Disaster Declaration to bolster the state's emergency response to wildfires across the state and support impacted residents in Fresno, Los Angeles, Madera, Mendocino, San Bernardino, San Diego and Siskiyou counties.

"Just got off the phone with President Trump who has approved our Major Disaster Declaration request. Grateful for his quick response," said Governor Newsom.

A Presidential Major Disaster Declaration helps people in the impacted counties through eligibility for support including crisis counseling, housing and unemployment assistance and legal services. It also provides federal assistance to help state, tribal and local governments fund emergency response, recovery and protective measures.

California previously secured a Presidential Major Disaster

emergency response to the Northern California wildfires as well as Fire Management Assistance Grants from the Federal Emergency Management Agency to support the state's ongoing response to fires burning across the state. Governor Newsom has declared a statewide emergency due to the widespread fires and extreme weather conditions and signed an executive order to streamline recovery efforts in communities impacted by the devastating fires. The Governor last month signed a package of bills to improve the state's emergency preparedness and response efforts, support wildfire survivors and safeguard communities in high fire hazard areas.

With another dangerous wildfire season underway amid the ongoing pandemic, the state is hiring 858 more firefighters and six California Conservation Corps crews to bolster firefighting support. California has tak-

en major action and made critical investments to fortify wildfire preparedness and response capabilities since the Governor took office. CAL FIRE completed the last of its 35 emergency fuels management projects in May, making 90,000 acres safer ahead of wildfire season and protecting 200 vulnerable communities.

Major investments include augmenting the CAL FIRE air fleet with new FIREHAWK S-70i helicopters and C-130 airplanes, and bolstering firefighting surge capacity and pre-positioning capabilities. The state also launched an Innovation Procurement Sprint to develop early warning technologies and place fire detection cameras across the state. This year's budget included \$85.6 million in new, ongoing dollars to fund permanent firefighting positions, and continues the funding for CAL FIRE to procure innovative technology that allows us to model fire behavior.
