L.A. County Leading Unprecedented Rapid Expansion Of **Interim Housing System To Prevent Spread Of COVID-19**

LOS ANGELES COUNTY -

The Los Angeles County Homeless Initiative, the Los Angeles Homeless Services Authority (LAHSA) and a network of service providers for people experiencing homelessness are leading the rapid expansion of its interim shelter system in a massive public health effort that aims to bring as many people as possible inside to protect their health and prevent the spread of COVID-19.

As part of this work, the County will use state and federal funding with the goal of securing 15,000 hotel and motel rooms that will operate as temporary shelters as a prevention measure for highly vulnerable seniors and those suffering from chronic illness. This includes people experiencing homelessness who are over 65 years old, or who have an underlying health condition, and who do not currently have symptoms but are at high-risk for hospitalization if they contract the virus.

The first hotel site of this effort, dubbed Project Roomkey, opened on April 3 in Los Angeles. A total of 1,069 beds at 15 sites are targeted to be operational by the end of this week.

Los Angeles County, LAHSA and the City of Los Angeles have collectively allocated \$39.3 million in state emergency homeless

"Project Roomkey is part of Los Angeles County's multipronged effort to bring the most vulnerable in our community indoors. I am grateful for the collaboration with our state, federal and private sector partners to find critical housing solutions that will prevent the COVID-19 virus spread and help flatten the curve," said Supervisor Kathryn Barger, Chair of the Los Angeles County Board of Supervisors.

funding for Project Roomkey.

"Individuals experiencing homelessness often lack a safe

space to self-isolate or practice physical distancing," said Los Angeles County Supervisor Hilda L. Solis. "In addition, the unsheltered homeless population is particularly vulnerable to COV-ID-19 because many are older and/or have a higher burden of cardiopulmonary and immunocompromising conditions. By providing our unsheltered neighbors a place of their own, we can slow the spread of COVID-19 among those experiencing homelessness and protect them from exposure to the virus. Through Project Roomkey, federal agencies, the State, LA County, local cities, the Los Angeles Homeless Services Authority, and private sector partners will make sure no one is forgotten during this public health crisis."

"LAHSA is proud to step forward at this historic moment to bring together the resources of Los Angeles' homeless services community to provide shelter for thousands of our most vulnerable neighbors through Project Roomkey," said Heidi Marston, interim Executive Director of the Los Angeles Homeless Services Authority (LAHSA). "Our dedicated teams are working around the clock to help preserve the health of all of our housed and unhoused neighbors."

The sites are geographically dispersed throughout the County, in communities including West L.A., San Fernando Valley and Antelope Valley. The locations are not being publicly identified because they are not walkup sites. Guests must be referred by homeless service providers based on eligibility criteria established by the state and federal government.

Project Roomkey is a partnership between several agencies

working together to procure housing solutions quickly and stem the spread of the COVID-19 virus:

• The Los Angeles County Homeless Initiative has partnered with the State of California to procure the hotels and motels.

• The Los Angeles Homeless Services Authority (LAHSA) is leading the efforts to staff and operate the new interim housing sites and has been designated as the lead by the Los Angeles County Emergency Operations Center, which is the coordinating body for disaster response in the

• The Los Angeles County Fire Department is assisting with logistics to quickly stand up the interim housing effort.

• Staffing at the sites will include case management services by homeless service providers and County employees deployed as disaster service workers.

• Clients will have access to health care and behavioral health services from the County.

• The entire effort is supported by FEMA and the State of California, which have allocated funding for the leasing of temporary shelters for people experiencing homelessness throughout the state.

This program is distinct from the County's current effort to provide medical sheltering sites, which designates quarantine and isolation rooms for people who have tested positive for COVID-19, are symptomatic and waiting for test results, or have been exposed to the virus.

Citrus College Delivers N95 Respirator Masks to Local Hospitals

GLENDORA – Citrus College recently donated over 600 N95 respirator masks to area hospitals as part of its ongoing response to the nation's current public health crisis.

On April 21, college personnel delivered masks to Foothill Presbyterian Hospital in Glendora, San Antonio Regional Hospital in Upland, Pomona Valley Hospital Medical Center in Pomona and City of Hope in Duarte. The masks, which were part of the college's emergency supplies inventory, were donated in response to the critical shortage of personal protective equipment affecting those on the front line of this global pandemic.

"Reports show that more and more health care workers are falling ill with COVID-19, while many others are being asked to re-use their masks due

to a scarcity of supplies. When the college realized we had a modest inventory of N95 masks, we knew we needed to do everything we could to get them into the hands of those who desperately need them," said Dr. Geraldine M. Perri, superintendent/president of Citrus College. "As an active community partner, Citrus College has long been committed to meeting the needs of the cities and citizens it serves. Donating these masks is one way we can do so during these challenging times."

Prior to distributing the masks, Citrus College personnel reached out to local hospitals to determine where the need was greatest. Once the recipient list was confirmed, the logistics of delivery were finalized.

"We are pleased that we could provide additional help to our valued health care partners," said Claudette E. Dain, vice president of finance and administrative services at Citrus College. "These hospitals do so much to support our students and our community, so we are happy that we are able to assist them with this donation."

The physical closure of the Citrus College campus took place on March 18, and a limited number of essential employees were granted access to the campus to help facilitate the donation of the masks. The campus will remain closed through June 12, 2020.

"Although California's community colleges have had to drastically adjust the way they operate because of COVID-19, it has been inspirational to see that so many colleges have found ways to provide assistance and relief," said Dr. Patricia A. Rasmussen, president of the Citrus Community College District Board of Trustees. "I am thankful that Citrus College had this opportunity to give back to our partners in the health care field. They have been the true heroes during this crisis and deserve all of our support and gratitude."

Family Caregivers Need to Know

threatens the health of millions in this country and around the world, but the novel coronavirus presents unique challenges for more than 5 million Americans living with Alzheimer's and more than 16 million family members and friends serving as their caregivers.

"Public health strategies aimed at limiting contact with others are nearly impossible for people living with Alzheimer's and other dementias who rely on family caregivers and others to live their daily lives," says Beth Kallmyer, vice president, care and support, Alzheimer's Association. "This reality affects these individuals across all settings, including home, adult day services, residential and assisted living facilities and nursing homes."

To help family caregivers navigate the complex COVID-19 environment, the Alzheimer's Association is offering additional guidance to families, including:

• Foster safe hygiene habits. People living with Alzheimer's and other dementias may forget to wash their hands or follow other precautions to ensure safe hygiene. Caregivers are encouraged to be extra vigilant in helping individuals practice safe hy-

• Monitor sudden or sustained behavior changes. People living with Alzheimer's and other dementias may not be able to communicate if they are feeling bad or showing early symptoms of illness. Caregivers should monitor family members closely and respond quickly to any signs of distress, discomfort or in-

creased confusion. These signs do not necessarily indicate a serious condition like COVID-19, but it's important to determine the underlying cause.

• Prepare for potential changes in care and support. As public health containment strategies for COVID-19 escalate, families need to anticipate that less help may be available. It's important for families to anticipate these changes and make plans for filling gaps in caregiving.

• Be calm and create a nurturing environment. The current COVID-19 pandemic is creating added anxiety for everyone. Do your best to remain calm, particularly in your interactions with family members living with dementia. These individuals often take their cues from the people around them. Creating a calm environment will help them

feel safe and protected. • Play gatekeeper with outside caregivers and guests. Carefully monitor who is coming into the home to ensure all who enter are healthy. Be proactive in asking outside caregivers and guests about their current health status and make sure they are not experiencing any early or recent symptoms of illness.

· Ask residential care facilities about communication policies. To protect the health of residents, many facilities are restricting access to outside visitors. Ask the facility about alternative communication methods during the crisis, including phone calls, video chats or emails. If your family member is unable to engage in calls or video chats, ask the facility how you can connect with staff to get health updates.

For this reason, wearing cloth face coverings when leaving the house for essential activities is more important than ever. These coverings are just the latest addition to a growing tool kit of critical measures including staying home whenever possible, frequently washing hands, and practicing safe physical distanc-

What is a cloth face covering? A cloth face covering is a material that covers the nose and mouth. It can be secured to the head with ties or straps or simply wrapped around the lower

face. It can be made of a variety of materials, such as cotton, silk, or linen. A cloth face covering may be factory-made or sewn by hand, or can be improvised from household items such as scarfs, T-shirts, sweatshirts, or towels.

How well do cloth face coverings work to prevent spread of

There is limited evidence to suggest that use of cloth face coverings by the public during a pandemic could help reduce disease transmission. Their primary role is to reduce the release of infectious particles into the air when someone speaks, coughs, or sneezes, including someone who has COVID-19 but feels well. Cloth face coverings are not a substitute for physical distancing and washing hands and staying home when ill, but they may be helpful when combined with these primary interventions.

When should I wear a cloth face covering?

You may choose to wear a cloth face covering when you must be in public for essential activities, such as shopping at the grocery store. Wearing a cloth face covering does not eliminate the need to physically distance vourself from others.

How should I care for a cloth face covering?

It's a good idea to wash your cloth face covering frequently, ideally after each use, or at least daily. Have a bag or bin to keep cloth face coverings in until they can be laundered with detergent and hot water and dried on a hot cycle. If you must re-wear your cloth face covering before washing, wash your hands immediately after putting it back on and avoid touching your face. Discard cloth face coverings that:

- No longer cover the nose and
- · Have stretched out or damaged ties or straps
- Cannot stay on the face · Have holes or tears in the
- fabric

If you are already using cloth face coverings while out and about, thank you for taking this step to slow the spread of COVID-19. If you aren't, help us save lives by doing so.

- Los Angeles County Chief like any we've ever faced be-Executive Officer Sachi A. Hamai has released the County's 2020-21 recommended budget, a \$35.5 billion spending plan expected to undergo extensive changes in the months ahead as revenues decline and costs rise due to the COVID-19 emergency.

The County expects an estimated \$1 billion drop in revenues as it concludes the current fiscal year, and anticipates an additional \$1 billion-plus revenue decline in 2020-21. Those shortfalls, combined with increased spending to respond to the unprecedented COVID-19 crisis, will shape the budget as it makes its way through a months-long process with the adoption of the budget by the end of June 2020 and concluding with the final budget scheduled for the end of September 2020.

In fact, all recommendations in the proposed budget are likely to be reconsidered, given the deep uncertainties ahead.

"We are hoping for the best but preparing for the worst as we chart the course ahead," Hamai said. "As always, we will prioritize vital services to the public and our essential role as the safety net for our most vulnerable residents."

In anticipation of the economic challenges ahead, the Board has already imposed hard freezes on hiring and purchasing and has directed County department heads to prepare for a range of potential program reductions in the coming fiscal

In order to close out the current 2019-20 budget year on June 30, the County will draw on one-time reserves and disciplined spending unless federal stimulus funding becomes available.

It will also close out the fiscal year with a cash balance of \$196 million—a decrease of \$950 million from the \$1.146 billion that had been projected as the closing balance before the COVID-19 crisis hit.

Responding to such drastic revenue decreases here and nationwide, Los Angeles County has joined with the National Association of Counties and other partners to advocate full FEMA reimbursement of COV-ID-19 expenses, and to enable municipalities to use funding from the Coronavirus Aid, Relief, and Economic Security Act, known as the CARES Act, to offset revenue losses.

Los Angeles County Waives **Adoption Fees for All Animals**

LOS ANGELES COUNTY -The Los Angeles County Department of Animal Care and Control (DACC) is currently waiving adoption fees at all seven animal care centers in an effort to quickly place animals in homes during the COVID-19 crisis. The fee waived adoptions are possible thanks to an \$80,000 grant DACC was awarded from the Petco Foundation to support life-saving efforts for Los Ange-

les County animals.

In addition to the fee waived adoptions, the Petco Foundation investment will enable DACC to undertake a variety of other lifesaving measures including purchasing necessary medical equipment and partnering with veterinary partners to provide pets in DACC care extensive medical treatment beyond the regular capacity of our medical program.

"We are grateful for the Petco Foundation's generous support to help animals during the COVID-19 crisis," said DACC Director Marcia Mayeda. "Because people are adhering to the Safer at Home requirements, many can devote time to a new pet. This generous grant from Petco Foundation makes it easier for families to make that decision at this time." County Fire Department Delivers Safety Messages As Temperatures Increase And Wildfire Season Approaches

LOS ANGELES COUNTY -Over the last couple of weeks, the Los Angeles County Fire Department (LACoFD) has seen a concerning surge in home fires across the County. As residents continue to follow the Safer At Home Order, L.A. County encourages families to be mindful of fire hazards at home, and to practice fire escape safety steps with family members and loved

"In home fires, a properly-prepared and maintained window, clear of obstacles, may provide the quickest, safest way out," stated Los Angeles County Fire Chief Daryl L. Osby. "In the event of a fire, crawling low in the smoke and trying to find your way to the front door isn't the most effective way to escape, because residential fires often originate in the living room or kitchen where these doors are located. Now is the time to speak with all family members and individuals living at home about how to stay safe from home fires."

LACoFD has also recently released a new family-friendly fire safety tool, named the Family Instructions for Rapid Escape (FIRE) guide, and an accompanying coloring book. Both are available at no cost and can be downloaded from LACoFD's website, fire.lacounty.gov.

The FIRE guide walks families through simple steps to ensure a fire-safe home, and teaches new strategies to safely escape if a fire strikes at home. LACoFD asks that residents make sure they have working smoke detectors and carbon monoxide detectors on each level of their home.

Additionally, with warmer weather approaching, wildfire season is also coming soon to L.A. County. LACoFD is planning for wildfires and looking at what the wildland season may look like during the COVID-19 pandemic. For residents who live in a wildland interface area, now is a good time to:

 Clear leaves and other debris from roofs, gutters, and decks.

• Remove flammable materials like firewood stacks and low hanging trees around your roof to create a defensible space around

• Prepare your family's "Ready, Set, Go!" wildfire action

• Look at ways to "Harden your Home," by protecting vents near eaves and consider installing double-pane windows. Please make sure your address is visible to firefighters.

Additionally, as the weather heats up, the County wants to highlight the importance of water safety for families who own or access swimming pools:

• Never take your eyes off a child that is near or in a swimming pool; children can "drown without a sound."

• Don't rely on fences or bar-

riers and inflatable devices for safety in a swimming pool. Even if your child has had

swimming lessons, they are still at risk for drowning; nothing substitutes adult supervision.

• Learn CPR, you never know when you might need this lifesaving skill.



Project Roomkey: Remedy or Slick, Quick Fix

The residents of Covina and West Covina came out in force to challenge the placement of atrisk homeless persons in our East San Gabriel Valley hotels and motels. Nothing is known about these placements ... where they came from, what their problems are making them at risk and why they are homeless. What fueled the protests was circumventing our city governments in what appears to be an end run just to get the homeless off the streets.

It is not just those cities. Laguna Woods, Laguna Hills, Lawndale, Bell Gardens object also. Newsom charged those cities, and others blocking Project Roomkey to get homeless off the streets, with the "not in my backyard syndrome." That was the same charge when cities refused to roll over on allowing high density housing projects along rail lines and high traffic corridors with no environmental review and ignoring local zoning ordinances to meet Newsom's quest for 3.5 million new housing units.

We have 150,000 homeless individuals in California with the largest numbers in San Francisco and Los Angeles. On March 18th Gov. Newsom issued an Emergency Order providing a list of 950 hotels in 53 counties that were declared "eligible" to participate in the state's leasing program to house those homeless. I didn't find any standards making those "eligible" other than vacant

On April 18th, Newsom announced, "State effort has secured 10,974 hotel and motel rooms and 1,133 trailers for extremely vulnerable individuals experiencing homelessness, to help flatten the curve and preserve hospital capacity ... State negotiated a master agreement template with Motel 6 which counties can now use to access these facilities for Project Roomkey" That could provide an additional 5,000 more beds involving 47 motels. Governor's words outside a Motel 6 in Silicon Valley, '...we have an agreement and this motel will be "repurposed for the homeless."

I've not seen those contracts, but one source says the Motel 6 housing for the homeless contracts would allow local governments to convert those properties into permanent housing. Perhaps that is what "repurposing"

The press release goes on to say, "These Project Roomkey placements are spread across 42 counties and are already providing safe shelter to people experiencing homelessness, with 4,211 rooms occupied. The counties are responsible for identifying which individuals need a Project Roomkey placement, and then moving those individuals into the rooms." By placing the responsibility on the counties, it also provides "safe shelter" to Gov. Newsom and the Sacramento leadership.

The 1,133 travel trailers from FEMA and private vendors means they are temporary shelter and are "... to provide quarantine capacity - moving people out of shelters and into isolation placements, focused on people with COVID-19 or those demonstrating symptoms."

Judge David Carter negotiated out an agreement to settle a lawsuit filed by L.A. Alliance for Human Rights to get the homeless off the streets and into safe quarters reducing their exposure to COVID 19. It sounds more like pushing an agreement to a decision that had already been made by placing as many homeless into hotels and motels as could be made to happen. While they are negotiating quarters for the homeless on the streets in that court room, L.A. County District Attorney, Jackie Lacey, revealed a potential to release another 2,000 from L.A. County jail. And as always, we are promised they would be non-violent, non-serious, non-sexual. Any more releases must be substantiated they have a place to go - a home, a house - not land on the street in a tent.

Let's walk back a few years to

2011 and the Supreme Court ruling requiring California to reduce prison capacity from 180% to 137.5% of design capacity. To comply with the order, AB 109 was passed and signed by former Gov. Jerry Brown.

AB 109 shifted responsibility for housing and supervision of non-serious, non-violent, nonsexual offenders to already-full county jails with early releases estimated to be 45,000 criminals back to our streets. When reviewing the criminal history of those early releases, prior felony offenses were not considered. Did those releases all go home and find a job or land on the

Prop 47, Safe Neighborhoods & Schools Act, was submitted to the voters and was passed reducing felonies to misdemeanors. Possession of heroin, cocaine, methamphetamine and shoplifting anything under \$950 became misdemeanors and those already in prison for those offenses could petition for early release. That reduced prison populations by 13,000 as they walked out the door to a home or landing on the streets?

Prop 57, Pubic Safety & Rehabilitation Act, in 2016 was the next effort to empty our prisons. This eliminated direct filing on juveniles and made non-violent offenders already in prison eligible for early parole. Non-violent crimes were listed as hate crimes, assault with a deadly weapon on a peace officer, trafficking a minor, rape by intoxication ... Under Prop 57 laws, how will the prison system determine the release of the next 2,000 non-violent, non-serious, non-sexual releases?

We have the homeless downand-outers, good people, who just have fallen on hard times and need a helping hand to restart their lives. They deserve that chance by any means possible and that's why county tax measures were supported. But Newsom and the Democrat majority in Sacramento have to do their part by making sure those who do the crime, do the time. And, with drug interdiction and mental health evaluation before they are re-

It's time for Gov. Newsom to take responsibility and stop dumping on local government.

Christians, Is This Who We Really Are?

Our concern about the meaning of the Christian faith as it addresses the world continues.


Consider the face put on Christianity this Easter. Very few congregations held traditional services on this the central Christian festival. There was, I regret, a smattering of public services in which the devout ignored calls for social distancing. I hesitate to judge whether this activity flowed from authentic faith or was only thumbing the nose at the nation and its safety. Throughout the country, worship took place in empty sanctuaries while the services were streamed on TV and watched by the faithful.

President Trump, who rarely puts a foot in any church, watched the streamed service of the First Baptist Church of Dallas, Texas. Trump has often expressed his admiration for its pastor, Robert Jeffress. I have to wonder if Jeffress really defines what it means to be Christian or if he badly misrepresents its heart. At least the President seems to believe that Jeffress has it right. So let's take a look at what Jeffress has said about the nature of the faith as he has reflected on serious issues facing the nation.

Jeffress supported Governor Rick Perry in the Republican primaries for the 2012 presidential nomination. On October 7, 2011, he introduced Perry at the Values Voter Summit in Washington, DC, by indicating that one of Perry's rivals, Mitt Romney, is "opposed to Christianity." According to Jeffress, "Romney's Mormonism contradicts the teachings of Jesus."

Jeffress further held that the teachings of Judaism, Islam and Hinduism reject "the truth of Christ", and that their adherents will go to hell if they do not accept him. Jeffress had earlier referred to Roman Catholicism as a "Satanic cult."

Certainly while Jeffress is entitled to define what it means to

be a Christian, to use this distortion as a political weapon is a travesty. I believe Jeffress seriously misrepresents Jesus. He managed to ignore Romney's false religious commitment however, when he finally endorsed him in the 2012 Republican primary. If Romney belonged to a non-Christian cult, even so he was far superior to Barack Obama who according to Donald Trump, Obama was probably not even an American.

In November 4, 2012, the Sunday before the 2012 election, here is what Jeffress had to say about President Obama.

"I want you to hear me tonight, I am not saying that President Obama is the Antichrist. I am not saying that at all. One reason I know he's not the Antichrist is the Antichrist is going to have much higher poll numbers when he comes. President Obama is not the Antichrist. But what I am saying is this: the course he is choosing to lead our nation is paving the way for the future reign of the Antichrist."

An outspoken opponent of same-sex marriage, Jeffress has described such marriages as being "counterfeit." In 2008 in his sermon "Gay Is Not OK he said, "It (homosexuality) is so degrading that it is beyond description. And it is their filthy behavior that explains why they are so much more prone to disease."

His 2016 support of Trump was full-throated. And there he

was, representing Christians at Trump's inauguration. In September 2019, after the impeachment inquiry had been announced, Jeffress declared on Fox News:

"I have never seen the Evangelical Christians more angry over any issue than this attempt to illegitimately remove this President from office, overturn the 2016 election, and negate the votes of millions of Evangelicals in the process. They know the only impeachable offense that President Trump has committed was beating Hillary Clinton in 2016. That's the unpardonable sin for which the Democrats will never forgive him. If the Democrats are successful in removing the President from office, it will cause a Civil War like fracture in this nation from which our country will never heal."

• There is much more. Jeffress Is entitled to his take on religion, but my concern focuses on an American President who endorses what the pastor believes without reservation. A President who assigns to hell the majority of America's citizens is morally unfit to lead them. If at any point Trump has rejected the bigotry Jeffress continues to spew, he has failed to make it clear.

• Apart from what Trump believes about all those who are eternally damned because they have not accepted Jesus, the distorting of the Christian faith by Jeffress and his followers is disastrous. If this is what Christianity is really about, thoughtful people should separate themselves from it without delay. Perhaps that is really what Trump believes, or as I suspect, he is simply using this minister as bait to attract evangelicals. Jeffress' distortion and Trump's acquiescence is one of the Christian faith's more serious misrepresentations.

"TIME JOCKEY" - Times-Mirror

L.A.'s Newspaper... The Otis-Chandler Family became one of the most influential and impactful families in the City of Los Angeles in the first half of the 20th century. As owner and publisher of one of the primary newspapers of Los Angeles, the family was involved in nearly every event and activity which took place in the city. After World War II, Norman Chandler had become the publisher of the Times and even though his newspaper was profitable, he was still seeking other types of publications which could augment his earnings and profitability. Following the war, Chandler started a second daily publication which was geared to young soldiers who were returning from military service. He called it the "Mirror" newspaper and its contents included entertainment, social activities, investment opportunities and want ads, especially ads for single men and women.

The "Mirror" was the opposite of the news-based "Times" and soon its popularity grew beyond expectations. It was published and distributed in the afternoon, while the "Times" was printed and sold every morning allowing customers to

read their daily news before the livelier side of the news was circulated in the "Mirror". But the Chandler run L.A. Times wasn't the only newspaper in the growing metropolitan city and William Randolph Hearst's Herald Examiner was in hot competition with the "Times". Hearst had also started an afternoon newspaper and named it the "Herald-Express". The competition between the two newspapers was heated as each company had a morning daily and an afternoon publication. It was the "Times" vs the "Herald-Examiner" in the morning and the "Mirror" vs the "Her-

ald-Express" in the afternoon. Otis Chandler had taken over the reins of the Times in the 1960's from his father Norman, who had spent lavishly to bring in the best talent he could to write for both his newspapers. Even though the "Mirror" was highly popular it was losing money at a rate of almost \$30,000 a month. But Otis Chandler was still seeking other publishing opportunities in the Los Angeles area and established the Times-Mirror Corporation which began printing books and special editions of worldwide and national events.

Times-Mirror Corporation, a deal was reached between the two newspaper giants of Los Angeles. The Times-Mirror Corporation agreed to end publication of the "Mirror "afternoon newspaper and in turn the Hearst family agreed to cease printing their morning edition, the "Herald-Examiner". The deal gave the Los Angeles Times complete control of the morning news and gave up all afternoon newspaper presence in the city. Even though the "Mirror" publication achieved initial success, its primary benefit was being part of the Herald-Times deal giving complete control to the Los Angeles morning newspaper market. Eventually, the "Herald-Express" could not keep up with competition from the "Times" and its operations ceased. The Times-Mirror Corporation had won out and today it's the 2nd largest metropolitan newspaper in the United States....

The Death of a Nation!


As I sit back and watch what is happening to our nation, I can't help feeling what I am seeing is the 'death of a nation'...

Was Economic Shutdown **Worse Than The Disease?**

One death from China's coronavirus was already too many! But, lets also understand that we have influenza outbreaks every year (with more than a few deaths). Had all of our states and hospitals been better prepared for treating Wuhan coronavirus patients, the shutdown of our entire country probably would not have been necessary. Hot spot shut downs, with dedicated hospitals in areas not yet overwhelmed with the virus, could have avoided much of the economic and personal pain that the USA has been suffering (especially for the past month). Nevertheless, our ongoing economic disaster was primarily caused by the Chinese Communist Party's apparently intentional misrepresentations about the danger of its Wuhan "bat virus". When the USA belatedly (due to CCP secrecy for over a month) realized the truth about this extremely contagious coronavirus, America's reaction may have been somewhat overblown, politically motivated, and driven by media exaggeration.

Whatever, the economic dominos soon began to fall. The price of oil has plunged around the globe to prices never before seen (due to no demand and no place to store too much oil). Production cuts (agreed to by top producers) are barely making a dent in the demand destruction wrought by COVID-19's international shutdowns. Brick and mortar retail stores in the USA are considering bankruptcy protection, while restaurants and bars have been shuttering their establishments. The longer we confine ourselves with ongoing extremely restrictive freedoms, the longer it will take to eventually move back toward normal.

America's recession started in March. Outside the US, the definition of recession is two negative quarters, which is why people like to say there is no recession yet, even when it's clear the next quarter will also likely be down. However, in the USA, one bad quarter is enough to qualify

as a recession. According to the National Bureau of Economic Research (NBER), recession in the US reflects, "a significant decline in economic activity spread across the economy, lasting more than a few months, normally visible in real GDP, real incomes, employment, industrial production, and wholesale-retail sales." There's no doubt that's what we will continue to see in the coming weeks, just as there's no question the previous (amazing strong) business cycle ended in February. The low point should come in the second quarter, maybe as soon as May; but full recovery is likely to take a long time. One Wall Street forecast has GDP not recovering to its prior peak until mid-2022. This pessimism may be influenced by warnings that most health experts expect a virus resurgence in the fall. However, most economists cannot bear more than a grudging reflection of that in their forecasts. Even IMF forecasts pushed Covid-19 recurrence into a worst-case alternative projection. (Maybe that's because there's only so much bad news you can take, or give, in one serv-

The President recently faced what he called the most difficult decision of his life, namely, when and how to rekindle the economy (well before the coronavirus is totally eliminated, and/or a perfect vaccine is available for everyone). The President is a businessman, thankfully, not a career politician or lawyer. He is certainly not a doctor, so he understands that the economy cannot survive "an induced coma" for

several months. (You can't bring an economy out of a coma as easily as bringing a human patient out of a coma.) Employees and/or customers may not still be around to make a business run successfully if any business lies dormant for too long.

Viruses kill, but so does poverty. Finding the right balance (in today's challenging times) takes creativity and significant courage. Saying that we must reach a perfectly safe world before going back into business is not only naive, it also implies that there is no deadly risk of mass deaths from shortages, starvation, and poverty if we create a self-induced Global Great Depression. It is obvious to most Americans running or owning businesses that the USA needs to "get back to work" as soon as possible!

The market naturally looks ahead. In the short, sharp 35% decline from late February through April 17, the market reflected a fast-moving virus attack, while more recently it is beginning to reflect the hoped for recovery to come.

With the virus sending us into isolation, all trading was being done remotely. There were no traders on the floor of the NYSE. There was little professional human interplay, which usually makes up a big part of the personality of market sentiment.

When investor mentality is convinced that the worst is over, markets will rally without any formal notice. There will be no "raising of a green flag" that I know of. However, one day, I believe in the not-too-distant-future, you'll know that BIG Money (with better information than we'll ever have) has been establishing a pivot point. If you try to find out why, you'll likely miss out on the first 10% of the next big rally!

Your Money - Ask Julia

Our bank has a 6-withdrawal limit which includes paying bills and moving money from savings to checking. With the Stay-Home orders, how can we stay within that limit?

On April 24, the regulation was changed allowing banks to offer unlimited withdrawals. This is expected to have taken effect this week. However, it does not require banks to comply, so check with yours. You might have to open an account at a different bank so you can spread your bills between the two. If the bill is the same every month, you might pay 2 months for some bills, and alternately pay 2 months on other bills.

In the simplest way, please explain how inflation can hurt the value of the dollar?

Whatever your dollars can buy today will take more dollars to buy when there's inflation. 72 divided by [percentage rate], equals the number of years it takes to double the price of goods, (or double the amount in a savings account). This is called the Rule of 72. For example, at 8-percent rate of inflation, a loaf of bread would double in price every 9 years. (72 divided by 8 equals 9). Now if inflation hits double-digits like it did in the 1970's, at 18-percent, a loaf of bread would double in price every 4 years.

I got my mortgage loan about eight years ago. My 30-year loan is down to 22 years. Can I get a new, 22-year loan? And, is this a good time to refinance?

Now is a good time to refinance. And, yes, some lenders

offer a loan to match your current number of years left on the loan you are refinancing. However, you could get a 30-year loan, but pay extra each month to reduce it to a 22-year loan. That way, if something unforeseen happened, you could fall back on the 30-year payment amount without causing hardship. Ask the loan officer, or go to Bankrate.com for calculating a payment amount. To find a loan professional who is not limited to the loans that a bank or credit union offers, findamortgagebroker.com

I'm a retired teacher, collecting my pension. My husband is also retired, collecting Social Security. If he dies, I will not get any of his Social Security. This will greatly impact the budget. Can you help me plan ahead for this possibility?

You are well informed! It might come as a surprise to other readers that teachers, and others with a 403-b retirement savings plan, are not entitled to their spouse's Social Security benefits, but it's true. It will take some saving and safe investing now to

plan ahead for the possibility of a drop in household income. When the time comes, you might consider downsizing your housing, or getting a reverse mort-

My husband puts the maximum amount allowed into a qualified plan with pre-tax dollars so that it grows tax deferred. I'm thinking that we'd get a better tax advantage in the long run by paying the taxes now and being able to take our investment money in retirement with minimal taxes. Who's

If the money he's putting into a qualified plan is being matched by his employer at a high percentage, it's probably a good idea to put as much there as allowable. Some employee retirement plans allow you to take some money out, once a year, and transfer it to an IRA. Another option would be to put some post-tax money into an insurance product that grows a cash value, has funds that are accessible while the insured is alive, and which is tax-advantaged for you and your beneficia-

Most people are thankful for being alive. Before the coronavirus crisis, we had not been thankful for a small bag of potatoes or toilet paper and ignored the importance of a single mask.

When a baby is born, parents are filled with a blessed and happy heart. They are ready for new life. The reason for the preparation is that the doctor tells you in advance that the baby will be born, and the parents are excited to prepare for the baby.

The baby grows up, graduates from school, finds work, marries, and has a new family.

The family makes constant plans. But not every family makes the last and most important plan. Wise parents prepare their final expenses to ease the mental and economic burden on their children.

Many parents prepare partially, paying only for their cemetery costs. When time comes, the parents will return and use the cemetery and will require paying for additional expenses. The grave marker, grave marker installation costs, ground opening and closing costs, outer burial container, outer burial container installa-

Less Highway Congestion During Stay-At-Home Orders Not a License to Speed

CHP Citations Jump by 87% for Violators Speeding More Than 100 mph

SACRAMENTO — Caltrans announced a joint effort with the California Highway Patrol (CHP) and the California Office of Traffic Safety (OTS) to urge drivers in the state to slow down given a recent 87% increase in citations for speeding in excess of 100 mph that coincides with decreased traffic volumes during the COVID-19 pandemic.

From March 19 when the state's stay-at-home order began to April 19, the CHP reports issuing 2,493 citations statewide for speeding more than 100 mph, as compared to 1,335 during the same period last year. This increase in citations occurred as Caltrans has measured an average decline in traffic volume on state roads of approximately 35% as compared to this time last year.

"Excessive speed and unsafe driving threaten everyone using our highway system," said Caltrans Director Toks Omishakin.

"Viewing less congested roads as an invitation to drive dangerously jeopardizes the safety of construction and maintenance crews who are working to maintain reliable access to our highways when people need it most."

"It is alarming to see the number of citations officers are writing for excessive speeds on California roadways," said CHP Commissioner Warren Stanley. "Higher speeds can lead to much more serious injuries and significantly increase the chance of death should a crash occur. Keep yourself and those on the road around you safe. Slow down and drive at a safe, legal speed."

California's "Move Over" law continues to be in effect and requires all drivers to move over a lane or, if unable to do so safely, slow down when they see amber flashing lights on Caltrans vehicles, law enforcement and emergency vehicles, and tow trucks.

"Fewer cars on the road doesn't give drivers the green light to travel over the speed limit," OTS Director Barbara Rooney said. "Driving at a safe speed when you must go out is one way to keep you and your family safe during this pandemic."

During the COVID-19 emergency, Caltrans continues to provide the general public with a safe and reliable transportation system. The department is maintaining all critical functions during this crisis, including ensuring roadway access to medical facilities and the convenient transport of essential goods and services throughout the state. Some nonessential work has been deferred to limit spread of the COVID-19 virus, but maintenance and construction crews are still addressing hazards, safety concerns and other critical functions on the highways.

IRS Enhances "Get My Payment" Online Application To Help Taxpayers

nal Revenue Service announced significant enhancements to the "Get My Payment" tool to deliver an improved and smoother experience for Americans eligible to receive Economic Impact Payments.

The enhancements adjusted several items related to the online tool, which debuted on April 15. The additional changes will help millions of additional taxpayers with new or expanded information and access to adding direct deposit information.

"We delivered Get My Payment with new capabilities that did not exist during any similar relief program, including the ability to receive direct deposit information that accelerates payments to millions of people," said IRS Commissioner Chuck Rettig. "These further enhancements will help even more taxpayers. We urge people who haven't received a payment date yet to visit Get My Payment again for the latest information. IRS teams worked long hours to deliver Get My Payment in record time, and we will continue to make improvements to help Americans.'

"We encourage people to check back in and visit Get My Payment," Rettig added. "These enhancements will help many taxpayers. By using Get My Payment now, more people will be able to get payments quickly by

information."

How to use Get My Pay-

Available only on IRS.gov, the online application is safe and secure to use. Taxpayers only need a few pieces of information to quickly obtain the status of their payment and, where needed, provide their bank account information. Having a copy of their most recent tax return can help speed the process.

As a reminder, Get My Payment is a U.S. Government system for authorized use only. The tool is solely for use by individuals or those legally authorized by the individual to access their information. Unauthorized use is prohibited and subject to criminal and civil penalties.

- For taxpayers to track the <u>to Economic Impact Payments</u> status of their payment, this feature will show taxpayers the scheduled delivery date by direct deposit or mail and the last four digits of the bank account being used if the IRS has direct deposit information. They will need to enter basic information includ-
 - * Social Security number
 - * Date of birth, and
- * Mailing address used on their tax return.
- Taxpayers needing to add their bank account information to speed receipt of their payment will also need to provide

WASHINGTON - The Interbeing able to add direct deposit the following additional informa-

- * Their Adjusted Gross Income from their most recent tax return submitted, either 2019 or 2018
- * The refund or amount owed from their latest filed tax return
- * Bank account type, account and routing numbers

Get My Payment cannot update bank account information after an Economic Impact Payment has been scheduled for delivery. To help protect against potential fraud, the tool also does not allow people to change bank account information already on file with the IRS.

The IRS urges taxpayers to be on the lookout for scams related to the Economic Impact Payments. To use the new app or get information, taxpayers should visit IRS.gov. People should watch out for scams using email, phone calls or texts related to the payments. Be careful and cautious: The IRS will not send unsolicited electronic communications asking people to open attachments, visit a website or share personal or financial information. Remember, go directly and solely to IRS.gov for official information.



Consumers are protected from a price increase of 10% or more for 30 days on goods and services and for 180 days on contractor-related services. Keep detailed records of purchases you make during a declared emergency.

Baldwin Park Unified Serves Nearly 131,000 Meals Amid School Closures

BALDWIN PARK -

Baldwin Park Unified continues to ensure every child has access to healthy, nutritious meals—despite school closures prompted by the COVID-19 virus—through its curbside meal distribution plan.

To date, the District has served nearly 131,000 meals since March 16, when the District enacted school closures on the recommendation of county and state officials.

Meals are served from 11 a.m. to 1 p.m. Mondays and Wednesdays at Bursch Elementary School (4245 Merced Ave.), Jones Junior High School (14250 Merced Ave.) and Baldwin Park High School (3900 Puente Ave.).

Monday distribution provides meals for two days; Wednesday distribution covers three days. All meal services are drive-through, ensuring parents can remain in their cars and limit contact with others. Students do not need be present when parents collect their meals.

"It is paramount for our families to know that we will continue to provide meal distribution services as long as our schools are closed due to the COVID-19 virus," Superintendent Dr. Froilan N. Mendoza said. "It is a trying time for everyone, but the Baldwin Park community has shown time and again they can rise to any challenge with passion and empathy. This is who we are and we will get through this together."



Baldwin Park Unified's Special Education Department, psychology services, custodial staff, school police and Business Department assisted Nutrition Services in serving more than 700 students at Baldwin Park High School on March 25.

Meals are prepared exclusively by Baldwin Park Unified Nutrition Service employees. Each site is staffed by eight kitchen workers and one nutrition supervisor.

District and site administrators have assisted by personally handing out food to families, led by Superintendent Mendoza, who has been helping with meal distribution at Jones Junior High and Baldwin Park High School

Park High School.

"My heart aches with pride to see Dr. Mendoza greeting each family. He welcomes each car with a big smile," Director of Nutrition Services Rosa Estrella said. "I would like to thank MaryAnn Curiel and

Alberto Pineda for their tireless efforts in scheduling staff, purchasing food and ensuring members are properly trained. Every single Nutrition Services member is an all-star. I couldn't be prouder."

Students received three days' worth of meals on April 10 to provide for the week of Spring Break, April 13-17.

After Spring Break, drivethru meal pickup, and walk-up for those without vehicles, will continue to be served regularly on Monday, April 20.





2. No permit or permit fee will be required for these ban-

3. Additionally, the City will allow these banners and clings to be hung through December 31, 2020 with no permit require-

4. In addition to the "Duarte Stronger Together" banners, the City will waive permit fees for all temporary banners through the end of the year. A City permit is required for all these temporary banners. Check with the City for more information.

A limited quantity of these banners will be available at the subsidized rate. Once the subsidized quantity is depleted, the banners and clings will be available at their discounted rate of \$53 for the banner and \$30 for the clings (tax not included) through mid-December.
