# Sheriff Villanueva, Along With Local Asian Community Groups, Call For Zero Tolerance For Any Hate Crimes

**LOS ANGELES COUNTY** - On Thursday, March 25, 2021, Sheriff Alex Villanueva held a press conference in front of the Hall of Justice to announce his support for the Asian community. He was joined by Consul General of Japan in Los Angeles, Akira Muto; Honorary Consul General of Cambodia in Los Angeles, Mr. Kim Chha Hout; Consul General of the Republic of Korea in Los Angeles, Kyung Jae Park; Mayor of Monterey Park, Yvonne Yin; Mayor of San Gabriel, Chin Ho Liao, the support of Consulate General of the People's Republic of China in Los Angeles, Zhang Ping, the Sheriff's Community Advisory Council, and other highly respected community leaders.

Since the beginning of the pandemic, there has been a significant rise in hate crimes against the Asian-American community. The fatal shooting of eight people, including six women of Asian descent, in Atlanta, Georgia, on Tuesday, March 16, 2021, is the latest attack against Asian-Americans,

and it shook the nation. Unfortunately, it was not an isolated incident. On Sunday, March 21, 2021, a man disrupted a 'Stop Asian Hate' protest in Diamond Bar by driving through a group of protesters while hurling insults against China.

Sheriff Villanueva called for zero tolerance for hate crimes in Los Angeles County, especially towards Asian Americans. He urged people to report crime by calling 911 if it is an emergency, contacting a local law

enforcement agency, or remaining anonymous by calling LA Crime Stoppers at 800-222 or by visiting [lacrimestoppers.org](http://lacrimestoppers.org).

Undersheriff Tim Murakami talked about his experience as a 4th generation Asian-American. He explained that histori-

cally, the Asian community has been very quiet. For the most part, they accept things, overlook them and move on. He urged the community to stand up as a group and realize "they're Americans, they have the right to be here, they have the right to be respected and the right to be protected."

Sheriff Villanueva reminded everyone that everyone is looking for the same things in life, security and a sense of belonging at the end of the day. "If you're a recent arrival or you've been here for generations, all of you are welcome in Los Angeles County. We welcome you in this great nation of us," he concluded.

# Walnut High Sophomore Jason Wang Wins Science & Engineering Fair

**WALNUT** - Walnut High School sophomore Jason Wang won the top award during the 71st Annual Los Angeles County Science & Engineering Fair (LACSEF) and entry into the 2021 Regeneration International Science & Engineering Fair (ISEF) slated for May 3-6.

Wang learned he took 1st Place during the virtual awards ceremony YouTube live stream on March 21.

His winning research project was titled, "Polar Vortex and Long-Duration Events: Climate Change in the Upper Midwest and Canada."


The 15-year-old investigated whether areas most affected by a meandering jet stream have also experienced an increase in "stuck" weather patterns such as longer cold spells or heat waves.

Wang analyzed NOAA public weather datasets on Google BigQuery, and used linear regression and Tableau to visualize regional climate trends over recent decades.


In addition to being designated an ISEF finalist as one of LA County's top 7 projects, Wang received 1st Place in his Earth/Space Sciences category (for the second year-in-a-row), the American Meteorology Society Prize (for the fourth consecutive year), along with awards from the Office of Naval Research/U.S. Navy, Mu Alpha Theta Mathematics Society, the Professional Engineers of California Government, and advances to the California State Science & Engineering Fair.

Wang has represented Suzanne Middle School and Walnut High School at the LA County Fair each year since 6th grade, and advanced to the California State Fair each year since 7th grade. As a freshman, Wang was named Top 300 in the Broadcom Masters national STEM competition.

Regeneration ISEF finalists compete for nearly \$5 million in awards, prizes and scholarships. Each year more than 1,800 students earn the right to compete at the Regeneration ISEF by winning a top prize at a Society-affiliated local, regional, state or national science fair. The LA County Science & Engineering Fair is the largest and longest-running regional fair in the Western U.S., with 63 schools and about 350 students entering this year's virtual fair.

# Rosemead High School Celebrates New Track & Field with Groundbreaking

**EL MONTE** - El Monte Union High School District held a socially distanced groundbreaking ceremony at Rosemead High School on March 25, with administrators and staff cheerfully celebrating the launch of construction for the school's new track and field.

Members of the EMUHS Board of Trustees joined Rosemead High School administrators and staff to give speeches and commemorate the start of much-needed renovations and upgrades to the school's track and field. Board President Florencio Briones and Rosemead High Principal Dr. Brian Bristol were among the speakers who thanked the community for their continued support of students.

The project, which features a new synthetic football field

and repairs to the rubberized track, is expected to be completed in July 2021.

"Rosemead High School is excited for this project to be underway and we are thankful to our community for supporting this project for the purpose of providing our students with the upgraded facilities they deserve," Dr. Bristol said. "We cannot wait for our Panthers to make great use of the track and field."

The \$5 million project is funded by Measure D, a bond approved by voters in November 2008 that focuses on modernizing El Monte Union campuses and classrooms. Upgrades and renovations have continued at a steady pace amid school closures, preparing school sites for the eventual return of students.

"We are pleased to be able to provide these enhanced facilities that support our students in their athletic endeavors," said Norma Marcias, Director of Facilities, Maintenance Operations and Transportation. "Safety is always our number one priority and promise when it comes to our students, and renovating our facilities is a part of that promise."

The groundbreaking ceremony also celebrated upcoming renovations to Rosemead High School's concessions buildings, a separate project funded by Measure HS - a bond approved by voters November 2018.

"The support our community has shown for our students is incredible and it is that support that makes these campus improvements possible," Superintendent Edward A. Zuniga said. "Thank you to the El Monte Union community, and to everyone involved who has done the hard work to ensure that our Panthers continue to have the safe, modern facilities they deserve."

# Electric Vehicle Careers: Juice up at Citrus College

Keeping up with the jargon of the electric vehicle (EV) industry these days can be challenging. In that context, the word "juice" is now widely understood to mean "electricity that makes an engine work." Juice is one of dozens of terms unique to EVs, and the lexicon seems to be growing as fast as the industry.


Currently, automotive plants are turning out upwards of 500K new EVs each year. According to caranddriver.com, "Electric cars are the future..."

With momentum building towards what seems like a revolution in transportation, it's clear that thousands of workers trained in this new technology will be needed to design, manufacture, build and maintain EVs. This will include workers to build and maintain charging stations and other EV infrastructure.

Not surprisingly, the automotive industry is turning to community colleges for workforce training to meet what will no doubt be a colossal need for skilled workers.

Citrus College, located in the greater San Gabriel Valley, is once again taking the lead in training workers for this job-creating industry. The college currently offers a Certificate in Clean Energy and Vehicle Electrification. Courses prepare students to advance in the field with training in alternative fuel, hybrid, electric and fuel cell vehicle technology. Typical good paying EV jobs include hybrid and electric vehicle technicians.

Late last year, Citrus College partnered with Proterra, a leading innovator in heavy-duty electric transportation, to train workers to build electric buses. The customized nine week program, with limited enrollment, is a first-of-its-kind

workforce training program in advanced electric bus manufacturing. This comes at a time when the City of Los Angeles has ordered 155 new electric busses and plans to convert its bus fleet to emission-free vehicles by 2028, when it will host the Olympics and Paralympics. In addition, Governor Newsom has recently issued an executive order to achieve 100 percent zero-emission new vehicle sales by 2035. His proposed budget for next year includes a \$1.5 billion investment in the clean transportation sector.

From hybrid to fully electric, new models for 2021 from U.S. manufacturers and their global counterparts will include pickup trucks, SUV crossovers and luxury automobiles. Electrek, a

company that tracks and analyzes news on the transition from fossil-fuel to electric transportation, proclaimed that "2021 is going to be the year for all-electric cars and should greatly accelerate the electric revolution. There are so many new models hitting the market that it should shift the entire industry."

Got juice? You might want to consider a new career in this fast growing field.

The Ticket Program supports career development for people ages 18 through 64 who receive Social Security disability benefits (SSDI/SSI) and want to work. Through this free and voluntary program, eligible participants can work with service providers to receive the supports and services they need to find and maintain employment.

Ticket program service providers can help you determine if working from home would be a good fit for you. They can help identify work from home opportunities and polish your resume for those positions.

If you're already working with a service provider, and you've started a remote position, here are 4 tips that can help you succeed when working from home:

1. Work from your home office. If you can, designate one room where you'll do your work. Try not to do anything else in that room. If you don't have the extra space, set up a desk or table that's dedicated to work.
2. Create a morning routine. A morning routine will help you prepare for work and set you on the path to a productive day.
3. Keep a schedule. It's impor-

tant to maintain boundaries between your work and home life. If you have a home office, shut that door at the end of the day. Decompressing after work can be difficult when you're at home, but setting a schedule helps you maintain that boundary so you can switch your attention from work to home.

4. Stay connected. Take advantage of videoconferencing to stay connected with your co-workers. It may take some practice to learn how to interact with your colleagues this way. Studies show that people learn better through video, they retain more from

## California, FEMA to Complete Vaccine Mission in Oakland, Los Angeles April 11

Community Vaccination Centers will Transition to Providing Johnson & Johnson Vaccines April 1

**OAKLAND** – Having already successfully administered almost a half million vaccinations to Californians to protect against COVID-19, the California Governor’s Office of Emergency Services (Cal OES) and Federal Emergency Management Agency (FEMA) announced the completion of the life-saving, eight-week mission on Sunday, April 11.

In mid-February, the Biden-Harris Administration approved a pilot project to establish Community Vaccination Centers based at the RingCentral Coliseum in Oakland and Cal State LA campus with a capacity to vaccinate approximately 6,000 individuals a day at each site for eight weeks. The sites have outpaced that initial expectation and regularly administer more than 7,500 shots per day.

Nearly 67 percent of vaccines were administered to targeted underserved communi-

ties and people of color.

“In the fight against COVID-19, equity is key. This pilot program has shown the rest of the nation a forward-leaning way to serve our communities most in need,” said Cal OES Director Mark Ghilarducci. “We could not be more pleased with the success of these sites or the partnership we have built with our federal partners.”

“This partnership has been a tremendous success and shows what can happen when all levels of government come together to meet a challenge that has affected this state, the nation and the world,” said FEMA Region 9 Acting Administrator Tammy Littrell. “Beyond just providing vaccinations, this effort is helping to reopen schools, businesses and communities.”

Further, to maximize the number of individuals served over the final two weeks of the mission, the two agencies will begin providing the Johnson & Johnson vaccine to new patients at the jointly operated Community Vaccination Centers (CVC) beginning April 1. Until April 1, the sites will continue to administer Pfizer second dose vaccinations to individuals who previously received their first dose at either the main Community Vaccination Centers or at the Mobile Vaccination Clinics operated in conjunction with these sites.

Johnson & Johnson is a single-dose vaccine as compared to the two doses required for the Pfizer and Moderna vac-

cines. California’s top health officials unanimously agree that the Johnson & Johnson vaccine is safe and effective.

These joint federal pilot sites have helped expand the rate of vaccinations in California in an efficient, effective and equitable manner, with an explicit focus on making sure that communities with a high risk of COVID-19 exposure and infection are not left behind. These two locations were chosen since they are in some of the most diverse and socioeconomically challenged communities in the country. These communities have been disproportionately impacted by COVID-19 and are home to essential workers who have borne the brunt of keeping the economy open over the past year.

In order to continue serving the communities following the completion of the state/federal mission on April 11, Cal OES and FEMA are coordinating closely with local officials on the possibility of reusing the two sites.

Vaccine appointments at the two Community Vaccination Centers will be released daily beginning on April 1 and made available to eligible individuals through visiting the state’s MyTurn website (<https://myturn.ca.gov/>) or by calling 833-422-4255.

Members of the public may check their eligibility for vaccination, sign up for notifications and schedule appointments in select areas through the site.

## COVID-19 Hospitalizations Drop Below 700; L.A. County Nears 4 Million Vaccine Doses Administered

**LOS ANGELES COUNTY** - As of March 26, nearly 3,800,000 doses of COVID-19 vaccine have been administered to people across Los Angeles County. Of those vaccinated, 1,232,348 people received second doses and 67,016 people received the single dose Johnson & Johnson vaccine.

This week, Public Health is expecting to receive 340,000 vaccine doses; a 21% increase over the doses received this week. This allocation includes approximately 14,000 doses of the Johnson & Johnson vaccine. Of the 340,000 doses we expect to receive next week, 65% will go to vaccine providers located in vulnerable and hard-hit communities across the county, specifically those communities in the lowest quartile of the Healthy Places Index and communities

with high COVID-19 case rates. With more than 500 sites offering vaccination services across the county, we continue to move the needle in our vaccination coverage efforts, with a strong focus on hard-hit communities.

Vaccine eligibility categories were expanded to include gardeners and landscapers, housekeepers and private child caretakers working at least 20 hours per week, and flight crews that live or are based in Los Angeles County. Persons in these occupations are now eligible for vaccine and can now register for a vaccination appointment.

The State announced starting April 1, COVID-19 vaccine eligibility will expand to individuals age 50 and older, and starting April 15, for individuals age 16 and older. The County hopes the expansion of eligibility includes

increased doses of vaccine coming into L.A. County. Public Health greatly looks forward to this expansion, however the success will be dependent on receiving a substantial increase in vaccine supplies.

L.A. County is working to ensure that eligible residents and workers in hard hit communities have increased access to vaccines. For information about who is eligible for COVID-19 vaccine in L.A. ## Traveling and Gathering for Spring Break and Religious/Spiritual Holidays Increases the Risk of Getting and Spreading COVID-19

**LOS ANGELES COUNTY** - As we approach spring break and numerous religious and spiritual holidays, it important to remember that travel and gathering in-person with others increases the risk of getting and spreading COVID-19. While COVID-19 numbers have decreased in L.A. County, transmission remains widespread and is increasing in many other states and countries.

The safest way to observe religious and spiritual holidays at this time is still to gather virtually or with people who live with you.

Los Angeles County residents should continue to avoid all non-essential travel and stay within 120 miles from their place of residence, unless they are traveling for essential purposes. A Travel Advisory remains in effect in Los Angeles County.

Anyone who is arriving in Los Angeles County from outside

the state must self-quarantine for 10 days; travelers should remain at their home or lodging for the 10 days and avoid contact with others. People should get tested if they have COVID-19 symptoms, were in crowds, or were involved in any other activities that may have put them at risk for getting COVID-19.

Since L.A. County is in the Red Tier of the State’s Blueprint for a Safer Economy, a private gathering can occur indoors with up to three separate households, with masking and distancing required at all times and limited to two hours. Outdoors is still safer than indoors. People who are fully vaccinated can gather indoors, without required masking and distancing, with either two other households of people who are fully vaccinated or with one other household of unvaccinated/partially vaccinated people, un-

less any of those people or anyone they live is at risk for serious illness from COVID-19.

People are considered fully vaccinated:

- 2 weeks after their second dose in a 2-dose series (the Pfizer or Moderna vaccines), or
- 2 weeks after a single-dose vaccine (the Johnson & Johnson/Janssen vaccine).

If it has been less than 2 weeks since your shot or you still need to get your second dose, you are NOT fully vaccinated.

Gatherings, even with people you know who have no symptoms and who have tested negative, can still result in spread of the virus to many people. The risk of spread increases when people are not diligent about consistently and correctly wearing face masks or keeping their physical distance and when people gather indoors.



# Border Chaos: Just Raw Numbers

"It is taking time and it is difficult because the entire system was dismantled by the prior administration. There was a system in place that was torn down by the Trump administration." Homeland Security Secretary Alejandro Mayorkas.

**Former Mayor of Glendora and Border Patrol (CBP) since Biden Harris Administration took charge:**

Mayorkas' solution to border chaos: fire 30 members of the Homeland Security Advisory Council, Democrats and Republicans, and retain only William Bratton, former New York police commissioner, Karen Tandy, retired administrator, Drug Enforcement Administration, and William Webster, former FBI and CIA director. Mayorkas said a new Council will be formed "in the next few weeks, once the new model has been developed." (Epoch Times, 3-27-21)

In President Biden's 'First 100 Days' Plan, were Executive Orders revoking Trump's basic foundation of border security. Tom Fitton, Judicial Watch, posted the Biden Orders:

- Reversed most of Trump's immigration agenda from deportations to asylum policy, including defunding wall construction. Government Accountability Office (GAO) is investigating the legality of wall defunding.

- Rescinded Trump's immigration restrictions on 13 countries helping keep us safe from foreign terrorists, and Democrats are eager to begin undoing most all of the approximately 400 high-profile immigration policy changes made by the Trump administration.

The cease order on construction of the border wall in areas along the Texas border has contributed to the massive inflow of immigrants, criminal illegals, and massive amounts of narcotics - methamphetamines, marijuana and fentanyl. Rep. Bryan Slaton (R-Texas) has legislation pending for Texas Department of Public Safety (DPS) to complete the wall and name it after President Trump.

Just raw numbers from our southern Texas and California borders, provided by Customs

stringing his ability to deal with the border surge leaving Texas awash in illegals and a surge in COVID 19 after the release of those illegals into various communities. An NBC fact check indicated January and February there is always a surge of attempts to get across the border because of the cooler weather. Reports I've read indicate Biden's efforts to send families back are correct, but wants to retain unaccompanied minors.

From January to February 2019 there was a 31% surge in unaccompanied alien children (UAC) but this year under Biden Harris Administration there is a 61% surge. Mara Salvatrucha (MS-13), reportedly recruits new members at shelters housing illegal minors.


To combat the attempted recruitment by the drug cartels of teenager traffickers, former President Trump went to court and the appeals court found the U.S. is not legally obligated to accept unaccompanied minors. The Trump administration sent most Central American minors, the majority of whom were ages 15 to 17, back to their home countries to join family there.

With direction from Trump, Vice-President Mike Pence and Secretary of State Pompeo met with Mexico's Foreign Affairs Secretary, Marcelo Ebrard, to have Mexico stop the human flow at their southern border. Those efforts became successful when Trump threatened increased tariffs.

President Joe Biden is now sending V.P. Kamala Harris to the border to review the situation and come up with some viable solutions.

# "We Are Not Divided, All One Body We" Or Are We?

This is the first column in a two part series on the divisions that have plagued the church ever since its inception. This week I will briefly list just four of the major divisions. Each one has generated enough books to fill a library, so I will do little more than just name them. Next week I will focus on the division currently facing the church in the United States.

## 1. REGARDING GENTILES

Within a generation of its existence there arose a serious argument as to whether the church was to be made up of Jews and those non-Jews who conformed to Jewish rites, or would it welcome uncircumcised Gentiles (Galatians 2:11): "When Cephas (Peter) came to Antioch, I (Paul) opposed him to his face, because he stood condemned." Peter represented the exclusion of Gentiles, and Paul their inclusion. In a few years Gentiles were not only welcomed, but the church became a Greek speaking, non-Jewish institution.

## 2. CHRISTOLOGY

In 325 the Emperor Constantine called a meeting of Christian bishops to settle questions concerning the nature of Christ. A majority held that Jesus Christ was God in every respect, and a minority that he was like God. The conflict hinged over a single letter in the spelling of a Greek word. It so happened that the split also revealed the impending geographic division between Constantinople and Rome. The theological outcome was a creedal statement aimed at resolving the conflict.

## 3. GREEK ORTHODOXY versus LATIN CATHOLICISM

In 1054 the division between East and West reached its climax. Part of the conflict was theolog-

ical. Does the Holy Spirit proceed from the Father and Son or just from the Father? Most of the struggle, however, really involved whether the Greek-speaking East or the Latin-speaking West would predominate. Would all truth and authority flow from Constantinople or from Rome? To this date the division persists.

## 4. THE REFORMATION

In 1517 Martin Luther nailed on a church door a list of issues to be debated. Among other religious matters was the right of the Pope to grant forgiveness to the departed---depending on receiving certain monetary gifts. In addition, Luther was concerned with increased Roman Catholic political control of the German states. The Reformation continued with John Calvin in Geneva and John Knox in Scotland. It came to a head in England when Henry VIII declared himself to be head of the English church. The Pope had refused to allow the king to remarry following his divorce, so Henry took the papal bull by the horns. In subsequent years Protestantism and Catholicism vied for control of both the church and the English realm. In the long run Henry's rebellion prevailed and he became "Defender of the Faith." While the four I have listed amounted to

major divisions within the Christian family, throughout Christian history there have been hundreds of lesser conflicts. Each of these divisions, as well as scores of lesser conflicts, had a basis in the theological arguments, but were these the real issues, or were they used to obscure the underlying social and political conflicts?

Here is an illustration of a very minor issue that divided one American denomination.

The Disciples of Christ suffered a split in 1906 over the use of musical instruments, basically pipe organs, in worship services. A sizable minority held that nowhere did the New Testament authorize their use. The result was a new denomination called the Churches of Christ. While the argument focused on that issue, was it the real cause of the division? The denomination had proudly affirmed that it refused to divide over slavery and abolition as had other denominations. But the great majority of the anti-musical instrument congregations were in slave-holding states. So was slavery the real reason for the split? What is more, Southern congregations unable to afford pipe organs departed from the main body of wealthier northern churches.

My conclusion: While the issue seemed to focus on the New Testament and its authorization of musical instruments, I suspect that the real issues causing the split had more to do with slavery and economics. What this minor debate was really about is just an example of how social issues underlay each of the four major ruptures I have identified.

# We Have Stepped Over The Homeless Crisis For Too Long

As we begin to emerge from this COVID pandemic, we learn that homeless population numbers have increased to 66,000 in Los Angeles County. Year after year, inept political leaders continue to make missteps and decisions that favor developers and special interest groups pushing the lucrative narrative of "housing first" when most know drug rehabilitation and mental health treatment are what is desperately needed for those living in squalor on the streets. A study of the inaction to solving the homeless crisis can lead one to conclude corruption, arrogance and stupidity have only made this crisis worse.

Common-sense and compassionate reforms to the Lanterman-Petris-Short Act could be broadened and enhanced to provide treatment care and shelter for the seriously mentally ill.

Leaders of County and local municipalities must mandate the Los Angeles Homeless Service Authority change direction and fund qualified religious non-profits that wish to help house, shelter and feed those seeking assistance. LASHA must fund economical infrastructure to do

intake and care for all women, children, seniors, and men in the order. LASHA must stop wasting taxpayer dollars on "shelter first" policies and immediately address the underlying human condition that put people in homelessness in the first place.

County or state authorities should immediately establish a steering committee of the uppermost authorities on helping the homeless, drug rehabilitation and mental health treatment that include Reverend Andy Bales from Union Rescue Mission and addiction specialist Doctor Drew Pinsky. Give them the power and authority to recommend and oversee implementations of sound solutions.

Taxpayers should neither accept nor tolerate this horrendous humanitarian crisis any longer. Elected politicians must stop ignoring cries for solutions and apply the expected due diligence to save those living in desperation on the streets.

# Fed Optimistic, But Are Investors?

Stocks swung wildly following last week's FOMC's highly anticipated meeting as the yield curve pulled back, steepened, then pulled back once more. The central bank sharply upgraded its 2021 GDP growth forecast to 6.5%, the largest annual output since 1984, and also said it expected unemployment to drop. Fed Chair Jerome Powell added that inflation was forecast to reach 2.4% this year, but called it a temporary surge. The biggest news was a pledge not to raise interest rates until 2024. Really?

If the Fed is so confident in the outlook, why not raise rates sooner? The Fed's plan (that it rolled out last August) wants to let inflation run consistently above its 2% target, while also keeping rates steady until it sees maximum employment. The central bank may also hope to view that "surge in activity" as durable, before proceeding to tighten monetary policy.

Why are the capital markets so volatile? Some attributed the movement to the differing reactions of bond market players. At first, they focused on the Fed's "no hikes through 2023," but then planned to let inflation run hot. In reality the volatility may just be a broader symptom of Treasury market unpredictability. Investors and markets don't like uncertainty! Until we reach a broader consensus over how inflation will play out, we could see unstable moves in any direction.

What exactly are the BULLS saying and what are their actions?

"It's a mistake to dump growth stocks out of fear of rising inflation," said Mad Money's Jim Cramer. "The Fed's basically saying Party on Industrials." Accordingly hedge funds buy them hand over fist. Problem is, if they want to buy the banks or the smokestack stocks, they may need to sell something else like the high-growth tech stocks. That's called the "hedge fund playbook."

The negative - BEAR - thinkers should be concerned. "If the yield on the 10-year Treasury Note climbs to 2.0%, that could be enough to tip the risk market scales and lead to a 10% correction in the S&P 500. If the 10-year climbs to 2.5% bonds may even start becoming more attractive instead of stocks," according to the latest BofA fund manager colleague of mine. "Higher growth and higher inflation are now the consensus."

As the market scenario continually changes - almost on a daily basis - investors head into the week with plenty of wildcards to size up, including U.S. trade and security relations with China, the Treasury yield curve and an increased focus on the poten-

tial for higher corporate tax rates. The probability of tax increases coming this year could rise if the economy shows unexpected strength.

A wildcard is still COVID-19. Medical experts in the U.S. are trying to calm fears that some COVID-19 vaccines are unsafe. European countries suspended AstraZeneca's vaccination amid reports of blood clots among some recipients. The European Medicines Agency, which evaluates drug safety for the EU, has maintained that the benefits of the shot (when it comes to preventing hospitalizations and deaths) still "outweigh the risks of side effects." Of the more than 17M people in the EU and the U.K. who have received a dose of the Oxford-AstraZeneca vaccine, fewer than 40 cases of blood clots had been reported as of last week.

When Pfizer and Moderna initially distributed their vaccines in December there were reports of severe allergic reactions, or anaphylaxis. However, those cases appear to be rare, with the U.S. having administered 113M doses to date. Risks from not getting vaccinated appear to remain higher than from being vaccinated!

So, why not focus on the economy, coming inflation as well as risks to the USA's political future?

# Your Money - Ask Julia

*We owe taxes, but we don't have the money to pay now. What can we do? Can we just file for an extension?*

The extension form is a request for an extension of time to file. It is not an extension to pay. When you file the Request for Extension, you must pay the amount you calculate you will owe when you actually file your tax return. The IRS moved the income tax due date from April 15 to May 17. California moved their due date to match the IRS due date. This later date is for Individual income taxes, not businesses. If you pay quarterly estimated taxes, your deadline was not extended. If you still cannot pay on, or before, May 17, file your completed tax returns on time, or before, and select a payment plan. The penalty for filing on time, but paying late, is far less severe than the penalty for filing late when you owe. If you have a credit card that allows you to transfer balances at zero, or a very low interest rate, consider using it to pay your taxes. Then you must do everything in your power to pay off that credit card as quickly as possible.

*I used the standard deduction, but wish I had itemized. Is there anything I can do?*

You can file an amended return within a three-year period.

*The stock market is up, but I'm really nervous that it'll crash, and my retirement savings will be greatly depleted. Is it time for me to sell my stocks?*

You've heard the saying, "Buy low. Sell high." If you sell now, while the Market is high, you

might miss some growth if the Market goes even higher, but you would not suffer the consequences of a Stock Market crash. Get some personalized advice from a financial professional or two.

*I ordered some gloves and masks online. I did not receive a confirmation. The correct amount showed up as a charge on my credit card, and now a whole list of other charges is appearing from the same company for stuff I didn't order! Help!*

Contact your credit card company immediately. You should be able to freeze or cancel that credit card, and be refunded the fraudulently charged amounts. Change your log-in and password for that card. Use a different log-in and password for each of your financial entities (cards, banks, credit unions, bill pay sites, on-line stores, etc.).

*I recently moved out of my parent's home and am on my own. Where can I find more preparedness guidelines and information?*

Free information is available

on the Federal Emergency Management Agency website: [www.FEMA.gov](http://www.FEMA.gov). Additional information is available on the CDC site. Due to Covid-19, we have become much more aware of what we need to have for disaster preparedness. Imagine our current situation of quarantines and difficulty finding certain goods at the grocery stores, and add to it power outages, phone towers down, and no internet because of a natural disaster (earthquake, wildfire, tornado, severe winds). California is part of the Pacific Ring of Fire, has some really major fault lines, and has a huge shoreline that can be severely damaged by a large surge or tsunami. Disasters in other parts of the world (ship blocking the Suez Canal, for example), or in other states (severe winds, multiple tornadoes, flooding), can create shortages in your area. Make a plan to acquire necessary items and do not procrastinate in taking action to get those items and store them safely. If you are renting, I highly suggest purchasing a Renters Insurance Policy.

# CRA Announces New Partnership with California Organized Retail Crimes Association

*Collaborative Formed to Address a Growing Crisis for Businesses Statewide*

**SACRAMENTO** - The California Retailers Association (CRA) and the California Organized Retail Crimes Association (Cal-ORCA) announced a new joint partnership to combat Organized Retail Crime (ORC) throughout California.

"ORC is a growing problem not only for businesses, but our communities," said Rachel Michelin, CRA President and CEO. "ORC fosters a host of illegal activity, including the recruitment of youth, homeless and others into theft crimes. These networks frequently use their proceeds to finance other illegal activity including drug smuggling and human trafficking."

ORC involves theft or fraudulent activity conducted with the intent to convert illegally obtained goods into financial gain, often through subsequent online or offline sales. Typically, ORC networks organize multiple theft rings at retail stores and employ a "fencing" operation to sell the illegally obtained goods for financial gain. The digital revolution and subsequent growth in

online shopping and social networking, along with increasingly lax enforcement of property crimes, have exacerbated large scale criminal theft, contributed to significant business losses and greatly impacted retailers' ability to provide jobs and keep their doors open to serve their communities.

"ORC is on the rise nationwide and California is a 'hot spot' for these activities," said George Torres, CFI, LPQ, Executive Member of CAL-ORCA. "Now more than ever, we need laws and enforcement tools to fight back against these increasingly sophisticated, complex and often far-flung criminal networks and our partnership with CRA will help us significantly expand and advance these efforts."

CRA, in collaboration with Cal-ORCA, is working to combat ORC in California through legislative and regulatory measures that will continue to empower law enforcement and the business community to stop current crime rings and prevent fu-

ture large-scale thefts. In addition to the new collaborative, CRA and Cal-ORCA have partnered with Aurore, an online Retail Crime Intelligence platform designed to address ORC both in California and nationwide. The platform enables CRA and CAL-ORCA to build a data network across states and businesses that empowers members to collaborate, share intelligence and resolve more ORC cases.

"Joining with CRA and leveraging new technology to get ahead of ORC is a no brainer," said Detective Joe Hopkins, Member of the CAL-ORCA Board of Directors and Los Angeles Police Department. "CRA's work with the retail industry and larger business community along with Aurore's cutting edge technology will allow Cal-ORCA to do the hard work around connecting repeat offenders, sharing intel and enabling us to work together. Through this collaborative and new online platform, we will see a coordinated response to this vast issue."



## LA County Residents Can Soon Access Funeral Expense Relief from FEMA

Beginning in early April, Los Angeles County residents will be able to apply for financial help for funeral expenses through FEMA's COVID-19 Funeral Assistance Program.

To be eligible for funeral assistance, LA County residents must meet all of these FEMA established conditions:

- The death must have occurred in the United States, including the U.S. territories, and the District of Columbia.
- The death certificate must indicate the death was attributed to COVID-19.
- The applicant must be a U.S. citizen, non-citizen national, or a qualified non-citizen who incurred funeral expenses after January 20, 2020.

There are no residential or legal status requirements pertaining to the deceased person.

If you had COVID-19 funeral expenses, we encourage you to prepare to apply for FEMA funeral relief by gathering documentation that will be needed, such as:

- An official death certificate

that attributes the death directly or indirectly to COVID-19 and shows that the death occurred in the United States, including the U.S. territories, and the District of Columbia.

Funeral expenses documents such as receipts and funeral home contracts that include the applicant's name, the deceased person's name, the amount of funeral expenses, and the dates the funeral expenses happened.

Proof of funds received from other sources specifically for use toward funeral costs. FEMA will not duplicate benefits received from burial or funeral insurance, financial assistance received from voluntary agencies, government agencies,

or other sources.

Applicants may apply for multiple deceased individuals. If multiple persons helped pay for funeral expenses for one individual, they should apply under a single application as applicant and co-applicants. FEMA's financial assistance is limited to a maximum amount of \$9,000 per funeral and a maximum of \$35,500 per application.

In the coming weeks, FEMA will be establishing a toll-free telephone number to assist applicants with their submissions, but in the meantime, the County of Los Angeles encourages eligible applicants to visit FEMA.gov for additional information.

# Bicyclist Killed, Hit and Run Arrest Made



**IRWINDALE/WEST COVINA** - On Saturday morning, March 27, 2021, at about 1:41 A.M., Irwindale police officers responded to the report of a bicyclist down in the eastbound lanes of Huntington Drive at the San Gabriel River Bridge in the city of Irwindale (2900 Block of Huntington Drive).

On arrival, officers located a non-responsive female adult in the roadway with significant traumatic injuries. Paramedics from the Los Angeles County Fire Department arrived and pronounced the female deceased at the scene.

Based on witness statements and evidence found at the scene, it was evident the victim had been struck by a vehicle going east-bound on Huntington Drive, which fled the scene after the collision.

A short time later, officers from the West Covina Police Department stopped a vehicle in the area of Francisquito and Sunset Avenue in the city of West Covina. During the course of their investigation, they discovered evidence connecting the vehicle to the fatal hit and run traffic collision in the city of

Irwindale. Irwindale Police Officers went to the scene in West Covina and assumed the investigation. As a result, the driver, 21-year-old Adrian Ortega of La Puente, was arrested without incident.

Ortega was booked at the West Covina City Jail on felony vehicular manslaughter, felony drunk driving and felony hit-and-run charges. He remains in cus-

tody on \$100,000.00 bail.

The woman will not be unidentified until the next of kin is notified.

This remains an active investigation and Police are asking anyone who may have witnessed this traffic collision or who may have information about the crime to contact the Irwindale Police Department Detective Bureau at (626) 430-2245.

# Man Beats Elderly People, Kills a 70-Year-Old Lady

**BALDWIN PARK** - On Wednesday evening around 9:40 pm, the Baldwin Park Police responded to the 3400 block Mangum Street of a call of a man attacking elderly people with a log. The suspect, Giovanni Rivera, 27 who was a resident at a duplex owned by his mother had knocked out some windows of the house. He lives in the back part of the house while renters live in the front part of the house.

The incident started when the suspect vandalized the windows of the house. The suspect's mother headed over, accompanied by her 70-year-old friend and a couple of family members, according to police.

When they all arrived, they were attacked by Rivera. He was attacking and beating them with a two-foot log. He beat his mother and the 70-year-old woman who tried to protect his mother. The other couple who were family members were also attacked when they tried to intervene and prevent the attack on the others. They had no choice but to retreat, however, the 70-year-old lady fell in the front yard where Rivera rushed over to her and stood over her and continued to bash

her head in with the log. When police arrived, Rivera retreated to the back of the house where he barricaded himself from police. The Sheriff's Department was called to assist and they showed up with their SEB SWAT unit (Sheriff's Special Enforcement Bureau).


SEB used tear gas, entered the home with a police dog and arrested the suspect with the aid of the K-9. The unidentified 70-year-old lady was pronounced dead at the scene. She was a longtime friend of the suspect's mother. The mother and the other two victims were transported to the hospital.

Deputies also took Rivera to a hospital because the dog bit him. He was booked shortly after 3:30 a.m. on Thursday at Baldwin Park jail. He is being held at the Inmate Reception Center in Los Angeles. Bail set at \$2,000,000.00.

At this time, there is no indication what provoked the attacks or the vandalism. This incident is still under investigation.

# California Tax Deadline Extended; Federal Date Also Pushed to May 17

The Treasury Department and Internal Revenue Service announced that the federal income tax filing due date for individuals for the 2020 tax year will be automatically extended from April 15, 2021, to May 17, 2021. The IRS will be providing formal guidance in the coming days.

"This continues to be a tough time for many people, and the IRS wants to continue to do everything possible to help taxpayers navigate the unusual circumstances related to the pandemic, while also working on important tax administration responsibilities," said IRS Commissioner Chuck Rettig. "Even with the new deadline, we urge taxpayers to consider filing as soon as possible, especially those who are owed refunds. Filing electronically with direct deposit is the quickest way to get refunds, and it can help some taxpayers more quickly receive any remaining



stimulus payments they may be entitled to."

Individual taxpayers can also postpone federal income tax payments for the 2020 tax year due on April 15, 2021, to May 17, 2021, without penalties and interest, regardless of the amount owed. This postponement applies

to individual taxpayers, including individuals who pay self-employment tax. Penalties, interest and additions to tax will begin to accrue on any remaining unpaid balances as of May 17, 2021. Individual taxpayers will automatically avoid interest and penalties on the taxes paid by May 17.

Individual taxpayers do not need to file any forms or call the IRS to qualify for this automatic federal tax filing and payment relief. Individual taxpayers who need additional time to file beyond the May 17 deadline can request a filing extension until Oct. 15 by filing Form 4868 through their tax professional, tax software or using the Free File link on IRS.gov. Filing Form 4868 gives taxpayers until October 15 to file their 2020 tax return but does not grant an extension of time to pay taxes due. Taxpayers should pay their federal income tax due by May 17, 2021, to avoid interest and penalties.

The IRS urges taxpayers who are due a refund to file as soon as possible. Most tax refunds associated with e-filed returns are issued within 21 days.

This relief does not apply to estimated tax payments that are due on April 15, 2021. These payments are still due on April 15. Taxes must be paid as taxpayers earn or receive income during the year, either through withholding or estimated tax payments. In general, estimated tax payments are made quarterly to the IRS by people whose income isn't subject to income tax withholding, including self-employment income, interest, dividends, alimony or rental income. Most taxpayers automatically have their taxes withheld from their paychecks and submitted to the IRS by their employer.

The federal tax filing deadline postponement to May 17, 2021, only applies to individual federal income returns and tax (including tax on self-employment income) payments otherwise due April 15, 2021, not state tax payments or deposits or payments of any other type of federal tax.

The California Franchise Tax Board extended the deadlines for individual taxpayers to file their 2020 income tax returns and pay their 2020 taxes from April 15, 2021, to May 17, 2021. 2020 income returns filed on or before May 17 will be considered timely, and no interest or penalties will accrue on account of 2020 income tax payments made by May 17.
