Bonita Unified Honors Food Services Dept for Dedication to School Community

LA VERNE/SAN DIMAS – Bonita Unified School District presented members of its Food Services Department with the Purpose Award during a recent Board of Education meeting, celebrating their exemplary commitment to students and families throughout the pandemic.

The Bonita Unified Food Services team has provided its community with more than 750,000 free meals via curbside pick-up since the closure of schools in March 2020. On average, the District serves more than 1,700 breakfast and lunch meals daily.

“The District has been so supportive of us and our efforts since the very beginning, and it feels good to know that they know just how hard we have all been working to ensure that our kids receive free meals,” said Kim Castellano, a Food Services team member of more than 11 years.

Susan Hume, Assistant Superintendent of Business Services, said the District was committed to providing free meals to the community when campuses closed, whether or not the costs would be covered by the federal government, because it was the right thing to do. The BUSD Food Services

team adapted quickly to create a curbside pick-up system that would safely provide meals to students in a consistent way.

As local and state public health officials recommended that schools remain closed through the fall semester, the federal government extended the waiver that would ensure schools would be reimbursed for all free meals provided.

“This award is about thanking our staff for the incredible adaptability, perseverance and care they have shown during these challenging times, and how much we all appreciate their hard work and willingness

to show up every day for our students,” Bonita Unified Board of Education President Chuck Coyne said. “Thank you to the BUSD Food Services Department for your un-

wavering commitment to our school community.”

Operating out of five locations throughout the District, the Food Services team provides the community with con-

venient curbside pick-up from 11:30 a.m. to 1:30 p.m., Monday through Thursday at the Central Kitchen, Lone Hill Middle School and La Verne Heights, Roynon and Ekstrand Elementary Schools. Local partners frequently donate food, lunches and care packages for the BUSD staff to hand out to families.

“Bonita Unified School District’s core values are equity, mastery and a focus on results, and every single member of the Food Services Department embodies these values in way or another,” Bonita Unified Superintendent Carl Coles said. “Our teams do more than simply hand out meals; they connect with our students, parents and families, providing them with consistency in a time fraught with so much uncertainty.”

R.D. Olson Construction Breaks Ground On Vistas At Glendora, A Clearwater Senior Living Project

117-unit assisted living and memory care facility to provide extensive amenities, 24-hour care

GLENDORA – R.D. Olson Construction, an award-winning general contracting firm in California, announced the groundbreaking of Vistas at Glendora, a Clearwater Senior Living project, which is a 117-unit, 107,980-square-foot assisted living and memory care facility in the San Gabriel Valley area of Los Angeles County. Construction is expected to complete Fall 2022.

The senior living community will be comprised of 88 assisted living units and 29 memory care units, offering specialized care for people living with Alzheimer's or another form of memory impairment. Residents will have the option of single or double occupancy rooms, with studios, one- and two-bedroom room layouts available. Twenty-four-hour care and concierge services will be available for all residents.

“There is a significant shortage of senior living facilities in

the Los Angeles area, and as the population ages the need for modern, highly amenitized facilities will continue to grow,” said Bill Wilhelm, president of R.D. Olson Construction. “Vistas at Glendora will provide excellent care for area seniors in an environment that is warm, welcoming and complete with a wide variety of activities and amenities for residents to enjoy.”

Community amenities will include multiple dining venues, a wine vault, display kitchen, BBQ station, game room, theater, activity rooms, a lounge featuring a bar and piano, hair salon, state-of-the-art fitness center, art studio, four outdoor courtyards and a variety of indoor and outdoor seating areas. Vistas at Glendora, a Clearwater Senior Living project features a contemporary feel, with precast stone, brick veneer and other modern

design elements.

Located at 333 West Dawson Ave., the community is in close proximity to Los Angeles, the Inland Empire and Orange County, allowing convenient access for friends and family visiting from throughout Southern California.

R.D. Olson Construction partnered with owner Clearwater Living, architecture firm AO, and interior designer Klang & Associates on the project.

Other senior living projects from R.D. Olson Construction include the \$30 million renovation and construction of a new building for Atria Senior Living – a 1960s assisted living community in Newport Beach – and La Costa Glen, a Continuing Care Retirement Community in Carlsbad featuring independent living, assisted living and skilled nursing offerings.

Duarte Collaborating with Local Business to Prevent Catalytic Converter Theft

DUARTE - With catalytic converter thefts on the rise nationwide, the City of Duarte Public Safety Department is taking measures to protect residents' property. They are easy to remove from a vehicle's exhaust system and there are no identifiable markings for law enforcement to return the stolen property to the rightful



Napolitano Introduces The Mental Health for Latinos Act

WASHINGTON, DC - Rep. Grace F. Napolitano introduced H.R. 2529, the Mental Health for Latinos Act, directing the Substance Abuse and Mental Health Services Administration (SAMHSA) to develop and implement an outreach and education strategy to promote behavioral and mental health among Hispanic and Latino populations.

"Despite the strides we have made, machismo, other cultural tendencies, and disparities within our healthcare system are still preventing members of the Latino community from receiving life-saving mental health services," Napolitano said. "These barriers to care, which existed long before COVID, are causing too many to suffer in silence, and this must change. The Mental Health for Latinos Act boosts our continued efforts to reduce stigma and promote mental wellness, while meeting the diverse needs of Hispanic and Latino populations across the country. As our nation confronts an unfolding mental health crisis due to the

pandemic, our critical legislation reinforces the timeless message that there is zero shame in asking for help and that seeking support is a sign of strength."

H.R. 2529 outlines a strategy which must be designed to:

- Provide information on evidence-based practices, interventions, and treatments that are culturally and linguistically appropriate;
- Increase awareness of symptoms of mental illnesses common among such populations, taking into account differences within subgroups, such as gender, gender identity, age, sexual orientation, or ethnicity;
- Ensure full participation of both consumers and community members in the development and implementation of materials;
- Meet the diverse cultural and language needs of the various Latino and Hispanic populations;
- Address the impact of the

SARS-CoV-2 pandemic on the mental and behavioral health of the Latino and Hispanic populations.

Napolitano, the founder and Co-Chair of the Congressional Mental Health Caucus, has co-authored legislation in past Congresses introduced by Rep. Judy Chu (CA-27), to reduce stigma among Asian American, Native Hawaiian, and Pacific Islander populations. She also works closely with fellow mental health champion and Chair of the Congressional Black Caucus' Youth Suicide and Mental Health Task Force, Rep. Bonnie Watson Coleman (NJ-12), to raise awareness and identify solutions to address the issue of Black youth suicide and mental health.

LA County's \$36.2 Billion Recommended Budget Unveiled

"Better Than Before" Spending Plan Focuses on Equity and Safety Net Services; No Layoffs Proposed

LOS ANGELES COUNTY - Los Angeles County's \$36.2 billion Recommended Budget, focused on expanding and sustaining extensive safety net services, will be presented to the Board of Supervisors on Tuesday, April 20 by Chief Executive Officer Fesia Davenport.

The spending blueprint, the first step in the annual budget process, is built on the leaner baseline and extensive cuts established in the 2020-21 budget cycle and does not propose any layoffs or furloughs.

The Recommended Budget is intended to provide the Board with a dynamic spending plan that funds key priorities and keeps service levels strong, while also ensuring the flexibility to respond to the continuing challenges of the COVID-19 pandemic and beyond.

"The pandemic has exposed and increased the gap between the haves and have-nots in Los Angeles County," Davenport said. "This budget seeks to address that by expanding safety net services to the most vulnerable, while also supporting the County's equity-focused programs and initiatives as we move toward recovery. Our goal is to make Los Angeles County a more just and equitable place for all our residents—by not just rebuilding, but actually becoming better than before."

Key investments include:

- Combatting and preventing homelessness with an additional \$16.6 million to fund Measure H strategies, for a total of \$426.7 million. Proposed focus areas include increasing and sustaining the supply of interim housing beds and motel vouchers; streamlining the bed reservation system for interim housing; and increased funding for Permanent Supportive Housing services.
- Addressing COVID-19's parallel crisis in mental health by adding \$9.8 million and 300 positions to the Promotores de Salud Mental Health Program—nearly quadrupling staffing for this vital community-based outreach and education program.
- Adding \$29.9 million to expand mental health crisis and intervention services—responding to a sharp increase in need during the pandemic, including a 30% spike in calls to the Department of Mental Health Helpline.

Setting aside a \$100 million "down payment" for the first year in the three-year ramp-up to fund direct community investments and alternatives to incarceration under Measure J. The "care first, jails last" initiative,

approved by voters last November, will be fully implemented by June 30, 2024, as specified in the measure. This \$100 million investment is the largest single allocation for a new program in the Recommended Budget.

The Recommended Budget reflects a decrease of \$2.1 billion over the previous year, primarily due to the end of one-time funding from sources including the federal CARES Act. (An in-depth look at the County's \$1.22 billion in CARES Act allocations and outcomes is here.)

The Recommended Budget to be presented to the Board on Tuesday, April 20, is expected to evolve and include additional detail about programs and available funding in the months ahead. For example, the County anticipates receiving \$1.9 billion in American Rescue Act funding, with the first installment expected to arrive in May. The Chief Executive Office is currently working with the Board of Supervisors on recommended allocations in the following proposed areas:

- Health: Sustained COVID-19 response prioritizing the most heavily impacted.
- Economic Recovery: Building an equity-focused bridge to recovery.
- Equity Investments: Systemic and infrastructure improvements to build a County that is "better than before."
- Sustainability & Preparedness: Supporting our fiscal future by restoring losses and preparing for the next emergency.

The Recommended Budget is the first step in the County's months-long budget cycle, which moves next to public hearings in May, followed by what are known as "Final Changes" budget deliberations in June. The process concludes with adoption of the Supplemental Budget in October.

L.A. County Test Positivity Rate Hits Record Low as Vaccinations Increase

LOS ANGELES COUNTY - Testing results are available for nearly 6,272,000 individuals with 18% of people testing positive. April 16's test positivity rate is 1%, the lowest test positivity rate since the beginning of the pandemic. The test positivity rate peaked over 20% in late-December during the surge.

Nearly 5,400,000 doses of COVID-19 vaccine have been administered to people across Los Angeles County. Of these, nearly 3,500,000 were first doses and more than 1,900,000 were second doses. As of April 9, 71% of L.A. County residents 65 and older received at least one dose of the vaccine. In total, 41% of the County's population 16 and older have received at least one dose of vaccine.

Los Angeles County expanded the number of sites offering

vaccination services across the county from 566 locations the previous week to 709 vaccination sites across the county last week; 266 sites are in the hardest hit communities. Vaccination sites across the county had capacity to administer nearly 734,000 doses last week. Last week, 323,470 total doses were allocated to Los Angeles County.

This week, Public Health is expecting to receive approximately 362,000 vaccine doses; an increase of nearly 39,000 doses from this week. Approximately 68% of this week's vaccine supply will be for first doses and 32% for second doses. Of the 362,000 doses of vaccine the County expects to receive this week, 73% of doses will go to sites located in the most vulnerable communities.

Additional doses will be allocated directly from federal partners and the state to pharmacies, health clinics, FEMA sites, and multi-county entities. Together, Public Health estimates over 600,000 doses of vaccine will be allocated to vaccination sites across the county this week.

Everyone living or working in L.A. County 16 and older is eligible for COVID-19 vaccine. Hypertension and Diabetes are Most Common Underlying Health Conditions in COVID-19 Deaths

Vaccination Eligibility Expands to Residents 16 and Over

LOS ANGELES COUNTY - From August 2020 through January 2021, 87% of people hospitalized with COVID-19 had at least one underlying health condition, or comorbidity. The most common comorbidity was cardiovascular disease, which includes high blood pressure, and was noted for 66% of the people hospitalized for COVID-19. Forty-two percent of hospitalized people had diabetes, and 36% had obesity.

Underlying conditions are strongly associated with deaths due to COVID-19. Since the beginning of the pandemic, 85% of people who died as a result of COVID-19 infection had an underlying condition. The most common condition was high blood pressure or hypertension, which was an underlying condition for 52% of those who died. Forty-one percent of those who died had diabetes, 26% had cardiovascular disease other than hypertension, 21% had neurologic disease, and 16% had chronic renal disease.

People who live with chronic illnesses suffer the worst outcomes of COVID-19 infection. These numbers should remind us of the importance of ensuring equitable access to preventive healthcare and the other resources that reduce people's vulnerability to this virus. If you have serious underlying health conditions, talk with your healthcare provider if you have concerns about getting vaccinated. Because chronic diseases like high blood pressure, diabetes, and obesity so dramatically increase the risk of getting severely ill or dying with COVID-19 infection, vaccination is particularly important for people living with these conditions.

Public Health released several protocols to help the people of Los Angeles begin to enjoy additional opportunities for shared activities. These include guidance on reopening indoor seated live events and perfor-

mances; guidance on safety modifications required for private events, meetings, and conferences; and relaxed rules for informal gatherings. The protocols provide guidance on distancing, masking, infection control, and capacity requirements needed to minimize risk while gathering or attending events with those not members of our household.

Public Health continues to identify variant cases in Los Angeles County. The two most commonly circulating variants of concern in L.A. County have been the UK (B.1.1.7) and California (B.1.427/429) variants. Of the 40 specimens analyzed by the L.A. County Public Health Laboratory in the past week, 55% were the UK variant and 28% were the California variant. The Public Health Laboratory also detected the three Brazil (P.1) variants last week. Although these are the first confirmed Brazil variant cases in LA County, it is likely there are other undetected cases of this variant circulating in our region.

Since January 2021, when healthcare workers began to be vaccinated, their cases declined sharply. During the last week of December, there were over 1,900 new cases of COVID-19 among healthcare workers. In the

past three weeks, there have been 50 or fewer new cases across the entire county each week. These are the lowest numbers of weekly cases among healthcare workers that seen in this pandemic.

Tragically, 256 healthcare workers have passed away from COVID-19, and we mourn the loss of these heroes. At the peak of the surge, the week of January 3, 2021, 24 healthcare workers passed away. In the past month, six healthcare workers have died from COVID-19.

Ethnic Studies: Education or Indoctrination

California Board of Education (CBOE) approved guidelines for ethnic studies courses in high schools defending the need because "researchers say [this course] can improve graduation and college-going rates among all students-and especially teens of color. The Ethnic Studies Model Curriculum is aimed at empowering students by illuminating the often-untold struggles and contributions of Native Americans, African Americans, Latino Americans, and Asian Americans in California." This is the first statewide model in the nation.

• And, would "become operative only upon an appropriation of funds by the Legislature."

We now have AB 101, again by Assemblyman Medina introduced in December 2020, and now being heard in Appropriations. A quick summary:

"Requires students in the graduating class of 2029-30, to complete a one semester course in ethnic studies in order to receive a high school diploma. Requires, commencing with the 2025-26 school year, local educational agencies and charter schools offer at least a one-semester course in ethnic studies.

Local school boards have several options to implement ethnic studies at their schools with credits toward graduation:

- an ethnic study course adopted by the CBOE;
- any ethnics study course;
- a course meeting the California University A-G requirements;
- or, a locally developed course.

What Medina's AB 101 has given us is a desperate manipulation to pass mandatory ethnic studies legislation in any form to be delivered in any uncoordinated fashion, without state approval, and leaving students with a semester of something unnecessary that should be in a comprehensive civics or history class.

Medina still needs funding and Governor's signature for this course, and Gov. Newsom's remarks included:

"This bill... would require ethnic studies to be taught in high school at a time when there is

much uncertainty about the appropriate K-12 model curriculum for ethnic studies. I have been closely monitoring the progress of the development of the K-12 ethnic studies model curriculum. Last year, I expressed concern the initial draft of the model curriculum was insufficiently balanced and inclusive and needed to be substantially amended. In my opinion, the latest draft, which is currently out for review, still needs revision."

April 15th edition of Epoch Times reported, "Teachers in ... Santa Clara county were reportedly instructed last year to hide from students' parents their 'ethnic studies' teaching materials, which describe the United States as a settler colonialist regime responsible for genocide and white supremacy ... training for teachers ... according to slides obtained by City Journal reporter Christopher Rufo ... began with a 'land acknowledgment' claiming the county and its public schools are all built on land illegitimately taken away from Native American occupants."

Dr. Shirley Weber, former assembly member (D-San Diego) appointed as Secretary of State and Africana Studies professor emeritus, was involved with IQC and creating the model curriculum. She was also author of AB 3121 establishing a committee to study reparations for African Americans; AB 931 to raise the "legal force standards from 'objectively reasonable' to 'necessary'" putting law enforcement officers at higher risk; and, AB 2466, with then-Senator, now L.A. County Supervisor, Holly Mitchell, to restore voting rights for felons not in prison or on probation giving us 50,000 new voters, many from county jails per AB 109, the 2016 realignment bill.

Weber's platform matches the Biden Harris Administration's promise to establish a national commission to study reparations, slavery, Jim Crow segregation and discriminatory federal policies including education.

This four-year effort to make ethnic studies mandatory has been unsuccessful. Former Gov. Brown signed AB 2016 authorizing curriculum development even though the Senate analysis of that bill concluded it was unnecessary and redundant because the Instructional Quality Commission (IQC) was revising the History-Social Science Framework, including ethnic studies courses.

Forward to March 2020, the San Francisco Chronicle reported in the most ethnically diverse state with 92 languages spoken, the IQC had come out with a draft model curriculum focusing on "four core groups" -- African, Asian, Mexican/Latino and Native Americans. The draft "sharply diverged from the politically neutral AB 2016 [to] partisan political agendas and activism - for instance equating capitalism with racism, lionizing 'revolutionary' warriors, and advocating for student engagement in 'tactics of resistance' and 'direct action' such as protests against police brutality and anti-Israel boycotts."

September 2020, Assemblyman Jose Medina (D-Riverside) presented AB 331 making ethnic studies a requirement for high school graduation by 2024-25. After a review of the curriculum, it got parked in the Appropriations suspense file with Anthony Portantino (D-Glendora) agreeing to several conditions:

- Charter schools were exempted from the requirements;
- Implementation date was extended to 2030;

like Chicago, have some of the worst records of violence rather than the more gun friendly areas.



I make 50 meals a week and then try not to acknowledge a lot of that is white guilt. Ah well. Keep stirring up good trouble and I will continue to be

the Bean Queen of PigeonTown."

Claremont is a small city of about 37,000 people, many of whom are related to the five colleges, a graduate university and the numerous senior residential communities. It is neither Beverly Hills nor skid row, and most residents live comfortable middle-class lives. Even so, there are the homeless who live in our parks and on our streets. More Democrat Hypocrisy: California's SB 660 and SB 663

A new wave of voter suppression may be coming to California authored by a Democrat.

These affronts to your California State Constitutional rights are currently being considered by the Senate of California. Unlike the alleged 'Jim Crow on Steroids' claims of voter suppression in Georgia these draconian bills actually are voter suppression. This latest attack is in the form of Senate Bills SB 660 and SB 663; both authored by California State Senator Josh Newman of Fullerton.

Of historical note: when Newman voted to support the Gas Tax initiative in 2018 he was recalled by his constituents. Newman narrowly won back his seat in the 2020 election.

Senate Bill 660, would specifically prohibit a person from paying money or providing any other thing of value based on the number of signatures obtained on a state or local initiative, referendum, or recall petition. "Penalties would be severe, with civil penalties costing signature collectors \$50 for each signature gathered under the by-signature pay rate or \$25,000, whichever one is more. It also instructs the Attorney General to get involved in any violations by bringing civil action." (Italics added)

Senator Newman, stated that he believes paying people to collect signatures leads to inflated supporter signatures. He further states that, paying for signatures brings an undue number of petitions, recall or otherwise, to the ballot. The people who gather signatures, for pay, often have no other source of income or use these monies to augment low wages.

SB 663: would provide, to an elected official who is the subject of a recall election, the names and addresses of every voter who signed the petition. The stated reason is to "make sure that those who signed the petitions understood the recall petition they may have signed".

From the bill: "Existing law authorizes a voter who has signed an initiative, referendum, or recall petition to remove their name from the petition by filing a written request to do so with the appropriate elections official prior to the day the petition is filed.

This bill would extend that period by authorizing a voter to file the written removal request until the day prior to the 45th day after the petition is filed.

A voter who has signed a recall petition pursuant to the Constitution or laws of this state shall have their signature withdrawn from the petition upon filing a written request that includes the voter's name, residence address, and signature with the appropriate county elections official or city elections official prior to the 45th day after the petition is filed."

Further; This bill would, "authorize the target of a recall petition to inspect the petition ... for purposes of communicating with registered voters to determine whether they signed the recall petition and whether they understood the recall petition they may have signed, and to assist registered voters to withdraw their signatures on the recall petition, if they so desire.

The bill would prohibit the target, the target's designated representatives, and entities contracting with them from publicly disclosing the names or addresses of the signers of a recall petition, except as specified, and would specify various requirements relating to ensuring the security of, and safeguarding against unauthorized use of, the information contained in the recall petition."

Passage of SB 663 would lead to harassment of voters who signed the recall petitions; first by letters and telephone calls. Then people would be showing up at the doorstep of signers homes. It would not be hard to envision

people being threatened by operatives of the subject of the recall.

These two proposed legislations would be nothing short of voter suppression and intimidation. If this legislation passes it most assuredly would be signed by Governor Newsom as he is the subject of an impending recall initiative.

To combat these bills everyone is urged to contact your state representative and express a desire to see these bills rejected by the California State Senate. Telephone calls and letters do have an impact on how Representatives vote!

Is This the New Mission of Corporate America?

Many of my Wall Street colleagues recently shared concerns about proposed board diversity plans. Differences of opinion between those advocating for greater corporate diversity and those seeing it as an industry quota system have created tensions. Other arguments played out recently in many areas of Corporate America that are increasingly becoming outspoken political forces. Once upon a time the business world sought to maximize profits for shareholders via lobbying or marketing efforts, but their newfound power is developing into some kind of governance system, while many investors appear to be buying into this vision.

Georgia recently made needed improvements in its voting security laws, including new ID requirements for absentee voters, shortened absentee voting, guaranteed (but limited) drop boxes, expanded early voting and bans on handouts for people waiting in line to vote. GOP lawmakers said the bill was necessary to restore election confidence, but Democrats feel the measure will restrict voting rights, and some have exaggerated this by calling it "Jim Crow 2.0". Soon after the decision MLB announced it would no longer hold the 2021 All-Star Game in Atlanta, and other corporations were quick to jump on board. Dozens of executives have come out to blast the new law, including leaders at Apple, American Express, Coca-Cola, Delta, Merck and Microsoft.

While corporations have long sought to influence policies that directly impact their business, recent trends suggest CEOs are now injecting themselves into political debates or activism that

could indirectly affect their bottom line. In an age of cancel culture, where ideas are carried on social media within minutes, someone may have to warn these overreacting entities of potential risks and consequences of picking sides. This political activism looks very risky! I have always thought CEOs owed their focus, concerns and communicated sensitivities to the bottom line of their representative corporations.

Switching to a happier subject, April has been the best market month (by far) over the last 50 years, #2 over the last 20 years, and #3 over the last century. The market, after its consolidation, looks very positive, especially with anticipated corporate earnings coming out shortly. The first quarter of 2021 closed with the Dow leading the major market indexes (for a change) being up 7.76%, vs. +5.77% for the S&P 500 and a tepid +2.78% for the Nasdaq composite. In fact, the Dow beat Nasdaq by the widest margin in any quarter in the last 15 years - since 2006. That's quite a shift from 2020.

Since 1983 April's gains have been steady. But for the last 10 years there has been an early dip first, then a mid-month plateau, with most gains coming in the last 8-to-10 days. In the last 10 years, Bespoke says, April has

risen nine of 10 times, with average gains of +2.34%. Looking beyond April, the old saying says "Sell in May and Go Away", but that rule hasn't held true in recent years. It could ring especially hollow this year assuming we emerge from most Covid-19 lockdowns.

Economists now estimate that the U.S. economy could grow by 6% to as much as 7% this year, fueled by a massive fiscal stimulus and the continued rollout of vaccines that are expected to have the pandemic significantly under control. That would be the fastest growth rate since 1984, during Reagan's "Morning in America" re-election campaign vs. Walter Mondale. This is no impossible dream, when you consider that a 7% gain would be a rebound from last year's 3.5% contraction.

An unprecedented amount of liquidity has entered the economic system in the last year. Total Covid-19 relief and other government programs total \$5.3 trillion so far. With that much money in hand we're now fueling a manufacturing surge, ready to meet new demand at a time when the pandemic should be winding down. That combination could fuel 6% to 7% GDP growth. Or not, if ongoing critical manufacturing component shortages and open border disruptions continue. Also, how much confidence exists that Washington leadership will not continue to harm the economy with its green new deal decisions?

Your Money - Ask Julia

I had to put my mortgage into forbearance a few months ago because I lost my job due to Covid. This has crashed my credit scores. Is there anything I can do?

Contact your lender and each credit bureau. Due to the CARES Act (Coronavirus Aid Relief and Economic Security Act), lenders are not supposed to report a forbearance to the credit bureaus. Also, plan ahead now to meet the terms of repayment according to your forbearance contract. News is reporting that some companies are struggling to find employees because those employees are making more on unemployment than they would by returning to work. This could mean that there's a window of time making it easier to find a job. Once the additional, supplemental unemployment benefits end, this window of opportunity will most likely close.

What do you suggest we do if there's a really bad recession?

For economists and the government to call it a recession, there must be an economic downturn that lasts for two quarters, or six months. We are not there, yet. The good news is that you have some time to prepare. Don't procrastinate. Focus on getting out of debt and saving up for those rainy days. If the recession is joined by inflation, there could be even fewer jobs, everything will cost more, and adjustable rates on credit cards will rise. Adjustable-rate mortgage rates would also rise, but now have built-in limits on the frequency (usually annual) and a cap on the

amount of rate increase.

What ages are really important for retirement planning?

At age 59 1/2, as long as certain conditions are met, you can start taking withdrawals from qualified retirement plans and IRAs without incurring a 10% penalty. Since these have been growing tax-deferred, you'll now have to pay ordinary income taxes. At age 62, you could start collecting reduced Social Security benefits. Depending on what year you were born, you could take full Social Security benefits when you reach "full retirement age" (65 for some, 67 for others). At age 65, you're eligible to enroll in Medicare. (If you want coverage at the earliest possible date, the Social Security Manual suggests enrolling about 2 - 3 months before turning 65.) For those eligible for Social Security, Medicare Part A Hospital Insurance benefits are automatic. There's a monthly premium if you decide you want Medical Part B Insurance benefits. At age 72, you are required to take minimum distributions from most tax-deferred retirement plans if

you want to avoid a 50% penalty on the amount that you should have been withdrawing. The federal government determines your life expectancy, which is what the annual required minimum distribution is based upon.

Our financial advisor talked to us about doing a reverse mortgage so we could fund a deferred annuity. What would you advise?

Change financial advisors! For the protection of seniors, the governing forces of the financial industry insists on a six-month or longer waiting period after a reverse mortgage before discussing investing those funds. The purpose of a reverse mortgage is to increase cash flow, or to fund long-term care.

Are annuities taxed?

With qualified annuities (funded with money you have not paid taxes on yet), withdrawals are fully taxed as ordinary income. With non-qualified annuities (funded with money that you already paid taxes on), only the earnings are taxed upon withdrawal.

Pet Licensing Amnesty Program

LOS ANGELES COUNTY - Because of the economic downturn brought on by the COVID-19 pandemic, some pet owners may have delayed purchasing their annual pet licenses and are now subject to late penalty fees.

To provide opportunities for pet owners to economically renew their pet licenses, the Los Angeles County Department of Animal Care and Control (DACC) is waiving late fees for renewed or new licenses purchased between April 15th and June 30th, 2021. These fee waivers are open for residents of all


unincorporated Los Angeles County areas and the participating cities of Agoura Hills, Azusa, Carson, Inglewood, Irwindale, La Habra Heights, Maywood, Palmdale, Rolling Hills, Rolling Hills Estates, and Walnut.

In addition to the late fee waiver, DACC is happy to offer a free microchip for all non-microchipped pets licensed during this time. Microchipping is highly encouraged because it greatly increases the likelihood that lost pets will be returned to their families. Microchipping is mandatory in all unincorporated County

jurisdictions and many cities in Los Angeles County. The free microchip offer is redeemable by appointment at any of DACC's seven animal care centers.

"We hope this license penalty amnesty program and the offer of free microchips encourages pet owners to license and protect their pets," said DACC Director Marcia Mayeda.

"TIME JOCKEY" - Champion Matadors

String of Titles... This year marks the 50th Anniversary of San Gabriel High School's run as California Interscholastic Federation (CIF) Boys Soccer championship season. The year was 1971 and soccer had become an official CIF sport the year before. In 1971, San Gabriel fielded a team which no one knew how good it could or would become. Coach John Wilde started the program pretty much from scratch.

In 1971, the Matadors opened the regular season with a 16-0 league record and defeated South Torrance with a convincing 2-0 victory in the first round of the playoffs. In the next round, San Gabriel defeated rival Mark Keppel High School by a score of 3-1 to advance to the finals. In the championship game, San Gabriel played a tough Cathedral High School Phantom team but the Matadors proved too tough and won by a score of 3-1. It marked the 19 consecutive game won by the Matadors and it gave San Gabriel High School its first CIF title.

The 1972 season opened with high expectations of a repeat sea-

son and another CIF championship. Once again, Coach Wilde crafted a team that returned a number of experienced players and the experience of a championship run. It went through the entire season suffering only 1 tie and no defeats and then entered the playoffs. In the opening round, San Gabriel was scheduled against Valley Christian and overpowered them in a 3-0 victory. In the next round, the Matadors met their championship game opponent from the previous year, Cathedral High School, and another tough game was played. The game was close the entire way but a late goal by San Gabriel proved to be the deciding difference. The Matadors won by a score of 1-0 and advanced to the CIF finals for the second consecutive year.

Awaiting them for the championship match was another repeat finalist in South Torrance High School. The Spartans were much improved and dominated their competition all season long and the Championship game was no different. South Torrance scored two quick goals and by halftime opened a 3-0 lead which in soccer is a pretty safe lead to hold up. But Coach Wilde got his

team together and encouraged them to play their game. The pep talk worked. The Matadors would not quit and dominated the 2nd half scoring four strong goals to win 4-3 and give the Matadors their back-to-back championship seasons. They finished the season with an 18-0-1 record and for the second consecutive season finished undefeated.

San Gabriel dominated the All-CIF teams with players such as Miguel Lopez, Jesse Ramirez, Jaime Brenes and Orlando Brenes all being named to the first team All-CIF. A number of other players were honored and of course Coach John Wilde received Coach of the Year. It's been 50 years since the start of that remarkable back-back championship season run but even a half-century of memories can't erase that the special championship run of the San Gabriel High School Boys Soccer teams....

Contactless front door pick-up will still be available by appointment. The Library expects to resume normal operations by


September 2021, subject to public health guidelines in place at that time.




