Governor Newsom Swears in Rob Bonta as Attorney General of California

Bonta makes history as California's first Filipino American Attorney General

SACRAMENTO - Governor Gavin Newsom today swore in Assemblymember Rob Bonta as California's 34th Attorney General. A national leader in the fight to reform our justice system and stand up to the forces of hate. Bonta is the first Filipino American in the state's history to serve in the role.

"California and the nation need leaders like Rob Bonta to meet this pivotal moment in our history with the courage, energy and tenacity it will take to shape a society more reflective of our values," said Governor Newsom. "Carrying the lessons of his remarkable upbringing at the center of historic social justice movements, Rob has been at the forefront of courageous fights for racial, economic and environmental justice from day one. As Attorney General, Rob brings to bear the legal and moral authority to effectively engage a broad array of groups - community leaders, law enforcement, the

Legislature and more - in a meaningful dialogue, so that California continues to build bridges and advance together in a direction that does justice to all our communities."

Confirmed by the Legislature, Bonta was selected by Governor Newsom to fill the

position vacated by Xavier Becerra, who was recently sworn in as Secretary of the U.S. Department of Health and Human Services. The Governor announced the nomination last month at the historic International Hotel in San Francisco, a site where Asian and Pacific

Islander Californians famously rallied in 1977 to save the homes of elderly residents and preserve their community.

"Thank you, Governor Newsom for the faith and trust you have placed in me. Serving as California's Attorney General is the honor of a lifetime," said Attorney General Rob Bonta. "There are a lot of challenges we face across America today. People see institutions that work well for those with wealth and power at the expense of everyone else. We see hate on the rise. And

too often, justice and accountability for those who harm others feel out of reach. As The People's Attorney, I won't back down when I see Californians hurt. Together, we will get justice for families cheated by multi-national corporations. We will defend communities ravaged by big polluters. We will work to repair our justice system, and we will attack the forces of hate and white supremacy. I'm excited to get to work!"

The son of activists, Bonta grew up in a trailer in La Paz, where his parents served at the headquarters of the United Farm Workers movement. Inspired to pursue justice through the law, Bonta studied at Yale Law School and went on to work pro-bono protecting vulnerable Californians from exploitation and racial profiling. He served nine years as a Deputy City Attorney in the San Francisco City Attorney's Office before running for local office in Alameda County. In 2012, Bonta became the first Filipino American in California history to win election to the Legislature, representing Assembly District 18 in the cities of Oakland, Alameda and San Leandro.

Azusa Shooting Suspect is Jailed

AZUSA - A suspect who shot a woman at the parking lot of the Home 2 Suites Hotel at 229 S. Azusa Ave. in Azusa on April 13, has been jailed with bail set at \$2,050,000.00.

David Ray Mesa, a45 years old male Hispanic and a parolee was held to answer charges of attempted murder, domestic violence and a number of other charges.

Back on April 13th the suspect met the victim in the parking lot of the hotel around 6:45 p.m. There was some type of argument and the suspect pulled a gun and shot at the woman from inside the car and was hit in the neck and critically injured. She is still hospitalized and in critical condition from the last reports made avail-

On April 16th, 2021, Azusa Police Detectives in cooperation with the U.S. Marshals Service /

Fugitive Recovery Team tracked Mesa to the City of Colton where he was arrested without incident. There is no information provided as to the exact relationship the victim and suspect had with each other. It appears that this was a premeditated event since the suspect brought the gun with him. No motive was given for the attempted murder of this woman.

Mesa who has been a resident of Azusa for less than two years has been arrested 5 times, all felonies, according to LA County Sheriff Department records. He was sentenced to 6 months in jail on one charge but only served less than 2 months.

Mesa has another court appearance on May 25th.

This incident remains under investigation, and the Azusa Police Department encourages anyone with information to contact Detective Rush at 626-812-3252.

Finding The Next Superintendent/ President Of Citrus College Is An **Inclusionary Process**

After nearly 13 years of dedicated service, Geraldine M. Perri, Ph.D., is retiring from Citrus College. Dr. Perri is only the seventh superintendent/ president to lead the institution during its 106-year history, and she has the distinction of being the first female superintendent/ president. The college is now embarking on the search for her replacement, and the sixmonth recruitment process is both inclusive and complex.

After the Citrus Community College District Board of Trustees learned of Dr. Perri's decision to retire, it reviewed proposals from various search firms to assist in finding viable superintendent/president candidates. Working with a consultant helps the board to ensure that the process is fair and equitable, and that recruitment is far-reaching.

The search firm started gathering data almost immediately about the qualities the college community and the community-at-large wanted to see in the new superintendent/president. All college constituent groups were surveyed, as well as the board and various members of those communities that Citrus College serves. The search firm gathered information and shared it with the board. It also began writing a job description and brochure information for the recruitment process.

Next, a search committee was formed, consisting of faculty, classified staff, managers, and community and Citrus

their time to receiving training on cultural competency, implicit bias and confidentiality, and they were also instructed on the procedure for screening appli-

The search firm then began advertising the position statewide and nationally, and it worked with the search committee to develop interview questions. Candidates applied online during COVID-19, and the committee selected those candidates they wanted to interview. Meanwhile, the board determined its questions for the


finalists and worked with the search firm to receive training in cultural sensitivity and labor

After the search committee completes its interviews, it will select finalists, who will then be introduced to the college community in a series of online forums. Community members may access the virtual forums to also view the finalists. Forums will take place online from May 25-27. Visit www.citruscollege.edu/ presidentialsearch for the link to these forums in mid-May.

The college community will again be given the opportunity to provide input to the board about the finalists before the board interviews candidates and selects the new superintendent/president. At that point, the process will have taken nearly six months, but it will have also involved all college constituent groups in selecting the next leader for Citrus College.

Traffic Management System Project

Upgrades to reduce congestion and improve traffic flow along major thoroughfares

AZUSA – In an ongoing effort to improve the performance of Azusa's street system and ensure safer traffic flow, the City of Azusa is pleased to announce the completion of a citywide traffic signal synchronization project at 52 intersections throughout

Traffic Signal Synchronization is a method of timing groups of traffic signals along an arterial street to provide for smooth movement of traffic with minimal stops, thereby reducing delays which result in a better flow of traffic, and minimized gas consumption and pollutant emissions experienced by motorists. Project improvements include a centralized traffic control system, modernized traffic controllers and signal poles, video detection cameras, fiber optics and wireless connections, ADA compliant curb ramps, crosswalks and new sidewalks. With centralized control of signalized intersections, the City will have the capability to monitor and adjust sig-

The project has been developed in coordination with the County of Los Angeles using traffic count data from the City's major arterial streets, which serve as essential connectors between neighboring cities, major freeways, and to various regional destinations. The project is made possible in large part by approximately \$4 million in combined grant funding from the Los Angeles County Metropolitan Transportation Authority and the Mobile Source Air Pollution Review Committee, representing various governmental agencies working to advance air quality and safe transportation issues in the region.

"By synchronizing our traffic signals, our system will be safer and more efficient for both drivers and pedestrians, while reducing pollution levels from idling vehicles and improving connectivity with our neighboring cities. This is an important technological step for our community and I'm excited for all Azusans to experience the benefits of this project, whether traveling by car, bike, or on foot." said City Manager Sergio Gonzalez.

Use of Johnson & Johnson Vaccine Resumes in Los **Angeles County**

LOSANGELES COUNTY-After a thorough safety review by the Food and Drug Administration (FDA) and the Centers for Disease Control and Prevention (CDC), they determined that the pause in the use of the Janssen (Johnson & Johnson) vaccine can be lifted and that use of the vaccine should resume. Vaccine providers in LA County with doses of the Janssen vaccine can resume administration of the vaccine, provided they distribute the updated Janssen fact sheets to any recipients of the vaccine. Public Health will be posting updated safety information about

the Janssen vaccine shortly. The decision comes after CDC's independent Advisory Committee on Immunization Practices reviewed data related to the recent reports of a rare and severe type of blood clot that occurred in individuals after receiving the vaccine. Based on their review of all available data, both the CDC and the FDA determined that the vaccine is safe and effective in preventing COV-ID-19.

The three vaccines that are currently available through the FDA's Emergency Use Authorization (EUA) remain the most powerful tools we have in reducing transmission, preventing serious illness and death, and eventually ending the COVID-19 pandemic that has claimed the lives of almost 24,000 people in LA

City Of Azusa Announces Completion Of | El Monte Union Eases Graduation **Requirements for Class of 2021** EL MONTE – El Monte of action for the benefit of our

Union High School District Board of Trustees voted to adjust the graduation requirements for the Class of 2021, easing the path for seniors who have struggled to complete their schoolwork since the introduction of distance learning in March 2020.

The credit requirements for graduation will be reduced from 220 to 190 and students will have until Aug. 15 to complete their coursework. The one-time adjustment in credits is applicable only to Class of 2021 candidates, benefiting more than 170 El Monte Union seniors who are approaching the end of the school year with 175 to 190 credits.

"El Monte Union continues to provide the best educational opportunities for our students," Superintendent Dr. Edward A. Zuniga said. "Distance learning has presented a myriad of obstacles that have greatly affected El Monte families and reduced the opportunity for our students to stay current with their studies. We are mindful of their struggles and feel this is the best course

community."

Throughout the pandemic, students have encountered an array of obstacles through distance learning, including limited internet access, the responsibility of caring for siblings, the lack of school structure, not having a quiet place to work on assignments, difficulty in adapting to an online environment, or socialemotional struggles that prevent students from being successful in distance learning.

The adjusted graduation requirements mirror the California Department of Education (CDE) mandated requirements for high school graduation. The CDE requires only 130 credits for a student to graduate, a mandate that does not require a student to complete elective classes.

El Monte Union's credit adjustment eases graduation requirements by eliminating a required fourth year of English credits, one semester of health credits, and 15 elective credits. Graduation requirements for math, science, social science, physical education, and the combined credits of visual or performing arts, foreign language or career technical education remain the same.

"El Monte Union's requirements for graduation are more stringent and rigorous than what is mandated by the state of California," Assistant Superintendent of Education Services Larry Cecil said. "The District requires four years of English and 75 elective credits, on top of what the CDE requires. In this extraordinary year we feel it is equitable to ease these standards to ensure our seniors graduate with their peers."

Seniors who are unable to complete the adjusted graduation requirements by the end of the school year will be able to gain additional credits during summer school. Seniors who do not meet the adjusted requirements by Aug. 15, 2021 will need to meet the current graduation requirement of 220 credits. El Monte Union will add a third class to its summer schedule to better accommodate these students.

As Additional Variant Cases Are Identified, Public Health Encourages Vaccinations to Reduce Risk of **Getting COVID-19 Infection**

LOS ANGELES COUNTY -As of April 18, more than 6,488,391 million doses of vaccine have been administered in the County, including 4,176,360 first doses. Already, almost 2,312,031 million people have been fully vaccinated.

Over the past two and a half months, with vaccination campaigns aimed at increasing uptake in communities of color, the County has seen vaccine uptake increase 170% in Black communities, 151% among multiracial individuals, 130% in American Indian/Alaska Natives, 129% among Latinx residents, 91% among Asian residents, and 78% among White residents.

The County has now vaccinated about half of Asian, White, and American Indian/Alaska Native residents in L.A. County and have also made some important gains in vaccinating multiracial community members, where vaccinations increased from 11% to 37% with one dose. In Latinx residents, the vaccinated proportion of the population increased more than fourfold of what it was two months ago, and in Black residents, the proportion increased more than threefold.

Over the course of the pandemic leading up to the very early days of the vaccine rollout, the County saw about 1 in every 10 L.A. County residents get infected with COVID-19 - and that's a very low-end estimate of the real numbers, given how many people who were infected but didn't get tested for one reason or another. During that same period, we saw about 1 in every 500 L.A. County residents die from COVID-19.

Looking at the data on breakthrough infections after vaccination that the CDC released last week, the risk of infection in people who are fully vaccinated was 1 in 13,275 - much less common than 1 in 10 infected with COVID-19 who were not vaccinated. And the risk of death goes from 1 in 500 to 1 in a million.

If you're taking a Pfizer or Moderna vaccine, getting the second dose is important. Although one vaccine gives you 50% to 80% protection, the second dose offers nearly 100% protection from getting a severe case of COVID-19. Make sure you show up for your appointment for your second dose, and if you don't have an appointment, contact your vaccination provider to schedule a time to receive your second dose. As a reminder, if you received Moderna for your first dose, you need to get Moderna for your second dose; if you received Pfizer the first time, you will need a Pfizer vaccine the second time. Your vaccination card tells you which vaccine you received. As a reminder, for those who received the Johnson & Johnson vaccine, you are done. It is one dose, you wait two weeks and you are fully protected.

L.A. County's case rate remains low and stable. On March 13, the County was seeing 544 cases a day. A month later, on April 13, that number decreased to 413 cases a day, a 24% decrease. Over the same period of time, the County saw a 24% drop

in daily hospitalizations, from 544 to 413, and daily deaths dropped even more dramatically by 84% from 31 to 5.

Public Health continues to identify variant cases in Los Angeles County. The two most commonly circulating variants of concern in L.A. County have been and remain the UK (B.1.1.7) and California (B.1.427/429) variants. Of the 59 specimens analyzed, 50% were the UK variant and 10% were the California variant. Most of the specimens analyzed were associated with clusters of cases, and where specimens were sequenced from larger outbreaks, the UK variant is currently identified more often than other virus variants. The Public Health Laboratory did not detect any additional Brazil (P.1) variants last week, although it is likely there are undetected cases of this variant circulating in our region.

The identification of these variants highlights the need for L.A. County residents to continue to take measures to protect themselves and others including wearing a mask, maintaining at least 6 feet of distance from those who do not live in your household, and getting the COV-ID-19 vaccine as soon as you can. All currently available information indicates that vaccines appear to be highly effective in preventing transmission, hospitalizations, and deaths, even with the increased presence of variants.

Throughout the pandemic, the higher the levels of area poverty, the higher the rates of death due to COVID-19 infection. Fortunately, with significantly less community transmission, death rates have plummeted across all communities and the difference in the rates between communities with high rates of poverty and communities with very little poverty has narrowed to 0.8%.

The pandemic also disproportionately affected Non-White populations. The impact on Pacific Islanders was particularly severe, with nearly 6 times as high a hospitalization rate as among White residents, and more than 3 times as high a death rate. Although Latino/Latinx residents were hospitalized at only 2.9 times as high a rate as White residents, they died from their infections at 3 times as high a rate. Black/African American (1.7), American Indian/Alaskan Native (1.6), and Asian (1.3) residents also died of COVID-19 at rates higher than those of White residents.

Price Of A Pure Environment | Doing And Being -- A Second Look

Our country is being directed politically by two divergent political platforms and one agenda has been broadcasting climate change as gloom and doom and the only fix is to throw huge amounts of our tax dollars at the problem with more restrictions turning our lifestyles back a cen-

One side of the aisle believes our government needs to take a strong stand on reducing, if not eliminating fossil fuels, and drive new energy sources forward with tax dollar investments in those other options. My side of the aisle, believes in allowing the private sector to develop all forms of energy creating a balance of options, without government subsidies and an expedited environmental review process.

U.S. Senator John Barrasso (R-WY), ranking member of the Senate Committee on Energy and Natural Resources (ENR) says "...the green new disaster is back with a total price tag of up to \$93 trillion ... [that] would bankrupt the nation." He reported a year ago when the Green New Deal resolution was presented in the Senate it received zero votes in

The American Action Forum says the Green New Deal (GND) is the progressive path to creating an absolutely pure environment and part of that is a vision of high-speed rail throughout the country and eliminating air travel - no more airplanes. That group estimates a cost between \$1.1 to \$2.5 trillion to complete that system. California's bullet train started out at \$19 billion and is now sitting at \$100 billion to finish that project.

Ever notice when a government body comes forward with new laws and regulations for our own well-being they always come with a fee, or what some call a

South Coast Air Quality Management District (SCAQMD) is in charge of stationary air pollution sources in Los Angeles, San

Bernardino, Riverside and Orange Counties and has a \$14 billion plan to implement rules for clean air. First problem, their revenue budget is about \$171 million. They've looked at various taxes to implement that plan and

all attempts have failed.

Rule 2305, Warehouse Actions and Investments to Reduce Emissions (WAIRE) Program is up for hearing on May 7th. This rule would target approximately 3,000 warehouse properties requiring owners with more than 100,000 square feet of space to reduce truck emissions by banning non-electric trucks from their properties or paying a charge, called a "mitigation fee". SCAQMD has a few problems with this proposal:

1. SCAQMD does not control emissions from trucks, the Air Resources Control Board (ARB) does that.

2. The warehouse property owners are providing storage space for goods and don't dictate what vehicles their customers

3. Large zero-emission trucks are not yet commercially viable.

A commercial real estate investment firm estimated the cost to warehouse operators at nearly \$1 per square foot, every single year, with NO SUNSET DATE. Annual increases are expected with no limit on this new endless tax that we all will pay for when we buy those stored goods.

SB 32 by Cortese (D-SD 15) and Stern (D-SF 27) called Building Decarbonization Requirements requires every city and county to include an eighth element in their general plan on environmental justice, or incorporate environmental justice concerns throughout the other elements and identify goals, policies, objectives, targets, and feasible implementation strategies to decarbonize newly constructed commercial and residential buildings.

Air Resources Board (ARB) says residential and commercial buildings are responsible for roughly 25% of California's GHG emissions when accounting for fossil fuels consumed onsite, like refrigerants and electricity demand, with 10% of emissions attributable to fossil fuel combustion, including natural gas.

Cal Green, billed as the firstin-the-nation mandatory green building code, designed standards to meet California's 2006 AB 32 to reduce greenhouse gases (GHG) to 1990 levels.

The goal of reducing (GHG) emissions to 40% below the 1990 level by 2030 and 80% by 2050 began with Global Warming Solutions Act of 2006, also AB 32, by Fran Pavely (D-Agoura Hills). ARB was required to determine the 1990 statewide GHG emissions level and approve a statewide GHG emissions limit that is equivalent to that level. In 2016, Pavley was back with another SB 32 with the same goals. She served full terms in the state legislature, and is currently working as the Environmental Policy Director for the USC Schwarzenegger Institute.

Staff report says the current SB 32 is a state mandate and should reimburse local governments, but also disclaims the state's responsibility for providing reimbursement because local governments can charge for the costs of implementing the bill's provisions.

A few weeks ago I suggested that I have felt the need to move from doing to being. The implication was that having spent most of my adult years engaged in a considerable list of concerns and issues in the outside world, the time had come when I needed to turn my attention inward. I offered this transition without having a clear grasp on what "being" might mean.

While I am still searching for entrees to this inner world, it has occurred to me that the sharp division between doing and being is obscure. Clearly it means far less involvement for me in politics, or my need to engage in one more campaign or personal project, and to spend more time and effort on nourishing my inner life. As I have thought about what this implies, I have wondered if the division between doing and being is not as sharp as I had assumed. I am one person with one set of gifts. Perhaps the difference is really a matter of emphasis.

My very modest venture into watercolor painting may now only partly involves proving something or creating something for others to admire—or even to purchase, but may open the door leading to a greater appreciation of nature, colors and shapes. I think of Buddhist monks who

spend days creating intricate sand mandalas, and the moment these marvelous works of art are finished, every grain of sand is carefully swept away. Perhaps for me art may have little public value, but may be a way for me to explore my inner world.

The same may be said of the books I have been reading. Formerly reading was largely research I found useable for some project in which I had become involved. Perhaps I now read mainly to enrich my inner life. Perhaps my encounter with

the true, the good and the beautiful is for their own wisdom and not that they hold any utilitarian value or data to be of use in some future column.

Moving from doing to being may mean more attention will be paid paid to grand children, friends and neighbors for their

own sakes, and will no longer be about my need to convince someone of my wisdom, or my wish that they share one of my projects or political concerns.

Paying attention to my inner world may strangely enough offer a way to pay more attention to others. Perhaps this transition will offer me the opportunity to listen to what someone else has to say instead on reflecting on what or how I plan to reply.

None of this is a way to deny who I am or quiet my deepest concerns. I will continue to explore the commitments that lie at the center of who I am. Capital punishment, health care, the environment, the poor, the left out will stay in focus. The exploration of my inner world and my commitment to "being" will not be used as an escape to some isolated, private hermit's cell where I will live unconcerned about those issues at the heart of who I am. "Being" may in fact be another avenue to that outer world.

If for many others "being" involves meditation, prayer and other spiritual practices, it occurs to me that my exploration of "being" will enrich my understanding of the "doing" that has shaped most of my life.

In 2016, I was a victim of crime, shortly after the passage of Prop 47 when violent and property crimes increased due to lighter sentencing. My pickup truck stolen and found twelve days later stripped apart in Compton. Sadly, this was a statistic all too common in the city of Cerritos. Older vehicles were stolen due to the fact property crimes (especially those under a certain dollar amount) were hardly ever prosecuted. While thankful to not be the victim of a more serious crime, I can still clearly remember the pain I felt, losing some personal possessions, like my favorite pair of bowling shoes, snow boots and the cherished suit I had just picked up from the dry cleaners that was a treasured gift from my now deceased father.

While the loss I felt paled in comparison to those felt by those who have lost loved ones, the common denominator remains rule of law must be enforced. Recently, there have been moves for a more "compassionate reform" to the prosecution of crime, but where is the compassion to victims of crime. Where is the notion of personal responsibility and holding habitual criminal offenders accountable for their actions?

Criminal Justice Legal Foundation President Michael Rushford, he compared crimes reported in 1992 with 2011, when there was tougher sentencing for habitual felons. There were 932,996 (45%) fewer of the seven major crimes, 190,681 (55%) fewer violent crimes, and 2,129 (54%) fewer murders. "That's almost one million fewer victims when we were enforcing tough sentencing." 2011 was also the year ceive increased sentences and "low level" crimes such as property theft or drug offenses had reduced sentences. This leniency extended to many theft and drug crimes not even being reported, creating a culture of fear and complacency in not only the inner cities but also suburban enclaves like Cerritos, which I

So why are we going backwards? Because we seem to forget about real data and results in this day and age. It is a well-documented fact that stronger sentencing deters crime. Isn't pre-

tims, which he ignores, or downright insults, as is in the case of the mother of Joshua Rodriguez, who was kidnapped, tortured and murdered. Instead of showing empathy, he removes sentence enhancements, ignoring the brutality of the crime, and complained that the victim's family couldn't "keep their mouth shut".

Even the Los Angeles County Sheriff Alex Villanueva, a fellow Democrat, has come out to support the recall effort against Gascon. We need peace through strength of law enforcement. Sheriffs can make all the lawful arrests, but if the DA is not prosecuting the criminals, they will be in jail and out the next minute, committing those crimes again. Neighborhood watches and community partnerships with law enforcement is key, but so are tougher consequences for criminals to send the message to evervone.

Gascon isn't working for anyone but the criminals. It's time for real solutions and real criminal justice reform, with a focus on results.

America May Have an Economic **Boom on Its Hands**

There have been many economic factors contributing to our present extraordinary expansion. In the last several days of Wall Street reporting on financial indicators, one stands out as a dramatic example: March Retail Sales. The first signs of a spending wave were also previously evident from retail sales reports. March provided the third spending surge in a year, each following a month or two after a round of fiscal stimulus. COVID-19 vaccinations probably also aided this spending surge, hopefully opening the door to an ongoing, more self-sustaining recovery.

On a percentage basis last June's 18.3% retail sales rise will retire undefeated unless there is another nationwide shutdown. That said, the 9.8% increase this March was even more impressive because it came from a much higher base. Only two retail sales categories recovered even halfway back to pre-pandemic levels last June, grocery store sales and non-store (including internet) sales. In contrast, most categories were at records in January before slipping in February and roaring to new highs in March. After the March surge, retail sales were 17.1% higher than February 2020 and 50.0% above their April 2020 low.

America can again get dressed up and finally have someplace to go. Two of the previous biggest losers - apparel stores and eating and drinking businesses broke from weak seven-month trends in March. This message was clearly backed up by the Beige Book, which, for the first time in a year, found most businesses in most districts anticipatWhat's up in the Economy?

More restaurants are reopening. Resorts in New England and on the Jersey shore are staffing for the summer. The Boston Fed expects record hotel and vacation rentals this summer, based on current bookings. Even in New York, hotels permanently closed last spring are reopening. New York City bookings are still low, and hotel rooms still cheap, but activity is picking up (despite ongoing political turmoil).

In the South tourism isn't just anticipated, it is already happening. The Richmond Fed reported strong vacation rentals, busy beach towns, and strong restaurant sales. The Atlanta Fed district, which includes Georgia and Florida, reported a tourist boom. Many hotels have reopened and report 80-90% occupancy. The Dallas Fed reported "very strong activity" at restaurants and hotels. Airlines reported strong ticket sales, despite few business travelers. People are flying to Texas (and other open states) for vaca-

In the Midwest Cleveland reported a modest rise in business travel, with more expected in the future. Chicago noted strong restaurant growth, as well as a pick-

up in air travel and hotel business. The St. Louis district and Memphis reported stronger tourism thanks to a combination of warmer weather and rising vaccination rates. The San Francisco (Fed) district reported modest improvements in travel and leisure, but activity remains well below pre-pandemic levels there (thanks to that governor). California, Arizona, Oregon, and Hawaii, all in the twelfth district, still have some of the toughest pandemic restrictions anywhere in the country. Given California's importance to the economy, when it fully reopens and travel and leisure recover there, the whole country could get another

Stimulus fueled the March retail bounce, meaning some of the fizz could fade in coming months unless government checks keep coming. But, unlike previous experience with pandemic aid, the overall economy could grow into this upward trend as vaccines finally open the door to a return to full employment and consistent spending. What that could mean, in GDP terms, is stronger growth in 2021 (even more than in 2019).

However, what will the inflation penalties be for significant government hand-outs and record high deficit spending? When will the value of America's dollar reflect our government's seemingly non-stop printing of money?

In the simplest way, please explain how inflation can hurt the value of the dollar?

Whatever your dollars can buy today will cost you more dollars to buy when there's inflation. The Rule of 72 (72 divided by percentage rate) is usually used to calculate how many years it would take for your retirement savings to double at a specific rate of return. However, the same Rule of 72 can be used to determine how many years it would take to double the price of goods. For example, at 8-percent rate of inflation, a loaf of bread would double in price every 9 years. (72 divided by 8 equals 9). IF inflation hits double-digits like it did in the 1970's, at 18percent, a loaf of bread would double in price every 4 years. On top of inflation, we have all learned that a pandemic, natural disaster, ship stuck in the Suez Canal, or certain moves by government (shutting down a pipeline, changes in foreign trade), can greatly affect prices of toilet paper, food, building supplies, generators, gasoline, etc. Also keep in mind that interest rates during inflation rise on adjustable loans such as mortgage, credit cards, etc. If a business has adjustable loans, or has to pay more for manufacturing materials and/ or goods to stock their shelves, they pass it on to you. When an employer is required to pay higher wages, they raise the price of whatever they're selling. Advice: Get out of debt and save for the

is this a good time to refinance? Now is a good time to refinance. And, yes, some lenders offer a loan to match your current number of years left on the loan you are refinancing. Statewide Task Force Continues to Root out Fraud in California's **Unemployment System**

SACRAMENTO - As part of the ongoing effort to protect Californians from fraud and ensure the integrity of the state unemployment system, the California Governor's Office of Emergency Services (Cal OES) in partnership with California Department of Corrections and Rehabilitation (CDCR), the California Employment Development Department (EDD), and the State's Districts Attorneys, the US Attorney's Office today announced additional progress by a state-led task force on investigations and interdiction efforts and has instituted new safeguards to protect Californians from fraud.

Since being established in November, the California Task Force on Pandemic Unemployment Assistance Fraud has led to the arrest of 68 individuals and opened 1,641 additional cases.

"This coordinated and targeted partnership between government and law enforcement has been very successful so far in detecting and disrupting COVID-19 related fraud schemes," said Mark Ghilarducci, Director of Cal OES and California's Homeland Security Advisor. "We want to send a clear and unmistakable message to those who would choose to exploit a once in a generation crisis, to steal from vulnerable individuals - do not try it. We will leverage all resources to investigate and prosecute you."

The Task Force has worked closely with EDD to employ new tools and bolster existing programs to strengthen its fraud detection methods. Updates include EDD's implementation of ID.me to help validate the identity of individuals filing a new claim for unemployment benefits, use of Thomson Reuter's fraud criteria to validate other claimant information, and review of existing claims to take action on highly suspect claims.

"At a time when Californians are struggling with economic challenges due to COVID-19, it is disgraceful that so much EDD fraud has occurred," said Alameda County District Attorney Nancy O'Malley. "Even more troubling is the impunity with which inmates in our jails and prisons and their co-conspirators have defrauded the public of funds that should go to those actually in need. The Bay Area Task Force is actively investigating and prosecuting these wrongdoers to ensure the integrity of our unemployment insurance system and the availability of support for those who have legitimate claims."

Representing district attorneys' offices overwhelmed by both Pandemic Unemployment Insurance (PUI) and Unemployment Insurance (UI) fraud. Sacramento District Attorney Ann Marie Schubert is leading the charge on regional task force efforts working together to return taxpayer dollars.

Governor Newsom directed Cal OES to facilitate a coordinated effort, with other state agencies, the District Attorneys and the US Attorney's Office of multiple local, state and federal law enforcement entities to hold those responsible for PUA/UI accountable to fullest extent possible under the law.

"Strong cooperation among local, state and federal law enforcement helps stop these schemes and bring perpetrators to justice," said Employment Development Department Director Rita Saenz.

The full list of organizations participating in this effort includes: California Governor's Office of Emergency Services, the California District Attorneys Association, United States Attorney's Office, Federal Bureau of Investigation, United States Postal Inspection Service, US Department of Labor, Internal Revenue Service, Federal Deposit Insurance Corporation - Office of the Inspector General, Social Security Administration - Office of the Inspector General, United States Secret Service, United

States Marshalls Service, Federal Bureau of Prisons, California Department of Corrections and Rehabilitation and the California Employee Development Depart-

Some of the statewide efforts of the task force to date include:

• Allocating \$5 million in state funding to immediately support and enhance the joint investigative efforts of regional District Attorney Task Forces.

• Establishing a new data sharing agreement which allows the CDCR to more broadly share information with EDD investigators to cross-match inmate data and more rapidly identify fraudulent claims.

• Utilizing the State cyber security threat intelligence, big data analysis and threat assessment capabilities to support investigative efforts.

• Supporting federal, state and local law enforcement in conducting search warrants, indictments and facilitating arrests of fraud perpetrators.

The US Attorney's Office for the Eastern District of California, which covers 34 counties across Northern and Central California, has appointed districtwide coordinators to work closely with federal and state agencies on combatting EDD fraud at the federal level. The US Attorney's Office is working on multiple investigations and has charged several defendants, including known gang members, who have stolen millions of dollars of EDD UI benefits.

"The U.S. Attorney's Office is committed to combatting fraud targeting benefits intended to assist individuals suffering during the ongoing COVID-19 pandemic like the conspiracy rings we are prosecuting in the Chowchilla Women's Facility," said Acting U.S. Attorney Phillip A. Talbert. "We will continue to work with our local, state, and federal law enforcement partners to investigate and prosecute fraud arising out of the pandemic."

Sacramento needs an honest leader with a clear vision." Jenner doesn't show a party preference.

"TIME JOCKEY" - Hammerin' Hank

Greatest of the Home Run... The recent passing of Hank Aaron recalled the magnificent baseball career of one of the greatest baseball players of all time. As a young boy growing up in the South, Hank was a skilled athlete who loved to play multiple sports but his favorite was baseball.

Working with his father on their farm, young Hank spent hours chopping wood, it was hard work but it unexpectantly developed his wrists into what would become his trademark athletic ability. When Hank told his father that he wanted to play baseball, his father truthfully said that their kind weren't allowed to play in the major leagues. But in 1947 that all changed when Jackie Robinson became the first black man to play in the major leagues.

A couple of years, Robinson and the Brooklyn Dodgers toured the south to play a series of exhibition games. Young Hank skipped school to see Robinson and the Dodgers and listened attentively when Robinson spoke to a group of young teens encouraging them to follow their dreams no matter the obstacles. Aaron wanted to follow Robinson into the Major Leagues and eventually impressed scouts enough with his playing ability to be signed to a contract.

When he reported to his first

Negro League team, he only had enough money for a bus ride and one change of clothes. But it was the start to one of the greatest baseball careers ever. Aaron started out playing shortstop and would eventually be drafted by the Milwaukee Braves. Fast forward to 1973. Aaron had enjoyed an illustrious career playing for a team in a small revenue market starting in 1954. He was never known as a home-run hitter as he never hit more than 47 home runs in a season but had led the National League on four separate occasions. He also won two batting titles and had a .364 average in 14 World Series games, and would eventually collect 3,000 hits in his career.

On June 10, 1972, Aaron hit his 649th home run to pass Willie Mays for second place on the All-time home run list. He was now within sight of Babe Ruth's 714 mark needing only 66 home runs to break the mark. For the next season and a half, Aaron closed in on what was considered Baseball's most coveted record. Under immense pressure, Aaron hit his 713th home run with two days to go in the 1973 season. Baseball and its fans would have to wait over the winter for Aaron to continue his pursuit of Babe Ruth's record. The Braves opened the 1974 season on the road and

in his first at bat, he hit home run number 714 to tie the record. For the next two games, no home runs are hit, no records are broken by Aaron but the excitement was heightened when the Braves returned home to play the Los Angeles Dodgers. In front of 53,000 fans and 35 million viewers on a nationally televised game, Aaron did not disappoint. On an Al Downing fastball in the 4th inning, Hank Aaron hit home run number 715 into the left field bleachers. It was the cumulation of a pressure filled journey to become the black man who broke one of sports most coveted records. Aaron would later say that Babe Ruth was still the greatest home run hitter of all-time but the humble and quiet Hank Aaron would leave his mark on baseball as one of the greatest ever to play the game. His passing is a reminder that nearly 50 years ago, Hank Aaron achieved something special, under extraordinary pressure and conditions, that no one had previously or since, even come close to




COVINA - A man identified as Gilberto "Gibby" Angulo, 27, of Montebello, has been arrested by Upland police on suspicion of sexual assault on a

Angulo, who worked as a cheerleading coach was arrested Wednesday, April 14, at his home in Montebello after a girl reported that he had sexually assaulted her, the Upland Police Department said.

his arrest.







Three-Day Full Street Closure of Lone Hill \$10,000 Reward Offered for Information Leading to the Arrest of Hiker's Killer

LA County Board of Supervisors approved a \$10,000 reward on Friday for information leading to the arrest of whoever killed Gerald "Myles" Purdue on Mt. Baldy last month.

Sixty-three-year-old Gerald "Myles" Purdue, an avid hiker, was found shot dead at Mile Marker 3.09 Mount Baldy Road in the San Gabriel Mountains, on Thursday, March 25, 2021, shortly before 2:00 P.M. Homicide Bureau detectives are asking for the public's assistance in obtaining information leading to the arrest and conviction of those responsible for the murder.

Two people who had stopped in the same turnout found the body in a culvert less than 60 yards from where Purdue's car was parked.

Investigators are particularly interested in the dark-colored 4door sedan, which was seen parked behind Purdue's car shortly before the body was found.


