New Invention May Reduce The Need For Masks in Schools, Offices and Other Indoor Environments

A new approach to indoor ventilation has been developed that can significantly decrease the risk of COVID and influenza outbreaks in schools, offices and other indoor environments, and even speed a reduction in mask wear.

The innovative invention captures and cleans individuals' breaths within seconds, before potential viruses have a chance to be dispersed throughout a room, improving overall indoor air quality. Current methods, including upgrades to existing HVAC systems, have proven somewhat ineffective as COVID outbreaks continue to create disruptions in indoor settings throughout the United

"Existing ventilation systems in schools, offices and elsewhere were not built for virus control. Not only does better ventilation decrease the risk of catching COVID, it has been shown to also improve work productivity and school performance," said Larry Schoen, P.E., Fellow ASHRAE, Principal Engineer for Schoen Engineering Inc. "And even after upgrading a traditional HVAC ventilation system with better filters, it still allows virus-laden

air to affect others in a room, creating the potential for contagion.'

According to Dr. Rama Rao Amara, Emory University School of Medicine: "We know that COVID, as well as many other viruses, are airborne, meaning they spread through the air in microscopic, aerosolized particles. So, it makes sense that these particles can be easily pulled by the room's HVAC system or larger air purifier. To stop COVID and

other pathogens, such as influenza or even the common cold from spreading in indoor environments, it is vital to capture an exhaled breath before these aerosols have a chance to journey around a room. We need to re-evaluate how indoor air quality is managed.'

Called Air-Clenz, the new technology has been customized for classrooms so teachers can see students as they did in pre-COVID settings. The size and positioning of the unit on the desk or cafeteria tabletop let students place their computers, textbooks or lunch trays within the air collection unit, so exhaled air is captured and cleaned of viruses or other pathogens while a student studies, eats or works.

to the face before it becomes dispersed has been totally overlooked," said Stuart Sheldon, CEO of Air-Clenz Systems. "Except for a face mask, which most individuals would not want to wear for the rest of their lives, there is no known system in the world that captures even 50 percent of one's exhaled air without also cleaning 100 percent of the air in a room or enclosed space. There are literally hundreds of different commercial air purifiers and HVAC system options, but none come close to achieving what Air-Clenz can achieve."

The technology adds to the HVAC system for even cleaner

Dr. Anita Broach, Air-Clenz's Chief Scientist, adds: "Research demonstrates that Air-Clenz' technology typically captures and cleans more than an estimated 85 percent of a person's exhaled breath in approximately three seconds. The captured air is then cleaned to a 99.9 percent level before being recirculated.






Suspects Arrested, Stolen Vehicle **Recovered After Freeway Gun Incident**

WEST COVINA - An Around 3:00 p.m. on Monday, November 29, the CHP had a call from a motorist that two men in a Ford Pickup Truck had pointed a handgun at them. The victim and sus- 2 pects were traveling eastbound 2 on the I-10 Freeway approaching West Covina. The victim fell back & behind the truck and followed the truck at a safe distance letting the CHP know where they were at. The suspects exited the freeway at Vincent Avenue and continued on surface streets with the victim following and relaying this information to the CHP. The CHP then notified the West Covina Police Department and soon officers were in the same area as the victim and suspects.

The truck and suspects were soon located around 3:15 p.m., and a felony stop was initiated. The West Covina Police held the suspects at gunpoint and notified the CHP who soon arrived and took over the arrest process.

Once in custody, one of the suspects was identified as an adult male, 18-year-old Jason Armando Orellana of Los Angeles and a male juvenile who was not identified. Both were arrested for brandishing a firearm at an occupant of another vehicle. It was also found that the Ford F-150 was stolen out of Las Vegas and they were charged with having a stolen vehicle, along with

altering a Vehicle Identification Number, brandishing the firearm, possession of a "loaded" firearm and possession of a loaded firearm while not being the registered owner of that weapon. The weapon is reported as being stolen as well.

The juvenile was eventually released to the custody of his parents with a juvenile court appearance pending.

Orellana remained in custody for his crimes as a criminal check was being conducted in Nevada for other crimes outside the State of California.

6.Get Scammed. Fraud is always a problem, but during the holidays fraudsters take advantage of your giving spirit. Check out any charity before you give.


7.Click the Link. Scammers send bogus delivery emails or texts trying to get your information. Don't fall for it.

Verbal Confrontation Leads to Stabbing

WEST COVINA - On Thursday evening, December 2, police and paramedics were called to respond to Yogurtland in the 1000 West Covina Pkwy. in West Covina around 7:30 p.m. to a report of a stabbing victim.

When the first responders arrived, they found the victim to have injuries considered not lifethreatening but serious.

The incident and attack occurred in the area of the bus stop near the intersection of South California Avenue and West Covina Pkwy. Apparently, there

was some type of verbal confrontation that escalated into a stabbing attack. The victim removed himself from the area and ran through the parking lot to seek help and ended up at Yogurtland. The victim was transported to the hospital for treatment. The victim was not identified nor a description of the suspect given.

There is an ongoing investigation and the police are requesting anyone who may have seen something or know something to please contact them so they can figure out what actually happened and hopefully find the suspect.

Los Angeles County Reports Additional Case of the Omicron Variant

LOS ANGELES COUNTY -The Los Angeles County Department of Public Health (Public Health) has received confirmation of an additional case of COVID-19 with mutations consistent with the new Omicron variant (B.1.1.529). The individual is a college student who returned to Los Angeles County after holiday travel on the East Coast. The individual is fully vaccinated, had mild symptoms, and is self-isolating.

Public Health has identified close contacts in Los Angeles County, all of whom are quarantining and being tested. Public Health is working with the university to determine if there are any additional close contacts. Based on travel history, it is likely that the infection was acquired outside of Los Angeles County.

Public Health has been tracking the emergence and spread of Omicron, labeled a variant of concern by both the WHO and the CDC. The Los Angeles County Department of Public Health (Public Health) received confirmation of its first case of COV-ID-19 with mutations consistent with the new Omicron variant (B.1.1.529). The individual returned to Los Angeles County after travel to South Africa via

London on 11/22/2021. This infection is most likely travel-re-

Testing is an important tool in early detection of infection to reduce spread and Public Health encourages residents who have traveled for the holidays to get tested if they traveled internationally or to locations in this country with high transmission rates. International travelers arriving at the LAX international terminal are being offered free rapid COVID-19 tests and information on federal recommendations for quarantining and testing.

"While we are still determining the transmissibility and the severity of Omicron, I encourage residents and travelers to take additional steps to protect yourself and those around you by getting vaccinated or boosters, tested if you feel sick or are a close contact, and wearing your mask," said Dr. Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "Layering on as many protections as possible will give us a better opportunity to slow the spread of this potentially dangerous variant as we prepare for holiday gatherings and a potential winter surge.'

Residents who have traveled

for the holidays should get tested if they traveled internationally or to locations in this country with high transmission rates, or they participated at gatherings and events with large numbers of people. There are free testing sites throughout the county and individuals can go to https:// covid19.lacounty.gov/testing/to find out information about where to get tested. Residents must also isolate if they have a positive COVID test result and quarantine if they are a vaccinated close contact with symptoms or if they are an unvaccinated close contact.

All residents across LA County should continue following masking protocols, which require residents to wear a mask when indoors or at large outdoor mega events - regardless of vaccination status. Individuals should also wear a mask when at any crowded indoor or outdoor events.

Getting vaccinated or boosted remains critical in preparation for the holiday season. Residents can walk-in to any Public Health vaccination site or make an appointment at the hundreds of additional sites across the county. For more information, visit VaccinateLACounty.com.

Public Health Increases Support at Skilled Nursing Facilities, **Homeless Shelters and Schools**

LOS ANGELES COUNTY -Due to the presence of the newly identified Omicron variant, L.A. County modified its Health Officer Order for Skilled Nursing Facilities to require routine testing of residents and staff and recent testing for visitors entering any indoor spaces at these

From December 15 through January 31st, all skilled nursing facility residents, employees, and contractors who may encounter residents must test for COVID-19 infection once a week, regardless of vaccination status. Additionally, to obtain entry into a skilled nursing facility, all visitors regardless of vaccination status must provide proof of either:

A negative PCR test performed within 72 hours prior to entry OR A negative antigen test performed within 24 hours prior

Antigen test kits will be made available to skilled nursing facilities to facilitate visitor testing.

People who show documentation of recovery from COVID-19 within the last 90 days (i.e. a positive COVID-19 viral test result on a sample taken no more than 90 days prior) are exempt from weekly testing and from showing proof of a negative viral test for entry.

Public Health teams have also realigned plans to ensure protection for those living and working at interim housing sites, jails, and shelters. This includes ensuring adequate supplies of testing kits and PPE, along with modifying policies to ensure safety of staff and residents.

With 1.7 million students and staff attending school in-person, Public Health is working with school districts to reinforce the importance of existing schoolbased health requirements and routine testing programs.

Suspect Turns Self in at Covina **Police Station after Stand-Off**

COVINA - Covina police officers responded to the 300 block of East Navilla Place which is an apartment complex and is north of Rowland and east of Citrus Avenue on November 3 to a reported domestic violence incident. Police basically closed off the street because of the police activity.

They ordered the suspect, who they believed had barricaded himself in the apartment to come out and surrender. The suspect did not respond. A containment area was set up and after about an hour and a half, the officers forced entry. They found that the suspect was nowhere to be found, he was gone. Officers weren't sure if he escaped the containment or

had simply left before officers arrived.

It appeared that suspect, identified as 33-year-old Joseph Gonzalez, had left the apartment unaware that the police were responding. He later found out that the police were there at the apartment and simply went to the Covina police station and turned himself in. He was fully cooperative and the police appreciated this, however, he was arrested on various felony domestic violence charges and bail was set at \$50,000.

At his court appearance on November 5, there was insufficient evidence and the charges were dropped and he was released. Gonzalez appears to have no recent arrest record if any at all. It appears that this may have been one of those "She said, He said" issues.

Although they may have been some mitigating circumstances, there was not enough to move forward with this case.



Prop 47 Beginners License For Smash N Grabs

Shopping districts in San Francisco, Los Angeles and areas throughout California are being terrorized by "smash and grab" thieves destroying property and grabbing thousands of dollars of merchandise and most are escaping punishment due to Prop 47, low or no bail policies for misdemeanors implemented by California Judicial Council, and policies of Democrat District Attorneys brought into office with huge campaign donations by Open Society Foundation's George Soros.

Prop 47 law says any shoplifting, forgery, fraud or theft under \$950 will result in a citation, no prosecution and no jail time. Thieves can walk in, take \$500 worth of merchandise and walk out. If caught, he/she/ get a citation and then can walk back in, take \$800 worth of merchandise, get a citation and walk away. And do that as many times as any of them want to as long as, at any one time, it is not more than \$950. "Smash and grab" is the same only bigger, faster, and has become more destructive and violent. The thieves have been practicing expecting L.A. D.A. George Gascon to not press charges or bail, and as L.A.P.D. Chief Moore reported, the ones arrested were back on the street before the ink was dry on the re-

SB 10 by Sen. Hertzberg (D-Van Nuys) was passed and signed by former Gov. Jerry Brown after a two-year battle to eliminate cash bail. Voters overturned SB 10 when they supported Prop 25 last year demanding the bail system be retained. The Judicial Council came back ordering no cash bail due to the Corona Virus pandemic.

Sen. Jim Nielsen (R-Tehama) former Chair of Board of Prison Terms, referring to no bail, said, "This is a stay-out-of-jail card. Criminals will thumb their noses and dismiss court orders. With our criminal justice system already weakened by AB 109,

Proposition 47 and Proposition 57, this bill will further deteriorate our public safety. With parole supervision virtually eliminated, bail agents are the only boots-on-the- ground supervision for most convicted felons."

Gov. Newsom announced on TV news, the "smash and grabs" had nothing to do with Prop 47, and said, "If people are breaking in, people are stealing your property, they need to be arrested. Police need to arrest them. Prosecutors need to prosecute them. Judges need to hold people accountable for breaking the law ... These are not victimless crimes, and I have no empathy for these criminal elements ... Even thefts under \$950 should be prosecuted as misdemeanors or "stacked" into felony complaints ... "Attorney General, Rob Bonta, appointed by Newsom, agreed with him.

Both defended 2014's Prop 47, billed as Safe Neighborhoods and Schools Act turning drug and theft felonies to misdemeanors and allowed those already convicted and in prison to petition for reductions in sentences. That reduced prison population by 13,000, on top of AB 109's early released 45,000 criminals already back on our streets. Prison overcrowding was the excuse, but the majority in Sacramento refused to build new prisons or let out more contracts to private sector prisons.

(R-Granite Bay) tweeted, "Newsom says Prop 47 isn't to blame for the lawlessness in our cities. Crime in California is absolutely out of control and our politicians are absolutely to blame."

Sen. Dianne Feinstein (D-S.F.) opposed Prop 47 and her opinion article, Oct. 15, 2014, L.A. Daily News, really called it saying, "Supporters of Proposition 47 call it the "Safe Neighborhoods and Schools Act. In truth, it will do anything but make our communities safer. Prop. 47 would do two things. First, it would reclassify a wide range of crimes from a felony to a misdemeanor ... and mean shorter prison sentences for serious crimes like stealing firearms, identity theft and possessing dangerous narcotics such as cocaine and date rape drugs ... [and] would result in the resentencing and release of thousands of individuals already convicted of these crimes."

L.A. D.A. George Gascon is credited with co-authoring Prop 47, but not mentioned is his partner in this destructive accomplishment. Those who supported Prop 47:

Mayor, Karen Bass, ACLU, AFL-CIO, California Teachers Association, SEIU California, Reed Hastings, CEO Netflix, all contributors to prevent recall Newsom.

Stop Normalizing Islamophobia

Over the Thanksgiving holiday, a video surfaced of Rep. Lauren Boebert (R-CO) making anti-Muslim remarks about Rep. Ilhan Omar (D-MN) during an event speech. She falsely claimed that once, while riding with Omar in a Capitol elevator, an allegedly frightened Capitol police officer hurried after them.

"Well, she doesn't have a backpack. We should be fine," Boebert recounted saying in her made-up story, insinuating that Omar could have been a suicide bomber because of her Islamic faith. Boebert later offered a nonapology apology on Twitter and phoned Omar in early December, but she refused to apologize directly to Omar for her fabricated elevator story. Instead, she doubled down by accusing Omar of being "anti-American."

Unfortunately, this is not the first time that Boebert has made pointedly hateful anti-Muslim comments. Prior to her latest remarks, she called Omar, who is the first hijab-wearing Member of Congress, the "Jihad Squad member from Minnesota" during a speech on the House floor as well as an "honorary member of Hamas" on other occasions. More disturbing though, but perhaps unsurprising, is the silence from Republican leadership who have refused to publicly rebuke Boebert's dangerous and bigoted rhetoric. House Democratic leaders have condemned Boebert's latest comments, but even they have yet to issue a formal resolution or penalty regarding her statements as of this writing. Meanwhile, Omar has reported hundreds of death threats.

It might be tempting for some to quickly dismiss this story as one about a media-hungry, unhinged Congresswoman looking to stoke the extreme fringe of the Republican base. But doing so would overlook a more fundamental issue. This isn't merely about two women bickering, another instance of "cancel culture" stifling Boebert's free speech, or a Muslim woman who simply can't take a joke. The real issue

here is the ongoing normalization of Islamophobia in America, which has soared to frightening new heights since 9/11. Regardless of whether it occurs in the halls of Congress or in the San Gabriel Valley, Islamophobia must end because, just like other forms of hate, it has no place in a free and just society.

The term "Islamophobia" first circulated around 1910 to describe the French colonial treatment of Muslims in North Africa. While scholars are divided on its precise definition, it generally refers to a fear, prejudice, or hatred of Muslims that leads to hostility and intolerance through the harassment and abuse of Muslims. Often motivated by ideological, political, and religious hostility, Islamophobia transforms into structural and cultural racism. Islamic traditions, culture, and religion come to be viewed as threats to Western values. Examples of routine Islamophobia today include the false claims made by some politicians and media pundits that Muslim Americans seek to replace the Constitution with "Sharia law" as well as Hollywood and the mainstream media's endless portrayals of Muslims as inherently violent and oppressed.

Muslims and people of Arab and South Asian descent bore the brunt of popular anger and retribution after 9/11. They also became the main target of U.S. government policies that resulted in racial profiling and FBI infiltration of mosques across America. From 2000 to 2009, hate

crimes against Muslims in the United States spiked by over 500 percent, according to Brown University's Watson Institute. Since 9/11, Muslims have had their religion automatically conflated with the reprehensible terrorist acts of a few individuals despite the fact that Islam has billions of adherents worldwide. The Trump administration further exacerbated anti-Muslim sentiment through its policies, including the "Muslim ban" which barred citizens of seven predominately Muslim countries from traveling to the U.S.

Twenty years after 9/11, a September 2021 report by UC Berkeley's Othering and Belonging Institute surveyed Muslim Americans and found that 76 percent had experienced Islamophobia between October 2019 and October 2020. Close to a quarter of respondents identified "discrimination/racism/prejudice," followed by "ignorance/misconceptions of Islam," as the top issues facing Muslim Americans.

These survey results only confirm why Boebert's Islamophobic remarks against Omar must be forcefully condemned, regardless of partisanship. Her words are an attack on the larger Muslim community. Leaving this behavior unchecked would send a message that hatred against Muslims is totally acceptable. Even worse, it may inspire more acts of anti-Muslim hatred on top of the over 500 incidents reported in the U.S. so far this year.

The Muslim American perspective is rarely sought out in public debates over matters of their own discrimination. In that context, Rep. Omar's response provides a much-needed voice: "I know that when we proudly stand up for our values-when we celebrate the diversity of this country, and the freedoms enshrined in our Constitution, others stand with us."

Build Back Toward Bankruptcy

Inflation has emerged as a huge problem for America amid supply chain bottlenecks plus excessive government spending and government restrictions. Gasoline prices are at seven-year highs. While the White House blames OPEC for this surge, it was caused by Biden's administration restricting America's energy production capacity. Why blame the cartel? Instead of allowing Americans to continue producing oil and gas like they had been doing prior to his election, Biden announced a release of oil from the U.S. Strategic Petroleum Reserve. on edge, with a lot of questions surrounding its infectiousness, ability to cause serious disease and to what degree it's able to evade the immune response from prior infection or vaccination. The strain first identified in South Africa was dubbed a "variant of concern" last week by the World Health Organization, sparking fresh worries it could prolong the nearly two-year COVID-19 pandemic. While no cases of this variant have yet been identified in the U.S., the CDC is "continuously monitoring" the situation and many say it is only a matter of time before it is in the USA.

The Omicron variant has about 50 mutations, more than 30 of these are on the spike protein that allows the virus to bind to human cells. The receptor-binding domain (i.e., the part of the virus that first makes contact with our cells) also has 10 mutations, which is far greater than just two for the rapidly spreading Delta variant. The first South African physician to raise the alarm over Omicron has called its symptoms unusual but mild. For example, none of her patients

experienced a loss of taste or smell, considered as hallmarks of the disease, but rather showed up with body aches and "feeling so tired," according to Dr. Angelique Coetzee. Other South African scientists and health officials have also said there were no signs so far that Omicron led to more serious illness.

Americans need to be prepared to do "anything and everything" to fight the Omicron variant, White House chief medical advisor KING Anthony Fauci said Sunday, adding that it's still "too early to say" whether lockdowns or new mandates will be appropriate. More definitive information would become available in about two weeks, though it is important to take note that other "variants of concern" - like South Africa's Beta and Brazil's Gamma - did not take off around the world as initially feared. "There are lots of unknowns," added Sharon Peacock, director of the COVID-19 Genomics U.K. Consortium. "It's so important to stress how much we DON'T KNOW at the moment about this new variant."

"I've decided we're going to be cautious," President Biden told reporters. "We don't know a lot about the variant except it is a great concern, seems to spread rapidly." But who would now believe anything that Dr. Fauci says?

Your Money - Ask Julia

My friends had their car broken into while doing Christmas shopping. My neighbor had his house burglarized. Are there ways to reduce being a victim of these crimes?

Don't advertise to burglars. They figure there are gifts under that beautifully decorated Christmas tree on display in your picture window. Be aware of package deliveries and take them off your porch before a stranger steals them. Some delivery services now offer you the choice of selecting one of several convenient pick-up locations. When shopping, put your packages in your car trunk, or cover with a dark sheet or blanket. Do not leave your purse unattended in your shopping cart. Lock your doors, and keep your garage door <u>closed</u> when not in use. <u>Be</u> aware. Be alert. If you are taking a trip, be discrete about loading luggage into your car. Stop your newspaper and mail delivery, or ask a trusted neighbor to collect them. Put some interior lights on timers to go on at night, and leave your porch lights on.

How do I go about figuring out my RMD?

The IRS provides worksheets and tables for calculating your Required Minimum Distribution. (See IRS.gov) You must receive the RMD for the year you turn age 72 by April 1 of the following year. For all subsequent years, you must receive your

RMD <u>by December 31st</u> of that year. Failure to do so results in a 50% penalty of the amount that should have been distributed to

What's the deadline for opening a Roth IRA?

To start a new Roth IRA for 2021, you have until April 15, 2022. You can also open or add to a Roth IRA for 2021 in 2022. The Federal income tax and California State income tax due date will be April 15, 2021. Check with your CPA for further clarification about a Roth IRA, and/or visit the website: irs.gov

Can I just wait until 2022 to cash my end-of-year bonus check so I don't have to pay taxes on it as income in 2021?

No, the income would still be earned in 2020. However, you could ask your boss to issue the check in 2022. Either way, ask for taxes to be withheld. An important factor in deciding

whether to get your bonus this year or next is to determine whether or not you are going to be required to pay the Alternative Minimum Tax (AMT.) Either do your research online at the tax websites, or talk to your CPA.

What's the website for money the State is holding, waiting for people to claim it? If I find any funds there, how do I go about claiming it?

For the state of California, go to https://ucpi.sco.ca.gov/ucp
Don't let anyone charge you to do this for you. (If you do not have access to the internet, I'll look it up for you – no charge, no strings, no ulterior motive.) Instructions for filing a claim are on that website, and might require the claim document to be notarized. (Hint: Check the site and inform your friends, neighbors, relatives, co-workers, and clients that they possibly have a claim.)

Women Business Owners Take Decisive Action During the Pandemic

As the country takes steps toward economic recovery amidst an ongoing pandemic, women business owners are reporting increased optimism about the current economic outlook, which may be accredited to their resilience and decisive action, according to a recent survey of women-owned businesses by PNC Bank.

Leading the way in employee vaccination. According to the survey, nine in 10 (89%) women business owners have taken action to encourage employee vaccination, compared to 78% of male business owners. In fact, half (49%) are providing assistance or education about the vaccine and nearly half (48%) are requiring their employees to receive vaccinations.

Those efforts may well be making an impact: eight in 10 (79%) women business owners estimate that a majority of their employees have been vaccinated, and eight in 10 (81%) of those with 100% vaccinated employees report they are highly optimistic about their company's prospects over the next six months. Among those with fewer than 100% of their workforce vaccinated, 56% are highly optimistic

"The optimism reflected in this survey is significantly higher than in our previous surveys of women business owners and this year, there is an undeniable correlation between safeguarding their workforce and their future financial prospects," said Beth Marcello, director of PNC Women's Business Development.

Supporting employees through the pandemic. In addition to encouraging COVID-19 vaccination, female business owners have outpaced men in taking other actions since the start of the pandemic on behalf of their employees, such as implementing health and safety improvements (49%), allowing more flexible work arrangements (49%), and providing caregiving support and other benefits (14%).

Both women (36%) and men (44%) increased wages and salaries during the pandemic to retain and attract talent, and said they plan to increase compensation (27% and 37%, respectively) in the next six months.

Taking action on social responsibility. Women business owners differed substantially from their men counterparts in the area of social responsibility, according to the survey. Six in 10 (60%) women business owners have formally considered or reviewed policies supporting diversity and inclusion, gender pay equity, volunteering or charitable giving, or sustainability or the environment in the past 12 months. This is double the percentage of men business owners who have done the same (30%).

"It is clear from the data that female business owners are prepared for the challenges they face; in fact, more than half attributed their optimism to their own resilience and resourcefulness," Marcello said. "The support they provide for each other and their employees is key to thriving, and why we're optimistic about the future for womenowned businesses and their growing contribution to economic prosperity overall."

About the survey and Project 257: Accelerating Women's Financial Equality. The survey, among small- and medium-sized businesses with self-reported revenue of \$100,000 to \$250 million, was conducted by telephone among a national sample of women's business owners during August and September of 2021

"TIME JOCKEY" - Mighty Bees

High School Football... High School football in Southern California has always been a community event pitting the best from one local city against the best from another. In the late 1930's, the California Interscholastic Federation named the sport as a CIF sport and thereby allowed all Southern California High Schools to begin their own teams. The CIF established various levels of competition in order to promote fairness among all players and teams and came up with a system based on a players' ability as well as their age, weight and height. Most high schools were allowed to field a Varsity and Junior Varsity (JV) team for each sport they chose to compete in, but additional teams were allowed to be established based on a criterion the CIF termed as "ex-

ponents". By using a players' age, weight and height, a total "exponent" score would be calculated. The total "exponent" score would place the player into a competitive level which the player would be assigned and could play at during the current high school year. The player could play above his exponent level but could never play below his exponent specified level. The "exponent" levels were named "B", "C" and "D" and these levels along with "Varsity"

and "Junior Varsity" teams were all allowed if the high school could field enough members for each team.

The eastern San Gabriel Valley in the 1960's was known as the "suburbs" were young families moved and bought homes in newly established single-family neighborhoods leading to a population growth which would continue moving eastward. While the Varsity-level program continued to receive the most publicity and recognition, high schools still rallied to support their "lower" level teams which were really training squads for future "Varsity" level team. At San Gabriel High School, the "B" football achieved more success than their Varsity team counterpart when in the early 1960's they earned a winning streak of 42 games. In

the 1960 season, Coach Blynn Wilson lead the "B" football team to their fourth consecutive Sierra League Championship going undefeated in beating Rosemead, Glendora, Sierra, Azusa and Arroyo in the Championship game. In the 1961 season, Coach Wilson again produced a strong team going undefeated in Sierra League play while scoring 104 points and only allowing 13. In the 1962 season, the "B" team won their 6th consecutive Sierra League championship but finally lost a game, their League opener against Azusa, 14-13. San Gabriel High School would continue their success at the "B" level through the rest of the decade until the CIF changed their competition levels to be more school grade level than "exponent" based. The change allowed one of the more extraordinary winning streaks in Southern California high school sports to remain safe for an indefinite length of time and proved to be San Gabriel High Schools' most successful football program


