# Los Angeles County Sheriff Alex Villanueva Launches The "Wage Theft Task Force"

- LA County Sheriff Alex Villanueva launched the first of its kind "Wage Theft Task Force" to protect undocumented and documented workers in Southern California. "Rebuilding trust with our community, in particular the undocumented, is crucial to public safety, I want those wage theft victims to know that their immigration status does not matter," said Sheriff Alex Villanueva. This Wage Theft Task Force is a collaboration with the California Labor Commission, the LA County Office of Immigrant Affairs, the LA County District Attorney's Office, the LA County Federation of Labor and several community groups.

According to a UCLA Labor Center Study, low wage earners are the most vulnerable and a whopping \$28 million dollars is stolen every week in Los Angeles County alone due to wage theft by unscrupulous employers. California Labor Commissioner Lilia Garcia-Brower said, "I applaud Sheriff Villanueva for his leadership to stand up for hard working Angelinos and partner with my office to build a targeted judg-

LOS ANGELES COUNTY ment enforcement task force."

Potential victims of wage theft are urged to reach out to a LASD patrol station to file a complaint, which will be referred to our Special Victims Bureau to investigate. Upon completion of their investigation, the case may be referred to the DA's Office and/or the California Labor Commission. Attorneys will decide if this is a criminal matter or not; however, all victims (regardless of the criminal nature of their case) will be referred to the Office of Immigrant Affairs for further support. Eventually, after a judge renders a decision and if it is in favor of the victim, LASD will serve the court order to help the victim recover his/her stolen wages.

Virgilio Gonzalez was a livein healthcare worker for the elderly disabled in a congregate setting. Virgilio says he was a victim of wage theft and in 2018 after filing a report with the Labor Commission, he received a judgment for nearly \$70,000.00 in back pay. "Wage theft hurt me and my family, it is a crime, and I hope nobody else has to go through what I did," said Mr. Gonzalez.

## Los Angeles County Board of Supervisors Chair Hilda L. Solis Launches Economic Aid Program

LOS ANGELES COUNTY -Los Angeles County Board of Supervisors Chair Hilda L. Solis, Supervisor to the First District, has dedicated \$750,000 to a program designed to assist individuals, households, and small businesses who have been severely impacted due to the COVID-19 pandemic.

"The COVID-19 pandemic is a symptom of our system's failures, of institutionalized racism, and of decades of too little investment in our public health," said Chair Solis. "This is gravely reflected in the disproportionate number of COVID-19 cases, hospitalizations, and deaths in the First District which I represent. When Los Angeles County received funding from the CARES Act, I advocated for our spending plans to prioritize communities that have been the hit the hardest and help residents directly. While we were able to fund food and nutrition services, childcare programs, rent relief assistance, and other plans, more help is needed to meet the needs of Angelenos. As we await the \$1.9 trillion economic relief plan to be signed by President Biden, I am committed to using every resource at my disposal to help our community weather the storm. It is my hope that funding from this program will let families, seniors, and small business owners, especially mom-and-pop businesses who continue to struggle in this crisis, know that they are not alone or forgotten."

Debit cards will be distributed by four non-profit organizations who will target the following communities in the First District: unincorporated East Los Angeles, unincorporated San Gabriel Valley communities, unincorporated Walnut Park, and MacArthur

In an effort to reach more constituents of the First District's Southeast Los Angeles communities, the YWCA Greater Los Angeles has generously contributed an additional \$30,000 to this

Eligible individuals and households must have household incomes that qualify as extremely low. Qualified small business recipients are microbusinesses and very small businesses. Microbusinesses include street vendors, sole proprietors, and independent contractors. Very small businesses consist of mom and pop shops and nonprofit organizations.

Use of the funds are for rent, mortgage, housing, essential transportation, food, utilities, essential technology, medical care, and childcare.

This program is being funded through discretionary funding allocated to Chair Solis' office.





Covina Police Chief David Povero

LOS ANGELES - On Feb. 2nd, most of us watched the 6hour long pursuit. If you recall, it all started around 7 p.m. Feb. 2nd, when LAPD officers from the gang unit pulled him over. The suspect started reaching under the front seat as officer approached and they quickly backed off and the suspect drove

Well, the suspect, identified as Michael Zinkiewitz, 35, of San Pedro pleaded "NOT GUILTY" in court Feb. 10th.

The chase began around 65th Street and Vermont Avenue around 7 p.m. Feb. 2, after he sped away from a traffic stop. He led police on a chase through surface streets, running red lights, driving on the wrong side of the street and excessive speeds. Police chased the silver Chevrolet Malibu to the 110 freeway where the suspect drove all the way to San Pedro, then turned around and headed north and eventually getting on the 10 freeway eastbound.

Police and news helicopters joined in the chase which took a strange turn when the suspect would drive very slowly, stop and the drive off slowly again only to stop and to repeat this over and over again. It is believed stop sticks were deployed where his tire in the front was flattened.

During the very slow pursuit, the family of the suspect called

mental illness and depression. Once the police found out about this, they defused the pursuit operation as to not be as aggressive. They were still concerned as to whether or not he had a gun.

This pursuit took so long that one by one, police units were being replaced by other units because they were running low on fuel. News helicopters had to break off coverage because they were also low on fuel. One remaining news helicopter continued to follow and broadcasts via the internet as the TV stations had to resume normal broadcasting.

The suspect continued as the car's front tire and wheel deteriorated and came apart spewing sparks and disabling the vehicle about 1:30 a.m. on the eastbound 10 Freeway near the Vineyard Avenue exit in Ontario.

About this time the last news helicopter was running out of fuel and had to leave the scene. ARCADIA - Guest speaker Pete SIberell gave an excellent, informative Santa Anita Park presentation at the Arcadia Chamber's February Community Connection.

Lucky Baldwin had a racetrack from 1909-1911 at the current Santa Anita County Park until California outlawed gambling. In 1933 wagering became legal. Christmas Day 1934, Santa Anita Park officially opened; Anita Baldwin had sold 310 acres. In 1998, Frank Stonach purchased the Park for \$126 million; the Stonach Group also owns Golden Gate Fields (northern CA), Gulfstream (Florida) and Pimlico and Laurel (Both Maryland).

Last year, Santa Anita brought \$1.1 million in revenue to Arcadia. Before the Covid, SA provided 1160 jobs annually. Currently there are over 1000 trainers, jockeys, exercise riders and grooms working at the Park.

Besides racing, Santa Anita has been utilized for Arcadia F.D. Training, parking for events: City (Snowfest) and County (Household Hazard/Waste Collection). There is a Sprint Chute and Infield Horse Corral. The Park has hosted the Breeders Cup. Events have included 626 Night Market, In-and-Out Burger Company Picnic, and "City Lights" event.

Santa Anita is a great community supporter. The Foothill Unity Center holds its awesome "Back to School Event" at the track, and Santa Anita just recently donated \$11,000 to the Center from a Calendar Sale.

## Napolitano Re-Introduces Water Recycling Investment and Improvement Act

**WASHINGTON**, **DC** - improving water supply and will Rep. Grace F. Napolitano (CA-32) re-introduced the Water Recycling Investment and Improvement Act (H.R. 1015), to assist water agencies with the expansion, planning, design, and building of water recycling plants and modernizing water infrastructure in California and other western states.

"The drought is not over not here in Southern California, nor many other parts of the west," Napolitano said. "With climate change, population growth, and now a global pandemic threatening vital water supplies, we must act now to safeguard our communities from water shortages and drought. The Bureau of Reclamation's Title XVI water recycling programs have proven to be some of the most costeffective federal programs in

Increased funding for these water recycling and reuse projects is long overdue, and I thank all of my colleagues for supporting this legislation to better serve the water needs of our constituents."

H.R. 1015 would increase the funding authorization for the Bureau of Reclamation's Title XVI water recycling competitive grant program from \$50 million to \$500 million, giving local water agencies the necessary funding to increase capacities for existing recycling plants or create new cost-effective projects to boost water supplies. Identical legislation sponsored by Napolitano in the 116th Congress (H.R. 1162) passed the House Natural Resources Committee in March of 2020 and was later included in the Moving Forward Act (H.R. 2), which passed the full House in July of 2020.

Napolitano introduced H.R 1015 with Reps. Raul Grijalva (AZ-03), Jared Huffman (CA-02), Salud O. Carbajal (CA-24), Linda T. Sánchez (CA-38), Anna Eshoo (CA-18), Dina Titus (NV-01), Mike Levin (CA-49), Mark Takano (CA-41), Nanette Diaz Barragán (CA-44), Julia Brownley (CA-26), Brad Sherman (CA-30), Filemon Vela (TX-34), and Judy Chu (CA-27).

## L.A. County Dept of **Public Health Statement Regarding Schools Reopening**

LOS ANGELES COUNTY

- The state permits elementary schools to reopen as soon as we reach an adjusted case rate of 25 per 100,000. We are informing Los Angeles County schools tonight via an emailed letter that we expect to announce we have reached this threshold effective Tuesday, February 16.

This encouraging news means that dozens of elementary schools will be permitted to reopen for in-class instruction for students grades TK-6 as early as this week.

All schools wishing to reopen must submit plans to the County Department of Public Health and the California Department of Public Health certifying that they have implemented a full range of safety measures to permit a safe reopening.

## **Public Health Encourages Everyone to Continue Using the Tools We Have to Slow** the Spread of COVID-19 and Save Lives

As we have learned over the past year, coronavirus is spread via respiratory droplets expelled by an infected person. Smaller droplets and particles can remain suspended in the air for many minutes to hours and over long distances (usually greater than 6 feet). This is why wearing a mask, in addition to physical distancing, is so important. These two actions together help prevent people from both getting and spreading COVID-19.

The Center for Disease Control (CDC) released new recommendations on masking. Masks work best when everyone wears them consistently and correctly over their mouth and nose; however, not all masks offer the same protection. When choosing a mask, make sure that: 1) it has two or more layers of breathable, tightly woven material; 2) it completely covers your nose and mouth; and 3) it fits snugly against your face, including on the sides, and has no gaps. It is also recommended that it has a nose wire to keep air from leak-

ing out of the top of the mask,

which will also help reduce fogging if you wear glasses.

If you need or want extra protection or a better fit, CDC recommends either "double masking" by wearing two masks (a disposable mask underneath and a cloth mask on top) or wearing a cloth mask combined with a fitter or brace. It is not recommended to double mask with a KN95 or two disposable masks as this does not improve the fit.

As a reminder, a mask is NOT a substitute for physical distancing. Masks are to be worn in addition to staying at least 6 feet apart when around people who don't live with you, whether you are inside or outside.

Public Health urges everyone to celebrate the upcoming holidays (Valentine's Day, and Presidents Day) safely with just your household and to connect virtually with friends and family that don't live with you. Being around people who don't live with you puts you and them at a greater risk for COVID-19 because people can be infected with this virus and not yet know it.

It is critically important that people not attend or host any private gatherings and not leave their home if they are experiencing symptoms of illness, have tested positive for COVID-19 or if they have been in close contact with or likely have been exposed to someone who is positive for COVID-19.

As a reminder, outdoor dining at restaurants, wineries, and breweries is allowed with safety measures in place to decrease the increased risk of spread since customers are permitted to spend time unmasked at these businesses. Indoor dining is not permitted. All employees that can come in contact with customers must wear both a face covering and a face shield at all times. Persons who do not live in the same household are not allowed to share a table. All establishments must post signage to this effect and verbally inform customers that everyone sharing a table must be from the same household. Tables must be positioned at least 8 feet apart and televisions or other screens must be turned off.

## Arcadia Fire Department Responds To House Fire

**ARCADIA** – On February 10, 2021 at 6:06 p.m., the Arcadia Fire Department responded to a house fire located at 1925 S. Santa Anita Ave. Fire crews arrived on scene reporting heavy fire and smoke from the rear of the home, with additional reports indicating four victims were trapped inside. Three individuals

## Recovering



As I plow through the start of my tenth decade it is becoming increasingly clear that I will never recover the physical stamina I once enjoyed. My struggle is to hold on to what is left, realizing I am slowly losing the battle, and that everything is gradually grinding to a halt. As Bette Davis said: Old age is not for sissies."

Then there are those who may be aware that remnants of the disease still inhibit their daily activities. The more devastating the attack, the more difficult the recovery. While the immediate crisis may have passed and life is slowly returning to normal, there may still lie dormant the bacteria or the virus that initially caused the onslaught. So while the disease may be held in abeyance, it may come roaring back at any moment.

The United States has recently recovered from the most devastating internal attack since the

Civil War. 

## **Cracks in the Economy**

At the Fed's Federal Open Market Committee meeting held recently the FOMC announced that they would leave key interest rates and quantitative easing unchanged. Fed Chairman Jerome Powell later said that the economic outlook remained "highly uncertain" and would depend on the path of the coronavi-

Many of my colleagues on Wall Street are getting nervous now that the 2020 federal budget deficit is forecasted to surpass \$2 trillion, surpassing 10% of GDP! The Fed may not have enough tools to control Treasury yields. While the Fed can control short-term rates, it is allowing the Treasury yield curve to tilt higher. The Fed may also soon start to curtail its quantitative easing on long-term Treasury bonds. The 10-year Treasury this past week already rose to yield 1.18%, up .08 basis points for the

Speaking of GDP growth, the Commerce Department announced that its preliminary estimate for recent GDP growth was an annual rate of 4%, well below the Atlanta Fed's latest estimate of 7.2%. Driven down by the second quarter's national lockdowns to fight China's COV-ID-19 spread, 2020's 12-month GDP contracted 3.5%, the largest annual GDP contraction since

Looking ahead, the International Monetary Fund (IMF) forecasts that the U.S. GDP will expand 5.1% during 2021, while

private economists are forecasting 4.3% growth. The pace of future GDP growth will be impacted significantly by Covid-19 restrictions. So, assuming California and other states soon reopen their economies, GDP growth should improve.

There's no question the economy faltered late last year. COV-ID case rates soared, hospitals filled up, and fatalities once again climbed. A number of states and cities tightened economic restrictions. Retail sales fell in all three months of the 4th quarter, and weekly jobless claims rose from 711k in early November to as high as 927k in early January. There's compelling evidence the economy not only stalled, but that future growth was negatively impacted.

Last month some weekly economic statistics - jobless claims, for instance - began to improve, but they improved more slowly than they deteriorated in the prior two months. Meanwhile, other weekly statistics were still losing steam. The NY Fed's Weekly Economic Index, which

peaked in the last week of December at negative 0.6% year-onyear, fell in three of the past five weeks and currently stands at -2.27%, its lowest in seven weeks.

Elevated weekly unemployment claims translated into a disappointing monthly jobs report, with just 49,000 jobs added in January. 159,000 jobs were lost during November and December. The official unemployment rate dropped recently from 6.7% to 6.3%, but two-thirds of that drop reflected 406,000 discouraged workers who stopped looking for work. If they were still among those counted as unemployed, the rate would be 6.6%.

Last year's net job losses totaled 9.3 million. Unemployment stood at 10.1 million last month, not counting the 4 million who stopped looking for work in the past year. In that light, the 49k jobs added last month seems particularly small. There still is an enormous amount of work to do to get back to full employment. The recent recovery in weekly added jobs statistics was slower than the deterioration in December! And, because USA growth fell during the second half of the fourth quarter, and recovered at a slow rate in the first quarter so far, it's entirely possible GDP could fall in the first quarter.

Is it true that some changes are being made to Proposition 13 that could affect what happens when I inherit my grandparent's home?

Although it needs some clarification, on February 15, 2021, Prop. 19 went into effect, having been certified by Alex Padilla, California Secretary of State. It is an amendment to Proposition 13. Part of this proposition deals with primary residency and inheritance. On April 1, 2020, another segment of Prop. 19 goes into effect. It deals with transferring the assessed value to a different California home. For you, and your grandparents, it would be wise to talk with a CPA about the impact Proposition 19 could potentially have on your Capital Gains tax.

I recently started my own business as a sole proprietor, not a corporation. How can I find out what tax deductions are available for me to legally take?

## Avoid Pandemic Paper Delays: Use E-File With Direct Deposit For Faster Refunds As IRS Prepares To Open 2020 Filing Season

**WASHINGTON** - With filing season opening on February 12, the Internal Revenue Service urged taxpayers to take some simple steps to help ensure they file accurate tax returns and speed their tax refunds to avoid a variety of pandemic-related issues.

Although every year the IRS encourages taxpayers to e-file their returns and use direct deposit to receive refunds, to those taxpayers who have previously not used e-file, the IRS emphasizes using it this year to avoid paper-related processing delays. Taxpayers can file electronically by using a tax professional, IRS Free File or other commercial tax preparation software. The IRS cautioned paper-filed tax returns and paper checks will take even longer this year due to a variety of reasons.

Taxpayers have until Thursday, April 15, 2021, to file their 2020 tax return and pay any tax owed. The IRS expects to receive more than 160 million individual tax returns this year with nine out of 10 returns filed electronically. At least eight out of 10 taxpayers get their refunds by using direct deposit.

"The pandemic has created a variety of tax law changes and has created some unique circumstances for this filing season, said IRS Commissioner Chuck Rettig. "To avoid issues, the IRS urges taxpayers to take some simple steps to help ensure they get their refund as quickly as possible, starting with filing electronically and using direct deposit.

"Following months of hard

work, we are ready to start this year's tax season," Rettig added. "Getting to this point is always a year-round effort for the IRS and the nation's tax community. Doing it in a continuing COVID-19 environment while simultaneously delivering stimulus payments for the nation is an unprecedented accomplishment by IRS employees. I also want to thank all our tax partners and tax professionals for their hard work that makes tax time smoother for the nation. All of us stand ready to serve America's taxpayers during this important filing season."

Be tax ready: Review pandemic-related changes

Last year's sweeping set of tax changes not only affected individuals and their families but may also affect the tax return they're filing this year. A new IRS fact sheet explains what taxpayers need to know to file a complete and accurate tax return. The IRS recognizes that filing this year may be challenging for some taxpayers and it's important to understand how to claim credits and deductions, get a refund timely and meet all tax responsibilities.

#### Recovery Rebate Credit helps people still eligible for **Economic Impact Payments**

For those who may be eligible for stimulus payments, they should carefully review the guidelines for the Recovery Rebate Credit. Most people received Economic Impact Payments automatically, and anyone who received the maximum amount does not need to include any information about their payments when they file. However, those who didn't receive a payment or only received a partial payment may be eligible to claim the Recovery Rebate Credit when they file their 2020 tax return. Tax preparation software, including IRS Free File, will help taxpayers figure the amount.

#### New language preferences to help taxpayers

Additionally, this year for the first time, Forms 1040 and 1040-SR are available in Spanish, and the IRS has a new form allowing taxpayers to request that they receive information from the IRS in their preferred language. The Schedule LEP, Request for Change in Language Preference, will allow taxpayers to request information in some 20 different languages besides English.

The IRS also wants to remind taxpayers of other important changes that could impact their tax return this year.

#### Remember to factor in retirement plan distributions

Some taxpayers found it necessary to take coronavirus-related early distributions from 401(k) plans and traditional IRAs in 2020. Under the CARES Act, those distributions - up to \$100,000 - are not subject to the

10% additional tax that otherwise generally applies to distributions made before an individual reaches age 59 ½. In addition, a coronavirus-related distribution can be included in income in equal installments over a three-year period, and an individual has three years to repay a coronavirus-related distribution to a plan or IRA and undo the tax consequences of the distribution.

Taxpayers should also remember that they can make contributions to traditional IRAs until April 15, 2021, and still deduct that amount on their 2020 tax return, if eligible.

New for 2020: non-itemizers can deduct \$300 for charitable cash contributions

Previously, charitable contributions could only be deducted if taxpayers itemized their deductions.

However, with the CARES act, taxpayers who don't itemize deductions may take a charitable deduction of up to \$300 for cash contributions made in 2020 to qualifying organizations. For the purposes of this deduction, qualifying organizations are those that are religious, charitable, educational, scientific or literary in purpose.


Now more than ever, the safest and best way to file a complete and accurate tax return and

get a refund is to file electronically and use direct deposit. Taxpayers can visit IRS.gov/filing for more details about IRS Free File, Free File Fillable Forms and Free tax preparation sites. E-filing is also available through a trusted tax professional. Free File is a great option for people who are only filing a tax return to claim the Recovery Rebate Credit, either because they didn't receive an Economic Impact Payment or did not receive the full amount.

The fastest way to get a retund is to file electronically and use direct deposit. Most refunds are issued in less than 21 days, but some refunds may take longer for a variety of reasons. Taxpayers can track their refund using Where's My Refund? on IRS.gov or by downloading the IRS2Go mobile app where they'll get a personalized refund date as soon as 24 hours after the tax return is electronically submitted.

Most early Earned Income Tax Credit/Additional Child Tax Credit filers should see an update to Where's My Refund? by February 22. The IRS cannot answer refund status inquiries unless it has been 21 days since the return was electronically filed.

IRS tax help is available 24 hours a day on IRS.gov, where people can find answers to tax questions and resolve tax issues online from the safety of their



# **Monitors And Drive Cycles**

Recent repairs to your vehicle's "Check Engine Light" have included a reset of the On Board Diagnostic (OBD) system. This process has also reset the OBD readiness monitoring system. The readiness monitors now need to re-test the computer system before verifying that all systems are functioning as designed and working properly.

### WHAT DO I DO NOW?

Drive the car normally. All OBD systems self-test the computer while you are driving, and you will never know it. Depending on the manufacturer of the vehicle, there are 5 to 10 readiness monitors that need to be tested.

To allow your vehicle's readiness monitors to perform their tests and reset the OBD system

to a "ready" state, and to determine that all systems are working properly, your vehicle will have to be driven though a drive

(Who knew my car had to pass a test to work properly?)

Your vehicle's specific drive cycle can depend on the vehicle make and model. A normal drive cycle is 5 miles of city, stop and go driving and 5 miles of steady 60 MPH of freeway driving in the same key cycle.

Keep in mind that repairing a check engine light for one system or code may unlock another hidden pending code of another system while the drive cycle tests are being performed.

If the Check Engine Light illuminates on the dash again, don't

be alarmed. It means the system failed the test. This may happen because when the original check engine light was on, all OBD monitoring stops. Just stop in and we will re-check the system.

NOTE: A flashing check engine light should be corrected immediately.

### - Chief Ernie "TIME JOCKEY"

**Passing...** Chief Ernie of the Gabrieleno Band of Mission Indians - Kizh Nation passed away on January 19th, just eight days after his wife of 70 years, Virginia, passed away. Both were 88 years old and were only six weeks difference in age. Virginia and Ernest are survived by their five children, nine grandchildren, eight great-grandchildren, one great-great-grandchild and two sisters. Funeral services are being provided through Pierce Brothers Mortuary in San Gabri-

Chief Ernest Perez Teutimez Salas was born in Los Alamitos and raised in the San Gabriel area at the San Marino Ranch under family ownership of Benjamin Wilson, James de Barth Shorb and George S. Patton Sr., and the Richardson Ranch in El Monte. He was elected Tribal Chief of the Gabrieleno Band of Mission Indians - Kizh Nation and was also the spokesperson for the San Gabriel Gabrieleno Band of Mission Indians. He worked tirelessly in bringing state recognition to the Gabrielenos with the passage of AJR96 in 1994 and suggested the name of Gabrielino in naming a new high school in San Gabriel, the first publicly named building named for the Gabriele-

The Tribal Chief and members are all lineal descendants of the indigenous people who inhabited the Los Angeles basin for thousands of years with Chief Ernie's lineal genealogical records and family history providing evidence of being a descendant of the indigenous tribes of Southern California. Chief Ernie's ancestors were from the village of Sibanga (or Siba), in the Whittier Narrows area, which was later known as La Mision Vieja. The tribe was known as the people of the willow houses and the word "Kizh" means "home" or "house". One of their villages was the original site of the Mission San Gabriel when the Spanish came to colonize Alta California beginning in 1769. The original Mission was made of a local plant resource called tule but it was not strong enough and washed away, forcing the Spanish Missionaries to move to higher ground. At the current location of the Mission in San Gabriel, the indigenous people provided the necessary labor to build the church which took 34 years to complete. Many of the indigenous people were mistreated resulting in a large reduction in the Native American population.

The Spanish named the indigenous people Gabrieleño after the Mission San Gabriel, a name which continues to apply today. Chief Ernie descends from the Kizh leader Nicolas Jose who, due to mistreatment by the Spanish, led a historic revolt in 1785 at Mission San Gabriel along with a young woman named Toypurina. Chief Ernie was also a descendant of important Spanish families like the Perez Nietos family, Manuel Perez Nietos and Juan Crispin Perez Nietos, who received the largest land grant in Alta California known as Rancho Los Nietos, an immense 360,000-acre grant. The Rancho Los Nietos land grant included areas which eventually became known as Huntington Beach, Bolsa Chica, Seal Beach, Long Beach, Los Alamitos, Gardena, Los Coyotes, Bellflower, Norwalk, Santa Fe Springs, Whittier, and more. Chief Ernie kept his culture alive continually performing his native tribal ceremonies and telling the history of his people. His passing will be a loss to the Native American community of Southern California and to the history of the Los Angeles

## **Suspect Arrested For** Vehicular Manslaughter After Fatal Traffic Collision

IRWINDALE - On Tuesday, February 9, 2021, at about 5:28 A.M., Irwindale police officers and the Los Angeles Fire Department responded to the report of a person down in the northbound traffic lanes of Irwindale Avenue at the Foothill (210) Freeway overpass. Officers located a non-responsive male adult with significant traumatic injuries at the scene. The male was transported to a local trauma center, where he died from his injuries.

Based on witness statements ₹ and evidence found at the 2 scene, it was evident the victim had been struck by a vehicle going northbound on Irwindale Avenue, which fled the scene after the collision.

Detectives from Irwindale Police Department commenced an investigation into the crime and, during the course of the investigation, were able to identify the vehicle and the driver involved in the fatal hit-and-run traffic collision on February 9th.

On Wednesday, February 10, 2021, IPD detectives located the vehicle, a light grey 2017 Ford F-150 Raptor pickup truck, at a residence in the 1100 block of Newburgh Street in the city of Azusa. The suspect, Javier Prado, a 31-year-

old resident of Ontario, was arrested without incident at the scene by detectives.

Javier Prado was booked at the West Covina City Jail on felony vehicular manslaughter and felony hit-and-run charges and was held on \$50,000.00


