with January 6th Capitol Riots GLENDORA - Glendora Police Officers assisted the FBI with serving an arrest warrant for a suspect in relation to the events at the Capitol on January 6, 2021. Hunter Allen Ehmke was arrested Wednesday, January 13, 2021 without incident while he was dining with his family at his grandfather's home in Glendora. He is the grandson of Bob Kuhn, who served on the council in Glendora in the early 1990s. Mr. Ehmke was booked at the Glendora City Jail overnight. The next morning, he was released to the FBI, who transferred him to the custody of the U.S. Marshals Service who booked him into the

Metropolitan Detention Center. His initial appearance in federal court in the Central District of California was on January 14 before Magistrate Judge John E. McDermott of the U.S. District Court for the Central District of California. The judge released Ehmke on bail. The judge also ordered him to wear an ankle monitor and to submit to a search of his home in Glendora. Initial appearance in federal court in the District of Columbia is scheduled for Thursday, January 21, 2021. According to the complaint

signed by Special Agent James Soltes of the United States Capitol Police, Capitol Police Officer Fluke observed an individual, later identified as Hunter Ehmke, wearing a dark grey jacket and dark colored pants, standing on a ledge approximately 3 feet off the ground. Officer Fluke, who is familiar with the U.S. Capitol Building from his employment with the Capitol Police, knew that the ledge had access to a multiple-pane window over 6 foot in height that leads to interior office of the

building.

Officer Fluke observed Ehmke pointing towards the window, followed by looking at the crowd to his south and waving his hand as if to summon others over to his position. Ehmke repeated the sequence of gestures again. Officer Fluke shouted out, "They're going to break the window" during this time in hopes to bring attention from fellow officers. Officer Fluke looked east to focus back on the crowd pushing on the shields and gave orders for the growing crowd to get back. Officer Fluke turned to look north again and observed Ehmke with a balled fist, pulling his arm back and twisting his upper body. Ehmke then swung forward striking a pane of the window about shoulder level of Ehmke. Officer Fluke began to run toward Ehmke while continuing

to hold his shield in both hands.

causing Ehmke to fall to the ground on the landing. Officer Fluke lost grip of the shield and fell to the ground that was covered in shards of glass. While Ehmke lay face-down on the ground, two other officers with the U.S. Capitol Police pulled Ehmke's arms behind his back and detained him with handcuffs. Office Fluke stood up and gave orders to the crowd to stay back and set a perimeter.

Officers moved north on the landing to set up a perimeter with CDU shields between a crowd of approximately ten individuals in the immediate area and the two officers, Officer Fluke, and Ehmke. This small perimeter line of officers also blocked possible attempts of breaching the now visibly broken window which, to Officer Fluke's knowledge, did not show signs of breakage prior to Ehmke striking the window. Ehmke was assisted onto his feet. USCP Officer Mooney obtained Ehmke's California driver's license and positively identified

over the radio to advise their situation and seek further instructions. These attempts could not be clearly heard or unable to be broadcasted due to the many other calls of service by USCP officers. As the officers discussed an action plan, the disturbance caused individuals of the crowd facing the Rotunda doors to divert their attention towards the approximately 10 officers in the northwest corner of the landing. Individuals in the throng began to show aggression by pointing fingers and shouting obscenities. One unidentified individual threatened Officer Fluke and the other officers, stating "you're not leaving with him", while pointing in the direction of Officer Fluke and Ehmke. Due to the growing aggression of the large crowd that far outnumbered the officers and the exigent circumstances at the time, officers made the decision to allow Ehmke depart under his own power. Officers took photos of Ehmke and the damaged window. Officers advised Ehmke that his actions were criminal and that they would seek a warrant for his arrest. Ehmke was told to immediately leave the Capitol grounds. Officers maintained custody of Ehmke's driver's license upon his release.

Los Angeles County Expands COVID-19 Vaccine Distribution with Launch of **Five Large-Scale Vaccination Sites**

LOS ANGELES COUNTY -Los Angeles County is expanding its capacity for large-scale COVID-19 vaccine distributions by opening five large-scale vaccination sites across the County.

The five established sites,



which were prudently chosen for their regional accessibility and their ability to handle large capacities of people, are:

• Pomona Fairplex, 1101 W McKinley Ave, Pomona, CA 91768

• The Forum, 3900 W Manchester Blvd, Inglewood, CA 90305

 California State University, Northridge, 18111 Nordhoff St, Northridge, CA 91330

· L.A. County Office of Education, 12830 Columbia Way, Downey, CA 90242

• Six Flags Magic Mountain, 26101 Magic Mountain Pkwy, Valencia, CA 91355

These large-scale vaccination sites came online on Tuesday, January 19, and will be able to vaccinate approximately 4,000 people per day at each site, significantly increasing the number of frontline healthcare workers vaccinated. Los Angeles County aims to complete 500,000 additional vaccinations among healthcare workers by the end of January. All vaccinations are administered free of charge.

Only priority groups identified by the Centers for Disease Control and Prevention (CDC), with additional guidance provided by the state, are receiving the vaccine; currently, only frontline healthcare workers, residents and staff in skilled nursing facilities (SNFs) and other long-term care facilities are eligible for vaccination.

Eligible healthcare workers must have verification documents, which include a healthcare worker badge with a photo, or a professional license and a photo identification (ID), or a signed letter from an employer and a photo ID, or a payment stub

from a healthcare provider with a name and a photo ID. Residents who are not in the eligible categories should not attempt to register for a vaccine appointment, at this time. Doing so will take an appointment slot away from the frontline healthcare workers.

"Los Angeles County is setting up these sites throughout the County to vaccinate our most vulnerable and at-risk residents to protect them from this deadly virus," said Los Angeles County Board of Supervisors Chair Hilda L. Solis, Supervisor to the First District. "Equity is our North Star in the distribution of the vaccine, and I thank long-term stakeholders such as the Pomona Fairplex for stepping up and working with the County to make getting a vaccine as easy, convenient and as safe as possible in hard-hit communities."

"The County's efforts to fight the COVID-19 pandemic rely on using all of the tools that we have available," said Supervisor Kathryn Barger. "As science and health experts continue to address this pandemic, these vaccines will help reduce the spread of the disease in Los Angeles County. These MPOD sites will help support the County's efforts to protect our residents and restore the fabric of our communities."

The County has also launched a new "Know Your Tier" public information campaign that highlights the County's new vaccinawebsite, tion VaccinateLACounty.com, and explains how residents can find out when they will be eligible to be vaccinated.

The large-scale vaccinations sites are in addition to more than 75 vaccination locations that have been established to facilitate the administration of doses to individuals within Phase 1A, tiers 2 and 3. To date, the Los Angeles County Department of Public Health has opened more than 20 designated vaccination centers for frontline healthcare workers and has made arrangements with dozens of pharmacies to facilitate vaccinations for frontline healthcare workers within Phase 1A. LA County began vaccinating frontline healthcare workers in December. This week, an estimated 80,000 vaccine doses will be administered at the community vaccination sites. Full Street Closure Of Fulton Road At Railroad Crossing



LA VERNE - Crews will be fully rebuilding the railroad crossing on Fulton Road in the cities of La Verne/Pomona, as part of the 9.1-mile Foothill Gold Line light rail project. This work requires a full closure of Fulton Rd. at the railroad crossing for approximately 3 months, including the temporary closure of the Metrolink Station parking entrance.

Beginning Monday, January 18th and continuing daily thru April 9th, Fulton Road will be fully closed to all traffic at the railroad crossing 24 hours a day, 7 days a week. Arrow Hwy and

Bonita Ave. will remain open and accessible by way of detour route. Crews plan to work daily during double shift hours of 6:00 AM - 11:00 PM. Overnight work and Sunday shifts may also be required.

Access to homes, businesses, and churches on Fulton Rd. within the closure area north and south of the railroad crossing will be maintained at all times, as well as access to 1st St., Roosevelt St., & Brandt St. The Metrolink Station parking entrance on Fulton Rd. will be closed temporarily.

A detour route will be in place

during the closure and signage will be posted to direct motorists and pedestrians as well as Metrolink customers. Fulton Rd. will be fully closed to all traffic at the railroad crossing between Arrow Hwy and Bonita Ave. The entrance to the Metrolink Station parking lot will be closed during the street closure (access to the parking lot will remain open from Garey Ave. to Santa Fe St.). Garey Avenue will serve as the main detour route. Arrow Highway will remain open to all traffic. Bonita Avenue will remain open to all traffic.



5 Tips to Protect Seniors from **Financial Scams Right Now**



Social isolation among seniors is not only linked to numerous negative health consequences like depression and cardiovascular disease, but it's also a primary contributing factor in financial exploitation and scams. Estimated to affect one in 10 older adults and cost billions annually, the threat of elder financial fraud is pervasive, and especially so right now.

"Scammers are banking on the fact that many seniors are apart from families and friends due to COVID-19. When someone is alone, physically or socially, they often miss out on the added benefit of a second pair of eyes and ears."

According to a recent Wells Fargo study conducted by The Harris Poll, 69 percent of all seniors age 60 and above believe they're not likely to be susceptible to a financial scam, despite nearly all seniors (97 percent) acknowledging that older people are very or somewhat susceptible to becoming a victim. When asked about their peers, the poll found that 47 percent of all seniors knew someone who had already fallen victim to a scam.

"The results indicate what most of us want -- the ability to age relatively unaffected from the realities associated with aging," says Dr. Marti DeLiema, a gerontologist and consultant for Wells Fargo's Aging Client Services. "The problem is that when someone doesn't feel they're at risk, they're unlikely to take precaution."

To better protect seniors from elder financial fraud and abuse, consider these tips from Wells Fargo:

1. Don't wait for a crisis. Seniors should speak with trustworthy family members about financial plans, as well as consult them when something doesn't feel right.

2. Stay up-to-date. Seniors

· Alleged emergency situations involving family members, often grandchildren, requiring immediate payment.

 Lottery winnings requiring upfront cash payment for taxes and other fees.

• Phone calls from alleged government agencies, such as Social Security, threatening arrest or penalties.

- The Los Angeles County Fire Department (LACoFD) has experienced a drastic decline in the test positivity rate and number of individuals out sick with COVID-19 within its workforce.

"With a nearly 75 percent acceptance rate in our Department, the COVID-19 vaccine is allowing us to keep our first responders on track to stay as healthy as possible during these most challenging times of the pandemic," said Fire Chief Daryl L. Osby. "With the second dose of the vaccine now being given to our team members, this will provide another layer of protection and allow us to continue to seamlessly provide the highest level of care to our patients."

The LACoFD's Emergency Medical Services Bureau coordinated its first vaccination clinics Countywide in late Decem-

LOS ANGELES COUNTY ber 2020, administering more than 3,000 vaccines to team members. At the time, the Department was reporting COV-ID-19 test positivity rates equivalent to that of the County's rate of 18 percent. In the weeks since the first vaccination clinics, the Department has steadily reported and documented steep declines in its COVID-19 test positivity rates from its highest weekly average of 18 percent to its current rate of 5.6 percent.

> "As expected, the vaccine began to have its impact seven to ten days after the first vaccines were given," said LA-CoFD Medical Director Clay

ton Kazan, M.D. "As the County continues to surge, new cases among Department personnel began dropping precipitously as did our test positivity rate. This is the first time in the entire pandemic that our data diverged from that of the County."

This week, LACoFD physicians, pharmacists, nurses, nurse practitioners, and paramedics administered the second dose of the COVID-19 vaccine to team members, including Fire Chief Daryl L. Osby who joined other first responders at Fire Station 54 in the City of South Gate.

Watershed Restoration **Projects Receives Federal Authorization**

ARCADIA - The end-ofyear Federal Funding and Coronavirus Relief Bill included a provision authorizing planning with the Army Corps of Engineers to restore creeks and wetlands in the Rio Hondo and San Gabriel Watersheds in Los Angeles County. The Rio Hondo and San Gabriel Watershed **Restoration Project is managed** by the Cities of Arcadia, Bradbury, Duarte, Monrovia, and Sierra Madre, along with partnership from the County of Los Angeles and the Los Angeles County Flood Control District. The authorization was made possible due to the leadership of Congresswoman Grace Napolitano (CA-32), Congresswoman Judy Chu (CA-27), Senator Dianne Feinstein (CA), and Senator Kamala Harris (CA) in the bi-annual bill that authorizes Army Corps projects, which was added to the funding and virus relief bills that were signed into law on December 27, 2020.

A3 Supervisors Call For Measures To Begin Expanding Vaccination Efforts

LOS ANGELES COUNTY - Seeking to support the County's efforts to address the COV-ID-19 pandemic and the tragic impact on its residents, Supervisors Kathryn Barger and Janice Hahn are calling for additional flexibility in vaccinating as many residents as possible and a process to begin vaccinating those 65 and older.

"Efficient and effective distribution of the COVID-19 vaccine to our residents and communities is the most critical hurdle in our ability to recover from this virus," said Supervisor Barger. "While we continue to prioritize the vaccination of healthcare workers who have been on the frontlines caring for our vulnerable residents, we must add flexibility to this process and begin efforts to vaccinate those 65 and older."

"Governor Newsom has encouraged all counties to open up vaccination appointments to residents 65 and older so that we can protect our residents who are most vulnerable to this virus," said Supervisor Hahn. "L.A. County needs to follow the State's lead without further delay."

Los Angeles County, in accordance with California guidelines, continues to vaccinate its healthcare workers as the priority population in Phase 1A. The County expects to complete this phase in the coming weeks given the size and scope of the region. The state recently announced accelerated prioritization of residents 65 and older in response to further recommendations by the Centers for Disease Control.

While the County still prioritizes the vaccination of healthcare workers, it is crucial to implement flexibility to vaccinate as many residents as possible and a process to begin vaccinating those 65 and older. Supervisors Barger and Hahn are calling for the County to begin vaccinating those 65 and older as soon as possible.

The County must ensure that its frontline healthcare workers are protected and limit the spread of COVID-19 from staff in its healthcare facilities. Nevertheless, more than 70% of COVID-19 related fatalities have been among residents over the age of 65, and the immediate vaccination of the County's most vulnerable neighbors cannot be delayed.

This is in line with guidelines from Dr. Anthony Fauci who has encouraged opening vaccination eligibility to people aged 65 and older, stating "when people are ready to get vaccinated, we're going to move right on to the next level, so that there are not vaccine doses that are sitting in a freezer or refrigerator where they could be getting into people's arms."

Public Health Announces First Confirmed Case of U.K. Coronavirus Variant in Los Angeles County

LOSANGELES COUNTY - The Los Angeles County Department of Public Health (Public Health) has confirmed the first case of COVID-19 variant B.1.1.7, the same variant discovered in the United Kingdom (U.K.), in an individual who recently spent time in Los Angeles County. The individual is a male who traveled to Oregon, where he is currently isolating. The variant was confirmed by Quest Laboratories in Washington state.

Although this is the first confirmed case of the U.K. variant in Los Angeles County, Public Health believes that it is already spreading in the community. Public Health is continuing to test samples. Viruses constantly change through mutation, and new variants of a and globally during this pandemic.

In the U.K., the variant B.1.1.7 emerged with an unusually large number of mutations. The variant spreads more easily and quickly than other variants. Currently, there is no evidence that it causes more severe illness or increased risk of death. This variant was first detected in September 2020 and is now highly prevalent in London and Southeast England. It has since been detected in numerous countries around the world, including the United States and Canada. The Centers for Disease Control conducts routine analysis of SARS-CoV-2 genetic sequence data to support public health response. The DPH lab is also regularly analyzing specimens for variants, including the U.K. variant, and, to date, has not identified other cases linked to this specific variant.

happen more easily and residents must more diligently follow the safety measures put in place to prevent additional cases, hospitalizations, and deaths. This includes wearing a face covering properly over your nose and mouth, physically distancing, and not gathering with people from outside your household. With community transmission at an all-time high, staying home as much as possible is the best protection. The same strategies that we've been using to help slow COVID-19 will only be effective in slowing spread of the U.K. variant strain of COVID-19 if they are used by everyone all of the time.

LOSANGELES COUNTY - As of Thursday, more than 279,000 doses of vaccine including more than 219,000 first doses and more than 60,000 second doses have been administered to healthcare workers and residents and staff at skilled nursing facilities in Phase 1A. The County is in the process of offering vaccinations to all remaining healthcare workers in Phase 1A. While many frontline healthcare workers have already received their first dose, we estimate an additional 450,000 healthcare workers need to be vaccinated.

Free Money on a Credit Card All The Lonely People

I thought I was following D.C. discussion on the CARES Act and second round of support money. All of a sudden, I received a credit card looking piece of plastic that tells me I need to call an 800 number to activate the card to access "YOUR" funds. Reading more, I discover it is no longer the CARES Act, it is now COVIDrelated Tax Relief Act of 2020 and is no longer a check but a Visa Economic Impact Payment Card enabled by Money Network.

I almost shredded it without even reading it. Every day I receive an average of six pieces of advertising considered junk mail. At first glance, this piece fell into that category. The envelope is not embossed with the name of the sender (U.S. Treasury) but merely reads Economic Impact Payment Card, Omaha, Nebraska, an advertising facsimile credit card and life insurance companies mail out. It does say, not a bill or advertisement, and important information. But how many pieces each week do I get that say the same thing to entice me to open it and go for it.

It was in the "shred" pile when I took another look. There are a bunch of numbers at the top, a scan line and no explanation what those numbers are and what they do. To activate this card and find out how much free money I am getting, I must call an 800 number and use a pin number attached to the card. My other credit cards, like this one, are promoted as a safe, secure and convenient, but that's after I filled out one long application and agree to terms and conditions. Does this card really know who I am, and would it know, if somehow, it

never got to me, and I was someone else calling in for me? It does say if your card has been lost or stolen to call an 800 number, but how would I know that if I never received it? Just like the vote by mail cards that were sent out - If you don't live at this house and have moved, please mail this card back with your new address.

It has 800 numbers and websites to check to get the answers needed. But we've learned this past year, and in my former work environment, many families struggle with their kids' education, and now with online learning, because they've not been able to afford computers, routers, internet service, printers, what many of us take for granted as regular household appliances. How does the homeless population get this card and check all this stuff out at websites and eipcard.com if they have questions?

When President Trump started the CARES Act, it was to provide almost instant help for families and keep businesses afloat so they could keep people em-

ployed, a roof over their head, food on the table, basic essentials, and money circulating to keep the economy, if not booming, at least alive. A check in the mail was quick, easy and gave people instant money and feeling a little more secure. I wasn't aware this second round of COV-ID support money was going to be a credit card and way too complicated for people stressed out and struggling. My interpretation: Use it free for domestic or international purchases at point of sale, but it you deposit it in a bank account and withdraw money, there's a charge. Free the first ATM or over the counter withdrawal, but pay a \$2 fee for the second transaction; and, \$3 if withdrawals are international. Why international to deal with the American COVID? I'll call that 800 number and ask. ATM inquiries about the balance on this card will cost you 25 cents each time. If you deposit the money in your account, make a withdrawal, it's free the first time but will cost you \$5 the second time. Guess this isn't free money after all.

The card, issued by MetaBank, Meta Financial Group, Inc is based in Sioux Falls. South Dakota and Dallas, Texas, with 10 bank branches nationwide, is FDIC secured and Glen Herrick is the CFO, formerly with Wells Fargo risk management group and the student loan division.

Three pieces of paper with a piece of plastic and charges to use it unless it is used at point of sale where products and charges are tracked. What happened to go green?

There is a difference between solitude and loneliness. There are those in every community who appear totally satisfied with being left alone. They are never rude; they just are content with their isolation.

In some cases there was more than one family member to be mourned. What is more, Christmas is usually a precious family time, and even though Americans had been discouraged from traveling, mostly to reunite families, airports were mobbed by people traveling at their own peril. And for many of the millions who remained isolated, the pain of being separated from loved ones was-and remainsjust too painful to admit.

This lonely loss has hit Wendy and me. As our years are running

out, not to see and hold children, grandchildren and now greatgrandchildren has been terrible. One day at a church convention I saw a very old friend accosted by a young woman who said, "Dr. Van Boskirk, I have always wanted to know you," and he, supported by his cane, replied, "You had better hurry." If these young children want to know us, they had better hurry. So, loneliness has descended on apartment 204.

Perhaps there must go out a call to each of us to be particularly aware of all the lonely people while they may be hesitant to reach out, their pain is real.

Isn't there always room for one more friend? Well, the year has been tough on all of us as fewer and fewer have escaped the dark domination of loneliness. So why not reach out to some lonely person out there?

A generation ago the Beatles riveted the world's attention on two lonely people whose names you may have forgotten. Eleanor Rigby sat by her window waiting for someone to love her, but no one ever came. She silently cleaned the church hall following someone else's wedding. And when Eleanor Rigby died, there were no mourners. Father McK-

enzie wrote sermons no one cared to hear, and was Eleanor Ridgy's solitary servant at her death. So alone, he was reduced to spending silent hours darning his socks, just as her name was buried with her body.

Guest Commentary: No Hotel at West Covina's BKK Landfill?

West Covina's City Council had given hotel developer Singpoli until October 31, 2020 to close escrow and purchase city owned land at the BKK landfill. The land sale did not occur.

Since late 2016 Singpoli had pursued the land deal for an "inpened. Singpoli's media representative for the BKK hotel project states that he no longer works for Singpoli.

While City officials are maintaining silence, it's possible that some explanation of why the land sale did not occur may have to be made to State Auditor. The reCouncil on July 21, 2020 the City Clerk read into the record 280 statements from residents in opposition to Singpoli's proposed hotel. No residents spoke in favor of the hotel.

While the City Council's and Singpoli's next steps at BKK are unclear, regulatory agencies that

the integrity of our most basic process--voting. Deliberating in some capacity on these possible and probable fraudulent activities is not only in the SCOTUS wheelhouse, but is imperative in these times of national stress.

In the football term, Justice Roberts has now "punted" twice on two of the most important aspects of our political and social landscape- the healthcare conflict, which takes up about onesixth of our economy (and now comes into question as we have faced a Covid pandemic) and the concept of voter integrity, which is at the heart of our Constitutional rights.

I will go as far as saying the Chief Justice has performed a ternational destination hotel." Singpoli's original plan called for an amusement park and a hotel. That was followed by a revised plan for thoroughbred racehorse training tracks and 1,110 stables along with the hotel. Singpoli's latest proposal retained the 400room hotel, though racehorse training had been replaced with features like an outdoor amphitheater and zip lines.

West Covina City Manager Dave Carmany did not respond to a request for comment about why the land sale did not occur. Councilman Tony Wu, the Council's most ardent supporter of Singpoli's proposals also did not respond to the same request as did West Covina's new Mayor, Letty Lopez-Viado.

Mr. Kin Hui the Chief Executive Officer of Singpoli has also remained silent about what hap-

cent Auditor's report about West Covina's deteriorating financial condition includes the City asserting that the BKK land sale to Singpoli would assist in replenishing the City's dwindling general fund. The City's response to the State Auditor's report is due in later this month.

Singpoli's proposed project, referred to by opponents, as the "Landfill Hotel" was to have been built directly adjacent to California's largest toxic hazardous waste landfill, a landfill that is also unlined. The public health and safety risks that poised, as well as potential destruction of nearby sensitive native California habitat led to years of contentious opposition to Singpoli's proposed hotel by local residents, particularly those in West Covina and Walnut.

oversee BKK are proceeding with their plans for BKK.

Recently CalRecycle issued a Stipulation Order to the City West Covina. It requires the City to fulfill public health and safety obligations at and around the landfill, ones that the City had neglected for years.

The California Department of Toxic Substances Control is proceeding with plans to upgrade primary safety systems at BKK such as the landfill gas and contaminated groundwater extraction and processing systems. These systems include hundreds of wells and miles of piping.

The U.S. Department of Fish and Wildlife is continuing to press the City to meet its unfulfilled commitments for habitat restoration that were a condition for development that's already occurred at BKK such as Big League Dreams and the failed golf course project.

Mr. Jobst is a 32-year resident of West Covina and cofounder of Livable West Covina, a civic group opposed to intensive development at the BKK landfill and focused of public health and safety associated with the landfill.

Concerns About Inflation

Joe Biden has referred to the latest coronavirus aid package as a "down payment" for dealing with the pandemic. Another stimulus bill providing more funding for tests, vaccinations, aid to cities and states, plus a third round of direct payments could add up to trillions of dollars! Why wouldn't that prompt worries about inflation as well as massive federal deficits.

The U.S. hasn't seen significant inflation in almost 40 years! Since the 2008 financial crisis the economy has experienced very low inflation and even some limited deflation. A moderate level of inflation occurs naturally in a growing economy, yielding slightly higher prices that encourage businesses to invest, as well as wages and interest rates to go up.

Central bank officials have indicated they will tolerate inflation levels higher than 2% to juice the economy and move toward full employment. However, if inflation rises at a faster rate than desired it could be harmful for investors. Inflation much above 2% could also force the Fed to tighten policy sooner than expected.

"The bottom line is that it will take a long time for average inflation to reach 2%," Chicago Fed President Charles Evans said last Monday. "To meet our objectives and manage risks, the Fed's policy stance will have to be accommodative for quite a while." However, others like Bill Dudley, the former president of the New York Fed, made waves last month by suggesting inflation might come back "much more quickly than the consensus suggests" due to pricing differentials as well as the lingering effects of the pandemic.



As for fundamentals, one of the most important is the global nature of inflation. The spread of vaccines and end of lockdowns should unleash demand, but it will also unleash supply. In countries where governments are not as generous in propping up income, production could boom while demand will take time to recover. Weak emerging economy inflation (meaning the lack of inflation) will also likely hamper inflation growth in the US and Europe. As a rule of thumb, US recessions crush inflation for years and globally synchronized recessions are even more disinflationary.

Regarding global economic growth, it does not look so good in the European arena. However, Wall Street does not see slow growth spreading to the US. Bloomberg News reports economists are abandoning European growth forecasts as a new, more contagious COVID strain spreads on the continent and lockdowns tighten. Double dip recession is now the EU consensus. EU growth fell in the first and second quarters last year. Growth returned in the third. The fourth quarter economic decline is expected to be -1.5%, while the first quarter consensus is -4.1%! That would equate to a fairly severe EU recession on the heels of a severe drop just last year.

The strength of German manufacturing and exports are expected to help the EU's largest economy escape the Q4 drop. But even if Germany avoids the recession, the rest of Europe is not expected to be so lucky.

The most successful international and US vaccination campaigns (in terms of percent of population vaccinated) are those with the fewest restrictions. Recently, the CDC urged states to open vaccination to everyone over 65. Fortunately, NY dropped its complicated approach in favor of an aged-based one. In NYC, the city's COVID app, which was terrific in directing people to test sites in recent months, tells people where to go for a vaccine shot, but does not indicate who is eligible or how many people can be actually be vaccinated. Hopefully the vaccination pace will improve in all states once officials settle on a workable plan and execute it.

Nevada (my state of residence) recently opened up an online process for older people to get vaccinated soon at multiple designated locations. A reservation is required before anyone can show up to get their first COVID-19 vaccination. This registration process in Nevada is currently limited to those of us over 70 years old. Several of my neighbors have COVID-19 vaccinations scheduled during the first half of February. This is a good sign that vaccination availability for at least higher risk people will soon be ongoing throughout the USA!

management techniques. Because of such reasons change is not a welcome alternative for many; such cases should be handled with utmost care and careful communication only. To complicate mater even more remote work puts a twist on the so-called working environment that many are still not use to.

The role of communication in the success of any business function is a well-documented fact. Its efficacy is ushering change is also evident from the fact that often organizations choose people with better communication skills to lead a change initiative, with the hope that they will able to gain widespread support across the organization.

Before we look into the virtues of communication, let's look closer at the process of change management. Managing change is essentially and a methodical approach used for a proper and effective transition of individuals, teams, and organizations from a current undesired state to a desired state in the future. Essentially change management comprises of both, organizational change management as well as individual change management process and if these practices are effectively used, they can lead to a better more efficient and profitable organization.

Generally, employees go through three phases before successful implementation of a change is done:

• Fear - This is usually due to a high level of internal rumors resulting from lack of proper communication from higher level management. A common example can be a fear of job cuts or of ities.

• Frustration - In many organizations, full details about a change are kept confined to the higher management only. Employees could get frustrated by the level of secrecy and may retaliate by showing resistance towards change.

• Acceptance - This is the final transition towards a change. In given time, employees understand and learn to appreciate the need towards change. This acceptance acts as a final catalyst for an easy and efficient change implementation.

To effectively communicate a change, some general guidelines should be followed:

• Trust: Before undergoing a change, it is of the foremost importance for an organization to inform its employees about the change. Trust is an important factor in asserting that a change is taken with a good attitude. An untrustworthy person, if given the responsibility to convey the change, would create a sense of uneasiness among the employees and or team members can cause a loss in productivity and morale which then leads to unnecessary rumors, and a higher attrition rate.

• Hard Logic: It's the general nature of human beings to be resilient towards change. We search for stability and are happy in such circumstances. Only good communication and a compelling logic would enable an employee to understand the benefits of a change. Seminars, Conferences and general meetings could be conducted to deliver such knowledge.

• Acknowledge Success: When profits or good production results from a change, it is nec-

"TIME JOCKEY" - Cabrillo Landing

California Discovery... In 1542, Juan Rodriguez Cabrillo, a Portuguese captain, set sail from Mexico north along the now western United States coast just to explore whatever he could. Flying under the flag of Spain, Cabrillo sought a location which he could safely drop anchor and would protect his ships. As he traveled along the coast, he came across a well-protected bay and dropped anchor adjacent to a short peninsula surrounding the bay. The location became known as Point Loma, and the bay is known today as San Diego bay. The date was September 28, 1542, and it was the first time any one other than the indigenous people had seen or set foot in Alta California.

Cabrillo's ship was named the "El Salvador" and when Cabrillo and his men disembarked, they noted their first historic steps. Described as "Closed and very good", Cabrillo was able to see the entire bay from their vantage location which became known as Ballast Point. He named the bay

and location San Miguel, an important name which the Spanish explorers also used in naming the area and mountains around Mission San Gabriel as well the Mission San Miguel.

Cabrillo had set sail from Navidad, Mexico with three ships: "El Salvado", "La Victoria" and "San Miguel". After his landing at Point Loma, following Spanish sailor traditions, the captain of an expedition voyage would name an island or some other location after his ships. On Cabrillo's voyage, "San Miguel" was the name used for the bay at what is now known as San Diego Bay. "La Victoria" was used to name the island off what is now known as Orange County and named it "Victoria". Today, that island is known as San Clemente Island

As the expedition continued to explore the California coast, another island was encountered and it was named "San Salvador" which was later changed to Catalina Island. Over the next couple of months, Cabrillo visited the various islands along the Southern California coast, then returned to "San Salvador" (Santa Catalina) to make repairs to his ship. Cabrillo slipped and fell injuring his leg, which later became infected and led to Cabrillo's death. He was buried on the island in January 1543 and his men returned to continue their voyage north.

Today, Point Loma is home to the Cabrillo National Monument along the peninsula protecting San Diego Bay. There is a statue of Juan Rodriguez Cabrillo, along with a California Historical Landmark plaque which commemorates the site of the first Europeans to land in California. Cabrillo and his voyages took place over 480 years ago but today his achievements are still commemorated and recognized along the coast of California....
