

Railroad Crossing Extended Thru Jan. 29 LA VERNE - Crews will

continue reconstructing the railroad crossing on Wheeler Ave. north of Arrow Hwy (La Verne), as part of the 9.1-mile Foothill Gold Line light rail project. This work requires the extension of the closure to continue performing underground utility work, median construction, new track installation, roadway paving, and new curb & gutter.

Underway and now continuing thru Friday, January 29th, Wheeler Ave. will be fully closed to all traffic (vehicular and pedestrian) at the railroad crossing 24 hours a day/7 days a week. Arrow Hwy (just south of the crossing) and Bonita Ave. (north of the crossing) will remain open and accessible by way of detour

Wheeler Ave. will be fully closed to vehicular and pedestrian traffic at the railroad crossing. Access to homes and businesses on Wheeler Ave. within the closure area north

and south of the railroad crossing will be maintained at all times, as well as access to Wheeler Park, Palomares Ave., 1st St., 2nd St., and 3rd St.

A detour route (see map) will be in place during the closure and signage will be posted to direct motorists and pedestrians. Please follow detour signs. Wheeler Ave. will be fully closed to all traffic at the railroad crossing between Arrow Hwy and Bonita Ave. San Dimas Canyon (northbound and southbound) will serve as the main detour route. Arrow Hwy (eastbound and westbound) will remain open to all traffic. Bonita Ave. (eastbound and westbound) will remain open to all traffic.

Noise from construction equipment will be produced near the active work zones. Bus stops may be temporarily relocated.

Please obey all posted construction signs and do not enter the construction work zone.

San Dimas Ave. /Bonita Ave. And San Dimas Ave./ Commercial St. **Intersection Improvements**



SAN DIMAS - As part of the 9.1-mile Foothill Gold Line light rail project, crews will be building street improvements at the intersections of San Dimas Ave./ Bonita Ave. and San Dimas Ave./ Commercial St. Crews will demolish the existing roadway and replace with new curb, gutter, ADA ramps, sidewalks, and driveways. New right turn lanes will be added on southbound San Dimas Ave (to westbound Bonita Ave.) and northbound San Dimas Ave (to eastbound Bonita Ave.). Crews will additionally install new traffic signals at both intersections. Work will be completed one intersection at a time from January through March 2021. Traffic flow will be main-

tained at all times, work will impact the shoulder or may require intermittent single lane closures.

Starting January 4 and continuing through March 31, 2021, the intersections of San Dimas Ave./ Bonita Ave. and San Dimas Ave./ Commercial St. will have intermittent lane closures to perform street improvements. Lane closures will be placed and picked up daily; work zones may stay coned off for safety.



When it comes to saving money, it helps to cut out smaller expenses that add up over time like frequent lunch dates, unused gym memberships or online subscriptions. But if you really want to make a dent in your budget, you need think bigger.



AZUSA - On January 1st, 2021 at approximately 6:40 P.M., the Azusa Police Department was dispatched to an assault in progress in the 500 block of East Third Street. Regional Safer at Home **Order Extended**

- Tier 1 Substantial Surge Updated Response (Revised Temporary Order) is issued to temporarily replace both the most recently issued Temporary Order and Reopening Safer at Work and In the Community for Control of COVID-19 Order (Order) issued by the County of Los Angeles Health Officer (Health Officer). This Revised Temporary Order will be effective from 11:59pm (Pacific Standard Time (PST)) on December 30, 2020 and will remain in effect for as long as the State Public Health Officer's Regional Stay at Home remains in effect in the Southern California Region.

This Revised Temporary Order has been updated and is issued as a response to the sustained and substantial rise in COVID-19 cases, hospitalizations and deaths. This Revised Temporary Order has been revised to align and comply with the State's December 3, 2020 Regional Stay at Home Order, as well as the Supplement to the Regional Stay at Home Order issued December 6, 2020. County Health Officer Orders may not be less restrictive than Orders issued by the State Public Health Officer.

The County is part of the Southern California Region (Region), which is defined as the counties of Imperial, Inyo, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura. Over the last seven (7) calendar days, the County of Los Angeles is averaging 14,614 newly diagnosed COVID-19 cases per day. Between November 13, 2020-December 30, 2020,

LOS ANGELES COUNTY hospitalizations of confirmed COVID-19 patients have increased by 524%to 7,415. In addition, the adult ICU bed admissions in the Southern California Region rose. And, per the California Department of Public Health, there is no additional adult Intensive Care Unit (ICU) bed capacity within the Region. Because of both the rapid continuing increases in new cases and test positivity rates within the County and the Region and the lag between case identification and hospitalizations, the Health Officer expects both the number of new cases and hospitalizations, including adult ICU admissions in the Region, to continue to

> Per the State Public Health Officer, current projections show that without additional intervention to slow the spread of COVID-19, the number of available adult Intensive Care Unit (ICU) beds in the State of California will be at capacity in mid-December. ICU beds are a critical resource for individuals who need the most advanced support and care and the ability to add additional ICU capacity is limited by the lack of available ICU nurses and physicians as a result of the nationwide surge in hospitaliza-

tions and ICU admissions. Without additional public health interventions and widespread public adherence to the personal preventive actions to avoid being exposed to this virus and spreading it to others, the high levels and rate of rise in both cases and hospitalizations, if either continues, are at risk of overwhelming the ability of hospitals to deliver healthcare to people suffering from

COVID-19 and from other illnesses requiring hospital care.

This Revised Temporary Order is issued to ensure that County of Los Angeles (County) residents remain in their residences except as necessary to conduct activities specifically permitted in this order, to limit close contact with others outside their household in both indoor and outdoor spaces and to further reduce the risk of community transmission of COVID-19 resulting from the unprecedented surge of new daily cases. This Revised Temporary Order is issued to reduce capacity at sites where non-household members interact. Limiting interactions among non-household members, especially in places where persons are in close proximity without a face covering or mask, is essential to slowing the spread of COVID-19.It is imperative that all persons and businesses within in the County take personal responsibility and follow all restrictions and infection control precautions required by this Revised Tem-

porary Order. This Revised Temporary Order is effective within the County of Los Angeles Public Health Jurisdiction, defined as all cities and unincorporated areas within the County of Los Angeles, with the exception of the cities of Long Beach and Pasadena that must follow their respective City Health Officer orders and guidance. This Revised Temporary Order is effective 11:59PM December 30, 2020 and will remain in effect for as long as the State Public Health Officer's Regional Stay at Home remains in effect in the Southern California Region.

CHP Announces \$27 Million Available To Combat Impaired Driving

"These grants represent an opportunity for the CHP to work collaboratively with local traffic safety stakeholders to strategically address impaired driving issues while making California's roadways a safer place to travel," CHP Commissioner Amanda Ray said.

Padilla's Senate Appointment Challenged

As D.C. continues to sort out ballots in the Presidential election, former V.P. Joe Biden continues to make appointments to his cabinet. Some of his appointments have left Gov. Gavin Newsom with the ability to replace positions with his choices for Secretary of State, Attorney General and perhaps a senator to fill V.P. Elect, Kamala Harris's seat.

Secretary of State Alex Padilla was appointed by Gov. Newsom to fill Sen. Kamala Harris's seat, presuming she and Biden win the election. The same day, Newsom appointed Dr. Shirley Weber to take Padilla's place. Padilla has a long resume in California politics starting out as personal assistant to Sen. Dianne Feinstein, going on to serve on L.A. City Council, and then elected to the California Senate. Facing term limits in the Senate, Padilla decided to run for Secretary

Assemblyman Kevin Kiley who has lawsuits filed against Newsom for illegal use of the Emergency Services Act, told the California Globe there are some legal problems with Padilla's appointment. The Constitution requires an election to fill Harris's seat. The letter to U.S. Senate Majority Leader Mitch McConnell and Minority Leader Charles Schumer includes, "The California Office of the Legislative Counsel has concluded that the Seventeenth Amendment to the U.S. Constitution 'requires the Governor to issue a writ of election' to fill the vacancy created by Senator Harris' resignation and requires 'the person elected in the vacancy election, takes office before the end of the exist-

ing term." Padilla became questionable when President Trump issued a 2016 Executive Order establishing the Presidential Advisory Commission on Election Integrity asking for data on enrolled voters from all 50 states. Padil-

la's response to the request:

".. As Secretary of State, it is my duty to ensure the integrity of our elections and to protect the voting rights and privacy of our state's voters. I will not provide sensitive voter information to a commission that has already inaccurately passed judgment that millions of Californians voted illegally ... The President's Commission is a waste of taxpayer money and a distraction from the real threats to the integrity of our elections today: aging voting systems and documented Russian interference in our elections." (June 2017).

The Election Integrity Project of California (EIPCa) has spent 10 years that I know of tracking ballots and elections to make sure the elections are honest and legitimate. Working with Judicial Watch, a conservative, non-profit watchdog, EIPCa advised Alex Padilla October 17th 420,00 ballots were mailed to those likely dead or moved away and two to four ballots were mailed to 20,000 voters. (In Charter Oak, wrong ballots were mailed to several voters.)

Attorney Harmeet Dhillon filled a lawsuit after a DMV audit found thousands of discrepancies in the motor voter registrations, including an estimated 14,000 illegals registered to vote. Reported were party registration changes not authorized by the voter.

Padilla received severe criticism for titling controversial propositions, including Prop 47, written by L.A. D.A. George Gascon, and Prop 57, to mislead the public by not titling them to reflect the true impact of these propositions. Prop 57, Parole for Non-Violent Offenders, became an issue after it was determined some of these non-violent offenders included sex offenders.

When Gov. Newsom appointed Alex Padilla to Sen. Harris's senate seat, he had to appoint a replacement Secretary of State. There are no specific qualifications for SOS just the candidate must be a registered voter, registered with their party for at least 3 months and not with a different party for the last 12 months, and not previously termed out of this office. Newsom's choice: Dr. Shirley Weber.

Dr. Shirley Weber is a 72year-old retired University of San Diego professor who served as the chair of the Department of Africana Studies and has represented San Diego Assembly District 79 since 2012. Her Committee assignments primarily involve education and is Chair of the Select Committee on Campus Climate to mitigate hate crimes on California's college and university campuses.

Weber has authored legislation to curtail use of force by law enforcement, placed Affirmative Action on the last ballot and created AB 3121 requiring a study and development of proposals to prioritize potential reparations for African American people who are descendants of enslaved people or those who were impacted by slavery.

Weber wrote the law allowing some felons in county jail to vote while behind bars, and requiring more voter registration information to be provided to probationers and parolees.


An Ever-Flowing Stream

Unfortunately, COVID is still here and has made it to Antarctica. COVID continues to directly or indirectly hasten deaths. Along with the arrival of two much anticipated vaccines is a new active variant. The effects of both remain to be seen.

Simply put, an ounce of prevention is worth a pound of cure. Any risk of taking proper doses of vitamins and minerals is dwarfed by the risks associated with COVID. Useful vitamins and minerals include zinc (inhibits viral replication), vitamin D3 and vitamin C, and quercetin (to help drive zinc into the cells). Additionally, melatonin, a hormone found naturally in the body that regulates our sleep cycle, also

has significant anti-inflammato-

For months we've heard that COVID is not like the flu. It is a different animal. It may leave the infected person with long term aftereffects. Given the potential problems, the FDA, CDC, NIH, HHS and the alphabet health agencies should be advocating for early pharmacological treatment and prevention. Instead, we are told to wash our hands, wear masks—which may or may not help—and to stay away from one another. Indeed, as California's Health and Human Services Secretary admitted, the state's order banning outdoor dining and closing playgrounds was "not a comment on the relative safety" of the activity but a tactic for keeping people at home.

Stay home although 66 percent of new coronavirus hospitalizations in New York were in people who had not routinely left their homes. Stay inside although there are studies echoing observations during the 1918 flu pandemic finding that people who went outside had better outcomes. A recent Spanish study showed that 80 percent of patients with COVID had low levels of vitamin D. Another study found that people with adequate vitamin D levels had a 51 percent lower risk of dying from COV-ID. People at risk for vitamin D deficiency include those who have dark skin, are elderly or overweight, or stay indoors. Interestingly, these groups are parry, antioxidant, and mitochondrial protective effects. What are we to do if we get ill from COVID? While the numi-

nous Dr. Fauci says we urgently need early treatments, existing effective treatments are largely ignored, discouraged, or even prohibited. The party line recommends doing nothing for symptoms of fever, coughing, or breathing problems other than rest, stay home, drink fluids, and monitor. The threshold for calling the doctor is appalling: coughing up blood, trouble breathing, chest pain, confusion, severe drowsiness, or "a blue tint to your lips or face." Wait until you turn blue?!

I have a better idea. Don't just curl up in bed. Call the doctor right away and request pharmacological treatment, backed by evidence. Sadly, most potential patients are unaware of early treatment because Facebook, Twitter, and Google, the de facto arm of government communication, block the information or permanently delete the accounts of physicians who advocate for safe, effective treatments.

They argue that the use of well-known medications is "offlabel," that is, prescribing a drug for a different condition or dose than the FDA had approved. According to the Agency for Healthcare Research and Quality, 20 percent of all prescriptions in the United States are for offlabel use. This is often done when the "doctor has seen evidence that a certain drug works well for an off-label use." For example, using a diuretic to treat acne or a chemotherapy agent as a preferred alternative to surgery for an ectopic pregnancy. Billions of doses of [censored] and [censored] have been safely used for over 50 years. Repurposing antiparasitics as antivirals certainly is not out of the realm of medical innovation.

Sitting at my Apple computer that could have been built by Uighurs in Communist re-education camps, I received another email from someone lamenting that he was blocked from social media. No, it wasn't for child porn (like the former political consultant right-hand man of congressperson Barbara Lee), but for advocating early treatment of COV-ID-19. Equity Markets Higher -Expansion Slowing?

All-time highs in all major indexes! NASDAQ and the Russell 2000 each recently gained over 3% and the S&P 500 added 1.25%. Cloud computing and cybersecurity stocks performed especially well due to multiple cyber-attacks on USA Departments (Defense, Energy, State, Homeland Security, Commerce, Treasury, and Institutes of Health). However, despite a still recovering economy many on Wall Street agree that the (stock) market has gotten ahead of itself.

When the Federal Open Market Committee met, they released the third in a series of forecasts for full-year GDP and jobless rates showing a massive improvement each quarter. Going back to March 23 - the stock market bottom - we witnessed a panicked Federal Reserve predicting unemployment over 30%. Since then, we have read their series of four rapidly improving predictions for increasing economic recovery. Is the Fed now predicting a worsening pandemic requiring more stimulus money? The Fed has already poured massive amounts of liquidity into this economy assuming that this would be the worst recession since the Great Depression, but their assumptions so far have been off the mark.

Going back nine months to March 22 James Bullard, President and CEO of the Federal Reserve Bank of St. Louis, told Bloomberg in an interview that he believed unemployment could hit or exceed 30% in the second quarter. On March 24th his Federal Reserve Bank backed up those prediction with detailed data, saying the coronavirus outbreak would cause 47.05 million layoffs in the second quarter of 2020, resulting in 52.81 million unemployed, a 32.1% unemployment rate!

The actual peak jobless rate was 14.7% in April, which was cut in half within six months. The highest number of unemployed

was about 20 million (in April), not the Fed feared 52.81 million. During the last six months the Fed has ratcheted down their predicted average unemployment rate for the year from 9.3% in June to 6.7% last week. They have also reduced their full-year GDP loss from -6.5% in June to -2.4% in December, all the while talking fearfully about COVID and its expected 2021 impact.

Should we also start to worry about inflationary implications? Specifically, a very-low unemployment rate can cause inflation. But even when the rate is very low, it usually takes a long time for inflation to gather any momentum. We had a 3.5% unemployment rate for two years in the last Trump driven cycle, but that apparently was not long enough to trigger significant inflation.

Congress, the Fed, and the media have now joined hands to say that the solution to our "stalled" economy (which in fact is still recovering despite new COVID-19 lock downs) is to throw more money into the economy to stimulate economic growth. Do they fear what a Biden administration and lock downs in blue states could cause in 2021?

Once again, many politicians and health officials visualize "one size fits all" COVID solutions. Strong arm tactics in closing businesses and schools are anticipated. Instead of considering age groups or health profiles of those at greatest risk for COV-ID-19 hospitalization and death,

blue state politicians continue to restrict nearly all small businesses (while inexplicably allowing large businesses to flourish). They promise relief for destroyed lives by creating trillions in cash out of thin air for those thrown out of work.

Why close schools and force children into house arrest when children are almost risk-free? Of over 340,000 deaths in the USA attributed to COVID-19 this year, fewer than 50 have been age 5-14, while a high percentage of COVID deaths are related to comorbidity causes. COVID is a disease with over a 99% survival rate for those under age 70.

Stimulus since the 2nd quarter lockdowns was the most generous Wall Street has ever seen. The recession was not long enough to be deflationary since GDP really only fell in two months. Recovery starting in May and June came relatively quickly for most businesses. However, the USA's March-April drop was unprecedented. There are still more than 10 million people out of work, and threatened new lockdowns will only make that worse. Labor slack remains a key to low inflation. It could take years before the unemployment rate declines below 4% again, let alone 3.5%. Unless a miracle continues Trump's leadership and/or open for business mentality dominates, any inflationary impulse should remain dormant.

However, could excess liquidity and huge amounts of cash sitting on the sidelines create dollar purchasing power declines? Our world may become very hard to predict until the USA finds a way to Make America Great Again!



Your Money - Ask Julia

Please explain inflation and recession.

Inflation is the increase in the price of products over time. Long-term inflation erodes your power to purchase. In other words, over time, your savings buys less; a dollar no longer buys what it could a few years ago. The factor to determine a Recession is when there has been two quarters (two 3-month periods of time) in a row of negative economic growth.

How long will it take to double my investment?

The Rule of 72 is a mathematical rule used to estimate approximately how many years it'll take an investment to double at a specific percentage rate of return. It's just division. Take 72 and divide it by the rate your money is earning. Your answer is how many years it'll take to double your money.

Because we have a small downpayment, we are being told we have to pay mortgage insurance. Can you explain a little about the mortgage insur-

Mortgage insurance is charged on any loan that has less than 20percent equity. The purpose of mortgage insurance is to pay the lender in case they have to foreclose because you breached the mortgage contract by, for example, failing to make your payments, or not paying your property taxes. Different lenders charge different mortgage insur-

I have the option of taking all the money now out of my fixed annuity, without any early surrender charges. I like annuities. Although I don't plan to use the money, I might want to access it later. What do you

suggest I do with this money?

Depending on your entire financial picture and what is best for you, I'd probably suggest either reinvesting in an annuity or purchasing a paid-up life insurance policy. Some company's products offer an option of almost immediate access to a good part of your money. Some policies offer penalty-free, accelerated access if you need the mon-

ey for a nursing home. It really boils down to what you want your money to do for you and what is most suitable for you.

It depends. Look at the difference between the Estate tax rate vs. the Capital Gains tax rate applicable in your mother's and your specific case. "TIME JOCKEY" - New Year's 2021

A Different Look... New Year's Day 2021 just wasn't the same as in years past especially here in Southern California. Due to the COVID-19 pandemic, the communities of Southern California were under stay-at-home orders which was probably the best way to stay safe with the explosion of COVID-19 cases and the unavailability of hospital beds especially for COVID treatment.

On January 1st in year's past, the Tournament of Roses Parade and Rose Bowl Game dominated holiday activities on the first day of the year but 2021 was the exception to years' past. On a picture-perfect day for Southern California, the millions of spectators who usually crowd together along Colorado to watch the parade, were nowhere to be found. The streets were empty, there was no floats riding along, no bands playing loudly, no horses trotting along and no fun and excitement. Instead, the streets were empty with only a good number of vintage cars driving along the street both showing off their prized vehicles and perhaps making some type of political statement. Either way it was a

pretty impressive display of automobiles all from different eras and various models.

It was the first time since World War II in 1942 that the Rose Parade has not been held in Pasadena, that's 79 years the parade has made its way along Colorado Boulevard. The Rose Bowl game was played but not at the Rose Bowl stadium in Pasadena. Due to COVID, it was played in Texas but it still used the Rose Bowl name and was the first time since 1942 when the game was played in Durham, North Carolina when fears of a West Coast attack forced the game to be moved. Also, with no one at the game it was a great time to take in the historical statues and monuments which are resident at the historic stadium.

In the front of the stadium is a statue of the great Jackie Robinson, who is primarily known for his baseball skills with the Brooklynn Dodgers but he also played for Pasadena City College and UCLA. Robinson never played in a Rose Bowl game but he did play in the Rose Bowl stadium and even set a record which still stands today of a kick-off return of 104 yards against

Caltech in 1938. I know you think it was only Caltech but Caltech was a football power in the 1920's and 1930's, and was one of the few major Southern California colleges playing football back then. Robinson's jersey number 42 is retired by the Dodger organization as well as all of Major League Baseball, but his jersey is also retired by UCLA, and by the Rose Bowl itself where it hangs above the rim of the stadium between tunnels 4 and 5. In addition, there is a life-size statue of Keith Jackson, the television announcer who called a number of Rose Bowl games after spending over 50 years in the broadcasting business and statues commemorating the 1999 U.S. Women's World Cup Team. It was good to see the various sites on New Year's Day like they've never been seen in 80 years but let's hope that next New Year's will be much more enter-



West Covina Shooting Leave Young Woman Dead

WEST COVINA - On Saturday, January 2, 2021 around 10:15 pm West Covina Police Department received a call of a shooting in the area of Azusa Avenue and Amar Road. When officers arrived, they found a 29year-old female suffering from a gunshot wound. Paramedics treated the young woman then she was transported to a local hospital where she was in critical grave condition. She later died at the hospital. There were no other injuries reported.

The 29-year-old young woman was identified as Gabriela De Haro. She and an unidentified man were in a vehicle when shots were fired into the vehicle. According to witnesses, they heard 3 shots and then a male voice started screaming.

According to detectives who are investigating the shooting that it appears the victim was traveling inside the vehicle when gunfire came from another vehicle. At this time there is no description of the person or persons responsible for this. The intersection of Azusa Avenue and Amar Road was blocked off for some time while investigators combed the scene for evidence and clues. Azusa northbound traffic was diverted through the parking lot of the Inland Plaza, crossed Amar

and then into the Seafood City parking lot via Officer Chiles Way. Southbound Azusa also had to try and use various parking lots to get around the blocked area. The Amar traffic was forced to take long detours around the crime scene.

Family members stated that the couple had simply gone out to get some tacos and were headed home when the shooting happened. At this time there is no clue as to why or what the motive was for the murder.

Gabriela was a graduate of South Hills High School. She loved dogs and was a Dodger fan. The couple had future plans that they were looking forward too. The family and friends are in shock and want justice for her.

Distraught Man Detained By Police, Held For Psychological Evaluation



IRWINDALE - On December 31st, Irwindale police officers were on patrol in the area of Myrtle Avenue and Longden Avenue when a distraught male adult suddenly ran into traffic directly into the path of the oncoming police car. The man acted erratically, stating he no longer wanted to live and yelled at the officer to shoot him. The man flung clothing and items around and repeatedly reached into his pockets, clothing and waistband, trying to antagonize

the officer. Additional officers arrived and engaged the man in conversation, attempting to calm him, however the male continued to act erratically and yell at the officers, telling them he wanted to die. The officers contained the scene and ordered civilians out of the area while they continued to engage the man, working hard to calm him and deescalate the situation. Eventually, the man responded to the officer's directions and allowed them to ap-

proach and detain him without incident.

The Los Angeles County Fire Department responded to the scene and the male was transported by ambulance to a nearby hospital for medical and psychological evaluation.

While this incident had the potential to have a tragic outcome, the actions of the initial officer and those of the assisting officers, undoubtedly led to the safe resolution of a potentially violent encounter.


