ing for your next big adventure? The Peace Corps is encouraging U.S. adult citizens to volunteer their service abroad to promote world peace and friendship.

While the Peace Corps temporarily suspended volunteer operations at all posts in March 2020 due to COVID-19, the agency is working to return to service and is accepting applications.

In time for Older Americans Month in May, a legacy of the John F. Kennedy presidential administration along with the Peace Corps itself, here's what to know:

#### **Experiences Vary Widely**

Partnering with communities abroad to develop sustainable solutions for the world's most pressing challenges, the Peace Corps has served in 61 countries globally. Volunteers serve in such sectors as education, health, youth in development, agriculture, community, economic development, environment and Peace Corps response. Over 240,000 American citizens -- 13,898 of whom served over the age of 50 --have served in the Peace Corps since it was established 60

# **Kiwanis Members Create Packages for Homeless Vets**

**DUARTE** - Joe Leal of Vet Hunters shared quite a story with the members of 14 different Kiwanis Clubs within Division 35. Vet Hunters is a grass roots movement that was started by one soldier who vowed to honor his fallen comrades, by serving the living and leaving no veteran behind. Search and rescue missions in the streets of America were initiated and 'vet hunting," was born. Joe shared that the words homeless and veteran should never go together. Vet Hunters are like the "e-harmony" of homelessness. They connect the homeless person to resources by bringing them to where the homeless veterans live. Their office is the streets and anywhere a homeless veteran may call home. Kiwanis Division 35, basically the east San Gabriel Valley, held its first in person service event since the pandemic started, packing over 200 care packages that will be given out to Vet Hunters. 14 clubs within Division 35, (including the West Covina Club and the Duarte Club) helped with this project under the leadership of Lt. Governor Mary Happy Price. There were over 50 Kiwanians and 100 Key Club, KIWIN, and Circle K youth building these

**SACRAMENTO** - The State pacts caused by the pandemic, as well as help them comply with AB 5. The funding, slated specifically for pay for artists and production workers, will be distributed in the form of grants based on the organization's size (i.e. smaller organizations get larger grants). There will be a maximum revenue cap for eligible organizations. This funding will apply to all performing arts industry, including theaters, operas, and symphonies. It will also create a low-cost payroll services to nonprofit performing arts organizations.

# Memorial Day 2021 - Honoring Those Who Risked Their Lives And Those Who Did Not Come Home

Across America, families are planning to celebrate the first Memorial Day weekend since COVID-19 forced us to lockdown in our homes, away from family and friends, for the majority of 2020.

Although some precautions remain, this year many people are planning barbeques, picnics and mini vacations for the weekend that has become known as the "official start of summer."

But what is the real meaning Memorial Day? What should we remember; why should we care?

According to the U.S. Department of Veteran's Affairs, Memorial Day commemorates the men and women who died while serving their country. Personally, I will always remember my uncle, PFC Alva Abrams who was killed during WWII in the Battle of Luzon in the Philippines. As a community college teacher, I will also remember the many student veterans in my classroom who struggled with the wounds of war along with their memories of fallen comrades.

These are dramatic stories of those who paid the ultimate price for their country, but as the COV-ID-19 pandemic has reminded us, the men and women of today's military must be ready to put their lives on the line each day they serve.

During the darkest days of COVID-19, the men and women of the U.S. military were integral to preventing illness and helping to stem the tide of infection and death. The Department of Defense's mission during a pandemic, "to preserve U.S. combat capabilities and readiness" also includes supporting the U.S. government's efforts to "save lives, reduce human suffering and slow the spread of infection."

The contributions of U.S. service members in fighting the pandemic were significant. They were sent to all U.S. states and territories to assist in state and local efforts. They supported community-based testing sites; provided logistical support and the transportation of key supplies; packaged and distributed food and other supplies; and cleaned and disinfected common spaces. They also worked to convert hotels, dormitories and other buildings into temporary medical facilities, and they boxed millions of needles and syringes into vaccine kits and delivered vaccines. And they did all this

while facing down an infectious disease that took millions of lives.

Memorial Day 2021 will be noticeably different than Memorial Days of the past. The one thing that should remain constant is our respect for the brave men and women who have died in the service of our country and those who continue to risk their lives today.

**Additional Variants Identified in** L.A. County; Vaccines Show to **Be Highly Effective in Reducing** 

Variant cases of COVID-19 continue to be identified in Los Angeles County. The most common circulating variant of concern in L.A. County is now the UK variant (B.1.1.7); in the past, the California (B.1.427/429) variants have been dominant. Of the 40 specimens analyzed by the L.A. County Public Health Laboratory in the past week, 53% were the UK variant and none were the California variant. The lab also detected 6 Brazil (P.1) variants last week and one South African variant (B.1.351).

The identification of these variants and the news of spreading variants from across the globe highlights the need for L.A. County residents to continue to take measures to protect themselves and others: this is particularly true for those who are not vaccinated against COVID-19

If you are not yet vaccinated or unable to get vaccinated, it is very important that you continue to wear a mask and maintain 6 feet of distance when around others not in your household and consider getting the COVID-19 vaccine as soon as you can.

**Infection By COVID-19 Variants** 

Recent research findings provide added evidence that the currently available vaccines appear to be highly effective against the variants of concern that are circulating here now. A new study by the Centers for Disease Control (CDC) showed that over the last few months, during a period when the current viral variants have been circulating widely, vaccines reduced the risk of getting sick with COVID-19 by 94% among fully vaccinated healthcare workers

COVID-19 vaccinations are available at County-run sites and many community sites without an appointment. Anyone 12 and older living or working in L.A. County can get vaccinated. For now, only the Pfizer vaccine is approved for children, so make sure to go to a site that administers the Pfizer vaccine for children and teens. Teens 12 to 17 years old need to be accompanied by a parent, guardian, or responsible adult.

COVID-19 vaccines are free to everyone who wants one; you should never be sent a bill or be charged a co-pay for a COVID vaccine, regardless of whether you are insured or whether you got vaccinated at your doctor's office, by a provider outside your network, or at a city or county site. If you get a bill from your insurance carrier, contact them to clarify what the charge is for. If you are billed at a vaccine site, you should report this to the Department of Consumer and Business Affairs.

LOSANGELES COUNTY -Los Angeles County will align with the State's June 15 plans that ease many capacity limits and distancing requirements and adopt CDC's masking guidelines for vaccinated and unvaccinated individuals. People who are fully vaccinated will no longer need to wear masks in most situations. There are specific requirements for large capacity indoor events. The County will also follow the State on lifting current travel restrictions on June 15 to align with CDC travel recommendations.

Current County reopening protocols will be amended or retired on June 15 to reflect these changes.

S.G.V. EXAMINER **A**3 **Arcadia City Council Declares No Confidence In Los Angeles District Attorney George Gascon** 

**ARCADIA** - At the May 18, 2021, Arcadia City Council Meeting, the Arcadia City Council adopted a Resolution Declaring and Affirming a Vote of No Confidence in Los Angeles District Attorney George Gascón. Arcadia joins at least 13 other cities in Los Angeles County to voice concerns about DA Gascón's sweeping policy changes that endanger public safety. These include new policies to not prosecute misdemeanor crimes, ignoring the rule of law and victim's rights, among several others.

The Resolution adopted by the City Council states that DA Gascón's reforms are eliminating key components of the criminal justice system, undermining law enforcement's ability to effectively police communities, and

undermine the rule of law in Los be consistent with state law, and Angeles County. Specifically, DA Gascón's reforms contradict state laws that were enacted by the legislature as well as approved by voters through the legislative ballot initiative process to prevent and prosecute crimes, and to protect the public. Council Member April Verlato, who requested that this item be brought forward, stated at the May 18, meeting that, "Gascón is not a legislator, he is the enforcer [of laws]."

The Arcadia City Council has a proud history of supporting public safety and evolving the City's law enforcement strategies to address the needs of the community: however, policies that aim to restructure or amend prosecutorial directives need to

issued with reasonable intent to enhance public safety, protect victim's rights, and promote the rule of law. For those reasons, the Arcadia City Council demands that DA Gascón uphold state law and refrain from issuing further Special Directives that contradict laws enacted by the legislature or vote of the people. If he fails to do so, the Arcadia City Council calls on DA Gascón to resign or be removed from office.

# **County Registrar Approves Petitions** for Public Circulation, Gascon Recall **Officially Underway**

Victims and Los Angeles residents are fighting for justice and the safety of their communities

LOS ANGELES COUNTY -Petitions for the recall of Los Angeles District Attorney George Gascon have been approved by the Los Angeles County Registrar and are now available for public circulation and signature gathering. The petition is available for download at https:// recallgeorgegascon.com/petition.

To successfully trigger a recall election, proponents must collect 579,062 signatures from registered voters in Los Angeles County (10 percent of the total number of registered voters) within a 160-day period. The deadline for signature collection is October 27, 2021. If successful, a recall election would likely take place in 2022.

"George Gascon got elected by disguising a radical, dangerous, and pro-criminal agenda as 'criminal justice reform,' but that's not what he is doing," said Desiree Andrade, organizer and spokesperson for the Recall blooded killers back onto our streets. We have no choice but to seek Gascon's immediate removal from office because his twisted social experiment is jeopardizing the safety of our communities and revictimizing victims and their families all over again."

"The outpouring of support for the recall movement and our fight to bring justice for victims has truly been amazing and is growing everyday as more residents learn about the destructive realworld impacts of Gascon's policies," said Tania Owen, Co-Chair for the Recall George Gascon campaign. "George Gascon has turned his back on victims and is failing to protect his constituents, so we are taking matters into our own hands. # **Holden's Social and Racial Justice Bills Clear Assembly Appropriations Committee**

SACRAMENTO - Eight of witnessing excessive force by tion. Assemblymember Chris Holden's bills cleared the Assembly Appropriations Committee. The package of social and racial justice bills that passed include police reform, AB 26; The Upward Mobility Act, AB 105; transportation contracts for disadvantaged communities, AB 349; and real estate appraisal reform, AB 948. The other bills authored by Holden that passed include lead free faucets, AB 100; affordable housing in 710 corridor, AB 512; electric investor-owned utilities' executive compensation oversight AB 1156; and records management at state departments, AB 1429.

"I am pleased to see my social and racial justice bills pass the Assembly Appropriations Committee today. This demonstrates both the commitment of the legislature and the ongoing public support for these important reforms," said Assemblymember Chris Holden. "I'm also proud that my bills that would reduce lead in our drinking water and help create affordable housing in the district passed."

AB 26 would establish clear guidelines for police responsibility and accountability when another member of law enforcement, including providing a selection of techniques to establish that an officer has in fact attempted to intercede.

**AB 100** would set a limit on the amount of lead leaching from drinking water faucets and fixtures.

AB 105 would address barriers to upward mobility and inclusion for people of color working in California's civil services system. Specifically the legislation would require diversity on all state boards and commissions that have volunteers, and reform processes that hinder upward mobility for people of color in the civil service system, giving attention to compliance, the appeals process, and annual parity goals for upward mobility.

AB 349 would require half of one percent of SB 1 dollars be used to conduct outreach efforts to small business and disadvantaged business enterprises. The bill aims to bolster efforts to include minority owned and women owned business in a post COVID-19 economic recovery to meet contract procurement goals established by the California Department of Transporta-

AB 512 would allow Housing Related Entities (HREs), like city housing departments and affordable housing developers, to purchase vacant land owned by Caltrans in the 710 North Corridor, at the original purchase price, for the purpose of building affordable housing.

AB 948 would require the Bureau of California Real Estate Appraisals to gather data on demographic information of buyers and sellers of real estate property and compile data of homeowners from protected classes who file complaints based on low appraisals. The legislation also requires appraisers to take anti-bias training when renewing their license.

AB 1156 would retain CPUC oversight of electric investorowned utilities' executive compensation structure, and ensure public transparency is maintained for such review.

AB 1429 would require the record management coordinators for their respective state departments and agencies to train all employees on correct records retention practices within 60 days of their employment and annually.

# Housing Mandate Irrational, Unachievable

I learned about Agenda 21 in Rosa Koire's 2011 book, Behind The Green Mask: U.N. Agenda 21, a plan created by the United Nations around 1990 to cure climate change. The remedy: squeeze all development into urban areas by ignoring zoning ordinances, taking control of open space for an improved environment, eliminate parking in developed areas curing greenhouse gas, (people can ride bikes or mass transit) and gain control of all resources including water, energy, health care, even education. Radical? Seems like it, but what is happening in California gives me pause to think about that agenda - real or political hype?

Enacted in 1969, the housing element law requires all cities and counties to plan for their residential needs as an element of their general plan and identify possible sites for that housing. Mid-1980s, the state established the Regional Housing Needs Assessment (RHNA) process, a statewide effort to project the number and types of housing needed eight to ten years in the future. Department of Housing and Community Development (HCD) plays the critical role of reviewing every local government's housing element to determine whether cities complied. Not identifying areas for creating new housing, could mean court- imposed penalties or litigation.

Projected numbers are given to regional agencies to allocate a "fair share" number of housing units out to cities and counties. Southern California Association of Governments (SCAG) is our region covering Los Angeles, Orange, Ventura, Riverside, San Bernardino and Imperial Counties with 191 cities, more than 38,000 square miles and 19 million people estimated to grow to 24 million in 25 years.

Examples of 6th cycle numbers:

• 2015-2025, we were told approximately 1.8 million new housing units were needed or

180,000 new homes annually.
8-year cycle 6, SCAG's sixcounty area need is 1,341,827 new units, 3.25 times more than last cycle at 412,137 units.

L.A. County must identify parcels for 812,060 new units.
SG Valley area number is 89,616 units.

• West Covina's estimate is 5,346 units, almost 7 times the 831 units in cycle 5.

• Glendora's estimate is 2,276 units in cycle 6, almost 4 times the 686 units in the 5th cycle.

• Density to meet those numbers can be 30, up to 50, units to the acre. (City acre is 40,000 sq ft)

Gov. Newsom promised 3.5 million new housing units by 2025. We've seen a slew of legislation to help him meet that goal and he's signed all of it. SB 13 allows Accessory Dwelling Units (ADUs) or 'granny flats' on any residential lot regardless of size, in any city, ignoring local set back requirements for safety and privacy, and with no parking required. SCAG says those ADUs satisfy a portion of RHNA requirements at all income levels and indicates approximately 70% in L.A. County qualified as affordable and nearly one-quarter met very-low-income levels.

Sen. Portantino (D-SD 25 Glendora) wrote SB 15 providing incentives to convert abandoned retail sites into very low and low-income housing by providing grants through the CDC of

seven times the average sales tax generated at that site for seven years with "...appropriation by the Legislature in the annual Budget Act." After Newsom's COV-ID lockdown effectuating large numbers of lost businesses, there are commercial sites eligible for this program if it passes ignoring local zoning. Question: If locals give up business sites and sales tax revenues, how do they pay for police services, libraries, the quality-of-life services? Bigger question: How will this provide much needed replacement jobs lost during the Newsom lockdown?

Housing site identification must consider income levels and ability to pay for housing. Median income in L.A. County is \$80,000 and affordability is paying no more than 30% of annual income on housing:

• Extremely Low - allows income of \$35,450 / affordable rent is \$886.

• Very Low - allows income of \$59,100 / affordable rent is \$1,478.

• Low - allows income limits of \$94,600 / affordable rent is \$2,365

• Moderate & Above Moderate - allows income limits of \$96,000 / affordable rent is \$2,400 or purchase a \$425,000 home.

Other considerations include housing for elderly, large families of 5 or more, homeless, transitional housing, emergency shelters, those with disabilities (undefined) residential care and farmworkers.

Declining population has cost California a congressional seat. The only numbers seeming to grow are the homeless and early release from prisons populations. Correct me if I am wrong, but it seems local government is being mandated to assume the responsibility for those with mental health and drug and alcohol problems that should have been resolved long ago by state legislators and Gov. Newsom.

"And yet equating Israel's political claims with anti-semitism is both unreasonable and dangerous. And that pressure must begin with an evenhanded approach by the only nation that can bring it about.

After the vehicle stopped, one of the passengers got out and pointed a gun at police officers. Officers had no choice but to fire on the suspect who was in his

20s. The suspect went down after being hit several times. Once the situation was under control, the police rendered assistance and the paramedics were called. The suspect was not identified.

Sheriff's investigative team were called in to assist with the investigation because it was an officer involved shooting. The suspect's gun was recovered at the scene. There was no motive as to why the suspect pulled a gun on the officers in the first place. No officers were injured.

The suspect was taken to the hospital with critical wounds but is stable and is expected to recover. He faces a number of charge and is being held in the jail ward at the hospital.

# **Higher Interest Rates on The Way!**

Inflation exploded higher during April. Base effects added to the year-on-year figures had only a little to do with the unexpected inflation jump from March to April of this year. Instead, blame a combination of government stimulus, reflation, bottlenecks and roaring consumer demand for this recent inflation jump.

Headline CPI rose 0.8% in April versus March, for a 4.2% year-over-year gain (well above the 3.6% consensus expectation). Core CPI (excluding food and energy) rose 0.9% for a 3.0% yearly increase, also well above the 2.3% consensus expectation. This represents the biggest monthly gain in headline CPI since 2009, as well as the biggest monthly CPI increase since energy prices spiked 9.6% in June 2009 (coming out of the last deep recession).

This recent core CPI increase was the biggest since a threemonth streak from July to September in 1981 when aggressive rate hikes boosted mortgage rates (which were the primary cost of housing in the CPI until the owner's equivalent rent was introduced in 1982). On a yearon-year basis, current inflation increases were the biggest (in the core numbers) since January 1996.

Base effects impacted the year-over-year measurements, biasing the math upward (not only from huge drops in energy prices in April of last year, but also the first full month of pandemic-constricted demand, which crushed some core prices). There's no weather-related explanation to argue away these massive monthly gains. This recent report is a strong confirmation that the supply chain bottlenecks firms have been complaining about are now causing much higher prices.

The single-biggest contribution to the core came from a 10.0% increase in used cars and



trucks, which are in very short supply and cost 20.9% more than in February 2020, the last month before the pandemic. Used vehicle increases have been impacted by an extreme slowdown in new car and truck production, primarily caused by the significant shortage of required microchips to complete new vehicles. The fire in a large chip manufacturing plant in Japan is partly to blame for this shortage, while very high demand for electronic chips (from many other industries) may make current new vehicle production slowdowns last much longer than many people anticipate.

However, the biggest core CPI increase since September 1981 may not change the Fed's mind about conditions justifying changes in monetary policy. Powell and the FOMC have - until now - insisted price increases should be transitory. Of course, they did not know how big these transitory increases would be. At the very least, this recent report demands extra work from the Fed to assuage markets it is standing its ground and why. The biggest yield increases after recent announced numbers were in 5- and 7-year Treasuries. The relative lack of movement in shorter yields reflects expectations that the Fed may not move for some time, while the smaller rise in long-term yields reflects the market's questionable faith in the Fed containing inflation in the long run.

Taxes and livability (crime, etc.) are not the only explanation for people's decisions to leave some cities. COVID policies, personal freedoms and workfrom-home rules were also big factors.

Nevertheless, policies matter, and it is no coincidence people are leaving cities and states with the most burdensome taxes as well as a declining quality of life. For those who can move to a state with more personal freedoms, lower taxes and better living opportunities, why not?

We've saved up for the downpayment and additional costs to buy a house, and our credit is really good. Do you have any guidelines?

Before you do anything else, get pre-approved for a mortgage loan. Pre-approved means that a lender has your application and supporting documentation, and has agreed to lend you 'up to' a specific dollar amount. I recommend using the services of an independent (non-bank) mortgage professional. Go to: FindAMortgageBroker.com With your pre-approval letter in hand, the offer you submit on the house you want can be taken much more seriously. Your lender can give you several pre-approval letters for different amounts. I strongly recommend you shop for a home considerably below what the lender says you can afford. With lower mortgage payments, you can enjoy a more flexible budget. While you are getting pre-approved, make and prioritize a list of "musthaves," "don't wants," and "might consider." For example, a "musthave" might be single-story, number of bedrooms and bathrooms, attached garage, while the "don't wants," might be a condo, or a

busy street, and "might consider" could be a pool. Also take the time to select the neighborhoods you'd really like (perhaps for school district, or community amenities), some you "might consider" (those bordering areas you'd really like), and those you definitely wouldn't live in (for example, too close to a freeway or railroad tracks). Visit neighborhoods on different days of the week, and at different times of the day and night. It's okay to interview more than one licensed Realtors before deciding which one to work with. Keep in mind that the Seller pays all Realtor commissions. Realtors working with buyers spend quite a bit of time researching, showing you properties, handling paperwork, and negotiating on your behalf. Just be loyal.

According to the National Highway Traffic Safety Administration (NHTSA), of the 22,215 passenger vehicle occupants killed in 2019, 43% (9,466) were not wearing seat belts. In 2019, 620 passengers killed in crashes across California were not wearing a seat belt.

California law requires a child to be properly secured in a car or booster seat in the back seat, until they are at least 8 years of age or at least 4'9" tall. Children under the age of

2 shall ride in a rear-facing seat unless the child weighs 40 or more pounds or is 40 or more inches tall.

# **Pursuit Policy Changes to Keep the Public Safe. Should We Shoot Them?**

Out of all the pursuits that go down, nearly 25% of these end up in traffic collisions. That's just taking the statistics in California from the CHP information that they provide. There are nearly 10,000 pursuits per year. Well over 20% of these end up in serious traffic collisions. Out of these, there were nearly 2000 people injured and around 1000 people killed per year. This includes the suspects, their passengers, innocent victims of the traffic collision, and even police officers.

We have all seen these pursuits on television and they seem to demand immediate attention. High-speed pursuit through various different cities have shown the suspects blowing through intersections, sometimes at speeds greater than 100 mph. Often, we have seen the tragic results of pursuits when the vehicle crashes into innocent people.

Various measures have been taken to try to slow down these pursuits. There were some cities across the United States that has a no pursuit policy. Often times all that this did would allow the criminal suspects to go on and commit felony crimes at a later date. There have been times when the same suspects that got away have killed people and they went on with other crimes where they killed people again.

We have seen were the police have backed off on pursuits only to see the perpetrators to continue on at high speeds. Often times they still result in major traffic collisions with injuries or fatalities.

When you have people that get injured or killed, they don't blame the suspects, in this litigious society they blame the police and everybody else when in fact they are supposed to be blaming the suspect. You see these deeppocketed attorneys seeing this as an opportunity to get money out of this tragic situation by going to the families and encouraging

Police departments are trying to implement better solutions to pursuits. There have been many new devices out there and old ones as well to help stop or slow down a pursuit. Everybody knows about the spike strips. But how many times have we seen vehicles spewing sparks all over the place and not stopping at all until their car burst into flames. Other catching devices which I had an opportunity to actually see in a real pursuit be deployed and wrap itself around the rear wheel of a vehicle which the officer was able to bring it to a stop. It's a device that shoots out from the front of a police vehicle and under the vehicle they are chasing and the device ends up wrapping itself around the wheel and axle and the police simply break their own vehicle to stop theirs.

So tell me what's the difference if the suspect is using a vehicle as a deadly weapon which is the same as a bullet (but much larger), by driving through intersections and streets in a deadly manner? To me it is the same thing if not worse. That vehicle which is like a bullet will kill an entire family in an instant.

type of pursuit were the suspect is blowing through intersections... that at the earliest convenience a police officer can get alongside the vehicle is to shoot the driver to bring this deadly pursuit to a halt. I have had a number of people agree with me, but other people have argued "what if it's just a 14-year-old boy driving his parent's car that he stole out of the driveway"? I can't answer that question outside of the fact by saying "so what?" He wants to play like an adult and commit adult crimes then he can die as an adult in my opinion. Don't endanger my family, my friends, and the lives of the people of our community. It works people. A perfect example is a pursuit through West Covina. The passengers in his vehicle started jumping out of his vehicle when he drove through a supermarket parking lot. The suspect still continued to run from police and got hung up in traffic. A police officer ran out to get the suspect to give up only to find that the car in front moved out of the way so the suspect could flee but not after backing up into the police car which would have trapped the vehicle. While the suspect was trying to maneuver and trying to get something or hide something under the passenger seat, the officer fired 2 shots with one shot striking the suspect in the face. The vehicle rolled through the intersection and came to a stop after jumping the curb. This terminated that pursuit. There were no innocent victims injured or dead because of a possible major traffic collision because of the way the guy was driving prior to being stopped. This officer may have saved a number of lives and in my opinion, I consider this man a hero for doing this. Some people may feel that this was a little excessive. I want those people to tell me that after this guy runs into the side of their car and kills a number of other family members.

# **Wildfire Preparedness for Pet Owners**

With summer and warmer temperatures around the corner, the Los Angeles County Department of Animal Care and Control (DACC) reminds all pet owners to prepare for wildfire season. Preparing in advance and making an emergency plan can make all the difference when faced with evacuation during a wildfire incident. While DACC encourages all pet owners to prepare, DACC encourages guardians of livestock and horses to be mindful of the additional challenges and considerations these animals require.

Ten tips to help you prepare your pets and animals for wildfire season:

1. Have an emergency plan for each pet: where will you go, who will take care of them, and how you will transport them. Make a list with contact information. transportation routes, and backup plans.

2. Research pet-friendly hotels and lodging and keep the list current. Reach out to friends and family outside the area to find out if you will be able to stay with them during an emergency.

4. Get your animals microchipped with up-to-date contact information in the registry, an important step that many people forget. Have visible identification such as collars and tags whenever possible and safe to do SO.

5. Prepare a minimum of a three-day supply of food and water for each animal.

6. For small animals, have an assembled emergency "go-kit" ready at all times. Include medications, medical records, licensing records, a photo of the animal, collar, leash, carrier, and any comfort items that will help your pet. Make sure exotics and birds have appropriate housing and food.

7. For large animals, train them to load into trailers prior to an emergency. Practice loading and unloading them. Gather any records, documents, and special items they may need.

8. Have proper transportation to transport your animals. This is especially important for large animals. Make sure you know how you will transport your animals and that all information is current. Conduct safety checks on horse and livestock trailers to ensure they are fully operational and ready to be used in an emergency.

9. Practice your plan. Make sure all family members and pets are familiar with the plan and what's expected of them.

10. Evacuate early! Don't wait until the last minute; activate your plan while roads are still open to avoid traffic delays.

"Having an emergency preparedness plan in place for your animals is critical to protecting them during emergencies," said Marcia Mayeda, DACC Director. "Properly designed emergency plans will ensure your peace of mind and your animals' well-being."
