He has camped 83 nights and earned 38 merit badges. Owen's Eagle project was designing and supervising the building of a mobile work station for Heritage Park. He used old wood and hardware so the work station would fit the time period of Heritage Park. Volunteers use the station for special events and during school field trips to the Park. ## **Traffic Collision Involving Foothill Transit Bus Results in Minor Injuries**

**IRWINDALE** - On Thursday, November 4, 2021, at about 12:40 P.M., officers from the Irwindale Police Department responded along with the Los Angeles County Fire Department to the area of Avenida Barbosa, north





of Arrow Highway, in the city of  $\overline{\mathbf{a}}$ Irwindale regarding the report of an injury traffic collision involving a Foothill Transit bus and a street sweeping truck.

On arrival, Irwindale officers discovered that a Foothill Transit bus was traveling northbound on Avenida Barbosa, north of Arrow Highway, when a collision occurred between the bus and the street sweeping truck, which was also traveling northbound on Avenida Barbosa. The Foothill Transit bus was occupied by the driver and only one passenger at the time of the collision.

Paramedics from the Los Angeles County Fire Department arrived and treated both of the drivers, as well as the bus passenger, for minor injuries. All of the injured parties were taken to local hospitals by ambulance.

Aftermath of the collision between the bus and the street sweeping truck that occured on November 4th at 12:40pm.

The northbound lanes of Avenida Barbosa between Arrow Highway and Buena Vista Street were closed for approximately 90 minutes during the traffic collision investigation.

Representatives from Foothill Transit and from the company operating the street sweeping truck responded to the scene and cooperated with investigators.

The cause of this traffic collision remains under investigation, however it does not appear that drugs or alcohol were factors in the collision.

Using a power point presentation, Sheriff Villanueva showed how deputies have begun to leave the department. From October 2019 through October 2020, there were 515 retirements. From October 2020 to October 2021, there were 617 retirements, a difference of 102 deputies who have filed for retirement. Many of those retiring have institutional knowledge and are experts in their fields with over 28 years of experience. Sheriff Villanueva shared that 238 sworn personnel have stated their interest in leaving the department.

Workers' compensation claims are also on the rise and have increased by 21.9% this last vear. He stated that from October 2019 to October 2020, there were 1,434 workers' compensation claims and as of October 2020 to October 2021, there Sheriff Villanueva points out that the five counties that surround Los Angeles County do not have vaccine mandates.

were 1,749, many attributed to the vaccine mandates.

As of November 2, 51.7% of the department's personnel are fully vaccinated and 1.7% are semi-vaccinated. He stated the reason for the low vaccination numbers was due to many not having faith in the vaccine or the political ideology behind the vaccine.

Sheriff Villanueva cautioned that there are 4,185 staff members, both sworn and professional, who may be subject to termination because of the vaccine mandate; 3,137 of the 4,185 are sworn deputies.

The five counties that surround Los Angeles County do not have vaccine mandates and at least half of the department's sworn personnel do not live in the County of Los Angeles. They can easily apply for employment in those counties.

Public safety is the priority of the Sheriff's Department and vaccine mandates are an imminent threat to the safety of the communities the department serves. The department is in danger of losing a significant number of deputies and it would be detrimental to the safety of residents of Los Angeles County.

## **CONSTRUCTION ACTIVITY**

As part of the Foothill Gold Line light rail project, KPJV crews will be working at the Lone Hill Ave. railroad crossing to build the new light rail bridge foundations. This work requires the full closure of the street for two days, as well as lane closures (including intermittent full southbound nightly directional closures) before and after the full street closure to prepare and then demobilize the work area. See detailed schedule below.

#### WHEN

Daytime Lane Closures: Beginning on November 1st, one northbound lane on Lone Hill Ave. and one left turn lane from westbound Auto Centre Dr. to southbound Lone Hill Ave. will be closed daily.

Nighttime Lane Closures: Beginning at 7:00 PM nightly, an additional lane in each direction on Lone Hill Ave. will be closed as needed, reopening the lane by 6:00 AM Monday - Friday and by 7:00 AM on weekend days.

Intermittent full directional nightly closures (southbound lanes only): As needed only (intermittently), a full directional closure of southbound lanes on Lone Hill Ave will be closed between Auto Centre Dr. and Glendora Marketplace at night. When needed, full directional closures will begin at 10:00 PM. Northbound thru traffic will be maintained. See map below for detour routes.

Two-Day Full Closure: Beginning Thursday night, November 11 at 9:00 PM and continuing thru Saturday night, November 13 at 9:00 PM, Lone Hill Ave. at the railroad crossing will be fully closed to all traffic (vehicular and pedestrian) between Auto Centre Dr. and Glendora Marketplace, 24 hours a day. See map below for detour routes.

• Crews plan to work multiple shifts, covering 24 hours a day, during the full street closure period to complete the drill shaft installation within the limited closure period.

#### **TRAFFIC ADVISORIES**

- Lane closures on Lone Hill Ave. between Auto Centre Dr. and Glendora Marketplace on November 1-10 and November 14-19; intermittent full southbound directional closures at night only between Nov. 1-19. Expect delays.
- Full closure of Lone Hill Ave. at the railroad crossing to all traffic (vehicular and pedestrian) 24-hours a day between Auto Centre Dr. and Glendora Marketplace for two days from November 11-13. Use detour routes.
- Access to the Glendora Marketplace and the businesses on Lone Hill Ave. within the closure area north and south of the railroad crossing will be maintained at all times.

- · A detour route (see map below) will be in place during the intermittent nighttime southbound directional closures and during the two-day full street
- closure. Signage will be posted to direct motorists and pedestrians. Please follow detour signs.

- Noise from construction equipment will be produced near the active work zones. Night work is planned.

## New Organics Recycling Requirements Starting January 1, 2022

**AZUSA** - Starting January 1, 2022, Azusa's trash collection and recycling services will change to comply with SB 1383 which requires ALL Californians to recycle organic waste. Acceptable organic waste includes green waste, 100% fiber-based food soiled paper, and food scraps. In the coming weeks, the City of Azusa and Athens Services, the City's franchised hauler, will be providing additional outreach and communication regarding the transition. Among the new changes include the following:


Single Family Residential:

Change from manual collection to automated collection
Athens Services will provide three 96-gallon containers (black for trash, blue for recycling, green for organic waste)

• Free residential bulky waste pickup on trash day with 24-hour advanced notice

• Free electronic waste dropoff and compost giveaway

## Vaccination Verification Requirements in Effect

LOSANGELES COUNTY week.

- Proof of full vaccination and photo ID for indoor entry into bars, breweries, wineries, distilleries, nightclubs, and lounges for all patrons and employees goes into effect. Patrons now need to be fully vaccinated to be indoors at any of these establishments.

On November 8, the City of Los Angeles' vaccine verification program, called SafePass-LA, went into effect, and requires proof of full vaccination for entry into the indoor portions of restaurants, bars, coffee shops, breweries, wineries, gyms, spas, nail salons, barbershops, movie theaters, shopping malls, and entertainment and recreation venues. This includes indoor portions of City facilities such as LA City Hall, senior centers, recreation centers, and service centers.

Public Health will be working closely with the City of LA to educate businesses and residents on the requirements of the SafePassLA program throughout the upcoming month and will unveil a virtual training and certificate program • Organic waste recycling and mixed waste collection

• Enhanced Outreach and Education to help businesses comply with the new recycling mandates

• Edible Food Recovery Program for required businesses

Along with the changes in collection service, Athens will be providing additional cleaning services throughout the City. This includes regular power washing of the bus stops and shelters throughout the City, as well as power washing of the downtown district at no additional cost to the Azusa community.

## **County Receives Housing Vouchers To Assist Foster Youth**

LOSANGELES COUNTY-The Los Angeles County Development Authority (LACDA) has been awarded 73 Housing Choice Vouchers from the U.S. Department of Housing and Urban Development (HUD), as part of the Foster Youth to Independence (FYI) initiative. Nationwide, public housing agencies competed for a portion of the vouchers that was made available by the Federal agency, to provide housing assistance to youth between 18 and 24 years old, who left foster care or are in the process of leaving foster care, and are homeless or at risk of becoming homeless.

The FYI is made possible in partnership with Public Child Welfare Agencies. In Los Angeles County, the LACDA will partner with the Department of Children and Family Services to obtain referrals for youth and provide housing assistance for up to 36 months. Supportive services will also be provided to assist the vouth on their path to self-sufficiency, including basic life skills training, housing counseling, landlord support services, employment and training, as well as education and career advancement services. The County's Department of Health Services is also part of the partnership and will provide administrative oversight to ensure the delivery of services, while the Los Angeles Homeless Services Authority will operate the Coordinated Entry System for Youth in an effort to prioritize housing and services for the most vulnerable.

"It is the agency's goal to contribute to HUD's commitment of preventing and ending youth homelessness," said Emilio Salas, Executive Director of the LACDA. "In 2020, the greater Los Angeles Homeless Count found 4,775 youth experiencing homelessness, which includes 18-24 year old Transition Aged Youth. Resources such as the FYI, will help keep youth housed while also providing necessary resources to assist their transition into adulthood."

"Compared to their peers, youth transitioning out of foster care are more likely to face housing instability or to become unhoused," said Bobby D. Cagle, Director of the Los Angeles County Department of Children and Family Services. "Among the biggest obstacles for these young people is securing stable housing. At DCFS, everything we do is fueled by our desire to see all youth in foster care reach their highest potential. The Foster Youth Independence initiative makes us hopeful that those who benefit from this effort will have greater opportunities to thrive."

"LA Health Services is committed to advancing the health of those we serve through our integrated whole-person health care system which centers around the complex needs of our unique patients," said Dr. Christina Ghaly, Director of the Department of Health Services. "LA Health services knows that the well-being of youth depends on our ability to provide whole-person care at the clinical setting and beyond; ensuring that foster youth have their most fundamental needs met is key to improving their health outcomes."

"We have worked diligently to build a youth rehousing system that addresses the housing needs of foster youth to help end their homelessness as quickly as possible. We have doubled the number of youths housed annually since Los Angeles County passed Measure H in 2017," said Heidi Marston, Executive Director of LAHSA. "To keep this momentum going, our government partners must invest more in housing. These 73 vouchers are an important step towards meeting the needs of those who are exiting the foster system in Los Angeles County."

## **Emanate Health to Host Separate Free Children's COVID-19 Vaccination Clinic** & Free Community Flu Shot Clinic

WEST COVINA — Emanate Health, the largest health care system in the San Gabriel Valley, announced that it will host a Children's COVID-19 Vaccination Clinic and a Community Flu Shot Clinic on the same day, November 13, 2021, in West Covina to promote wellness in the community.

"A 100-year global pandemic overlapping with the seasonal flu has created the potential of a "twindemic"—or two dangerous respiratory ailments crossing pathways simultaneously," said Emanate Health CEO Robert H. Curry. "We felt the need to immediately provide first-time

**WEST COVINA** — Emanate COVID-19 vaccinations to school children, while offering additional flu shots for the entire family on the same day at the same location."

Dr. Rochelle Walensky, Director of the Center for Disease Control and Prevention, agreed with the recommendation of an advisory panel of experts to make the Pfizer COVID-19 vaccine available to 28 million children in the United States. Children ages 5-11 can now safely receive one-third of the vaccine dose that adults and teens 12 years and up currently get. With the approval, Emanate Health elected to add a children's COVID-19 vaccine clinic to a previously scheduled community flu shot clinic.

Both clinics will be held at the Emanate Health Care Center, located in the Medical Arts Building I, 1135 S. Sunset Ave. in West Covina, adjacent to the Emergency Department at Queen of the Valley Hospital. The free COV-ID-19 clinic will be held in Suite 401 from 8 a.m. to 2 p.m. and free flu shot clinic will be held in Suite 200 from 8 a.m. to Noon.



## **Public Health Provides Framework for Lifting Masking Requirements**

#### LOS ANGELES COUNTY -On November 2, the Los Angeles County Department of Public Health (Public Health) provided the framework for lifting masking requirements at events and indoor establishments.

For outdoor mega events involving more than 10,000 people. Public Health outlined that before masking requirements are lifted, all of the following criteria need to be met: L.A. County case rates must demonstrate three consecutive weeks at or below moderate transmission as defined by the CDC - that is, less than 50 new weekly cases per 100,000 residents; hospitalizations remain low and stable at or below 600 daily COVID hospitalizations for three consecutive weeks; 80% or more of county residents 12 and older are fully vaccinated; and there are no emerging reports of significantly circulating new variants of concern that threaten vaccine ef-

#### fectiveness.

For masking requirements to be lifted at indoor events or establishments involving fewer than 1,000 people, including indoor offices and worksites, sites must have a vaccination verification process in place, and all employees and customers must be fully vaccinated, accommodating with additional requirements those employees with approved exemptions. Additionally, L.A. County metrics must meet all of the same standards as for lifting masking requirements at outdoor mega events.

Indoor masking will remain mandatory due to federal and state requirements on public transit and transportation hubs (federal), and at TK-12 schools, childcare, and youth settings; healthcare settings; correctional facilities; homeless and emergency shelters and cooling centers; and indoor mega events involving more than 1,000 people (state).

## **New Game Plan: Soros Creates Good Information, Inc.**

Billionaires George Soros and Reid Hoffman are leading the effort to "restore social trust" and "strengthen democracy" by "investing in solutions that counter disinformation and increase the flow of good information online." according to NTD, a New York-based, global television network founded in 2001 by Chinese-Americans who fled communism. This effort will be called Good Information, Inc. and first investments will be in media outlets providing customers with fact-based information, as well as local community news in markets where there are little to no local news outlets reaching online communities.

USC Reports provides statistics that surprise me as I sit here and type on my computer. 91% of California households have high-speed internet; 15% of Californians are not connected, or under-connected (meaning only cell phones); and, two of the highest areas not connected are L.A. County at 19% and Central Valley at 20%.

Links into the Good Information, Inc. press release on the new venture says 'page not available' If you go to https:// goodinfo.us/ you will see a page of different types of information - wrong, disproven, dangerous. Click on any one of them and it takes you to a page to sign up for more information. And, I call that a "gotcha." Do that and they have vour email, who you are and probably a lot more. Tread carefully.

To clarify, the dictionary defines disinformation as "deliberately misleading or biased information; manipulated narrative or facts; propaganda." Misinformation is "false information that is spread, regardless of intent to mislead." To further clarify, we need a political playbook of characters recruited to run this new organization that would "fund and scale local news companies with fact-based information," Axios reports. Axios is a news website launched by former Politico Hoffman. Dickerson, known as

George Soros has funded district attorney races nationwide including George Gascon, first, into office in San Francisco and then Los Angeles County. The \$2.5 million he brokered on the L.A. County district attorney race to replace Jackie Lacey has put him front and center on the destruction of our criminal justice system. Soros contributed \$1 million to Gov. Newsom to stave off his recall and another million against the Austin, Texas, ballot initiative requiring two police officers per1,000 population.

Reid Hoffman, known as CEO of LinkedIn, originally an employment service, is a venture capitalist and Internet entrepreneur now a partner of Greylock Partners, a venture capitalist firm in the Silicon Valley focusing on early start-up businesses in the enterprise and software infrastructure and semiconductor business, with a \$3.5 billion portfolio and 'ready to invest in building companies that matter'.

Fox News reported, Hoffman was involved in 2018 with a group providing disinformation in the Alabama Senate race between Republican Roy Moore and Democrat Doug Jones, falsely accusing Moore's campaign of being supported by the Russian Government. American Engagement Technologies (AET) run by Mickey Dickerson, was involved and received \$750,000 from

the "Obama's Hotshot," cleaned up the healthcare digital debacle in 2014.

Leading Good Information, Inc., is journalist and Democrat strategist, Tara McGown cofounder and CEO of multiple organizations including Acronym, a 501(c)(4) non-profit corporation backed by Hoffman, Lockwood Strategy and Courier Newsroom involved in massive expenditures on digital advertising in the 2020 presidential election reported to be \$100 million to defeat Trump. Axios also says Good Information, Inc., will acquire Acronym's newsletter "FWIW" covering digital political ad spending. Macmillon dictionary says FWIW, used in electronic communications, means for what it's worth, insinuating someone may or may not be interested in what you have to say. Or perhaps throwing out disinformation discounting any responsibility for truth.

In 2020, McGowan and Acronym, an investor in Shadow, owner of IowaReporter App, were caught up in the messy Iowa Democrat Caucus when the breakdown of that system failed to report precinct votes in the Iowa Democratic caucus. Newport Now, Christopher Allen and Rob Duca, February 2020, reported McGowan's comments: "To be clear: I own no equity in Shadow, nor any other entities affiliated with Acronym and have not been compensated by Shad-OW."

McGowan is married to Michael Halle, lead organizer for Hillary Clinton's campaign and former strategist for Pete Buttigieg's presidential campaign. McGowan served as director of the advertising branch of Priorities USA Action, the largest Democrat Party super PAC.

Good Information is seeking other investors and setting up an advisory board, one of which is Dan Pfeiffer, former White House Communications Director.

The energy from the bands and their fans' enthusiastic responses were both palpable and notably incapable of being fully captured over a Zoom stream. While we relished this chance to make up for lost time and with our ears buzzing from three days of reverb, we also recognized just how privileged we were to be alive and return to this semblance of relative "normalcy."

Although not considered an "essential" service during the pandemic, live music serves as a cultural hub for any city and brings people together from all walks of life, as John, Brian, and I can attest. One late evening, Brian suggested we drop by The White Horse, an iconic honky-tonk bar in East Austin. We were delighted to see so many patrons sporting their finest Stetsons and boots and skillfully dancing the Texas two-step to a band covering Dire Straits' blues-meetscountry hit "Sultans of Swing." The entire scene was straight out of the movie "Urban Cowboy," except on a smaller scale and with more authenticity.

These moments we experienced together are irreplaceable by the likes of Zoom and social media, as are the things that make life really worth living, such as deep-rooted friendships. Not even a global pandemic can take them away.

## **Draws International Flak As Attempt** To Build Up "New Cold War"

**Hypocritical Summit For Democracy**

In the early November 2020, President-elect Joe Biden announced he will summon a socalled Global Summit for Democracy before the end of 2021 to discuss issues of democracy, authoritarianism and human rights. At that time, it was on the news report that President Biden will host the first virtual Summit for Democracy on December 9-10, to be attended by leaders of governments and civil communities and private organizations. The aim was to set an agenda for the "restoration of democracy" and collectively "cope with the biggest threat against democracies today". This kind of summit, however, is not aimed at "fighting against totalitarianism, striking corruption and advancing human rights"; their sword is pointed toward China. Such a brazenly provocative act has caused negative responses internationally.

After learning about the agenda of the summit, Russian Minister of Foreign Affairs Sergey Lavrov fiercely criticized the United States in his speech at the United Nations. Minister Lavrov pointed out explicitly that the U.S. is initiating a new round of ideological struggles against countries which do not align with American ideas or interests. Such an act will not only cause a division in the international community, but also serve as an example of the Cold War mindset which draws a line to pit democracy against authoritarianism.

**Divide the World Again Into** 

#### "We" and "They"

As a result, this "Summit for Democracy" will actually become a game of "power controlling." It controls the power to decide how democratic certain countries are. Despite the U.S. assertion that it does not intend to split the world into groups based on ideologies, the "Summit for Democracy" is in fact undemocratic, attempting to divide the world once again into "We" and "They". Many national leaders and world opinions raised their questions as the U.S. alone chooses participants in this summit under the guise of democracy. Before this, President Biden said this summit will replace the G20 Summit, an attempt to surpass the framework of G7 and G20 which includes China, Russia and Saudi Arabia.

#### Creating a New Cold War **Situation Against China**

Much to the dismay of those who bought solar panels these devices last but for a limited time before they begin to fail.




## What Wall Street Expects From The Fed

The Fed looks at inflation in quarterly chunks. The core inflation rate in the third quarter was 4.5%, which is a lot better than the 6.1% core inflation in the second quarter, but still much higher than anticipated. The Fed's 4.2% annual 2021 inflation forecast disintegrated. The only way its annual forecast could be correct now is if inflation averages zero in Q4. It theoretically could happen, for instance if gas prices plummet, but it is certainly not likely. Wall Street's 4th quarter inflation forecast is still 5.0%.

Inflation could peak on a yearon-year basis in the fourth quarter of this year, though that depends to an extent on what finally emerges from the Build Back Better negotiations. House Speaker Nancy Pelosi's decision to delay the infrastructure vote continually suggests there is still doubt about the ability to reach a spending compromise appealing to both progressives and moderates.

The market currently expects two Fed rate hikes in the second half of next year followed by two more in 2023. While Wall Street believes the Fed will be patient, it is possible that the Fed will not be infinitely patient in the face of ongoing inflation and the realization that inflation is starting to show up in rents and other parts of the core where it was stagnant recently.

September Fed minutes reveal no awareness of a slowdown in monthly inflation rates, while



they did demonstrate a certain amount of frustration and surprise with year-on-year inflation's persistence. As noted in the WSJ, the President could remake the Fed well before rates lift off by appointing as many as four new Governors, effectively replacing a majority of the seven-member board in one fell swoop. The possibility of something along these lines makes policy more difficult to forecast, though it is not likely to undermine the Fed's commitment to either side of its dual mandate or its commitment to the new framework.

Still, if Governor Brainard could become the new Chair, she will likely do what new chairs do to shore up credibility, which usually means a tougher than expected stance against inflation. For example, the first year of leadership under Ben Bernanke or Janet Yellen. Whether Brainard becomes Chair or Powell stays, there will be at least four progressives on the seven-member board even if President Biden swaps out the two Fed Vice Chairs, as he is expected to do.


Tougher bank regulations resulting in a rapid increase in capital ratios could also have an economic impact similar to tightening. There is a real risk the Fed will tighten on top of tightening if they raise rates at the same time that they force banks to raise more capital. Even if the Fed starts tightening sooner instead of later, participants will stop tightening if the economy falters. Remember the early years of Janet Yellen as Chair.

Finally, they may not tighten at all in the second half of next year if inflation subsides. The bottom line, as we wait for the last important pieces that will go into Wall Street's near-term inflation forecast, is that there is an awful lot riding on Washington decisions. Uncomfortably high policy-fueled inflation in the first half of next year will make it difficult for participants to defend a belief inflation will moderate any time soon. The ongoing push for even more government spending can't be helpful if the goal is lower inflation.

It is challenging to have faith in this current administration getting anything right! Let's go Brandon.

For example, look at social media. Some use it as their Freedom of Speech platform to express their opinions, their hate for those who oppose their opinions, and to condemn our government. Do you make a game of "I think I can, I think I can" meaning I think I can get to a gas station on just fumes alone? If so, read on! I've known a few people in my time who enjoy the challenge of pulling up to the gas station on fumes. Sure...they have lost a few times and had to hoof it to the nearest station, buy a gas can and walk back to where their trusty vehicle finally stopped. Some even brag after this experience that now they actually know for sure how many miles they can drive after the fuel warning lights up! I'm happy those people enjoy such games and challenges, but playing that game can have costly, not to mention damaging results for your vehicle.

## **Transactional Leadership**

Leadership style plays a crucial role in the development of an organization. Transactional leadership is of the leadership style that is often used by many companies. Transactional leadership believes that punishment and reward motivate people.

Some organization use incentives to encourage their subordinates for greater productivity. Transactional leadership is a way of increasing the performance of its subordinates by giving them rewards. Transactional leadership is also called as 'true leadership style as it focuses on short term goals instead of long-term goals. In Transactional leadership, when the leader assigns work to its subordinates, then it is the responsibility of the subordinate to see that the assigned task is fin-

The main limitation of this leadership is that it assumes that people are largely motivated by simple rewards. Under transactional leadership, employees can't do much to improve job satisfaction. Transaction leadership

## **"TIME JOCKEY" - Model Magic** Hard to Believe What They Tell You

National Model Railroad Month... We usually think of November as the month to be thankful especially with Thanksgiving celebrated during the third week but November is also National Model Railroad Month. Throughout the United States, model train enthusiasts get together to share stories of model trains, train tracks and train accessories which are used to fuel their hobby interests. In April 1948, the Highland Pacific Railroad was established by the Highland Park Society of Model Railroad Engineers to allow fellow hobbyists to promote the use and interest of model railroad enthusiasts in the Los Angeles area. The society used Al's Hobby Shop in Highland Park as a base and for 10 years the society grew and promoted model railroads. But the business closed in 1959 and the Society sought a new location. A one-bedroom house in San Gabriel was acquired and in 1962 the Society relocated to the historic Mission city.

The house was remodeled to provide a site which the society could meet, show what they do, display their trains and promote their organization. But they also decided to build a highly detailed railroad layout complete with multiple tracks, hundreds of railroad cars, various grades of terrain all running through various geographic scenes complete with cities, towns, villages and all other railroad equipment and accessories. There are two roundhouses, several rail-served businesses, both narrow- and standard-gauge rail lines, and traction

interurban lines. There are tunnels for the trains to go through, along with hills to climb, bridges to cross and switches to take. The detailed train-scape takes one hour to completely circle the course. The entire track layout is 95% hand made including the tracks which are made with miniature nails representing the rail spikes. Town buildings are made in such detail that interior building lights go on and off much like someone had turned them on and off. The existing track and layout were completed somewhere around 1975 and has remained intact today with additional maintenance and upgrades applied as needed to keep everything in running shape.

As unique and special as the train track layout is, even more impressive is the Centralized Traffic Control center which is a master console used to control and monitor all activity over the miniature train track. But even better, all the trains are guided by a dispatcher and five engineers directing where their trains are going. The dispatcher and engineers all sit high above the model train track layout in a balcony perch, able to watch below where their trains are headed and apply any switches as needed. It's an adult's way to stay involved with the hobby he enjoys and at the same time to act like a real train engineer.

The detailed train layout has a possible connection to Walt Disney, who was a huge train enthusiast who included trains as part of his design of Disneyland. One of Disney's top animators was Ward Kimble who lived on San Gabriel Boulevard in San Gabriel. Ward would invite Disney and his wife to lunch in San Gabriel, and they would eventually make their way to the miniature railroad where they would run their trains all afternoon. It's a story that hasn't been widely circulated but there's so many consistencies that indeed Walt Disney enjoyed operating his model trains on the Highland Pacific Railroad in San Gabriel. If you ever see the exquisite layout of the Highland Pacific Railroad, you'd almost have thought that you were seeing something at Disneyland. The museum and site are open every Wednesday and some Saturdays, and more information can be obtained at

The Kiwaniannes are a nonprofit community service club affiliated with Kiwanis International whose goals are to raise


