Three-peat! Upper San Gabriel Valley MWD Named WaterSense Partner of the Year

MONROVIA - For a third consecutive year, the Upper San Gabriel Valley Municipal Water District (Upper District) was honored by the U.S. Environmental Protection Agency (EPA) as a 2021 WaterSense Partner of the Year. Upper District received the distinguished award for its exceptional efforts in assisting residents and businesses save water. Upper District received today's award at the WaterSmart Innovations (WSI) Conference and Exposition in Las Vegas.

The EPA highlighted Upper District's creative outreach efforts to promote water efficiency in 2020 despite the challenges presented by the COVID-19 pandemic. Upper District remained committed to educating its residents on the importance of water use efficiency while adapting its outreach strategies to virtual engagement.

"In 2020, our WaterSense partners continued to make saving water possible by educating consumers and businesses about WaterSense and water-efficient behaviors," said Veronica Blette, the WaterSense program manager. "Our award winners' creative and committed approaches to water conservation helped consumers save water, energy, and money on their utility bills at a time when they needed it most." into a five-week virtual program called Conserve-a-palooza to celebrate its 60th Anniversary during the pandemic. The program featured weekly conservation trivia and raffled various water-efficient devices, including WaterSense labeled weatherbased irrigation controllers and high efficiency washer machines. Winners were announced weekly, and water-saving tips were shared during a "Water Smart Minute" video on Upper District's website and social media.

Additionally, Upper District modified its landscape workshops to be featured as online classes. Throughout Spring 2020, six landscape and edible gardening webinars hosting over 150 residents were conducted. The speakers discussed WaterSense labeled products and how to find an irrigation professional. Upper District collaborated with a number of WaterSense partners on events and programs and encouraged its water retailers to become WaterSense partners.

The nationwide pool of approximately 16,000 semifinalists are the highest-scoring entrants in each state. All semifinalists have an opportunity to continue in the competition for some 7,500 National Merit Scholarship awards worth more than \$30 million to be awarded next spring.

Students entered the 67th annual National Merit Scholarship Program by taking the PSAT Test as juniors which served as the initial screen of program entrants. To move onto the finalist round, students are judged based on a detailed scholarship application covering their academic record, leadership abilities, employment, participation in school and community activities, and honors and awards received.

Students must also write an essay and be recommended by a high school official.

Vaccination Verification Requirements to **Begin at Outdoor Mega Events and Indoor** Portions of Bars, Lounges, Nightclubs, **Breweries, Wineries, and Distilleries**

LOSANGELES COUNTY -On October 7, new vaccine requirements went into effect at select establishments across L.A. County. The vaccination requirements applying to indoor portions of bars, lounges, nightclubs, breweries, wineries, and distilleries affect all patrons 12 or older and all employees.

Prior to entering indoor portions of these establishments, customers and employees will need to show proof of vaccination along with a photo ID. Proof of at least one dose will be adequate for admission, and on November 4, patrons and employees will need to show proof of full vaccination prior to entering.

There are also new requirements in effect for outdoor mega events, including large sport arenas and theme parks, where all attendees age 12 or older will need to show proof of vaccination or a negative test result to enter. Beginning November 1, a

photo ID will also need to be shown for attendees 18 and older along with proof of full vaccination or a negative test result.

If you are going to a Halloween event at a large theme park, or you're cheering on any LA sports teams by attending a game at an indoor or outdoor arena, be prepared to show your proof of vaccination or negative test result if you are 12 or older.

Beginning November 6, a recently passed LA City ordinance requires proof of vaccination from individuals eligible to receive a COVID vaccine to enter the indoor portions of many establishments in the City of LA, including restaurants, personal care establishments, fitness venues, entertainment and recreation venues, along with large outdoor events.

County schools continue to prove that vaccines and other preventive measures, especially masking, are extremely effective. Last week, there were 705 student cases and more than

3,100 student close contacts, decreases of nearly 50% in both groups. Among staff, there were only 97 cases and 51 close contacts. The mitigation strategies school partners have worked so hard to put in place are the driving force behind these downward trends, and we are grateful for all the effort to keep staff, students and their families safe.

As the fall holidays are close, residents of all ages are looking forward to safely celebrating Halloween. The safest activities will be those that are outside, including outdoor costume parties, pumpkin patch visits, outdoor ghost tours, hayrides, and trickor-treating - when done safely. It is best to set up trick-or-treat events outdoors, limit treats to commercially packaged, nonperishable items, set up stations with individually packaged bags so trick-or-treaters can grab and go at each stop, and keep a distance from other trick-or-treaters.

District Attorney Seeks to Reduce Catalytic Converter Thefts

LOS ANGELES COUNTY -District Attorney George Gascón announced that he is asking automobile manufacturers to work with him to explore creative solutions to address the rise in catalytic converter thefts across Los Angeles County and the nation.

"Catalytic converters are quick and easy to steal, and thieves can quickly turn them into cash," District Attorney Gascón said. "In addition, the lack of unique identifiers makes it virtually impossible to prove in court that a particular catalytic converter was stolen."

"These thefts are costly to vehicle owners and result in higher insurance claims for us all," Gascón said, urging automobile manufacturers to join him in seeking "to develop creative and inexpensive solutions to substantially prevent these crimes from occurring and reduce the likelihood of victimization in Los Angeles County and the rest of the nation."

District Attorney Gascón has reached out to the four major automobile manufacturers to request their help in finding a solution to this nationwide problem. To date, only Torrance-based Honda Motor Company, Ltd., has expressed interest in exploring possible solutions to reduce these thefts that target all vehicle owners.

There has been a sharp rise in catalytic converter thefts nationwide since the COVID-19 pandemic began, according to the

National Insurance Crime Bureau. California is among the top five states for catalytic converter thefts, according to the agency

Catalytic converters are used to turn hazardous exhaust from an automobile into less harmful gases. Thieves steal the converters because the devices are made of highly valuable metals such as platinum, rhodium and palladium. They can fetch up to \$1,200 each.

District Attorney Gascón led a similar effort to reduce cell phone theft when he was the top prosecutor in San Francisco. He sponsored legislation making California the first state requiring kill switches on cell phones that make the device inoperable if it is stolen.

County Allocates \$5 Million to Combat Illegal Cannabis Grows and Dispensaries

LOS ANGELES COUNTY

- In an effort to stop the illegal cannabis grow operations springing up in the Antelope Valley and the illegal dispensaries opening countywide, the Board of Supervisors approved nearly \$5 million to address these crises.

"Illegal cannabis operations continue to threaten the well-being of our residents, water supply, and environment," Supervisor Barger said. "By empowering and equipping our law enforcement partners with the resources they need, we can better protect our communities."

The Board allocated \$2.4 million to the Los Angeles County Sheriff's Department to bolster their efforts to stop illegal cannabis growing and water theft in summer in partnership with local,

the Antelope Valley, citing both environmental damage and quality of life nuisances. Of this funding, \$1.2 million is for the Department's Marijuana Eradication Team to eliminate the grows, \$503,000 will go toward overtime for patrol at the Lancaster Sheriff's Station, and \$707,000 will purchase 10 trucks needed to conduct investigations on rough terrain.

Additionally, the Sheriff's Department Cannabis Consumer Health and Safety Task Force received \$2.5 million to combat illegal dispensaries in unincorporated areas across Los Angeles County as well as illegal growers in the Antelope Valley.

During a 10-day operation this

state, and federal partners, the Sheriff's Department seized 16 tons, or \$1.19 billion worth, of illegal cannabis plants in the Antelope Valley. Additionally, they arrested 131 people in connection with the grows, served 205 search warrants, and rescued 180 animals living onsite.

Since 2020, the grows in the Antelope Valley have increased from 150 to more than 500.

The Los Angeles County Sheriff's Department's 2021-22 budget includes an additional \$500,000 in grant funding for cannabis eradication efforts.

The total supplemental budget approved by the Los Angeles County Board of Supervisors on Tuesday was \$39.3 billion.

Unvaccinated Black and Latinx Residents Have the Highest COVID Case Rates; Unvaccinated White Residents Have the Highest Death Rates

LOS ANGELES COUNTY hospitalization rates among both — Between August 29 and September 25, unvaccinated Black and Latinx people had the highest case rates with 587 to 594

vaccinated and unvaccinated residents, with a rate of 62 hospitalizations for every 100,000 unvaccinated people, which is Black residents.

These numbers highlight the need to continue efforts that make it as easy as possible to get the COVID-19 vaccine in our

new cases per 100,000 people. Across all racial and ethnic groups, infection rates among unvaccinated people remained two to three times higher than among vaccinated people. Black residents also had the highest

27% higher than the rate in the next highest group, Latinx residents.

Among unvaccinated people, White residents had the highest death rates of all groups, followed closely by Latinx and hardest-hit communities, especially in those communities with high numbers of residents with chronic illnesses and other risk factors that increase their chances of severe illness from infection.

Grant Provides Vital Funding For The CHP To Enforce Safety For Bicyclists And Pedestrians

SACRAMENTO – To help fund the California Highway Patrol's (CHP) yearlong effort to promote safety for bicyclists and pedestrians, the Department has been awarded the California Pedestrian and Bicyclist Enforcement and Education Project IX grant. Beginning October 1, 2021, this grant enables officers to conduct enhanced enforcement patrols and public awareness campaigns throughout the state.

"It is important for motorists to scan each intersection for foot and bicycle traffic before entering, and it is especially important during hours of darkness," CHP Commissioner Amanda Ray said. "Pedestrian and bicycle fatalities account for nearly one-third of all traffic-related deaths annually in California with the vast majority occurring at night."

In 2019 and 2020 combined, 7,594 people were killed in crashes throughout California, with pedestrians and bicyclists accounting for 2,354 of those deaths.

October is National Pedestrian Safety Month, and on National Walk to School Day, October 6, 2021, the CHP will focus its education and enforcement efforts in locations with high numbers of pedestrian and bicyclist crashes. Officers in plain clothes will work with uniformed officers to monitor crosswalks and areas surrounding schools for motorists who fail to yield the right-of-way or who drive unsafe and illegally.

The educational component of the grant funds traffic safety skills and training courses and informative presentations related to safe traffic behavior for highrisk populations, including older community members and youth. The grant also supports the distribution of safety equipment such as bicycle helmets and reflective gear.

Been Through Fire and Not So Much Water

An old English expression "go through fire and water" translates out 'to undergo great difficulties or dangers and endure any trial' and that seems to be an apt definition of what our Central Valley farming communities have been living with for years. The first seven-year drought brought about some needed water policy amendments to provide relief for farmers with a push towards more permanent long-term solutions. New reports say we're headed into another more severe and dire drought with voter-approved water infrastructure not moving ahead as fast as needed.

Former President Trump took on the plight of Central Valley farmers requesting updates of the 2008 and 2009 biological opinions of endangered fish and implementation of real-time monitoring of endangered fish in the Delta. Full implementation would have allowed shared water use policies by farmers and fisheries to move forward easily. Fish would get the water when they needed it for migration to spawn as determined by real-time monitoring and farmers would receive the water when needed for crop production.

One animal biotelemetry agency said, "Real-time receivers can detect the signal from a transmitter on a passing fish and immediately transmit its identity and time of detection to a website where they can be viewed on a computer or cellular telephone. Real-time nodes can aid regulatory biologists in making important decisions. This is a powerful new tool for resource managers and conservation biologists."

Additionally, "Two case studies illustrate the value of the nodes. The first entails detecting the arrival of migrating winterrun Chinook salmon near a water diversion and alerting regulatory biologists to keep the diversion closed to increase the migratory success. The second study involves the detection of green sturgeon at potential stranding sites, alerting biologists of the need to transport them from that

Former Mayor of Glendora site to the main channel of the river so they can continue their upstream migration to their spawning sites.'

Gov. Newsom, State Water Project and environmentalists immediately initiated a lawsuit and then updated environmental mandates to halt any increase in water deliveries to those south of the Delta. Now the Biden Administration is working with Newsom to overturn Trump's federal water policy changes.

Salmon Quick Notes: More than 9,500 adult winter-run Chinook salmon returned to the Sacramento River to spawn this year, the largest number of returning adults in the last 15 years; and, more than 200,000 juvenile winter-run Chinook salmon have already begun their journey downstream with more than 500,000 expected to successfully migrate downstream.

Congress passed the shortterm funding bill and Sen. Dianne Feinstein said, "The \$29 billion disaster portion of the bill will provide relief for the recent victims of wildfires and other natural disasters as well as farmers who lost crops due to wildfire and smoke damage."

• Removes federal overtime pay caps limiting the number of overtime hours paid to firefighters to fight wildfires for calendar year 2021.

• \$1.36 billion to Forest Service - \$175 million to rehabilitate burned areas and \$175 million for hazardous fuels management. (clearing debris from for-

est floors)

• \$10 billion to Department of Agriculture for crop losses from droughts, wildfires, hurricanes, floods, excessive heat, smoke exposure and other natural disasters.

\$200 million to Bureau of Reclamation to address drought in the West.

California got an extra bump with:

\$238 million for water infrastructure projects

• \$205 million for storage projects with \$80 million for Sites Reservoir, \$60 million for BF Sisk Dam Raise, \$50 million for Los Vaqueros Reservoir expansion and \$15 million for Del Puerto Canyon Reservoir.

• \$21 million for nine water recycling projects in California.

• \$12 million for four desalination projects in California.

Status of Feinstein targeted projects:

 Sites Reservoir - cost is \$5 billion, Prop 1 funded at 50%.

• Los Vagueros Reservoir Expansion - cost \$459 million Prop 1 funded at \$2.9 million.

• B.F. Sisk Dam, a 382-foothigh compacted earth-filled embankment with total capacity of 2 million acre-feet, but not on Prop 1 list.

· Del Puerto Canyon Reservoir, south of the Delta, a jointly funded project by farmers and Exchange Water Contractors to maximize supply, flexibility and local control and looking for supplemental funding.

December 2018, former President Trump, Rep. Kevin McCarthy and Sen. Dianne Feinstein agreed to support a 7-year extension of the 2016 Water Infrastructure for Improvements for the Nation (WIIN) Act to provide millions of federal dollars for California water projects. WINN never passed even with Republican Representatives Calvert and Valadao attempting twice to modify the Act giving Democrats more oversight. It appears, however. Feinstein and McCarthy have found their way through fire and water for the Central Valley.

Our Asylum System is Broken

Last month, appalling images emerged of U.S. Border Patrol agents on horseback chasing and appearing to whip desperate Haitian asylum seekers who had camped under a bridge along the Texas-Mexico border, attempting to cross into the U.S. from Mexico. The photos and subsequent deportation of thousands of Haitians provoked public shock and condemnation. But for many long-time immigration and human rights advocates, this latest mistreatment of Haitian asylum seekers was nothing new. It only confirmed that the U.S. immigration and asylum system is broken and desperately in need of meaningful reform.

The root causes behind why people are forced to flee their homes are often lost amid contentious immigration debates. According to the U.N. High Commissioner for Refugees, the 82.4 million people around the world who were displaced at the end of 2020 fled their homes because of persecution, conflict, human rights violations, and other breakdowns of social order.

In the case of Haiti, recent instability and lawlessness, exacerbated by a legacy of failed U.S. policies, have driven many Haitians to leave their country. Haitian President Jovenal Moïse was assassinated in July. One month later, a devastating 7.2-magnitude earthquake shook the country (reminiscent of the magnitude 7.0 earthquake in 2010), killed thousands, reduced buildings to rubble, and further damaged the economy. Yet these latest misfortunes do not even fully capture the extent of Haiti's struggles since it became the world's first Black-led republic in the early 19th Century after a successful slave revolt against French colonialists.

From 1915 until 1934, the U.S. violently occupied Haiti. In a New York Times column on October 4, lawyer Michael Posner also pointed to "decades of misrule, corruption and brutali-

ty by a series of Haitian governments that received steady U.S. financial and political support" despite glaring human rights abuses. For example, the notorious dictator François "Papa Doc" Duvalier sparked an initial wave of Haitian refugees during the 1960s. His oppressive regime relied on death squads to eliminate political opponents, which resulted in 30,000 deaths.

Our nation's discriminatory treatment of Haitians has also persisted in our immigration and asylum system. During the Reagan administration, U.S. authorities routinely targeted and detained Haitians arriving in Florida and intercepted Haitian boats in the Caribbean to prevent them from reaching America. Several federal court cases later determined that this policy violated constitutional guarantees of equal protection and due process of law. In the 1990s, under both the George H.W. Bush and Bill Clinton administrations, Haitians seeking asylum in the U.S. often faced immediate expulsion, yet Cubans fleeing Castro's Communist Cuba were treated with far more compassion.

Given this historical context, Haitians and Black Americans have argued that U.S. immigration policies have long been discriminatory. Haitians in particular had the lowest rate of asylum approvals from October 2018 through June 2021 out of 83 nationalities where asylum data is

available, according to a September 24 analysis by the Associated Press.

However, regardless of nationality, seeking asylum is enshrined under both international and U.S. law. The 1951 Refugee Convention and its 1967 Protocol define the rights of refugees and the displaced as well as states' legal obligations to protect them. The U.S. adopted these provisions under the 1980 Refugee Act, which guarantees that any person who arrives at our border or has already entered the country is entitled to seek asylum if they can demonstrate a "wellfounded fear of persecution."

The U.S. has nevertheless pursued policies in contravention of both federal and international asylum laws. In 2020, President Trump signed an order based on a rarely used provision of U.S. health law, Title 42, to prevent asylum seekers from applying for legal protection under the pretext of preventing COVID-19. Last month, President Biden again invoked this same order to justify the rapid expulsion of thousands of Haitians without due process.

Fundamentally, the shameful response to Haitian asylum seekers reaffirms that Congress needs to finally act and pass comprehensive immigration reform. This includes fixing a broken asylum system that presently prioritizes border enforcement, detention, and deportation, over the thorough and fair processing of asylum applications in compliance with international and U.S. laws. Rescinding Title 42 would be an important step towards building a more humane asylum system that timely and equitably adjudicates claims, including for Haitians arriving at our borders who fear persecution at home.

A Confusing Mess

Tensions over the debt ceiling apparently have been punted to December after Senate Republican leader Mitch McConnell offered to temporarily raise the limit to avoid an immediate risk of default. While Democrats and the GOP are still working on this agreement, any deal would set up another bruising political fight near the end of the year. The heat was turned up on Wednesday (the 6th) as Defense Secretary Lloyd Austin warned that a default would "threaten national security" and America's ability to defend itself.

Schumer previously ruled out using reconciliation to raise the debt ceiling, saying it is too convoluted and dangerous, though that seems disingenuous given Senate Democrats spent most of their time recently debating the details of an extremely partisan \$3.5 trillion reconciliation bill. Asked by a reporter recently President Biden explained reconciliation would open debate on any number of questions on any number of issues, not just once but twice, first during the vote to allow the legislation to the floor and then again before the vote on the legislation itself. The process would not likely allow Republicans to achieve anything - they don't have enough votes - but it would allow Republicans to force Democrats to reveal positions on issues they would rather not reveal

It could also use a lot of time, perhaps further endangering the Democratic majority's ability to reach internal compromise on the very leftist \$3.5 Trillion welfare/medical/climate bill. As far as that bill goes, Bloomberg News notes the White House team has pivoted from pressuring moderates to bow to progressives to encouraging progressives to bow to moderates. In



other words, they are encouraging a smaller bill which might be supported by all Senate Democrats. However, even a smaller bill would likely move America very far left, toward socialism. It also would create significant tax increase which would "soak main street business" more so than large corporations. One commentary (by Brian Reardon) stated that this "house tax package would hit privately held companies twice as hard as publicly traded C corporations". It could impose "marginal rates of 46.4% on private corporations while taxing publicly traded companies as little as 26.5%".

Both Schumer and Biden told reporters the next step toward permanently raising the debt ceiling might be a vote to suspend the filibuster for debt ceiling votes. The Senate can suspend the filibuster for anything with 51 votes including the Vice President as tie breaker. Senators Sinema and Manchin have said they oppose weakening the filibuster, but the WSJ reports they might make an exception for the debt ceiling. Neither has indicated a position on this specific issue. Fortunately, Senators Sinema and Manchin also are not supportive of the misnamed "Build Back Better Act" which could become a disaster for most private businesses in America.

"TIME JOCKEY" - Discovery Nugget

The Start of Something Big... On the morning of January 24, 1848, James Marshall was working on the building of a sawmill for Colonel John Sutter. Marshall was a carpenter and was overseeing his crew in completing construction of the sawmill when something caught his eye. A shining rock was glittering in the millrace of the sawmill just off the shores of the American River. Marshall picked up the rock and shared it with Sutter, both were confident that the rock was pure gold. But it wasn't until the summer of 1848 that Sutter and Marshall presented the nugget to Captain Joseph L. Folsom who was there to verify the discovery and report back to Washington D.C. Folsom entrusted the nugget to U.S. Army Lieutenant Lucien Loeser who sailed to Panama, where he crossed the isthmus on horseback to the Atlantic Ocean and then proceeded north to Washington D.C. The nugget was examined and tested and then presented to President James Polk.

On December 5, 1848, in his State of the Union address, President Polk announced the discovery of gold in California. Even though word had already leaked out and future prospectors started going west, the announcement made the discovery "official" causing tens of thousand of prospectors to pack up and travel west in search of fame and fortune. The mass exodus of people moving to California would become known as the "49ers" and the movement became known as the



Joe Castillo "California Gold Rush".

President Polk spoke of the great discovery in California and proclaimed that the newly founded wealth would cause the economy to grow beyond expectations and move the United States into the same power status as many of the other European countries. Prices jumped as more money was being made and spent.

By the early 1850's, over 300,000 migrants had traveled to California from other parts of the United States as well as from Europe, China, Mexico, Latin America and even Australia, but the increase of so many people from around the world led to decline of the Native American population in California. Prior to the Gold Rush, the Native American population was 350,000 but within a dozen years only 30,000 remained after most had died from disease, or killed or forced to leave the state after being displaced from their homes.

as a fingernail and had been hammered flat by Marshall as a means of identifying it. The nugget was deposited with the National Institute for the Promotion of Science and then transferred to the Smithsonian Institute in 1862. It remained with the Smithsonian but requests kept coming in to return the nugget to California. The Smithsonian denied the many requests citing the importance to the country and as a compromise chose to replicate the nugget complete with the hammer marks left by Marshall himself and then sent the copies to those who requested it.

In 1998, on the 150th anniversary of the discovery of gold in California, the Smithsonian relented and loaned to the State of California to be displayed at the California Gold Discovery Museum. After its return to the Smithsonian, it was placed on display at the "On the Water" exhibit at the Smithsonian Institute where it is currently housed, and even though its precious metal value is only worth approximately \$5, its historical value is priceless....

"Lady Lark Ellen", The Famous West Covina Opera Singer

WEST COVINA - A world-famous opera singer named Ellen Beach Yaw came to West Covina in 1905 to be near her sister, Mrs. Ben Thorpe. She initially established her home on County land at the corner of today's San Bernardino Road and Lark Ellen Avenue. This land later became part of West Covina and is the grounds for Lark Ellen Hospital.

She was born in Boston, New York State in 1868 and gave her first concert in New York City at the age of 14. After years of study and training Madam Yaw made her formal concert debut in St. Paul, Minnesota in 1894.

She became a world-renowned singer with fame and celebrity status in both the United States and Europe. She sang before all the notables of Europe in 1905-09, and was under contract to the Royal Opera House in Vienna for three years. She was said to sing effortlessly in an enormous range reaching C above high C. This ease and spontaneity inspired Gen. Harrison Gray Otis, founder of the Los Angeles Times, to give her the name "Lark Ellen" since her voice had the pitch and sound of a lark. The name had instant appeal and she became known as "Lady Lark Ellen" or just "Lark Ellen." Out of admiration and recognition, Gray Otis, in 1893 founded the "Lark Ellen Home for Boys."

Today's Lark Ellen Avenue that passed right in front of her first home, is named after her. In 1910 she married Vere Goldwaithe. At east corner of Barranca and his death in 1919 his ashes were placed in a crypt buried on the grounds of their home. When Lark Ellen Avenue was widened. the crypt was moved to the grounds of Lark Ellen Hospital.
