# Carina Rivera and John Wu Appointed as New San Gabriel Councilmembers



# 6 Tips on Running for Office as a Disabled Person

Whether you're happy with the current state of politics or hellbent on change, one thing is clear: People with disabilities are underrepresented in government. That invalidation has far-reaching consequences, no matter what side of the boat you're on. So, what's holding you back? It's time to step up! Follow this ultimate guide to running for office to get started.

#### **Fund the Campaign**

Before you announce that you are running for office, create a budget for everything you may need during the campaign, from printed materials to staffing to creating a website. How much money you need depends on the position you're running for, the district's size, and the opposition. For instance, if you're campaigning for city council in an area with a population less than 100,000, you may need at least \$10,000 or \$20,000 to cover all the expenses. In most cases, direct mailings can account for 70 percent of your costs.

#### **Know Your Opponent**

Before choosing between running for Congress, the state legislature, or municipal or local office, you'll need to focus on your opponent. More than 90 percent of the politicians are reelected, so choosing to run against an incumbent makes for an uphill battle. However, don't get discouraged. That is not to say it's impossible to get elected, but you need to carefully assess whether the incumbent is vulnerable before entering a race. Running for an open seat increases your winning chances.

### **Determine Eligibility and Platform**

Are you eligible to run for office? You may assume you are, but not all candidates make sure that they meet all the requirements for the office, such as residency and age. Another aspect to consider regarding the candidacy is what you are advocating for. Better healthcare? Helping minorities? For instance, if you're a veteran, you may want to look at the latest polls to know what other veterans need.

#### Get Started

First-time candidates with little to no political experience are usually confused as to where they should start. There are numerous resources and tools available online to help you run a successful campaign. Most of them generally cover the basics of creating a campaign, strategies for appealing to voters, building a team of volunteers, supporters and employees, and raising funds.

The quality of your team is crucial to your success. Among your staff, you should have a financing director, campaign manager, and graphic designer to help you with building an appealing website. You need to create a website for your platform where you share your message, essential updates, what you advocate for, and so on. To build and refine your site, consider working with a well-versed graphic designer who can make your website attractive to potential voters. Find a graphic designer via an online job board and check their reviews, delivery times, and prices to make sure they fit with what you're trying to do.

Especially important in a political campaign is networking

and engaging with voters and potential volunteers. Create business cards that include your name, office you're running for, and contact information. ZenBusiness recommends using a basic font and avoiding bright colors when designing your business cards.

#### Seek Help

You may find more resources in your community. If you already belong to a political party, reach out to your local committee to discuss your campaign. The organization should offer you advice, training, and even access to voter demographics, email lists, and historical data. You may also find out how to announce your candidacy, get your name on the ballot, and gather the information that can help support your platform.


### Don't Forget About the Importance of Social Media



From the instant you make the decision to run for office, you have to get to work. Start working now on your campaign, and use the tips above to boost your chances of victory.








# Vaccinated Children Provided **More Protection from COVID** Infection and Hospitalization than Unvaccinated Children

ing, Public Health reminds residents that vaccinations and masking remain important effective layers of protection, especially in school settings and crowded

As of February 10, 34% of 5-11-year-olds and 84% of 12-17year-olds had received at least one dose of the COVID vaccine and 26% of 5-11-year-olds and 76% 12-17-year-olds were fully vaccinated.

Unvaccinated children ages 5-11, were 2.5 times more likely to be infected when compared to those who were fully vaccinated. For those ages 12-17, vaccinated teens were almost 3 times less likely to be infected when compared to those who were unvaccinated.

Similarly, hospitalizations were also higher for unvaccinated children in both youth age

> Between February 7 and 11, nearly 477,000 tests were administered at TK-12 schools across the county; test positivity declined by 90% since the beginning of January to 1.5%. This remarkable decline likely reflects lower rates of community transmission as well as the impact of mitigation strategies that schools are using to reduce transmission.

> When looking at the number of COVID-19 cases among students and staff in K-12 schools by grade level, the largest number of cases have been among elementary school students, followed by high school and then middle school students. The week of January 10-16, there were over 21,000 cases reported among elementary school students, over 11,000 reported among high school students, and

9,200 among middle school students. By the week of February 7-13, cases had dropped to 1,650 for elementary school students, 810 for high school students, and 648 for middle school students.

The number of school outbreaks currently being investigated also declined to a total of 46, down from 56 that were under investigation last week. This includes eight new outbreaks (5 in elementary schools, one in middle school, and two in youth sports) between February 6-12.

The decision to require masks in schools, along with the other mitigation safety measures likely helped to successfully limit the number of school disruptions in LA County during the Omicron surge. Public Health is aware of only eight learning disruptions across LA County at the district level in 2022. Three school districts had selected school closures and the others had a delayed opening or non-instructional day. In each case, the school or district, not Public Health, made the decision to take this action based on staffing and safety concerns.

# **Baldwin Park Receives** \$1.25 Million Grant to **Create Family Bridge Homeless Housing**

**BALDWIN PARK** - At its regular meeting on Wednesday, February 16, the Baldwin Park City Council accepted a \$1.25 million grant from the San Gabriel Valley Regional Housing Trust (SGVRHT) to build more homeless housing.

SGVRHT approved Baldwin Park's grant application just two weeks after the City opened Esperanza Villa, a 25bed tiny home village for unhoused individuals, in November 2021.

"This new funding is another milestone in the City of Baldwin Park's efforts to uplift our unhoused neighbors and bring them out of homelessness," Baldwin Park Mayor Emmanuel J. Estrada said. "I'm grateful to the San Gabriel Valley Regional Housing Trust for awarding Baldwin Park this grant and supporting our efforts to keep Baldwin Park residents sheltered."


The grant will finance housing development at 13167

Garvey Avenue for families that are at risk of becoming or currently homeless. The construction will take place over two phases. In the first, the City will build tiny homes on the cityowned, 0.63-acre property that will open around the time the new school year starts this fall. Then, in the second phase, the City will rehabilitate three buildings totaling 5,212 square feet into shelters that will soon provide up to 50 beds. Baldwin Park purchased the property last fall.

The City will also begin searching for an operations vendor to manage the future housing facilities, and work with partner agencies to provide family counseling, food assistance, medical and mental health assessments, job placements and more to future tenants. The property will also continue to operate as a safe parking site for individuals living in cars.

# **Board of Supervisors Approve Commercial Cannabis Licensing** in Unincorporated LA County

LOS ANGELES COUNTY -On February 15, 2022, the County of Los Angeles Board of Supervisors passed a motion directing the Department of Consumer and Business Affairs' Office of Cannabis Management to start the development and implementation of an equitable commercial cannabis licensing program in the unincorporated areas of Los Angeles County.

The Office of Cannabis Management proposed recommendations in December 2021 following a July 2021 Board directive for a cannabis regulatory framework to address the administrative barriers that create inequitable outcomes and to call for investments to bridge the gaps in educational, technical, and financial resources caused by systemic racism and exacerbated by the War on Drugs.

The recommendations, approved by the Board, recommend launching the commercial cannabis program with a low number of licenses (up to 25 retail, 25 delivery, 10 cultivation, 10 manufacturing, 10 distribution, and 10 testing licenses) with priority for equity applicants. This would allow the County to lead the program with equity, to monitor and assess community impacts and efficacy of regulations, and to build appropriate infrastructure to support potential expansion in the following years.

Until LA County fully develops and launches its cannabis licensing program, all commercial cannabis activities, including retail, delivery, manufacturing, and cultivation, remain prohibited in unincorporated LA County.

"For the past few years, my office and I have worked closely with many community members to combat illegal cannabis businesses in unincorporated areas of the First District. And while we've been able to shut down many illegal dispensaries quickly and permanently, our residents remain frustrated about the lack of effective measures to protect their families from the negative impacts of these unlicensed establishments while also respecting the intent of California's voters who supported the legalization of cannabis," said Hilda L. Solis, Supervisor to the First District, who authored the Board motion. "To that end, the time is right to begin developing a plan for the legal distribution, retail, manufacturing, enforcement, and regulation of cannabis in unincorporated Los Angeles County that is rooted in equitable access, strong and effective enforcement, and community awareness

and education." "A cannabis program that is safe, regulated, and equitable is necessary for unincorporated LA County and for addressing the injustices that have caused communities of color to be disproportionately criminalized and shut out of economic gains from the legalization of cannabis," said Los Angeles County Board of Supervisors Chair Holly J. Mitchell, representing the Second District. "I am proud to coauthor this motion with Supervisor Solis and look forward to the Office of Cannabis Management leading the development of a framework to expand access to opportunity and reduce the stigma associated with the cannabis industry."

"Building a truly equitable regulatory program is challenging and requires a critical rethinking of the County's administrative infrastructures, the cannabis industry including its failures and successes, and government's role therein," said DCBA Director Rafael Carbajal, "The Office of Cannabis Management is committed to participating in this process with our partners to create a healthy, sustainable, and equitable cannabis market in Los

Angeles County." The Board also approved the Office of Cannabis Management's recommendations for a robust Equity Program, which will provide referrals and access to resources such as education, job training, technical assistance, and capital for qualified candidates. The impact of this program would be monitored by a Cannabis Working Group of subject matter experts and County Departments to track equity data and promote data-driven decision making.

The Office of Cannabis Management will work in collaboration with County Departments, community stakeholders and partners and will hold community engagement meetings to share information and gather feedback.

Later this year SGV Habitat will begin construction of a 12home project on Torch Street - the largest SGV Habitat project in Baldwin Park to date. These houses are part of SGV Habitat's "Expanding the American Dream" campaign, which seeks to transform the lives of 100 families by providing homes and/or home repair services by 2023.

"Our goal is to dramatically increase the number of affordable homeownership opportunities in the San Gabriel Valley" says Bryan Wong, Executive Director at SGV Habitat for Humanity. "The need for affordable housing in the area is overwhelming. With Habitat's 'hand up, not a handout' program model we are breaking down the barriers that previously kept many local residents from qualifying for a home purchase."

Currently market rate California homes cost nearly seven times the average household income. The price of homes in the San Gabriel Valley continues to escalate which causes most lower-income families and first-time homebuyers to be priced out of the market. The need for affordable housing is immense, and the lasting impact it can have on families is undeniable. Partnerships like this one between the City of Baldwin Park and SGV Habitat provide a solution to increase access to safe and affordable homes.

### Should Children be given the mRNA Shot?

Any opinions are mine based on the research I have done. I am not in the medical field; if you have any concerns you should talk with your doctor.

Short answer is no, no and no. The vaccines appear to modify your genes by putting new genetic information into your cells, which then causes your own cells to make the spike protein. Many scientists feel the spike protein is toxic to your body. The first two weeks after the vaccine, your immunity shuts down, making you more vulnerable to catch COVID or other viruses. Scientists do not know the long-term side effects of the vaccine. How long will that spike protein stay in the body. Initially, we were told that it stayed in the injection site for two weeks. They do not. They can stay in our body up to fifteen months and travel all over the body. Initially we were told that the vaccines prevented COV-ID. They do not.

The vaccines efficacy is only about two months, then you need another shot, and two months later you need another shot. Each time you are getting a booster, you are introducing more spike proteins into your body. Pfizer expects revenue around \$29 billion from the COVID vaccine in 2022. Perhaps there is an incentive to keep recommending boosters. How rich do you want to make the pharmaceuticals?

The only benefit of the vaccine for adults is preventing one from getting very sick or dying. You have to weigh the risk of having an adverse event from the vaccine versus having COVID, when there is inexpensive successful Early Outpatient Treatment.

Children are at very little risk from COVID severe disease. Most kids in the USA now have natural immunity and many have

nothing more than a cold for the vast majority of children and adults. Even during Delta, children rarely develop severe COV-ID disease. They have strong, healthy immune systems. There is no benefit for children to take this vaccine, unless they have comorbidities or immune deficiency problems. Children have a high risk of an adverse event or even death with the vaccine compared to having COVID. They are six times more likely to get sick from the vaccine. They carry low viral loads and in general, do not spread the virus. Statistically they have a near 0% chance of severe disease or dying from

The vaccine manufacturers have not tested these vaccines with children. Your child getting the vaccine becomes part of the testing trial. The vaccines can affect their future of fertility when they become adults. They just don't know. They suspect that pregnant women carrying a female fetus might have the fetus' ovaries effected by the vaccine. A female fetus has all the eggs she will have for a lifetime. The long-term effects on the vaccinees are unknown until the person is grown up and has children of their own. The FDA has failed in not mandating these studies.

Before the vaccine roll out, the Cardiothoracic Intensive Care been vaccinated. Omicron is Unit (CTICU) of a major San Di-

four or five myocarditis cases a year. In the last half of 2021 there have been 33 cases. Myocarditis primarily affects young men. Over 80% of people who get myocarditis get it after the second vaccine. If you get it after the first shot it's likely you have already been infected with COV-ID. The third vaccine myocarditis data looks bad. It suggests a dose-dependent response. The increased rate of myocarditis cases did not happen by chance. It only started after the COVID vaccines rolled out. How do the numbers change after the four or fifth vaccine? Again, we don't know as the pharmaceuticals never did this test.

## Yemen's Tragic Descent into Chaos

The United Nations has called Yemen "the world's worst humanitarian crisis," yet that designation hardly captures the full extent of misery endured by its people over seven years of violence and unrelenting war. For the most part, American mainstream news outlets have remained silent on this crisis and the U.S. government's complicity in prolonging the Saudi-led war.

In 2014, the Houthis, a Zaydi Shiite Muslim rebel movement, overthrew the Yemeni government under President Abd-Rabbu Mansour Hadi and seized most of northern Yemen, including the capital city of Sanaa. After Hadi fled to Saudi Arabia, a coalition of Arab countries led by Saudi Arabia launched a military intervention in March 2015, mainly fought from the air, to roll back the Houthis and restore the Hadi government. The ensuing proxy war continues today, pitting Saudi Arabia, the United Arab Emirates, and other Gulf Arab states against the Iran-backed Houthis. While Houthi religious beliefs differ from those of the Shiites who rule Iran, both peoples share a common enemy in predominantly-Sunni Saudi Ara-

Yemen's fragmented political history set the stage for the current war. Zaydi Shiites take their name from Zayd bin Ali, the great-grandson of Ali, the Prophet Muhammad's cousin and sonin-law, whom all Shiites revere. For thousands of years, Zaydi's followers have fought for control of Yemen with mixed success. Zaydi republican general Ali Abdullah Saleh came to power in 1978 after a succession of coups. His 33-year rule was notoriously corrupt and autocratic.

Under the leadership of their namesake Hussein al-Houthi, the Houthis emerged in the 1990s as a Zaydi resistance to Saleh and his corruption. Saleh launched military campaigns to destroy the Houthis after many became rad-

icalized following the 2003 invasion of Iraq. Al-Houthi himself was killed in 2004, but his death failed to extinguish the Houthi movement. When an "Arab Spring"-inspired uprising finally ousted Saleh in 2012, a momentary reversal of alliances found the Houthis colluding with Saleh against the new president, Hadi, who had been Saleh's former deputy. Conflict broke out in 2014, and the Houthis later killed Saleh when he shifted his support to the Saudi coalition.

The U.S. has continuously backed the Saudi-led coalition against the Houthis since 2015 and has directly participated in the war despite the absence of Congressional approval. It has provided military logistical support and supplied weapons to both Saudi Arabia and the UAE, who have conducted over 24,000 air raids according to the Yemen Data Project.

While weapons manufacturers have profited from the prolonged war, the Yemeni people have endured unconscionable suffering. Last year, the UN estimated that close to 400,000 Yemenis have been killed by the conflict, with 70 percent of these deaths being children under the age of five. A Saudi blockade of Yemen's ports has fueled the internal humanitarian crisis and has deprived the country of critical food, fuel, and medicine. Over 16 million Yemenis live on the brink of starvation. The indiscriminate targeting

and killing of civilians by the Saudis, Emiratis, and Houthis have also contributed to the death toll.

"Children are traumatized-we tell them don't worry, it's all fine, but they wake up to the sound of massive explosions just like we do," Abdulwasea Mohammed, the Yemen advocacy, campaigns, and media manager for Oxfam, told Common Dreams on January 26.

A year ago, President Biden pledged to withdraw U.S. support from the Saudi-led coalition's "offensive operations" in Yemen. Instead, the opposite has happened. The administration provided over \$1 billion in weaponry to Saudi Arabia in 2021. The U.S. also still provides logistical support for the Saudi air force's deadly bombings. While Biden's State Department has duly condemned the Houthis for their "terrorist attacks" in Yemen, it maintains virtually unwavering support for Saudi Arabia's crimes. When Saudi airstrikes killed at least 70 Yemeni civilians, including three children, in January, the administration called for parties to only "de-escalate."

This failed approach has only intensified the Yemeni peoples' agony. It is within the power of the U.S. to end this war in Yemen through enhanced diplomatic efforts and cutting off the flow of U.S. arms and military logistical support. Congress needs to also rein in America's unconstitutional involvement in this conflict through a new war powers resolution. The international community can also pressure Saudi Arabia to ease its blockade and can assist with sorely needed humanitarian aid

The alternative would be for the U.S. to continue its complicity in this needless bloodshed and for Yemen to sink deeper into

## Do You Know the Law? Can You Refuse to Show ID to Police?

This is an interesting topic... So do you think you know the law??? Can you refuse to show ID to the police in California? This is interesting and it depends on the "approach" when asked. This is a misunderstood "law of compliance" by citizens and also many police officers.

California does not have any laws that require individuals to show ID to the police if they simply ask you for it. If they ask you and you don't want to show it to them and you can politely refuse to furnish ID in most circumstances, they can't do much.

Let me give you a couple of scenarios. You are pulled over by the police while driving. Usually the police officer will come up and introduce themselves and identify what police department they are with. They should tell you why the traffic stop BEFORE they ask you for your driver's license. You, at that point, when asked for your DL and other paperwork for the vehicle are required to present it.

Now if you are pulled over and the officer simply asks for you driver's license, you may contest this. So far, he has not told you why you were stopped. You should ask why and if he tells you, now you are required to present

vour license. If the officer refuses to tell you why he pulled you over, then you can stand your ground and request a supervisor. An officer needs to have probable cause for stopping you in vour vehicle. Otherwise, it is considered "fishing" and that is certainly frowned on.

You don't need to answer personal questions. In fact, you don't really need to say anything to the officers. Be polite and keep you cool. Most police officers do "respect" your right not to talk with them. In my opinion, go ahead and have interaction with the officers. You can at any time simply not answer or respond to a particular questions or statements if you want.

If you are stopped by the police, the last thing you want is to incriminate yourself unknowingly. Therefore, by remaining calm, polite, and reasonable, you can avoid most issues and refuse most requests from the police.

If you are one of those people who doesn't want to cooperate, you better know your rights. So the officer pulls you over and then "tells you the reason" for the stop, the officer has complied with the requirements needed to request your driver's license. You must provide it per California Vehicle Code § 12500. If you refuse because you "know the law..." Better think again. You're going to have some issues which could get out of hand for you. This includes Vehicle Check Points which are sanctioned by the California Lawmakers. You show your driver's license when asked. Other paper work may be asked for as well.

So, let's say you elect NOT to show or provide your license. Here is the deal and many officers don't know they can do this. We had a guy who was defiant and would not show his license during a Vehicle Checkpoint. He was pulled into an inspection area and he still refused to provide a driver's license. There was a simple solution... tow the guy's truck. How can this be done you ask? Well, the officer may know who the truck belongs to via a plate check (10-28, 10-29). However, he doesn't know who the driver is because he won't identify himself or herself. Once the tow truck pulls up in front of the guy's truck, it is usually a game changer. If the driver's vehicle does get towed, this could be a rather expensive interaction with the officers. If he would have complied with the law, this could have been avoided. Many officers are not aware that they can do this (the towing of the ve-

It is okay to exercise your rights, but know what they are. If the officer has a "reason" then comply.

# **Fed Tightening Comes** with Recession Risk

The FOMC appears anxious to start raising rates, which is probably a good thing considering significantly increasing inflation. Whenever the Fed tightens, however, it is a good idea to prepare for at least some possibility of recession. That is especially true when, like now, the Fed is in a hurry.

With markets laser-focused on the situation in Ukraine investors seemed to shrug off the latest figures on red-hot inflation. Stocks powered higher despite a PPI (and strong CPI) that showed U.S. wholesale prices in January soaring 9.7% from a year ago, more than twice analyst estimates and just short of the largest jump on record seen in May 2021. This latest data continues to decimate the 'inflation is purely transitory' theory. After pricing in less than one Fed hike as of last September, markets and Fed watchers now expect between 6 and 7 hikes over the next year, with some arguing for 50-basis point increases (and not just 25).

For those doubting recent signals from the Fed, it's pretty clear that the hawkish monetary era has arrived. St. Louis Fed Chair James Bullard, a voter on the FOMC this year, said he now favors a half-point interest rate hike in March, the first increase

of that magnitude since 2000. While Bullard is on the more hawkish side of the central bank, other policymakers have also expressed urgency about rate increases as well as reducing the size of the Fed's balance sheet, which could put further upward pressure on yields.

The Fed faces a choice. Slow the economy somewhat, avert a significant recession, and tolerate inflation still being at uncomfortably high levels for a couple of years. Or, tighten the economy into a recession in which inflation will subside quickly. We should be concerned that recessions, once started, are not predictable or easily manageable. There's no such thing as intentionally engineering a safely mild recession. The Fed can engineer a recession, and then we will find out whether it is mild or not.

The Biden Administration's

popularity remains ultralow, despite recently strong GDP growth. This is partially because inflation is the #1 problem that most businesses and consumers now share. Consumers are becoming increasingly frustrated every time they go to a gas station or grocery store. Furthermore, businesses are finding it harder to plan as prices of key components continue to rise (even when they can get everything they need). This uncertainty causes price increases, which creates even more inflation, especially as service costs also

To break the back of inflation the Fed must engineer a "soft landing," which is easier said than done. Furthermore, the Fed's toolbox is also compromised due to the fact that if they raise interest rates too much the interest burden on the almost \$30 trillion in federal government debt will be unmanageable. Historic inflation hedges, like residential real estate and growth stocks hopefully will provide somewhat of an investor oasis.

# Your Money - Ask Julia

A friend told me that American truckers might follow the example of the Canadian truckers, and basically go on strike. If this happens, how will it affect me?

IF this happens, it could greatly affect the supply chain for at least several weeks. If the truckers do not pick up and deliver goods to the stores where you shop, the shelves will empty. Don't panic. Don't hoard. Just plan ahead by purchasing items you regularly use. Just like earthquake preparedness, it is better to be prepared and nothing happens than to be unprepared and something happens.

#### My W-2 has a code DD in box 12. What's that?

Box 12, Code DD is the cost of employer-sponsored health coverage. This is for your information only, and is not taxable for 2021. It should include both what you paid and what your employer paid for your health coverage. (ref: www.irs.gov)

#### Is the interest on student loans tax deductible?

Yes, IF you've made all payments on time, and IF your adjusted gross income is within current set limits. The deduction starts to phase out when your AGI (adjusted gross income) hits \$70,000 (filing 'single'), or between \$140,000 and \$170,000 (married, filing jointly). The maximum student loan interest deduction, each year, is limited to \$2,500. You'll need the 1098-E as proof of interest paid. These

figures stay the same for 2022. We bought a home in 2021. What are our tax breaks?

Detailed information is available at State and Federal tax websites, or ask your CPA if it's better for you to take the Standard Deduction, or to Itemize. Also see if you qualify to take deductions for mortgage interest, points paid at settlement, property taxes, exclusive use of home office space for a small business, mortgage insurance premiums, home improvement loan interest, and construction loan interest. You can only deduct interest on up to \$750,000 of your mortgage debt.

#### Can you tell me about Roth IRAs?

Although a Roth IRA is not tax deductible, it has many benefits. By following the current rules, you won't have to pay taxes on any of the money you take out, including the growth. "Qualified distributions" are distributions which are made after a five-year waiting period, and which are

made: 1. after the taxpayer reaches age  $59 \frac{1}{2}$  or 2. In the event of a taxpayer's death, or 3. Because the taxpayer becomes disabled, or 4. To pay for "qualified firsttime home-buyer" expenses (there are limits). Distributions which do not come under any of those qualifications are subject to tax and possible penalties. A real plus is that Roth IRAs are not subject to the mandatory distribution requirements (RMDs) triggered on traditional IRAs at age 72. The amount you can put into a Roth IRA each year is limited, typically not enough to fund your retirement.

#### How does life insurance fit into financial planning?

Some life insurance policies carry benefits that you can take advantage of while you are alive. For example, a Fixed Indexed Universal Life insurance policy gives you the reassurance of having life insurance, potential cash accumulation, plus the option to access that cash account down the road for any reason.

Norman Rockwell... Every artist has a talent that which brings out their creative skills whether its singing, dancing, sculpting, painting or drawing. For the artist whose skill it is to paint or draw, each artist chooses a particular type of art which he or she wants to excel in. It could be modern art or gothic, landscapes or portraits, architecture or automobiles, it all depends on what the artist feels comfortable in drawing. For Norman Rockwell, he chose a very simple topic, drawing everyday people doing everyday things. He drew images of people going through everyday ordinary tasks. The Saturday Evening Post was his platform that shared his unique art with America and Rockwell's magazine covers were the Post magazines' biggest draw.

Rockwell could draw people every day of the year but his best works were images during a holiday. New Year's Day, President's Day, Memorial Day, Easter, Independence Day and Thanksgiving were all the primary holidays which Rockwell brought out the best images of Americans taking time off to enjoy. But the Christmas Holiday was Rockwell's favorite with his artwork showing the joy, happiness and spirit of the

Christmas season that took Rockwell to the heights of the art world. Rockwell's Christmas paintings literally began with the start of his career when at the age of 14 he started by drawing four Christmas card covers for Mrs. Arnold Constable. Within a couple of years, national magazines, manufacturers and advertisers were requesting his services to draw Christmas scenes and request for his services would continue for the rest of his life. His annual Christmas cover for The Saturday Evening Post became so popular it was comparable to a town's lighting of the civic Christmas tree, the annual Christmas concert and Santa's sleigh ride around town.

The Christmas cards Rockwell

designed for Hallmark in the 1940's and 50's were the most popular in the card maker's history and the Brown and Bigelow Christmas calendar he designed were the hottest on the market. Christmas brought out the best artwork of Norman Rockwell, and when he was asked why that was so, he replied that if you really enjoyed your work, you would draw with the same joy and spirit so that those who see your art will have the same joy and spirit which had been drawn. Rockwell truly loved Christmas and the joy, spirit and feeling it had upon people but it was Rockwell's genius that he was able to paint the same joy, spirit and feeling on a blank canvas so that the viewer could "feel the same way". Indeed, Norman Rockwell's unique, simple and ordinary images of regular people doing everyday tasks is what made his artwork so special and continues to be enjoyed by millions especially during the Christmas season

# Drinking The 'Blood Of Jupiter'

As a kid growing up in Oklahoma City, there were certain murmurs about wine, here and there, that I would overhear my parents referencing. When I was old enough to read labels I saw "Burgundy", "Chablis", and "Chianti". Of course, many years forward, I learned that a jug (or box) of Franzia's "Burgundy" and "Chablis" were not Pinot Noirs from the Côtes de Nuit or Chardonnays from the Côtes de Baune, or in fact, Chablis itself. Those non de plumes were super-generic for any cheap white or red wine found in a jug or box. Neither Chablis nor Burgundy is a grape. The aforementioned Chardonnay is the predominantly grown and produced varietal in Chablis and the same can be said for Pinot Noir pertaining to Bur-

But Chianti was never presented as an alias or pseudonym. Rather, it was and is still Chianti, albeit Chianti Classico now and its primary grape is Sangiovese. The King of the hill. If you've ever traveled to or studied Tuscany then you know about the hills, slopes, mountains, and the amphitheatre of the Southern exposure in the region.

Sangiovese, the 'Blood of Jupiter' (etymology: sangius *Jovis*), is the iron fist in a velvet glove. It's a delicate grape. In the higher elevations it produces hints of fresh rose petals and wild cherry with fantastic acidity. In the warmer Montalcino, home of the great Brunello di Montalcino, you experience somewhat of a more powerful and tannic wine with an oxidative character exhibiting the heartiness of the forest and stewed tomato much like those coming from the cucina back at camp.

The aboriginal distinction of its "savoryness" elicits brain waves of hunger. Literally, I can feel my mouth starting to salivate as I inhale Sangiovese into my nostrils. Perhaps, this is why I (and many) believe Sangiovesebased wines are most suited to any cuisine, never mind Italian food. Clonal selection (I won't list

the 50+ clones currently known) as well as better farming has dramatically improved the overall quality of Chianti wines in the past 20 years or so opposed to those nesting wicker basket wines which my parents use to table.

However, the Grosso *Montalcino* is probably the most well known clone. Here in California, the Pepi vineyard Biondi Santi clone of Sangiovese Grosso (Brunello) was experimented with by Robert Pepi in Oakville 1996. California has produced some intriguing Sangiovese wines over the last 10-15 years, scoffed at by Sangiovese snobs and devoured by others. Although it may be sacrilegious for Sangiovese to be grown outside of Italy to the purist but, like in California, Australia has respectfully jumped on the

gondola to produce some fascinating wines.

Old world classics like Merlot, Syrah, and Cabernet Sauvignon are very tempting for new world winemakers to blend with Sangiovese. Yet, I tend to cringe a bit when those blends exceed 6% because of the easily influenced nature of Sangiovese. Those old classics are all alpha wines in the company of Sangiovese and tend to develop into wines other than Sangiovesetype wines. They lose that native bitterness and overall regional "Italianess" that I've come to love and appreciate. Perhaps the most ideal matrimony is that of Canaiolo (traditional Chianti blend up until the late 19th century) or Colorino (adding color) which brings about the old world nature of Chianti that, perchance, my sagacious parents were murmuring about when drinking the



# **Glendora Library Celebrates 50** Years At 140 S. Glendora Avenue

**GLENDORA** – On Monday, February 28, 2022, the Glendora Public Library's Board of Library Trustee's will celebrate the institution's 50 years at their current location, 140 S. Glendora Avenue. Supported by the Glendora Public Library and the GPL Friend's Foundation, the Board of Library Trustees have invited the City's Mayor and Councilmembers, partner agencies, and the public to commemorate the occasion with a ribbon cutting ceremony, followed by a brief celebration. ### Azusa Police Officer Shot, Suspect Killed

AZUSA - On Wednesday, February 16 around 4:15 PM, Azusa police went to the area of the 1000 block of West Gladstone to investigate a stolen vehicle that they came up on. They noticed a female in the car and a white male in his 30s by the car. As officers approached, there was a confrontation and the man took off running. A rookie officer along with his training officer gave chase and again they were able to catch the suspect, however during the struggle, the suspect pulled a gun and fired at the officers striking the rookie officer in the abdo-

men. Officers returned fire striking the suspect a number of

The injured officer was transported to the hospital in critical condition; however, he has been upgraded to serious condition and is expected to recover from his injuries.

The suspect was pronounced dead at the scene. He was identified as Mathew Cook, 32, a male white out of Los Angeles. He shows only one previous arrest and that was a low-profile felony where bail was set at \$1000. Without posting bail, he was given a citation and release an hour and a half after his arrest.

Outside of being "near" a stolen car, it is unknown why he ran which led to him getting himself killed after trying to kill the police officers that were chasing

The woman that was in the car was arrested on suspicion of possessing a stolen vehicle. She has since been released with a ticket.

The Los Angeles County Sheriff's homicide detectives are investigating the shooting.

Gladstone Street was closed off to through traffic while the "on scene" investigation was going on.

### **Traffic Collision Results in Fatality**

**IRWINDALE** - On Monday, February 21, 2022 at about 4:29 P.M., officers from the Irwindale Police Department responded to the report of an injury traffic collision in the eastbound lanes of Arrow Highway at Gayhurst Street in the city of Irwindale.

On arrival, our officers discovered that a gray 2019 Kia sedan was traveling eastbound on Arrow Highway when it collided with a white 2016 Ford pick-up truck that was making a left turn from westbound on Arrow Highway to southbound on Gayhurst Street. As a result of the collision, the Kia sedan subsequently struck a Southern California Edison (SCE) utility pole, causing a power outage to residences and businesses in the area.

Paramedics from the Los Angeles County Fire Department arrived and pronounced the male driver of the Kia deceased at the scene. A female passenger was extricated from the vehicle and taken by helicopter to a local trauma center with non-life threatening injuries. The driver of the Ford truck was not injured and remained at the scene, cooperating with the investigating officers.

All lanes of Arrow Highway between Elton Street and Lante Street were closed for approximately 8 hours during the traffic collision investigation. Officers from the Azusa and Glendora Police Departments assisted with the investigation. SCE crews are currently on-scene to restore

power and to repair the damaged utility pole. This work is expected to take 24-hours to complete.

The identity of the deceased driver, an adult male, is not being released at this time, pending confirmation of his identity by the Los Angeles County Medical Examiner-Coroner's Office.

The cause of this traffic collision remains under investigation and it is not yet known if drugs or alcohol were a factor in the collision.
